#### 23. PUBLIC PARTICIPATION - DECISION SESSION

It was reported that Councillor Warters had registered to speak on the Annual Highway Maintenance Report as Ward Councillor for Osbaldwick. He raised the following issues:

- He was disappointed to note that the funding for work on Tranby Avenue in the Osbaldwick Ward had been cut to £100k as at that level, in his opinion, the work would take at least 6 years to complete.
- He asked for a report on the background to Tranby Avenue be brought to the Cabinet Member and invited the Cabinet Member and the Leader of the Council to walk Tranby Avenue with him so they could see for themselves the poor state of repair.
- He queried annex 5, footway maintenance, in particular why Moatfield Road had been allocated funding as there had been no complaints. Upon inspection it appeared to

be in good order. He asked that the funding instead be put towards works in Tranby Avenue if possible.

- In relation to Osbaldwick Village (Murton Road), he queried if the developers of a nearby site would be paying for the repairs to the road. Officers confirmed this would be followed up.
- He asked that street name signs could be placed on walls rather than verges in the Osbaldwick area in future. This would assist grass cutting.
- He also highlighted that tree planting was being compromised by gas works as he had noticed rubble being placed into the ground instead of soil on verges after works had been carried out.

The Cabinet Member noted the comments made and apologised for the requested report on Tranby Avenue not being completed earlier.

#### 24. ANNUAL HIGHWAY MAINTENANCE REPORT

The Cabinet Member for Communities and Neighbourhood Services considered a report which provided a review of the service performance in highway maintenance over the last year. The report examined issues arising and proposed programmes of work to be undertaken in the financial year 2012/13 and a provisional list for 2013/14.

Officers had no further updates on the report and the Cabinet Member was happy to approve the recommendations.

Report of the Assistant Director (Culture, leisure and Public Realm)

#### **Review of City Centre Litter Bins**

#### Summary

1. This report details the proposed number and locations of bins to be removed and or replaced and the options for their replacements. A decision is required on the number of bins to be removed and a reduction in the options for replacements.

#### **Background**

- 2. There are currently 100 litter bins within the city centre foot streets and some of the adjoining areas, these are made up from five different types and many of these are in need of replacement or refurbishment. The opportunity exists to reduce the overall number of litter bins provided and to standardise the style of bins down to two, which would then be used within the Reinvigorate York Design Manual. This would link well with the de-cluttering of the streets initiative.
- 3. During a trial of a solar powered compactor bin in Kings Square in which we removed six standard bins, we saw no increase in litter levels and reduced the weekly empties of bins in the location from 105 to 14.
- 4. It was also noted that we removed a bin from the junction of Blake Street and St Leonards Place last year and there has been no significant increase in litter levels, also there are no bins along Stonegate, again with little evidence of litter.

#### Consultation

5. Reinvigorate York Design Group – Views on replacement and location of bins - unsurprisingly there was mixed opinion on the

type of bin to be used to replace the smaller bins, some favoured option 2 (annex 2), clarification is being sought on a few concerns that were expressed, although the concept of only 2 types of bin and reduced numbers were welcomed.

- 6. <u>Sir Ron Cooke York Civic Trust</u> Views on replacement and location of bins Sir Ron was very enthusiastic about the new solar powered bin due to its potential to reduce the number of bins on our streets and favoured option 1 for the smaller bin option (annex 3).
- 7. <u>Front Line Staff</u> Views on replacement and location of bins The solar powered bin was seen as a great success and option 2 was favoured for the smaller bins from both the look and serviceability point of view.
- 8. <u>York Minster</u> The minster are looking at options for replacement of litter bins in the minster gardens and adjacent locations, and are interested in procuring bins that compliment ours in design.

#### **Options:**

- 9. Option 1 Maintain the current number of bins.
- 10. Option 2 Reduce the number of bins to 53 by:
  - Removing 60 old bins
  - Replacing the remaining 40 bins with new smaller bins
  - Installing 13 solar powered bins

Please refer to Annex 1 for details of locations.

### **Analysis**

### 11. **Option 1** –

- Advantages none.
- Disadvantages:
- Budget pressures regarding replacements in future years
- Poor cleanliness standards at peak times

#### 12. Option 2 –

#### Advantages:

- Reduced budget pressures in future years.
- Improved cleanliness standards at peak times.
- Reduced street clutter.
- Have a minimum number of choices of bins for future years.
- We can use the bins removed from the city centre in our outer areas.
- We will be able to utilise mobile technology.

#### **Council Plan**

13. This will contribute to the Protect the Environment section of the council plan, by linking into the Public Realm Strategy and standards of future management.

#### **Implications**

- 14. **Financial** The purchase and installation of the new bins will be met from the allocated one off budget of 75k, the cost of an annual service for the solar powered bins will be met from existing budgets, income could be generated in the future via the use of wifi links on the solar powered bins.
- 15. **Human Resources (HR)** There are no HR implications.
- 16. **Equalities** There are no equality implications.
- 17. **Legal** There are no legal implications.
- 18. **Crime and** Disorder There are no Crime and Disorder Implications.
- 19. **Information Technology (IT)** There will be scope for use of Wi Fi from the Solar Bins and link to our mobile working technology.

- 21. Other There are no other implications.

#### **Risk Management**

#### Recommendation

23. The Cabinet Member is recommended to approve:

Option 2 – Reduce the number of bins to 53 by:

- 1) Removing 60 old bins.
- 2) Replacing the remaining 40 bins with new smaller bins.
- 3) Installing 13 solar powered bins.

#### Reason:

To improve the appearance and maintenance of the public realm and set the standards for future provision of city centre bins.





# Written representation received in respect of Agenda item 4 – Review of City Centre Bins

I would like to make the following comments on Agenda Item 4 for the meeting on 15<sup>th</sup> May.

The report does not convince me that this is the right solution for the City Centre. The use of the solar powered compactor bin in Kings Square appears to have been a success and, whilst I can see that there are other areas where this could be solution, I feel that this is where there is a "self contained" area. Residents and visitors sitting in Kings Square or other squares can see the bin. In much more open areas such as Parliament St where people tend to be on the move they are less likely to walk a long way with their rubbish if they cannot immediately see a bin.

I cannot believe that removing 5 bins from St Helens Sq, leaving just 1small one (not even a Big Belly one) will not to lead to an increase in litter. The report is less than clear on some issues.

- A photo of the solar powered bin would be useful.
- I am not sure which of the two small bins is proposed as the replacement design.
- Recommendation 2. Does this mean that some of the replacement bins will be smaller than those currently in place?
- Para 12. There is no explanation of why will be able to utilise mobile technology.
- Financial implications. How will income be generated via Wi-fi links on the bins given the Leaders much publicised "free city centre wi-fi"?
- The financial implications are very vague. There is no breakdown of the costs of Big Belly bins or the small bins or how much the annual service will cost.
- The source of the £75K is opaque. Members of the public will wonder where this money has come form.
- There is no reference as to how these changes will contribute to achieving the £40k budget saving in the budget (CANS 05)

When Labour were in opposition they supported the provision of bins that included recycling facilities. This doesn't seem to have been pursued and I feel that it is a missed opportunity. Indeed the one that was provided in St Helens Square is not longer there. Even if we currently extract cans

and bottles from litter bin waste this will no longer be an option with the waste that is compacted in the Big Belly bins.

When in opposition Labour frequently criticised litter bin provision in the city centre. This report seems to contradict those views and may well not achieve the desired outcomes.
