16. **Declarations of Interest**

The Cabinet Member was asked to declare any personal interests not included on the Register of Interests, any prejudicial interests or any disclosable pecuniary interests which he might have in respect of business on the agenda. None were declared.

17. **Minutes**

Resolved: That the minutes of the Decision Session held on 11

March 2014 be approved and signed as a correct

record.

Public Participation/Other Speakers 18.

It was reported that there had been no registrations to speak at the meeting under the Public Participation Scheme but that two Members of Council had registered to speak.

Councillor Reid spoke in support of the Dringhouses and Woodthorpe Ward Winter Maintenance Petition (agenda item 4). She stated that this was the third time that she had spoken on the issue of salt bins and that it was fortunate that it had been a mild winter. She understood that there had been a budget overspend in the winter maintenance budget and hence there would be a need to review this budget. Although some Residents' Associations had chosen to fund some salt bins, not all of the ward was covered by a Residents Association or Parish Council. The changes in respect of ward committee funding was also a factor. Whilst supportive of the efforts of involving residents through the snow wardens initiative, it was important that there was adequate provision of salt bins.

Speaking in respect of agenda item 5 – Annual Highway Maintenance Report, Councillor Reid stated that she welcomed the extra funding that the Government had announced for road repairs and hoped that York would receive its share.

Councillor Richardson, speaking in respect of agenda item 5 – Annual Highway Maintenance Report, stated that he welcomed the fact that Windsor Drive had been included in the proposed Surface Treatment Programme 2014/15 but raised concerns regarding the condition of South Lane in Haxby. He stated that the poor condition of the road markings meant that parking restrictions could not be enforced and that this was causing real problems in the area. Referring to the winter maintenance programme, Councillor Richardson expressed concern at the lack of salt bins on the main thoroughfare to Ralph Butterfield Primary School. He requested that, at the very minimum, a bin be provided on Usher Lane.

19. Dringhouses and Woodthorpe Ward Winter Maintenance Petition

The Cabinet Member considered a report in response to a petition, with 179 names and addresses of residents, submitted to the Council by Councillor Reid. The petition requested that the Council retain the existing salt bin and gritting position in the Dringhouses and Woodthorpe wards.

The Cabinet Member considered the following options:

Option 1: Consider the petition and reinstate the winter maintenance service to the 2012/13 arrangements

Option 2: Maintain the approved winter maintenance service for 2013/14

The Cabinet Member stated that he was satisfied that the current gritting regime was safe and effective.

Resolved: (i) That the petition be noted.

(ii) That Option 2 (Maintain the approved winter maintenance service for 2013/14) be approved.

Reason: The revised policy is derived from consultation and

best practice guidance and allows for routes and grit bin locations to be prioritised and ranked accordingly

providing a safe, efficient and effective service.

20. Annual Highway Maintenance Report

The Cabinet Member considered a report that provided a review of the service performance in highway maintenance over the last year. The report examined issues arising and proposed programmes of work to be undertaken in the financial year 2014/15.

The Cabinet Member stated that every effort would be made to ensure that York secured a fair share of the funding for road maintenance that had been announced by the Government.

Referring to concerns that had been raised regarding road markings on South Lane, the Cabinet Member stated that he would discuss this issue with officers. He would also ask officers to consider whether they could work with snow wardens in that area to address issues that had been raised regarding the situation on the route to the school.

The Cabinet Member thanked officers for their work in preparing the comprehensive report.

Resolved: (i) That the review of 2013/14 and proposals for 2014/15 be noted.

- (ii) That the allocation of budgets for 2014/15, as detailed in the report, be approved.
- (iii) That the implementation of the proposed programme be approved.

Reason: To ensure delivery of highway maintenance services in an efficient and cost effective manner.

Decision Session – Cabinet Member for Environmental Services, Planning & Sustainability 13th October 2014

Proposed Upper and Nether Poppleton Neighbourhood Plan

Summary

1. This report provides an update on the proposed joint Upper and Nether Poppleton Neighbourhood Plan and specifically requests that the Council approves the formal application to allow the Plan to progress.

Background

- As part of the Localism Act 2011, local communities are encouraged to come together to get more involved in planning for their areas by producing Neighbourhood plans for their area. Neighbourhood plans are centred specifically round creating plans and policies to guide new development.
- 3. Neighbourhood planning is about letting the people who know about and care for an area plan for it. It is led by the residential and business community, not the council, and is about building neighbourhoods not stopping growth.
- 4. If adopted by the Council, neighbourhood plans and orders will have weight becoming part of the plan making framework for that area. Designation of a Neighbourhood Area is the first stage in the preparation of a Neighbourhood Plan.
- 5. Upper and Nether Poppleton Parish Councils submitted a joint application on the 19th May 2014. This application and associated boundary map is attached at Annex A.
- 6. The proposal is a joint one from Upper Poppleton Parish Council and Nether Poppleton Parish Council. The application boundary is the same as that of the two Parish Boundaries, which are adjacent to one another. It is this 'area application' that we are asking Members to approve.

Next Steps

- 7. If the area application is approved, the Council must publish the following details of the Plan:
 - The name of the neighbourhood area
 - A map identifying the area
 - The name of the Parish Councils who applied for the designation.
- 8. If they receive formal approval, Upper and Nether Poppleton Parish Councils can prepare one Neighbourhood Plan for the two parishes with assistance from the Council. They are then required to undertake pre submission consultation by publicising the proposals and inviting representations for a period of not less than 6 weeks.
- 9. The Parish Councils can then submit the Neighbourhood Plan to the Council along with a consultation statement containing details of those consulted, how they were consulted, summarising the main issues and concerns raised and how these have been considered, and where relevant addressed in the proposed Neighbourhood Plan.
- 10. On receipt of the draft Neighbourhood Plan, the Council needs to publicise the Plan and invite representations for a period of not less than 6 weeks. Once the Council is satisfied that the Plan meets the requirements of the Town and Country Planning Act 1990 the Council then appoints an independent inspector. The Council is responsible for paying the costs of the examination (see Table 2 below) so it is in the Council's interests to ensure that the proposed plan meets the requirements.
- 11. The Examination and subsequent Referendum will follow. Should the vote be in favour (50% plus 1), then the Council will publish the Neighbourhood Plan.

Timetable

12. Table 1 below sets out an estimated timetable based on the experience of other Local Authorities. This will be influenced by the progress on the York Local Plan as a Neighbourhood Plan must be in conformity with it.

Costs

- 13. Based on examples from other Local Authorities, costs to the Council per Neighbourhood Development Plan is estimated to be approximately £40,000, albeit the costs of preparing neighbourhood development plans will vary depending on the complexity and size of the proposal, and the available supporting evidence. There is a significant level of human resource costs required. A high level of officer input at an appropriate level is needed to ensure legal conformity, plan content and appropriate liaisons with Parish Councils.
- 14. Whilst central government funding sources; Neighbourhood Planning Grant, from the Department for Communities and Local Government to the value of £30,000 is available for each Neighbourhood Plan produced, this still leaves a shortfall of approx £10,000 per neighbourhood plan. This shortfall will need to be met within existing resources.

Consultation

- 15. The Localism Act (Regulation 6) requires that the information to be published is:
 - A copy of the application
 - Details of how to make representations
 - Details of the deadline for representations, not less than 6 weeks after the date of publication.

This should be published on the website and in such other manner as is considered likely to bring the area application to the attention of people who live, work or carry on business in the area to which the area application applies.

- 16. The Council formally published the joint Upper and Nether Poppleton Parish Council's application on Monday 11th June for a 6 week period until 28th July 2014.
- 17. The application was published in the following ways which are legally compliant with the Act:
 - A letter, with the application attached was sent to the Parish Council (for info);
 - The neighbouring parish councils of Skelton, Rawcliffe, Rufforth with Knapton, Hessay, Moor Monkton and Overton;
 - A notice and a copy of the application was put up at several prominent locations around Upper and Nether Poppletons including the Parish's notice boards;
 - A letter with the application attached was sent to all businesses in Upper and Nether Poppleton;
 - A webpage has been created at <u>www.york.gov.uk/neighbourhoodplanning</u> where the joint Upper and Nether Poppleton application is available to view as well as additional information on the Neighbourhood Planning process.
 - A specific email address <u>neighbourhoodplanning@york.gov.uk</u> has been set up for representations as has a freepost address.
- 18. We have received 1 representation in support of the application for a joint Upper and Nether Poppleton Neighbourhood Plan.

Option Choices

- 19. The following options are available for the Cabinet Member to consider:
 - **Option 1** approve the application for a Poppleton Neighbourhood Plan, including the proposed boundary (attached at Annex A);
 - **Option 2** approve the application subject to amendments to the Neighbourhood Plan boundary;
 - *Option 3* reject the application.

Analysis

20. In accordance with the Regulations, the Council needs to consider how desirable it is to designate the whole of the Parish area as a neighbourhood area. Given that the proposed boundary is the existing Parish boundary and it is the Parish Council who wishes to proceed with Neighbourhood Plan, it is advisable that the application is viewed favourably. In addition, the extensive level of support received from residents and businesses of Upper and Nether Poppleton, would mean that the Plan would be beneficial to the community.

Council Plan

21. The proposed Poppleton Neighbourhood Plan will be a positive contribution to the Council Plan priority of "Building strong communities".

Implications

- 22. Financial/Programme If the council supports options 1 or 2 to produce a plan for Upper and Nether Poppleton the council will be required to pay for the examination and the subsequent referendum. The costs of these statutory processes will be met in part by central government funding sources from the Department for Communities and Local Government. Any shortfall will need to be accommodated within existing resource

Nether Poppleton with Upper Poppleton Parish Councils

Application to City of York Council For designation of Neighbourhood Plan Area

Introduction

The two parishes of Nether and Upper Poppleton are situated approximately four miles north west of the centre of the historic city of York. The River Ouse bounds the village to the north and east and by the A 59 York to Harrogate road to the south and west. Poppleton, Nether and Upper, consists of two old village cores, which have coalesced to form one community. Recent expansion in the Parish of new housing and commercial areas now are included within the parish boundaries and it is the whole parished area that is the subject of the Neighbourhood Plan.

Statement explaining why the parish is considered to be an appropriate neighbourhood area.

The Parish Councils have jointly worked on a number of projects examples of which are attached as Appendix B. Whilst meeting independently the Parish Councils represent the interest of all the residents of the area designated on the attached map(Appendix A). Nether and Upper Poppleton are statutory consultees on planning applications within the parishes. Consultation to date shows that there is a desire for a neighbourhood plan, particularly given the recent government legislation with regard to localism. The villages jointly produced a Village Design Statement in 2003 and this will give the initial platform for the development of a Neighbourhood Plan. The Parishes already manage many areas, including the village greens, the Millennium Green, the Moat Field and other significant green spaces. The Parish Councils give financial support to numerous village groups and organisations and actively keep parishioners informed though its websites, Twitter account, notice boards and regular newsletters.(Appendix C example)

Nether Poppleton Parish Council as the Relevant Body


The two parish councils are the official statutory first tier of government in this parished area and enjoy strong support of the local community. For the purposes of this submission it has been agreed that the Chairman of Nether Poppleton Parish Council, will act as the lead to the executive committee comprising 2 councillors from each Parish. The Councils have considerable collective knowledge of their areas and a deep understanding of the area's planning opportunities and constraints and how these interact with the aspirations and concerns of the residents of the parishes.

Conclusion

Nether Poppleton Parish Council has been formally designated as the relevant body, working with the City of York Council, to produce the Neighbourhood Plan for the whole parished area.


