Consultation

Micklegate Ward – Proposed junction protection on Campleshon Road at the Lorne Street junction

Decision Requested

To consider an objection made to a proposal to introduce no waiting at any time restrictions for 10m on Campleshon Road at the junction with Lorne Street.

Reason

To resolve issues received during the consultation period and complete the process.

Background Information

A project was undertaken to bring all the advisory School entrance markings into the Traffic Regulation Order to enable enforcement to take place. The proposals were advertised using delegated powers (Head of Network Management). One of the main pupil entrances to Knavesmire School is from the Campleshon Road elevation where no advisory marking was in place. Consequently, in addition to the proposal to enforce existing school entrance markings on Lorne Street and Trafalgar Street an additional zig-zag marking was proposed outside the school entrance with proposed no waiting at any time restrictions at the junctions with Lorne Street and Trafalgar Street.

We have received two objections to the proposal with regards the proposed no waiting at any time restrictions on Campleshon Road to the west of the junction with Lorne Street (adjacent to 30 Campleshon Road)

A plan of the proposal with recommended amendment is included as Annex A

Consultation Process

The proposals were advertised on street and in a local newspaper (The Press). Details of the proposal were hand delivered to properties adjacent to the proposed restriction.

Objections Received to the length of no waiting at any time restrictions on Campleshon Road to the west of the junction with Lorne Street

Objections received from residents of 30 & 32 Campleshon Road

Précis of objection from number 32 Campleshon Road:

We have a disabled son who is quadriplegic Cerebral Palsy and is 100% physically reliable on support and is wheelchair bound. Conversions are being undertaken at the property to accommodate our son's needs. This includes the adaptation at the front entrance to include a ramped access. When this is done the mobility vehicle will no longer fit onto our driveway and we will need to place this on the carriageway outside our property. We propose a disabled parking space is allocated to us at the front of our property to enable our son to have direct access to our home.

Précis of objection from number 30 Campleshon Road:

I am concerned that under the proposed scheme, the area outside our house which we use for parking will no longer by available. Parking availability on Lorne Street is often full and will become more heavily used under the proposed scheme and possibly more so under the Terry's development. I am concerned we will end up with nowhere to park our cars. Would it be possible to be issued with some sort of residents permit to park on the no waiting areas?

Officer Comments

The objections only refer to the proposed length of no waiting at any time restrictions (double yellow lines) on the carriageway adjacent to 30 Campleshon Road

A site meeting was conducted with the objectors to the proposal to discuss what could be achieved and how their needs could be incorporated. The resident of 32 Campleshon Road normally parks his vehicles on Lorne Street and has an area with 3 garages and hard standing to the rear of his property and I was given to understand their objection was made in consideration of their neighbour's needs.

A shorter length of 8m would allow an adequate length of disabled parking to be provided outside 32 Campleshon Road for the use of their mobility vehicle.

The residents have been advised that any disabled parking provided will be suspended when temporary orders are in place to prevent carriageway parking on race days and other major events at the Knavesmire.
