Positive: A reduction of non-resident parking should make it easier for residents and their visitors to park nearer to where they want to be. Any inconsiderate parking causing obstruction of individual access will be identifiable and make it easier for residents to solve between themselves. Because the level of parking has been reduced there should be less need for residents to park on the grass verges, causing damage, or close together causing narrow chicanes which can be difficult to manoeuvre and can cause obstruction for larger vehicles, including emergency service vehicles. Negative: The main negative impact is the cost of the permits and visitor permits. Those who are elderly may receive more visitors during the operative times which can be more expensive for them over other community groups. Current cost is £51.50 annually (less than £1 per week) with discounts for some vehicles (short length/low CO2 emissions).
