1. Employment, Office, Trade, Profession or Vocation

2. Sponsorship	
You should declare any payment or provision of any other financial benefit (other than from the Council) made or provided within the last 12 months in respect of expenses incurred by you in carrying out your duties as a member, or towards your election expenses. <i>Note - This includes any payment or financial benefit from a trade union</i>	
3. Securities	
You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and either the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, or one	

hundredth of the total issued share capital of any class of shares issued. "Securities" does not include building society accounts but includes securities of all other descriptions such as shares, debentures, stock, loan stock and units of a collective investment scheme

4. Contracts	
You should detail any current undischarged contract made between you, or a body in which you have a beneficial interest, and the Council under which goods or services are to be provided or works are to be executed You have a beneficial interest in a body which is a firm in which you are a partner or a body corporate of which you are a director, or in the securities of which you have a beneficial interest

5. Land, Licences and Corporate Tenancies
