LICENSING ACT 2003 SUB – COMMITTEES PROCEDURE FOR <u>REVIEW</u> HEARINGS

Introduction

The procedure adopted at the Licensing Review Hearing is at the discretion of the Sub-Committee but will normally follow the pattern outlined below.

The Council's hearings procedure is based on regulations made by the Secretary of State under the Licensing Act 2003. The procedure is intended as a general framework to ensure natural justice and a fair hearing. The Sub-Committee has a duty to view all evidence presented before them impartially.. No matter how strong local opinion may be, Committee Members can only make decisions based on relevant licensing issues as set out before the Sub-Committee in determining applications.

The hearing will be in public session. However, the Sub-Committee may exclude the public from a hearing if it considers it in the public interest to do so. However, the decision will be made in private.

In view of the requirement to hold hearings within specified times, the Licensing Authority will generally be unable to enter into discussions to identify dates convenient to all parties concerned. In exceptional circumstances, the Licensing Authority will consider applications to adjourn hearings to a later date.

Representations at Licensing Hearings

The Applicant for the Review, and the Licence Holder(s) are permitted to speak at the hearing. Ward Councillors, Responsible Authorities and Representors who have made written submissions during the consultation period will also be allowed to speak. Any party to a hearing may be assisted or represented by any person, legally or otherwise.

All parties will be given a fair hearing, and each party will have the same amount of time in which to address the Sub-Committee. **Each party will have 15 minutes to address the Sub-Committee and call any witnesses.**

The Sub-Committee may take into account any documentary evidence or other information in support of the application, representations or notice, submitted either before the hearing or, with the consent of all other parties, at the hearing.

If any Representors fail to attend the hearing, the Sub-Committee will normally proceed but will consider their written representation. In considering written evidence in the absence of a Representor, appropriate weight will be attached, given that the person cannot be questioned by the Applicant for the Review, the Licence Holder(s) and Members.

The Sub-Committee is required to disregard any information given or evidence produced by a party or witness which is not relevant to the application, representations, or notice, and the promotion of the licensing objectives. Duplication should be avoided. Comments must be confined to those points already made, although the parties may extend or expand on their written submissions. The Sub-Committee will have read and familiarised themselves with all the written submissions and the issues prior to the hearing, and therefore do not require the points to be repeated or made at length. The Applicant for the Review, the Licence Holder(s) and Representors cannot raise substantial new information at a hearing which has not been seen previously by the other parties.

The Applicant for the Review or any Representor **may not** introduce any new ground or objection not referred to in the written submission. Amplification of the original representation may be made but any additional or new representation may not be made at the hearing.

Any person behaving in a disruptive manner will be asked to leave the hearing. If this does occur, that person may, before the end of the hearing, submit in writing any information which they would have been entitled to give orally.

Procedure at the Hearing

- 1. Members of the Sub-Committee will appoint a chair.
- 2. The Chair will introduce the Sub-Committee Members and Officers and welcome the Applicant for the Review, the Licence Holder(s) and Representors (or their representatives), and establishes the identity of all who will be taking part.
- 3. The Chair will explain to the parties the procedure that will be followed at the hearing.
- 4. The Chair will proceed with the order of business on the agenda.
- 5. When the agenda item relating to the application is reached, the Chair will invite the Licensing Officer to present the application.
- 6. The Licensing Officer will outline the application, confirm the application details, introduce the report and give an update on any recent changes.
- 7. The Chair will invite all present, one by one to ask the Licensing Officer questions if they wish to clarify any points raised in the report.
- 8. The Chair will invite the Applicant for the Review (or their representative) to address the Sub-Committee and present information in support of the application and call any witnesses to support the application, one witness at a time [maximum 15 minutes].
- 9. The Chair will invite the Licence Holder(s) and Representors (or their representative) and Sub-Committee in the following order to ask questions of the Applicant for the Review (or their representative) and/or witnesses [maximum 5 minutes each party]
 - (i) Responsible Authorities
 - (ii) Ward Councillors
 - (iii) Interested Parties in support of the Review
 - (iv) Interested Parties opposing the Review
 - (v) Licence Holder(s)
 - (vi) Sub-Committee

- 11. The Chair will invite the Representors in support of the Applicant's Review (or their representative) in the following order to address the Sub-Committee and call any witnesses to support of their representation [maximum 15 minutes each party]
 - (i) Responsible Authorities
 - (ii) Ward Councillors
 - (iii) Interested Parties
- 12. The Chair will invite the Applicant for the Review and the Licence Holder(s) and representors opposing the review to ask questions of each Representor in support of the Review (or their representative) and/or their witnesses after each presentation [maximum 5 minutes per Representor].
- 13. The Chair will invite the Committee Members to ask questions of each Representor in support of the Review (or their representative) and/or their witnesses after each presentation.
- 14. The Chair will invite the Licence Holder(s) (or their representative) to present their case and call any witnesses to support their case [maximum 15 minutes].
- 15. The Chair will invite the Applicant for the Review and Representors (or their representative) in the following order to ask questions of the Licence Holder(s) (or their representative) and/or witnesses [maximum 5 minutes each party]
 - (i) Applicant for the Review
 - (ii) Responsible Authorities
 - (iii) Ward Councillors
 - (iv) Interested Parties in support of the Review
 - (v) Interested Parties opposing the Review
- 16. The Chair will invite the Representors opposing the Review (or their representative) in the following order to state the nature of their interest in the matter, present their case and call any witnesses to support their case [maximum 15 minutes each party]
 - (i) Responsible Authorities
 - (ii) Ward Councillors
 - (iii) Interested Parties

- 17. The Chair will invite the Applicant for the Review and the Licence Holder(s) and representors in support of the review to ask questions of each Representor opposing the Review (or their representative) and/or their witnesses after each presentation [maximum 5 minutes per Representor].
- 18. The Chair will invite the Sub-Committee Members to ask questions of each Representor opposing the Review (or their representative) and/or their witnesses after each presentation.
- 19. The Chair will invite the Applicant for the Review (or their representative) to summarise their case [maximum 5 minutes].
- 20. The Chair will invite the Representors (or their representative) in the following order to summarise their case [maximum 5 minutes each party]
 - (i) Responsible Authorities
 - (ii) Ward Councillors
 - (iii) Interested Parties opposing the Review
 - (iv) Interested Parties in support of the Review
- 21. The Chair will invite the Licence Holder (or their representative) to summarise their case [maximum 5 minutes].
- 22. The Chair will provide the Sub-Committee with a final opportunity to seek clarification from any of the parties on any points raised, or seek advice from the Licensing Officer on policy, or from the Legal Advisor on law and jurisdiction.
- 23. When all the evidence has been heard, the Sub-Committee will withdraw to consider the application. Before withdrawing, the panel will confirm how the decision will be provided (see below).

Procedure after the Hearing

- 24. If the Sub-Committee wish to seek further clarification from any particular party, the Democracy Officer will recall all parties back into the committee room for the questions to be asked.
- 25. If possible, and always in the case of a Review of a premises licence following a Closure Order, the Sub-Committee will make a decision on conclusion of the hearing and only the Democracy Officer and the

Legal Advisor to the Sub-Committee will remain in the room with the Committee Members. These officers will not comment on the merits of the application, but will be present to provide advice on legal and procedural points and to record the decision.

- 26. If the decision has been made, all the parties will be invited back into the committee room by the Democracy Officer. The Chair will announce the decision. This decision will then be communicated in writing to the Applicant for the Review, the Licence Holder(s) and Representors within 5 working days of the hearing. There can be no further questions or statements.
- 27. If the Sub-Committee is unable to make a decision on the day of the hearing, the decision will be made within 5 working days beginning with the day or the last day on which the hearing was held. The Democracy Officer will inform the parties that they are no longer required and the decision will be communicated in writing to the Applicant for the Review, the Licence Holder(s) and Representors within 5 working days of the decision being made.
- 28. The notification will include information about the rights of appeal against the determination made.

Declarations of Interest – guidance for Members

(1) Members must consider their interests, and act according to the following:

Type of Interest	You must
Disclosable Pecuniary Interests	Disclose the interest, not participate in the discussion or vote, and leave the meeting <u>unless</u> you have a dispensation.

19. Chair (10:17am)

Resolved: That Councillor Cuthbertson be elected to act as Chair of the hearing.

20. Introductions (10:17am)

Introductions were made.

21. Declarations of Interest (10:18am)

Members were invited to declare at this point in the meeting any disclosable pecuniary interest or other registerable interest they might have in respect of business on the agenda if they had not already done so in advance on the Register of Interests. None were declared.

22. Exclusion of Press and Public (10:19am)

Resolved: That the press and public be excluded from the meeting during the sub-committee's deliberations and decision making at the end of the hearing, on the grounds that the public interest in excluding the public outweighs the public interest in that part of the meeting taking place in public, under Regulation 14 of the Licensing Act 2003 (Hearings) Regulations 2005.

23. The Determination of Section 52(2) Application by Lesley Cooke, Licensing Manager for the Licensing Authority, City of York Council for Review of a Premises Licence in respect of Slavic Foods, 47A Crichton Avenue, York, YO30 6EF (CYC-069000) (10:20am)

Members considered an application by the Licensing Manager, City of York Council, for a Review of Premises Licence for Slavic Foods, 47A Crichton Avenue, York.

In considering the application and the representations made, the Sub-Committee concluded that the following licensing objective(s) were relevant to this Hearing:

- 1. The Prevention of Crime and Disorder
- 2. Public Safety
- 3. The Prevention of Public Nuisance
- 4. The Protection of Children from Harm

In coming to their decision, the Sub-Committee took into consideration all the evidence and submissions that were presented, and determined their relevance to the issues raised and the above licensing objective, including:

- 1. The application and supporting documents.
- 1. The Senior Licensing Officer's report and her comments made at the Hearing. She outlined the report noting reasons for the application for the review of the licence and the information contained within the annexes to the report. She explained that between December 2023-2024 illegal vape products were sold at the premises, as well as people working without the legal right to work in the UK. She advised that cautions had been provided by North Yorkshire Police in relation to some licence breaches, and that there was an ongoing review by the trading standards team into the sale of tobacco products on the premises. She highlighted that there was a representation received from North Yorkshire Police, as a responsible authority, in Annex 3.

In response to questions from Members it was confirmed that the correct notices for details of the review hearing were served within the correct deadlines to the premises licence holder. 2. The Applicant's representations of Ms. Waudby on behalf of the Applicant at the Hearing.

Ms. Waudby made the following points:

- Multiple licence breaches were found following five separate inspections of the premises.
- Alcohol was on display without trained staff on each inspection.
- Evidence had been gathered on an inspection demonstrating an individual who was working without the right to work in the UK.
- On 22 February 2024 a male was arrested on the premises for not disclosing his identity when asked by the Police, and it was found that he was the same person who was working without right to work in the UK on the property during the previous inspection. On this occasion the male did not know that he had the right to work and so his employer could not have known that he had the right to work in the UK.
- In January 2022 the premises licence was transferred from the original licence holder to the current licence holder, without the Local Authority being notified of a transfer of the licence.
- The Designated Premises Supervisor (DPS) was in attendance at previous inspections when breaches of the licence were witnessed, and the current licence holder has not engaged with this licencing review process.
- On an inspection on 4 December 2023 illicit tobacco and vapes were on sale on the premises. On an inspection on 22 February 2024 illicit vapes were seized on the premises.

In response to questions from the Sub-Committee, Ms Waudby confirmed that:

- The receipt shown in Exhibit SB/1, on page 193 of the agenda, was evidence demonstrating employees working without the right to work in the UK. Working without right to work in the UK was an offence under the Licensing Act.
- There was information on City of York Council's website on transferring a licence to another person, and it was the responsibility of the person taking on the licence for this to be done properly.

5. The representations made by a Responsible Authority.

Police Sergeant (PS) Jacqueline Booth, North Yorkshire Police, stated that the current DPS had become so in December 2023 and was in attendance when alcohol was being sold on the premises. She also advised that the licence holder was requested to submit the relevant documents to the Licensing Authority to confirm their identity.

PS Booth stated that the Police interviewed the DPS under criminal offences contrary to licensable activity, and the statement which was presented was included within Exhibit SB/3, page 196 of the agenda. The DPS received a caution. Further investigation took place, and the Police found that there was no working CCTV, and no staff training records. They were asked to notify the licence holder of these issues.

PS Booth indicated that on 4 December 2023 the licence holder arrived at York Police Station and requested the keys to Slavic Foods as he had bought the premises. Upon a request by the Police to provide proof of identity the licence holder did not return, but upon re-inspection the Police found that the premises was open to the public without the licence holder having accessed the keys from the Police.

PS Booth stated that she believed that the failure to do proper checks on who was working at the premises, failure to comply with official communication, and the sale of illicit tobacco put into question the suitability for the licence holder to comply with the licence conditions.

In response to questions from the Sub-Committee, PS Booth confirmed that:

- The receipt shown in Exhibit SB/1, on page 193 of the agenda demonstrated that the person who made the sale did so without adequate training and was able to sell alcohol without the licence holder being present.
- Unsolicited tobacco and vapes were seized in December 2023, and liaison took place with trading standards officers to prosecute in response to licensable activity offences. E-cigarettes were still found on a subsequent visit.

On behalf of the Applicant, Ms Waudby was then given the opportunity to sum-up. Ms Waudby concluded that there had been multiple failures by the licence holder to comply with the conditions of their licence, and that the licence holder had not engaged with the process and no assurances had been made to suggest that the nature of the premises would be improved.

PS Booth was then given the opportunity to sum-up and concluded that North Yorkshire Police supported the application to revoke the licence. The prevention of crime and disorder licensing objective was being seriously undermined and the Police had no confidence that the licence holder or the DPS would adhere to the licence conditions or promote the licensing objectives.

Having regard to the application and the relevant representations, the Sub-Committee had to determine whether to take any of the steps mentioned under Section 52(4) that it considered necessary for the promotion of the licensing objectives. Taking into consideration the above evidence and submissions received, the Sub-Committee deliberated the different options available to them and agreed to reject the following options:

- Option 1: To modify the conditions of the licence (i.e., to alter, omit or add any new condition).
- Option 2: To exclude a licensable activity from the scope of the licence.
- Option 3: To remove the Designated Premises Supervisor.
- Option 4: To suspend the licence for a period not exceeding three months.

The Sub-Committee noted that it also had the option to decide that no action is appropriate in order to promote the licensing objectives. The Sub-Committee agreed to reject this option.

The Sub-Committee's decision was to accept the following option:

Option 5: To revoke the licence.

Having heard the application for a review of the premises licence at Slavic Foods, the Sub-Committee resolved to revoke the licence for the premises (Option 5) on the grounds that the premises is not upholding the licensing objectives of the prevention of crime and disorder, public safety, the prevention of public nuisance, and the protection of children from harm.

Reasons

- In reaching its decision, the Sub-Committee gave due consideration to:
 - The promotion of the licensing objectives as set out in the Licensing Act 2003, in particular the prevention of crime and disorder and public safety.
 - The Council's Statement of Licensing Policy.
 - The Home Office Guidance issued under section 182 of the Licensing Act 2003.
 - The Licensing Sub-Committee agenda pack for the application.
 - The oral representations made during the hearing.
- 2. The Sub- Committee considered the following parts of the section 182 Guidance:
 - 2.6 The prevention of crime includes the prevention of immigration crime including the prevention of illegal working in licensed premises. Licensing authorities should work with Home Office Immigration Enforcement, as well as the police, in respect of these matters.
 - 11.17 The licensing authority may decide that the review does not require it to take any further steps appropriate to promoting the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.

- 11.18 However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate.
- 11.19 Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:
 - Modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times.
 - Exclude a licensable activity from the scope of the licence,
 - Remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management.
 - Suspend the licence for a period not exceeding three months.
 - Revoke the licence.
- 11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:
 - For the sale and distribution of drugs controlled under the Misuse of Drugs Act 1971 and the laundering of the proceeds of drugs crime.
 - For the sale and distribution of illegal firearms.
 - For the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected.

- For the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people.
- For prostitution or the sale of unlawful pornography.
- By organised groups of paedophiles to groom children.
- As the base for the organisation of criminal activity, particularly by gangs.
- For the organisation of racist activity or the promotion of racist attacks.
- For employing a person who is disqualified from that work by reason of their immigration status in the UK.
- 11.28 It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered.
- 3. The Sub-Committee received evidence of multiple breaches of the licence conditions on multiple occasions over a 9-month period. Breaches included CCTV not recording, lack of training records and lack of refusals process. The Sub-Committee considered that the persistent and significant breaches of the premises licence undermine the licensing objectives.
- 3. The Sub-Committee noted that there was evidence of an individual working in the premises without the right to work in the UK. The Sub-Committee viewed the employment of an illegal worker as a serious matter which would clearly undermine the licensing objective of prevention of crime and disorder. An incident involving the employment of an illegal worker on licensed premises would normally result in revocation of the premises licence.

- 4. The Sub-Committee received evidence that illicit vapes and tobacco have been seized from the premises. It considered that this undermines the licensing objectives, in particular prevention of crime and disorder and public safety.
 - 5. The Sub-Committee noted that the DPS had been present at the time of breaches of the licence and had accepted a caution in respect of the breaches identified on 22 February 2024. The same DPS was present when the Police again identified licence breaches on 8 August 2024. Given those failings the Licencing Authority and the Police have no confidence in the DPS to manage the premises to ensure that the licence conditions are adhered to, and the licensing objectives are upheld.
- 7. The Sub-Committee put weight on the fact that despite a stepped approach by the Police to give the management of the premises an opportunity to reform and comply with licence conditions, there had been no engagement with the Responsible Authorities by the premises licence holder.
- 8. The Sub-Committee considered all the options open to them and noted that whilst the Sub-Committee had to consider what appropriate steps to take on review, such steps taken must also be proportionate. It recognised that a request for revocation of a licence was a major and severe step that had to be treated seriously and would be likely to harm the business and its employees, and that they had to consider whether there were alternative measures such as imposing conditions or adopting another sanction using its powers available to it under section 52 (4) of the Licensing Act 2003.
- 9. They noted that the premises licence holder and the DPS had failed to comply with licensing conditions over a lengthy period. They felt that given the repeated failings at the premises (including significant breaches of conditions, the seizure of illicit vapes and tobacco and the presence of an illegal worker) the premises suffers from either a lack of regard or poor management control and they had no faith in the premises licence holder or the DPS to operate the premises in a responsible manner so as to uphold and promote the four licensing objectives in the future, and

particularly prevention of crime and disorder and public safety. The Sub-Committee had received no assurances from the licence holder that he has the ability to appropriately control and manage the premises licence as he has not engaged with the review process.

- 10. Due to the gravity of the situation and taking into particular account the promotion of the crime prevention objective, including acting as a deterrent, the Sub-Committee believed that other sanctions including the imposition of further or amended conditions or a suspension of the licence would be ineffective in the promotion of the licensing objectives.
- 11. Accordingly it was determined that the premises licence should be revoked.

Summary

- This report seeks Members determination of an application for a review of a premises licence which has been made under the Licensing Act 2003 in respect of Museum Gardens, Museum Street, York YO1 7RF, Premises Licence Number CYC 009433.
- 2. Name of applicant: Andrew Dickinson
- 3. <u>Summary of Review</u>: The application to review the premises licence relates to the following licensing objective:
 - The prevention of public nuisance
- 4. A copy of the application for review is attached at Annex 1 and is briefly summarised as follows:

A music event took place in the Museum Gardens on 19 and 20 July 2024, the applicant for the review raised complaints regarding the noise from these events. As the premises is an open space within the centre of York it is surrounded by a large number of residential properties therefore several thousand residents were affected by this event which finished at 22.30.

Outdoor events with limited opportunity to suppress/control noise should not be allowed to take place so close to residential properties.

Noise limits should be imposed and enforced to avoid causing a nuisance to residents.

The applicant requests the imposition of a further condition on the licence to prevent a re-occurrence of the noise nuisance experienced during this event.

5. A copy of the current premises licence and plan is attached at Annex 2. The premises licence currently authorises the following:

6. The premises licence was first granted on 27 September 2005

Consultation

- 7. Consultation was carried out by the Applicant and the Licensing Authority in accordance with S51(3) of the Act and Regulation 42, Part 4, Paragraphs 29 and 38 of the Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005, which concerns the notification of a review and the advertisement of a review by licensing authority. Copies of the application were served on all responsible authorities and the premises licence holder. Notice of the application was displayed in the vicinity of the premises, on the exterior noticeboard at West Offices and on the Council's website.
- 8. A representation was received from the Environmental Protection Officer at the City of York Council; it appears at Annex 3.
- 9. There were a further 24 representations received from 'other persons' this includes a representation from the Premises Licence Holder.
 - 2 of those representors wrote in to support the review applicant and 22 wrote to support the premises licence holder.
- 10. A list of representors appears at Annex 4, and a copy of the representations appears at Annex 5.
- 11. A map showing the location of the premises is attached at Annex6.A further map showing the premises in relation to the applicant's address is also included.

Other Relevant Information

12. The premises licence was first granted by the Licensing Authority in September 2005; it previously held a Public Entertainment Licence (PEL) which was converted to a Premises Licence when the Licensing Act 2003 came into force in 2005. In 2012 the premises licence holder varied the licence to add the sale of alcohol.

Options

13. By virtue of S52(4) of the Act, the Sub-Committee may in making their decision take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- 14. Option 1: To modify the conditions of the licence (ie to alter, omit or add any new condition).
- 15. Option 2: To exclude a licensable activity from the scope of the licence.
- 16. Option 3: To remove the Designated Premises Supervisor.
- 17. Option 4: To suspend the licence for a period not exceeding three months.
- 18. Option 5: To revoke the licence.
- 19. Option 6: Take no action

Where the Sub-Committee takes a step mentioned in Option 1 or Option 2, it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify. Otherwise, the modification of conditions or the exclusion of a licensable activity will be permanent.

In deciding which, if any, of these steps to take, the Sub-Committee should direct its mind to the cause or causes of the concerns which the application and representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response to address the causes of concern that instigated the review.

The Sub-Committee may decide that no action is appropriate if it finds that the Review does not require it to take any steps that are appropriate to promote the licensing objectives.

Analysis

- 20. The following could be the result of any decision made by this Sub-Committee:
- 21. Option 1: This decision could be appealed at Magistrates Court by the premises licence holder, the review applicant or any of the representors.

- 22. Option 2: This decision could be appealed at Magistrates Court by the premises licence holder, the review applicant or any of the representors.
- 23. Option 3: This decision could be appealed at Magistrates Court by the premises licence holder, the review applicant or any of the representors.
- 24. Option 4: This decision could be appealed by the premises licence holder, the review applicant or any of the representors.
- 25. Option 5: This decision could be appealed by the premises licence holder.
- 26. Option 6: This decision could be appealed by the review applicant or any of the representors.

The decision of the Sub-Committee will not have effect until the end of the period given for appealing against the decision, or if the decision is appealed against, until the appeal is disposed of.

27. Members are reminded that they may only use their discretion to take remedial action in relation to matters that are raised by this review and are relevant to the promotion of the licensing objectives.

Council Priorities

- 28. The Licensing Act 2003 has 4 objectives; the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm.
- 29. By taking the statutory requirements of the Licensing Act into consideration, as well as the four licensing objectives when determining licensing applications for review the Council are supporting the licence trade, as well as local residents and businesses. The functions support the Council's Plan commitments to make York a healthier, fairer, more accessible place, where everyone feels valued, creating more regional opportunities to help today's residents and benefit future generations. It supports the particular priority for a fair, thriving, green economy for all.

Annex 1 – Mandatory conditions

MANDATORY CONDITIONS IN RELATION TO THE SUPPLY OF ALCOHOL

- 1. In accordance with section 19 of the Licensing Act 2003, where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- 2. The first condition is that no supply of alcohol may be made under the premises licence –
- (a) at a time where there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 3. The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –
- (a) games or other activities which require or encourage, or are designed to require or encourage individuals to –
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either –
- (a) a holographic mark, or
- (b) an ultraviolet feature.

- 7. The responsible person must ensure that –
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
- (iii) still wine in a glass: 125ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

MANDATORY CONDITION - ALCOHOL PRICING

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1 –
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula –

 $P = D + (D \times V)$

where -

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence –
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

MANDATORY CONDITION: EXHIBITION OF FILMS

- (1) In accordance with section 20 of the Licensing Act 2003, where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- (2) Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
- (3) Where -
- (a) the film classification body is not specified in the licence, or
- (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- (4) In this section 'children' means persons aged under 18; and 'film classification body' means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

MANDATORY CONDITION: DOOR SUPERVISION

- (1) In accordance with section 21 of the Licensing Act 2003 (as amended by section 25 Violent Crime Reduction Act 2006), where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must -
- (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
- (b) be entitled to carry out that activity by virtue of section 4 of that Act.
- (2) But nothing in subsection (1) requires such a condition to be imposed -
- (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or
- (b) in respect of premises in relation to -
- (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence, or
- (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section -
- (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and which is licensable conduct for the purposes of that Act (see section 3(2) of that Act), and
- (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 – Conditions consistent with the operating schedule

Licensing Objectives

General

1. This licence excludes any adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.

Prevention of Crime & Disorder

- 2. A draft of the Event Management Plan (EMP) will be produced 2 months prior to an event and will be submitted to the Licensing Authority and all the members of the Safety Advisory Group (SAG). This shall include a noise management plan and dispersal policy. Following consultation with the SAG, the Licensing Authority shall notify the premises licence holder in writing that the draft EMP is acceptable or unacceptable before the event takes place. An event shall not take place until the draft Event Management Plan has been agreed by the Licensing Authority in consultation with the SAG. Once agreed no change shall be made to the draft EMP without the agreement of the Licensing Authority or Police.
- 3. The Premises Licence Holder shall give at least 28 days written notification of ANY event that involves the retail sale of alcohol to North Yorkshire Police and the Licensing Authority. For the purpose of clarity the 28 days notification shall not include the first day of the event or the date of notification.
- 4. The venue shall partake in the York radio scheme.
- 5. Documented staff training will be given regarding staff's obligation under the Licensing Act in respect of the:-
 - retail sale of alcohol
 - age verification policy
 - conditions attached to the Premises Licence
 - permitted licensable activities
 - the licensing objectives and
 - the opening times of the venue.
 Such records shall be kept for a minimum of one year and will be made available immediately upon request from any Responsible Authority.

This training shall be refreshed every 12 months as a minimum.

Public Nuisance

- 6. Prominent signage will be displayed asking customers to leave the area quietly.
- 7. A litter pickup and waste emoval from the site will not be undertaken until the morning after an event takes place.
- 8. Live and recorded music and performance of dance which meets the definition of Regulated Entertainment within the licensing Act 2003, shall only be permissible on a maximum of 6 days per calendar year.
- 9. A documented noise management plan shall be submitted to and approved by the Environmental Protection team of City of York Council within 1 month of the licence being granted. The noise management plan shall include a procedure for investigating noise complaints about the premises. Once agreed the premises Manager shall ensure compliance with all aspects of the approved noise management plan.

Protection of Children from Harm

10. A Refusals Register and Incident Report Register will be kept. Such documents will record incidents of staff refusals of alcohol sales to under-age or drunk people as well as incidents of any anti-social behaviour and ejections from the premises.

Such records shall be kept for at least one year. [For the avoidance of doubt, the one-year period relates to each respective entry in the logbook and runs from the date of that particular entry]: They will be made available immediately upon a reasonable request from any responsible authority.

11. The licence holder will operate a Challenge 25 Age Verification Policy at the premises. The only acceptable proof of age identification shall be a current Passport, photo card Driving Licence, Military ID card, or identification carrying the PASS logo (until other effective identification technology e.g., thumb print or pupil recognition, is adopted by the Premises Licence Holder).



Annex 3 – Representation from Environmental Protection

We make this representation in relation to the premises licence review for the Museum Gardens, Museum Street, York, YO1 7DJ.

Museum Gardens have been granted a premises licence which includes the ability to have events which meet the definition of regulated entertainment such as outdoor live and recorded music events.

In order to help manage noise from the site a noise management plan has been submitted with the licence. The noise management plan limits the number of larger outdoor events to 6 per year. It also restricts these events so that 3 can operate at 65db (A) LAeq over a 15 minute period and the other 3 events must operate at a more stringent 15dB (A) LAeq above background over a 15 minute period.

The plan includes monitoring of events and the controlling of noise levels during events, as well as a review post event to see what, if necessary, can be improved upon.

This was the first event to take place at the site and the applicants' noise monitors and sound engineers undertook monitoring and when levels were exceeding or approaching the noise limits relayed this back immediately to the sound engineer to reduce the noise levels of the event.

4 locations were monitored around the site, together with roaming monitoring around the site and the event was broadly compliant with the noise limits imposed. Whilst the noise limits were upon occasion exceeded at two locations around the site, these exceedances were only marginal and did not meet the threshold whereby they would be considered to be a breach of the licence conditions.

This is because the human ear cannot perceive an increase of noise of less than 3dB (A). This would mean that we would consider enforcement action when the noise exceeded 68dB (A) and this level was not exceeded during the events and only reached on one occasion when 68dB (A) was recorded for one 15 minute period; thereafter the noise levels were reduced back down to below 65dB(A) for the rest of the event.

There were only 4 complaints received and when they were received, monitoring was undertaken outside the complainant's properties and the levels observed were well below the noise limit threshold. For example 45 dB(A) was observed at one location and assuming a 15dB (A) reduction in sound due to an open window, which is a standard acoustic assumption, noise levels inside the complainant's property would have been 30dB(A) which would be below the acceptable noise limits that should be met for habitable rooms at that time of day within dwellings as defined in the World Health Organisation's guidance on community noise levels and in the BS8233:2014 "Guidance on sound insulation and noise reduction for buildings" standard.

Environmental Protection, therefore, believe that the conditions on the premises licence are robust, achievable and enforceable and are adequate for controlling noise from the events.

However, should the committee members be minded to add any conditions to the premises licence, they may wish to consider the following:

 A tamper proof noise limiting device shall be fitted to the sound system at front of house during events. This noise limiting device shall be approved by City of York Council's Environmental Protection team before use. The device shall not be altered or modified without prior approval from City of York Council's Environmental Protection team.

I write to express my complete dismay, disappointment and shock at the publication of the notice recently published to review the licence held at the Museum Gardens based on "The Prevention of Public Nuisance".

I am aware that this had been instigated following the live music events of 19th-21st July. Three nights that to my knowledge created no public nuisance incidents of any kind.

That the council are even considering this review is disgraceful. York Races attracts large crowds that regularly create public nuisance, it attracts stag and hen parties which are damaging to the reputation of the city yet the council do nothing to discourage them yet when it comes to other forms of entertainment and hospitality it fights tooth and nail against such events happening. Why?

The Museum Gardens traditionally hosts the Mystery Plays and recently The Proms - why therefore should live music events such as the ones held on the 19th-21st July be any different. Is this discrimination as it feels as though it is. Or is it the intention of the review to include the banning of these events also?

I attended all three nights at the recent Museum Gardens events - they were well run, excellently managed, the facilities were impressive and the backdrop superb. My husband used to attend similar events held at The Museum Gardens in the 70's and has said for 20+ years that he never understood why they stopped - he was delighted that such a beautiful location was once again being utilised. The music was not offensive, there was no bad language used on stage - yes music is subjective and not everyone likes the same sort however it was no louder or offensive than The Proms which again does not appeal to everyone.

At a time when life is miserable, finances stretched and times being pretty hard, seeing York so full of happy smiling people who are spending money in the city, creating positive vibes and an amazing buzz around the place was so refreshing. I have not seen so much joy in York for YEARS, not to mention the financial boost that our traders and hard working businesses received. There were no drunken brawls - seen so many times after York races - no traffic issues - as opposed to York Races where roads are gridlocked and diversions in place - no police intervention was required, no reports of any kind what so ever. Therefore where is the public nuisance?

These concerts, which sold out instantly with 8,000 tickets snapped up by music lovers from across the UK and even abroad, have not only been a success in themselves but will also provide valuable marketing material for future events, drawing tourism to our city even if people don't attend the concerts.

The influx of visitors to York provided a significant boost to the local hospitality industry. Over that weekend, there was a palpable buzz in the city, with hotels, bars, restaurants, shops, and even taxi companies reporting one of their best weekends in years. The economic impact was substantial, bringing in hundreds of thousands of pounds to the local economy.

FEEDBACK ON YOUR VARIOUS RECENT CONCERTS

Dear Ms Blacker,

As a neighbour of yours, I write to commend you on your execution of the York Proms event held on Sunday 28th July, and also to provide feedback on your Concert event of 18th-20th July.

My fellow residents in Marygate and I have worked with you over many years in supporting the Museums Trust in the public use of your facilities. We recognise the benefits to us not only through direct access to the events, but also for the long term financial viability of the historic green space on our doorstep. Our cooperation goes back to the initial establishment of a permanent licence for the Hospitium – when we agreed broad guidelines for access arrangements to your site, noise levels and exposure.


We have been supportive of your initiatives to use both the Hospitium and the site in general for community use — and as support for its maintenance. We recognise and accept that a certain level of noise and disturbance is inevitable from such events, even though our property is directly exposed to it (since our house, like most in Marygate, rises above the Abbey walls in direct adjacency and full exposure to any noise).

Your two recent July events (York Proms and 18-20th July Concert series), however, demonstrated quite different levels of respect for your neighbours. The Proms went off with acceptable levels of noise and other disturbance. While it was clear that an event was going on, other than for a few short passages of loud music or a short fireworks display, the disturbance was bearable. In contrast, the Concert series of 18th-20th July was a much greater burden: with prolonged, invasive and inescapable "boom, boom, boom" noise and vibration disturbance — caused largely by amplified drums and bass. But even within this event, not all performers appeared to inflict such long duration disturbance. The concert, for example, on Thursday 18th, was not particularly disturbing until the amplified drums and bass commenced around 9pm. On Friday 19th, such disturbance was not only restricted to the evening: the afternoon "sound check" included prolonged periods of loud music, drums and bass from 2pm until after 4pm — shortly before recommencing the event at 5.30pm.

The 18th-20th July event also created a parking nightmare for your neighbours, the details of which I feel you should also be made aware. Seemingly the organisers saw fit to install a series of notices on lampposts in Marygate around Sunday 14th July – only a few days before the event, and without any other prior warning or justification: reserving the entire parking available in the lower end of

Marygate (a 194m stretch at the bottom of Marygate) – without any communication of what provisions (none) had been made for alternative resident parking.

The text of the actual notice can be read from the photograph below. As you will see, the purpose and objective of the parking prohibition are not made clear, and the meaning of the text and the area actually affected ("183m from Bootham to 377m from Bootham") is not really clear either – unless you get your tape measure out. But it's a very extensive prohibition.



The notices generated quite a bit of concern amongst our neighbours, who flurried to find alternative arrangements for their cars. But our lodger (who uses our residential parking permit to leave his car on the street) left early on Monday 15th, not having seen the notices, to attend a residential course for his work.

In the very early morning of Thursday morning, 18th July (before the notice applied), an Austrian-registered coach appeared on the street near to the Hospitium road entrance, and parked within inches of our lodger's car. At this time, the two vehicles were then enclosed within parking cones. The quite limited area of the cones (in relation to the 194m space reserved by the notices) is clear from the photograph below, taken on Friday morning, 19th July.



We have not received explanation, given the ample space available at the time of the bus parking, why the bus couldn't have simply been parked slightly differently — and the cone arrangement too: with no need to move our lodger's car in the first place.

In the event, I only observed the coned-off area being used by a single vehicle at any one time – the Austrian coach there on the first day, which turned up before the notice applied – and subsequently only the occasional use by a single Enterprise rental van.

My wife informed the available personnel on Thursday morning that it was our lodger's car in front of the bus, and was told by one of the team that the vehicle was not a problem. Nonetheless: subsequently, presumably at the initiation of the organiser's event staff, York Council Parking Department called me during the day to ask about the car and ask for its removal. I explained our situation, and said we had no second key for the car, but anyway, were not insured to drive it. Our lodger would return later and move it. I asked if in consequence the car would be towed away, and was told: "possibly". Subsequently, one of the event staff knocked on our door, spoke to my wife and son; himself to ask for its removal. Finally, our lodger returned about 6.30pm and moved his car, to be told by the bus driver that "it doesn't matter to me, but you've f+++ed a lot of people around". I feel this affront could more rightly be directed at the organisers.

One of my neighbours spoke of the "entitled air" of the security staff. Certainly I can sympathise with this feeling, given the organisers' clear sense of entitlement in arranging such an expansive parking ban, when in reality such little space was actually required and no consideration was made for the residents.

Having had our cars hounded away by parking staff, we then got to watch event visitors come and park their cars freely in the extensive space not required.

If such extensive parking is required for future events, perhaps you should consider earmarking space within the curtain of the Museum Gardens; not allowing your event to spill out so intrusively beyond your walls?

As to the event itself: I was pleasantly surprised when the event started on Thursday 18th July, to discover that I found noise levels (within my house, with all the windows closed) not too intrusive. But around 9pm that changed unfortunately, when the amplified drums and bass became a permanent invasive and inescapable intrusion. I ask myself: if it was possible for the concert to manage without such disturbance until 9pm, why should it not be possible until the end?

As residents of Marygate, we, like the Museums Trust, are lucky to be located in a historic and conservation area: but this places obligations and limits upon us all. Our buildings do not meet modern standards of insulation and sound-proofing — neither for holding large events, nor for withstanding them. The materials make them flimsier and more susceptible to vibrations and rattles than a modern building could expected to be. And we are prevented by Council planning from double glazing, never mind sound-proofing.

Given these constraints, as well as the historic and limited size of the Museum Gardens site, it seems most reasonable when planning and holding events, to consider the long-term noise load and effect on neighbours caused by deep thudding and vibration, rather than applying vanilla council guidelines for noise measurement more suited to large events in open spaces or purpose-built stadia.

Maybe more thought by both the York Museums Trust and the Council should be placed on the nature of the artists, the music and the instruments and amplification to be used, before approving such large events, as well as the parking restrictions to be applied for them.

The best artists often produce many different versions of their songs, some with only limited or acoustic backing. Maybe a concert honed in this manner, taking greater benefits of the Museum and Abeey's historic backdrop is more appropriate, rather than trying to mimic the "scale" and customary arrangements of large modern music festivals and stadium rock concerts?

Though in the words of your event organiser:

"I have been heavily involved in the York music scene for 20 years and it has always been an ambition of mine to bring a live music event of this scale to the middle of the city with residents at the heart of it. The fact that we can start the event with the biggest band to come out of York makes it all the more special," said Rachel Hill, Project Manager at Futuresound."

...I can assure you that my fellow residents do not feel that we have been "taken to the heart" of the event planning. I hope corrections will be made in any future plans.

As one of the Museums Trust own staff in the sound engineers cabin told my wife: we are trying to comply with noise guidelines, but *it is a problematically small site*. Perhaps one unsuited to the nature and expectations of the event and its organisers?

As another fellow resident reminded me: there used to be both bats and owls within the curtain of the Museum Gardens. I wonder how these have been affected by your events?

I hope future event planning and execution will be more considerate.

Gardens

York Museums Trust takes the review proceedings issued in relation to the events held within the Museum Gardens between 18 July 2024 and 20 July 2024 very seriously and the trustees wish to make it clear that it was always their intention to uphold the licensing objectives.

York Museums Trust is experienced at hosting events without issues arising and are well known within the City for the way it successfully undertakes events in the Gardens ranging from the Mystery Plays to the Proms without concerns as to compliance with the Licensing Act 2003. It has a clear objective of contributing to the overall cultural offering within the City, expanding the financial benefit to the city and businesses within it, as well as providing a new revenue source for the Trust in the light of reduced grant support and increased running costs.

In the past they have been approached to use the site for many events which have been rejected. The proposal from Futuresound was the first one that provided reassurance as to the experience and expertise, not only to successfully operate an event of this nature, but also to be able to operate within a unique site such as the Museum Gardens and taking into account the presence of residential accommodation to 3 boundaries of the site. York Museums Trust takes its prime function seriously as custodian of the historic sites and collections within its care and diligently balances these with providing a broad offer of engagement opportunities within the Gardens, not only considering each event but the impact of the whole calendar of events to those who live and work nearby.

With these sensitivities in mind, more than two years of planning and consultation were undertaken between Futuresound and York Museums Trust and the necessary authorities. This included formal processes, such as working with the Safety Advisory Group, and working outside of the regular Advisory Group meetings with individual authorities to develop plans and work within their requirements.

York Museums Trust acted at all times with transparency to those who may be impacted and sought their comment. A community engagement programme was developed and begun in November 2023 with the first of three open consultation events. Local residents were invited by hand delivered letter. The final pre-event engagement was an information leaflet letterbox drop to over 1500 residences.

Over the course of the event days, the team were in constant contact with the Safety Advisory Group who had representatives on site whilst the event was live. Having employed a Noise Monitoring Consultant, there was ongoing dialogue, in the build-up to

and on the evenings of the events with the Public Protection Officers who were on/around the perimeter of the site when the performances occurred.

York Museums Trust embarked on the event with the intention to undertake best practice, adopt a partnership approach, and promote the licensing objectives. Feedback has been constructive rather than negative and evidence which will be produced at the final hearing will illustrate that the collaborative approach with the Public Protection team and the sound crews allowed the event to pass without causing public nuisance.

We would be grateful if you would kindly acknowledge safe receipt of this email and its status as a representation, received during the representation period. We reserve the right to file further documentation and Written Submissions in support of York Museums Trust position and can assure you that in the intervening period we will continue to liaise with the statutory authorities with a view to trying to achieve a mutually acceptable resolution to the situation.

I am writing with regards to the recently advertised review of premises licence for York Museum Gardens, Museum Street, YO1 7FR.

I was beyond surprised to see that the license for this amazingly versatile place was up for debate when I was in the gardens volunteering this week. I can only assume that this has come about following the recent concerts and proms events that took place in July.

I have thought long and hard since seeing this notice about the best way to put into words how I feel about this, aside from to say that it seems completely absurd and utterly short sighted, and have come to the conclusion that the best way to get my message across is to put it in as plain a way as possible. So, please see below my bullet point list (in no particular order) spelling out why I think that revoking their license would be completely idiotic and why I wholeheartedly support the garden's and wider Trust's use of the space as a venue for cultural events.

- You say that the review is to ensure Prevention of Public Nuisance From being at the Shed Seven event on the Friday myself and from speaking to people involved in the event, there were absolutely no instances of public nuisance, mis-behaviour, antisocial behaviour or otherwise in the venue. - This event will have been an immense economic boost for local businesses. Not only did the event
 organisers make use of local, independent traders to provide the food and drink on offer, the bars, cafes,
 restaurants and hotels in the city will have also benefited hugely from the thousands of people who were in
 York City Centre. Speaking to a couple of friends with local businesses this was definitely a brilliant boost to
 their takings this summer.
- Whilst many of the people that attended this event travelled to the city (and were encouraged to do so by public transport not car) the events in the garden over the summer were first and foremost targeted at York residents. Finally, something for the locals and not just tourists!
- It is widely known that YMT have been suffering financially for years and are facing some serious issues currently regarding the sorry state of repair of the Yorkshire Museum. The huge fees that they earn from events such as the Shed Seven gigs are a necessity in this regard. More so than ever as CYC continues to cut

their financial contributions to the trust. I hate to think what would happen to the Museum Gardens if YMT couldn't hold events there anymore. Could you imagine the outrage that would ensue if people had to pay to walk through or visit the Museum Gardens?!

I could go on, but what it boils down to is that yes, a few people might momentarily be irritated by a bit of noise (noise of people having fun) but in the large, most people either aren't bothered, or absolutely loved it. And the benefits of events in the museum gardens are above and beyond the negatives.

Hello,

I saw the notice in Museum Gardens re. the licensing review. I have read the COYC guidance on outdoor music events, and I suppose the objections received by the licensing department were about noise levels. My understanding is that many planning meetings took place between the promoters and COYC representatives before the Futuresounds and The Proms events went ahead in July. I would also expect that acceptable sound level limits were discussed and agreed prior to the events taking place, discussions which surely must have included the decibel levels expected from substantial crowds of people, applause, a Proms fireworks display and crashing cymbals, plus electric guitars from a rock band.

As a York resident I was very pleased that these Museum Gardens music events were taking place and I did actually attend one of the events. In my view the event was very well executed and orderly, there were many stewards dotted about and no noticeable drunkenness or bad behaviour from concert goers, who left the site quietly and sensibly. In addition, I have heard from friends, who have businesses in the city centre, that they were very busy both prior to, and after the concerts, and as such all the concerts were a boost for the night time economy of the city.

On the Friday night of the Shed Seven event I was visiting a friend in the Bootham area, behind the gardens near the river, and was surprised that I could not hear the music at all until I was ¾ of the way down Marygate and approaching the concert entrance, at the entrance to gardens I could hear some sounds. I was surprised at how little noise was leaking from the stage to the surrounding residential area, so I find it hard to believe that the sound was unacceptable in residential properties that were more than ¼ of the way up Marygate. Out of curiosity I did ask a couple of officials who were checking the decibels if the noise levels were meeting the COYC requirements, and I was told that they were.

It is wonderful that COYC have allowed these concerts to happen at last. I would hope that common sense prevails to ensure that a small number of objections don't mean that the Counsil will be influenced to rescind the licence for music events in Museum Gardens, because these types of vibrant, cultural music events bring a lot of joy to the THOUSANDS of concert goers who attend them , including many York residents/voters. The additional revenue to city centre food and drink outlets cannot be ignored either.

Similar events happen for example at The Piece Hall, Halifax and Kirkstall Abbey, Leeds and in many other cities without this objections shenanigans we are having here in York, perhaps people there don't begrudge others their enjoyment, and maybe they turn their TVs up or go out for the evening until 10.30pm to avoid having to listen to people enjoying themselves, heavens forbid!. I live in Haxby and we regularly have to put up with very loud fireworks displays for birthday celebrations or weddings etc that can go on until after 11 pm, however I don't get out my sound monitor or write to the COYC to object, it's only for a few hours and people are just enjoying themselves.

I hope COYC can actually stay in the 21st century now that it has a Labour led council, and that it will continue to support diverse musical events, for example The Proms for the minority of people who love classical music, and popular/rock shows for the majority.

I write as Shadow Executive Member for Economy and Culture, and on behalf of all City of York Liberal Democrat Councillors, as we believe this site is a strategic asset for York. We have seen from recent events the significant economic impact and benefit at-scale events bring, most recently at this site the highly regarded York Proms and the Shed Seven concerts. We make the below points in line with the Licensing Act 2003 in support of York Museums' Trust (YMT) retaining a license that gives them the flexibility to continue to deliver world class events at this special location.

Crime and disorder – YMT are a professional organisation and have a year-round task in managing crime and disorder in the Gardens. We note that last year they successfully integrated Thor's Tipi into Museum Gardens, operating in a manner that promoted the crime and disorder objective. Previous to this, and for many decades, they have hosted events that have not caused crime or disorder.

Protection of Children from harm – YMT are probably one of the best placed organisations in York to consider and act on this objective. They competently run a portfolio of venues that all have significant children and young people visiting. They are more that qualified to ensure events on their premises are run in a manner that protects children and young people.

Public nuisance – For many years YMT have managed the extremely busy Museum Gardens and hosted a wide range of events with little impact. This has included the York Proms, Thor's Tipi and other outdoor and indoor events. They are a well regarded institution and have clearly been able to balance at-scale events with the impact on residents and the wider city.

Public safety – YMT have a strong track record in managing safety in the Museum Gardens, having delivered a wide range of private and public events inside and outdoors. We feel as a responsible operator great weight should be placed on their competence to promote public safety are their events.

In summary, York Museums' Trust is a respected and well led organisation that cares about York and its environs. They bring significant economic benefit to our city and they should be supported to continue to enhance our cultural offering through retaining a flexible license that enables them to host world class events.

My name is , and I am the Managing Director of Production Group.

I was extremely proud and grateful to Futuresound to have been asked to provide full technical production for the Live at the Museum Gardens events. As someone who is born and bred in York, getting into the music industry through playing in bands in York, then ironically starting to work in Shed Seven's studio, which has led to 16 years of touring the world at the highest level, all of which has paid for my company. Not a brag, but more an example of what can come from events in York.

We as a production company put months of planning into the audio system, to provide maximum on site levels and coverage, whist keeping offsite levels to an absolute minimum. We achieved this to within a decibel, and did not break a 15 minute LAeq measurement over the weekend. All of the artists agreed that while this was a quieter then normal level, they were all happy to work within the limits as the site was so amazing, and all shared a passion to help this gig happen again.

As a York resident, the feedback and the buzz caused by this event was incredible. From TV, and Radio coverage, to the front page of the press, not least featuring Sarah Loftus of Make It York saying how amazing the event is, and that it needs to happen again...

Every effort was made by Futuresoound, The Museum Gardens, and ourselves to reduce any environmental impact from this event, which I believe we succeeded.

For a city based so much on tourism and culture, I feel like it would be incredibly disappointing to allow such a small amount of complaints to take the enjoyment away from the literally thousands of people who attended and had the time of their lives. Not to mention the income generated to the local business and economy.

I fail to see how shutting down half of York for a marathon, or the whole of Micklegate for a race, or the massive traffic restrictions put in for the races, which have a direct effect on thousands of residents/workers/and anyone who is travelling through York, goes without even a whisper, but a tiny amount of noise complaints is enough to shut an event of this prestige and magnitude down.

It would be a travesty for this license to be revoked.

Support events, and support culture.





Review of Premises Licence

- 3. The following provisions of the Secretary of State's guidance apply to this application: Chapter 10 Conditions attached to premises licences and club premises certificates and Chapter 11 Reviews.
- 4. The following paragraphs of the licensing authority's statement of licensing policy apply to this application: 8.0 Licensing Hours;13.0 Review of licences.
- 5. The Committee is reminded of their duty under the Crime and Disorder Act 1998 to consider the crime and disorder implications of their decisions and the authority's responsibility to co-operate in the reduction of crime and disorder in the city.
- 6. The Committee is reminded that the Human Rights Act 1998 guarantees the right to a fair hearing for all parties in the determination of their civil rights.
