- Cleaner streets are more important than safer as there is a safe feeling in the area.
- Younger people seem to have 'nothing to do' and hang around on streets.
- Graffiti in the area, although low needs addressing before it gets out of hand.
- The ambitions for the ward are all priorities although cleaner and safer streets should be two different ambitions.
- Your Ward newsletters were left in the lobby of Field Court not posted through individual letterboxes.
- More priority has to be given to older people in York.

6.2 Issues raised included

- The removal of the no.13 bus to Monks Cross.
- A building for the Addy.
- Turn the Bull Ring into parking bays to stop vehicles parking on the roads causing obstructions.
- A park for dogs so the kids play areas aren't used for dog walking.

- Reinstatement of the skips for Bell Farm.
- A grit bin is needed for Bell Farm Avenue.
- Better bus service is required.
- More work needs to be done to reduce vandalism.
- More play areas for all ages.
- Work is needed to stop people drinking and taking drugs.
- A play area is needed for football, to stop children playing in the street and damaging cars.
- More planting of flowers is needed to brighten up the area.

6.3 Residents were signing a petition regarding the removal of the no.13 bus service to Monks Cross. This is seen as an important route service to the residents of Bell Farm and for many it is their only method of transport to enable them to do their food shopping. The petition was signed by many residents.
