## Annex 1 – Mandatory conditions

### MANDATORY CONDITIONS WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

(1) In accordance with section 19 of the Licensing Act 2003, where a premises licence authorises the supply of alcohol, the licence must include the following conditions.

(2) The first condition is that no supply of alcohol may be made under the premises licence -

- (a) at a time where there is no designated premises supervisor in respect of the premises licence, or  
(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

## **Annex 2 – Conditions consistent with the operating schedule**

### **Licensing Objectives**

#### General

1. Alcohol will only be sold to people using the facilities that the hostel provides, internet and information centre, food and live music venue. The premise will not operate primarily as a public house.

#### Public Safety

2. CCTV is installed internally and externally.
3. All staff are trained regarding fire safety requirements.

#### Protection of Children from Harm

4. Children will not be allowed to enter the bar area.
