Conditions associated with disposal <b>The Arabian Oryx is a CITES Appendix I species which requires a permit for import or export. Whilst, in this process, we would be doing neither, I felt it was necessary, considering the Trusts policy on responsible collecting, to try and prove that these specimens were collected legally in the first instance. Unfortunately I have been unable to locate the original paperwork; however, I have discovered that these skins were part of a larger consignment of animal material the remainder of which went to Andrew Kitchener at Edinburgh. The following is part of an email Andrew sent to me regarding this material:</b> <b>We know that these specimens were legally imported (at the same time as ours from the same trip), so I am not unduly concerned about the CITES paperwork, but obviously it would be nice to have it. The only paperwork we would have to consider is a transfer of title form and possibly a Commercial Document for Animal Byproducts, which I can generate easily.</b> <b>Without the original paperwork this is the only indication of the validity of this material. However, due to the fact that this material is part of a collection held jointly with The Royal Museum of Scotland I am happy for the disposals procedure to go ahead.</b>
