# 6. Declarations of Interest (5.30 pm)

At this point in the meeting, Members were asked to declare any disclosable pecuniary interest or other registerable interest they might have in respect of business on this agenda, if they had not already done so in advance on the Register of Interests.

Cllr Crawshaw declared a personal, non-prejudicial interest in relation to item 7, as his mother was a member of the Steering Group for Digital Inclusion.

# 7. Minutes (5.31 pm)

The Chair noted that an agreement from the Leader to write to the relevant minister had been omitted from the draft minutes and that the following should be added to the bullet points on page 4 of the minutes:

That the Leader would write to the relevant minister to express Members disappointment in hearing about the Devolution Deal via a press release and to request that Members were in future notified in advance of any information being released to the press.

Resolved: Subject to the inclusion of the above wording,

that the minutes of the last meeting held on 05 September 2022 be approved and signed as a

correct record.

## 8. Public Participation (5.32 pm)

It was reported that there had been one registration to speak at the meeting under the Council's Public Participation Scheme.

Councillor Kallum Taylor addressed the Committee and raised concerns relating to items 6 and 7 on the agenda. He highlighted the difficulties residents had in accessing council services, through the call centre and digitally. He reported that there were lengthy waiting times and out of date web content.

# 9. 2022/23 Finance and Performance Monitor 1 (5.36 pm)

The Finance Manager, and the Head of Business Intelligence, presented the 2022/23 Finance and Performance Monitor 1 report. The Finance Manager highlighted a forecast gross overspend of £8.7m, which with £2m mitigations, was expected to be £6.7m net. Several additional financial pressures were identified including the pay award, price inflation and the increase in interest rates. Within Corporate Services, the expected overspend was £1.2m and there was expected to be a slight underspend in Treasury.

The Head of Business Intelligence noted a slight increase in staff sickness and an improvement in the response to Freedom of Information (FOI) requests and complaints.

Officers were asked a number of questions covering: FOI requests; an analysis of complaints performance; loans made by CYC; sickness data; government financial support for local authorities (LA); the budget deficit and increased costs; reducing costs; reserves and contingencies and local businesses.

Following discussion, the following action points were agreed:

- To provide further detail on the cost of FOI's and the types of individuals and businesses who request them
- To provide a link to complaint data, comparing the percentage of complaints that were responded to entirely against the number of complaints received
- To provide validated customer satisfaction data (paragraph 31 refers),
- To request the Children, Education and Communities (CEC) and Health and Adult Social Care (HASC) Scrutiny Committees have a close watching brief on the overspend and mitigations in the areas of their remit.

#### Resolved:

- To note the finance and performance information and the actions needed to manage the financial position
- ii. To action the points outlined above.

Reason:

To ensure expenditure is kept within the approved budget.

# 10. Progress of the Organisational Development Plan (6.12 pm)

The Head of HR and OD Corporate Services gave an update to the Committee on progress of the Organisational Development Plan.

The Officer responded to a variety of questions from Members covering hybrid working and communicating the new way of working to staff, behaviour change management, recruitment difficulties, staff absence, exit interviews, HR support for managers and reasons for staff turnover.

During the discussion it was agreed that this item should return to the Committee in six months' time to measure progress. The Head of HR agreed to include comparable recruitment and retention metrics as well as the results from the employee survey / focus groups.

#### Resolved:

- i. That an update on the progress of the Organisational Development Plan be added to the Committee Work Plan for six months' time.
- ii. That the progress made to date on the OD plan, as outlined in Annex 1, was noted.

Reason:

To allow the Committee to scrutinise the delivery of a resilient, skilled, and capable workforce to achieve the Council Plan.

#### 11. Customer Centre Performance (6.51 pm)

The Head of Customer and Exchequer Services presented a report on the current telephone performance pressures in the Customer Centre within the Customer Services Team. He explained the difficulties in recruitment and retention and noted 7 vacancies existed currently. This had resulted in longer wait times for customers and an increase in abuse to staff. It was reported that improvements had led to a decrease in phone traffic and a rolling recruitment programme was in place.

Members asked a variety of questions covering the call back facility, the working location of the customer service team, support for staff, access to workflow calendars and dealing with abusive calls.

Following discussion, actions were identified for the Head of Customer and Exchequer Services and/or Head of Business Intelligence:

- A breakdown of the number of calls that went direct to Customer Services and the number of calls that went directly to the Parking team to be provided for the Digital ResPark Scrutiny Review in December.
- Details on the length of calls to the Customer Centre to be circulated to Members.

#### Resolved:

- i. To provide a further update to the Committee in the next 3-4 months.
- ii. To formally recognise and thank the Customer Service team for their continued hard work.
- iii. That the report be noted.

Reason:

To secure scrutiny of council service performance where it impacts on customer experience.

# 12. Digital Inclusion Update (7.37 pm)

Members received a report from the Head of ICT which provided an update on Digital Inclusion. He highlighted the workstream priorities and noted

that since the publication of the report, Project Gigabit, to which paragraphs 27-29 referred, there had been a recovery of slippage in the timeline.

Barbara Swinn, Head of Strategy and Engagement for York Explore, explained York Explore's role in leading and supporting partnership development. She welcomed the funding received from CYC (City of York Council) which had provided for a part time post to co-ordinate these activities.

Members asked questions including, learning that had taken place and how this could be shared with other areas, the scope for free Wi-Fi networks in areas of social housing and the timescale for Project Gigabit.

Report of the Director of Transport, Environment and Planning Portfolio of the Executive Member for Transport and Executive Member for Economy and Strategic Planning

#### **City Centre Access – Action Plan Update**

#### **Summary**

- 1. In November 2021 the Executive, following three scrutiny meetings and extensive consultation, considered Police and Counter terrorism advice regarding access to the City Centre. On balance Executive made the decision to reduce the risk to life caused by the use of vehicles as a weapon in the City Centres most heavily pedestrianised streets. Deciding to remove as many vehicles as possible from accessing the whole footstreets area during pedestrianised hours. That advice has not changed and has been reiterated to executive Members by the Police and National security advisors, and the hostile mitigation measures are contracted to be completed in summer 2023.
- 2. Advice from North Yorkshire Police and the Counter Terrorism Unit (found in Annex C) requested to consider new measures to reduce the risk of a vehicle as weapon attack in the footstreets, particularly considering York's historic and narrow streets and high number of people visiting the city centre. Particular vulnerabilities were identified in relation to the areas which host some of the city's largest seasonal events and were based on the targeting of similar events across Europe by terrorists. Risk Assessments have taken place regularly through the multi-agency York Protect and Prepare Group convened under Safer York Partnership to drive forward an action plan to mitigate the threat of terrorism through local delivery of the Government's CONTEST strategy.
- 3. Recognising the impact that the decision would have in particular on Blue Badge holders and the need to mitigate impacts, asuite of accompanying decisions were also made. Amongst these was a

report on the "Strategic Review of City Centre Access", which included an action plan to improve access. This report provides an update on the delivery of the action plan. The update summary can be found in **Annex A.** 

4. At the full Council meeting on the 20 October 2022 the Council received a number of representations forming a petition relating to the removal of the blue badge exemption in the foot streets. These representations formed a petition titled "Reverse the Ban". A summary of comments is included in **Annex B**.

#### **Recommendations:**

- 5. The Committee is recommended to:
  - i. Note the update on the "City Centre Access Action Plan"Annex A;
  - ii. Consider the petition presented to full Council as required by the Constitution.

Reason: To provide ongoing scrutiny of the implementation of mitigation measures agreed by Executive and consider petitions presented to Council as required by the Constitution.

# **Background**

- 6. In November 2021, the Executive considered a number of reports including
  - "City Centre Strategic Vision Adoption of Vision and Next Steps",
  - "Strategic Reviews of City Centre Access and Council Car Parking",
  - "Consideration of Changes to the City Centre Traffic Regulation Order".

Links to these are provided in the background documents at the end of the report.

7. The last of these reports was to give effect to the Police Counter Terrorist Advice to make the City Centre as car free as possible and install Hostile Vehicle Measures. A subsequent Executive Member for Transport decision removed the majority of exemptions

- that permitted access, this has come into effect at the end of September this year. The Police advice has not changed and the contract for the hostile mitigation measures is expected to start in the new year and be completed Summer 2023.
- 8. In making the decision to remove vehicles from the foot street area, the Executive recognised the access impacts of such a decision, particularly on blue badge holders. In response, Executive adopted actions ("Strategic Review of City Centre Access Action Plan") to improve and support access in and around the foot streets, as well as the "My City Centre Vision" as a long-term ten-year vision that would support an accessible and thriving city centre. It was recognised that mitigation opportunities should continue to be reviewed to support the promotion of a safe and accessible city centre.

### **City Centre Access – Action Plan**

- 9. An update on the current progress of delivering actions in the Action Plan can be found in **Annex A**.
- 10. A number of the actions agreed at November Executive had significant dependencies. These are specifically updated as follows:

#### Access Officer Action

- 11. One of the first actions requested by the Executive was the creation of an Access Officer post. A number of subsequent actions were then assigned to the Access Officer.
- 12. A recruitment process for the Access Officer should have concluded before this committee considers this paper and Access Specialist Consultants, MIMA, have been brought in to support the work. MIMA will support the following in the first instance.
  - Consultation on improving pavement café licensing rules
  - Installing additional benches in the City Centre
  - Identifying the two priority car parks for investment in Gold Standard access
- 13. A separate consultant will undertake the City Centre Shuttle work.

#### **Dropped Kerbs Action**

- 14. The dependency for this action was funding. The programme of dropped kerbs was identified in the Action Plan as to be funded by a Department for Transport funding stream. Unfortunately, this element of the funding bid was not successful. Despite this, 8 additional dropped kerbs have been installed on Stonegate and the existing ones refurbished on Colliergate and Church Street. The work carried out in these locations highlighted the challenges of cellars and buried utilities can impose.
- 15. The Executive Member for Transport in March this year received a report detailing the approach to dropped kerbs. Due to the lack of funding from the Department for Transport, the council re prioritised to deliver a dropped kerbs programme to the same level of funding.
- 16. Since the funding was approved by in March 2022 the designwork has commenced on a programme of dropped kerbs and implementation will happen on Fossgate later in the Autumn and Low Petergate, Blake Street and Lendal in the Spring.

#### City Centre Bus Shuttle Feasibility Action

- 17. Through the scrutiny process, a trial of a City Centre Bus Shuttle service was identified as a potential mitigation. This was included in the "City Centre Access Action Plan" by Executive in November 2021. The Action Plan was clear that the first step as part of this action was coproduction with involvement of the access officer and potential services users to ensure their requirements shaped future proposals. This is particularly important given this mitigation emerged through scrutiny discussion rather than through direct engagement with blue badge holders, unlike the other actions in the action plan.
- 18. The Feasibility Study was dependent on the award of Bus Service Improvement Plan (BSIP) funding.
- 19. The Council has been told it will receive this funding in November and part of the bid has been specified to trial this service. However, due to delays in the announcement of the funding and then dependencies on making the Enhanced Bus Partnership, it was felt that Transport funding would be useful to expediate this process. The decision to do this was made at the July 2022 Executive meeting.
- 20. By bringing forward coproduction on possible vehicle and service options, which would include the identification of specific user

- needs, review of the vehicle type and the physical experience of some different vehicles, a trial of the service could be brought forward sooner.
- 21. A consultant has been appointed to undertake this work. Officers will be imminently working with the consultant on a programme.

#### **Current City Centre Operation**

- 22. As detailed above, the pavement café licenses issued as part of the regulations put in place on response to the pandemic remain in place. There are currently 115 pavement cafes across the city. This is roughly double the number that existed prior to COVID with the requirement for planning permission.
- 23. Consultation with businesses and residents is currently ongoing to explore improved café license regulations, which would take account of access impact of the operation of the licenses. The results of the consultation and recommended changes in guidance is set to be reported to a meeting of the Executive in November.
- 24. The decisions taken by Executive in November have removed the vast majority of vehicles from the City Centre, in the future this will be physically enforced through Hostile Vehicle Mitigation Measures.
- 25. The pedestrianised footstreet hours currently operate until 5:00 pm as per the permanent Traffic Regulation Order. The return to 5pm in the footstreets follows the decision, made by the council's Executive in July 2022, to postpone a statutory consultation to permanently extend footstreet hours to 7pm.
  - **26.** The decision to postpone this consultation aims to provide the opportunity to consider the lived experience of pavement cafes under a revised licensing guidance, wait for more clarity from the Government on the long-term legislative framework for pavement cafes, and make further progress with the delivery of the City Centre Access Action Plan.

#### **Petition**

27. A petition was received at full council titled "reverse the ban" and the subject is the decision at the November 2021 Executive meeting, on the advice of Police Counter Terror, to remove the blue badge exemption during footstreet hours. A summary of the petition can be found in **Annex B**.

#### Council Plan

- 28. The proposals are well aligned with the aims of the Council's Plan 2019-2023.
  - Well-paid jobs and an inclusive economy
  - Getting around sustainably
  - Safe communities and culture for all
  - Creating homes and world-class infrastructure

#### **Implications**

#### **Financial**

29. The £80k cost of the hostile vehicle mitigation temporary measures for Christmas 2022 and the £40k ongoing security for TRO compliance until permanent measures are completed will be funded from within existing transport budgets. The one-off £50k funding required for the city centre bus shuttle feasibility can be met from transport reserves.

# **Equalities**

- 30. The Council recognises its Public Sector Equality Duty under Section 149 of the Equality Act 2010 (to have due regard to the need to eliminate discrimination, harassment, victimisation and any other prohibited conduct; advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it and foster good relations between persons who share a relevant protected characteristic and persons who do not share it in the exercise of a public authority's functions). These duties were considered in detail when undertaking the Executive decision in November 2021 and subsequent decisions. The process of co-production detailed in this report will identify any equalities implications when implementing mitigations and these will be addressed in future reports.
- 31. The Action Plan captured the mitigations for the decision to remove the exemption for blue badge holders from the City Centre Footstreets that was considered under a detailed equality impact assessment.
- 32. However, as detailed proposals come forward, such as the results of the consultation on pavement cafes and the City Centre Shuttle

Bus Study Feasibility, they would each need a specific equality impact assessment of its own.

#### Legal

Traffic Restriction Orders (TRO)

33. The Executive decision of November 2021 implementation complied with the Council's power to make a permanent TRO is set out in Section 6 of Part 1 Road Traffic Regulation Act 1984. Before a TRO is made, the Council should ensure that the relevant statutory procedures set out in the Local Authorities Traffic Orders (Procedure) (England & Wales) Regulations 1996 (LATOR) are complied with including the requirement for formal consultation and advertisement in the local press. As objections were received these objections were duly considered.

#### **Risk Management**

34. Co-production ensures the risk that the proposals do not meet the needs of intended users.

- 5 This year's exclusion of blue badge holders is a disgrace!!
- 6 Everyone should be able to fully access the city centre
- 7 I feel ashamed that 'Make it York' excludes the disabled
- 8 Please connect with the Liberal Democrat strong commitment to human rights
- 9 This ban is dreadful, non-democratic and against human rights
- While trying to keep the city centre traffic free is an excellent aspiration, exceptions must be made for blue badge holders
- 11 Policy is excluding not including
- 12 It is time to do the right thing and open up the city to cabs and cars for the disabled
- 13 An unbelievable violation of human rights that diminishes the name of this good city
- 14 I find this very hard to understand

In February, during the time of Storm Dennis, it was my 94th birthday, and my family had booked a special lunch at The Ivy. We knew no cars would be allowed, so my daughter and I took a taxi - only to find that was not allowed near, even with my Blue Badge, I had a long (for me) and painful walk, in the wind and rain. It was even worse after the lunch as we had to walk to a taxi rank and had a long wait, No taxi was available to pick us up. My daughter and I were literally soaked through our coats, and very cold.

I now have to go to Monk's Cross or Vanguard to visit a shop, optician etc,

I understand the need to guard against terrorism, but I doubt whether old and/or disabled people are banned from the centre of London.

Good luck to your efforts.

- 76 This ban is in breach of a range of fundamental rights. It must be reversed!
- 77 This ban makes York inaccessible. Do not alienate people who need badges
- 78 This ban would be a breach of citizen's fundamental human rights how dare you call yourselves the representatives of England's first Human Rights City!!!

- Please let the disability return for disabled people and put them before things for tourists and people who are able bodied
- 86 Definitely want one [reverse the ban]
- 87 My father-in-law is 95 and has COPD. This ban is removing his right of access to the city centre
- 88 I am disabled with multiple points of arthritis and am awaiting a mobility scooter.
- 89 I think at least one route into and out of the city centre should be made available to us, preferably one for entry from North, South, East and West.
- 90 Can't take my car into the centre but have nearly been hit by delivery cars numerous time
- 91 I miss when York felt like home
- 92 As a carer for my mum and partner I can't manage to take them both into city centre any more
- 93 As a Blue Badge holder my life has been worsened dramatically by the ban. E.g. I can't access City Screen early evening any more and places like Bettys
- 94 I am truly ashamed to be living in a city that does not let blue badge holders into the city centre and hope to see this reversed
- The impact of the ban has taken an intense toll on the emotional and mental health of myself, my friends and family. Visiting my beloved city centre is no longer an option; 'allowing' us to enter before 10.30 and after 7pm casts disabled people and Blue Badge holders as second class citizens. I fell in love with York age 14 and moved here at 18. Now, age 35, I am unwelcome.
- 96 Please remember we all have human rights and being able to access our beautiful city should not be taken away. Not everybody can access it without their highly specialised vehicles
- Disabled and less mobile people need protecting from discrimination and degrading treatment by the City of York Councillors. These councillors are taking away our freedom, equality, opportunities, our right to socialise and enjoy activities in the city centre. We are patronised with suggestions of cycling, shuttle buses, benches and what's to say they will even be available when required. Wheelchairs and mobility scooters don't work for everyone and the terrain isn't always suitable anyway. Citing anti-terrorism measures implies that blue badge holders are likely to be engaged in terrorist activities! What have we don't that offends the council. Why do they hate us so much? This feels like the thin end of the wedge. What have they got planned for us next I ask myself.
- 98 Our lives would be much enhanced if my husband, who has Parkinsons, could get nearer to the city centre!
- 99 This is a very regressive policy
- 100 It's a basic human right
- 101 I am a carer for a lady with disabilities and she regularly goes into York centre and this has made life very difficult for her. I also agree that the security issues could absolutely be addressed in another way.
- 102 When "all" does not include everyone we are on a slippery slope
- 103 I am deeply embarrassed that my city does not welcome disabled people and furious that the council are so dismissive of our rights to move around the city on our own, with family or friends without any good reason
- 104 I got a blue badge purely to have better access to the city via taxi; now it is useless

- 105 We should more rights that cage tables and buildings!
- Disabled people deserve access to everything able-bodied people do: we shop, have appointments, meet friends + family, we party and do fun activities. You're blocking us from living our lives!
- 107 York: there's no point being a tourist city, if you don't look after residents who live here all year round
- 108 WHY
- 109 A ridiculous & totally insensitive decision and from the LIB DEMS
- 110 Everyone has a right to be in our city. Reverse the ban!
- 111 This ableism is bullshit!
- As a parent of a disabled young person it is criminal to exclude them easy access to the city. as a city of sanctuary the disabled should be equally welcome
- 113 It is surely possible to make our city work for disabled people
- 114 Where are our Human Rights?
- 115 Mum has blue badge. Unable to take her to shops, banks in York
- 116 My elderly mum of 92yrs who we can no longer get her into the city for her clothing/shoes etc
- 117 York should be open to all!
- 118 Please make York more disabled friendly!
- 119 This is an outrage in a world of equality of opportunity
- 120 Stop hating the disabled. What have they done to deserve this?????
- 121 This is incredibly ableist. You need to do better
- 122 My disabled mother in law can no longer come into town!
- This decision of the council has negatively affected the lives of disabled people in York. The negative effects are not hypothetical, they are documented, they are happening just as disabled people have warned the council time and time again. It has evidently been ignored by the council, or else it should have been resolved. If the council claims that they are listening to disabled people, I can only assume that, despite disabled peoples' continued please and warnings, the council's insistence of the ban and the recent castle car park initiative is the council's active hostility against disabled people. As a resident of York I am incredibly disappointed by the city's treatment of our disabled peers and the actions of the council is shameful. This ban alone should call into question the validity of the city's "Human Rights City" label. I urge the council to REVERSE THE BAN! And understand that this is a starting point in upholding fellow disabled residents' rights!
- 124 We need access in vehicles for blue badge holders back again, please
- 125 Equality of opportunity is crucial for those with mobility problems to enjoy life to the full
- 126 V. important to have enabling practices!
- 127 Please reverse the ban on disabled people
- There are many disabled people and those with Blue Badges should be able to reach the city centre. Lots of cities have free shuttle buses and this is [also] really needed in York for many people who can't walk much but have no blue badge.
- 129 This action has closed my world down
- Life is hard enough for the disabled and their carers. You have made it so much worse.
- 131 I am a 90 year old disabled lady. You have taken away my rights to be able to go into York centre to meet with friends at various places including St Sampsons Church [Centre]. Growing old comes to all of us. We can't stop it.

- 132 I have lived in York 57 yrs and since the blue badge ban I have been unable to access York.

  This is greatly distressing to me and I feel rejected and unwanted which adds to my isolation.
- 133 My father lived in York for the whole of his life and walked and cycled everywhere until his mid 90s. In the last few years of his life his remaining pleasure was to be driven into the city and where he could manage a short walk. This link with his past added to his wellbeing. To see this has been taken away from people who pay taxes to live in the city is iniquitous
- 134 This decision has completely removed access to my own city. It is unjust in every sense.
- 135 My 26 year old daughter has been excluded from her own city centre since the introduction of the ban. Having been limited in the first place to what was accessible to her, she is now totally excluded because she is unable to walk from any of the car parks to the shops. Her quality of life has been significantly affected.
- 136 My disabled husband can no longer visit the city he loves!!!
- 137 My mother is a blue badge holder who is over 100 and still able to walk and use shops with support. I used to be able to take her by car, into Goodramgate and park outside or near each shop she needs Boyes, Savers, Peacocks (ladies clothes now closed lost its customers due to ban?) and Boots pharmacy. Now the covid emergency is over, it's time to re-enable parking access on Goodramgate and other places, e.g. Colliergate for Barnitts, for blue badge holders.
- 138 (this all from one person) I am so saddened by the continuing effective ban of disabled people into the city centre, and ashamed of being a York resident (and born here). My mum died last month. She had MS for 40 years. Since the removal of parking and access into the centre, she was no longer able to be taken into town by my father. I was no longer able to take her to see a film at City Screen.

The small things in life that non-disabled people take as granted. Disabled people are workers, consumers, visitors, residents and tourists.

But most of all they are human beings.

They have rights protected by the Equality Act 2010 and the city I am from has breached these by making changes that have caused indirect discrimination. The Council (of which I also used to have great sympathy for and work at) has unfortunately caused great misery and suffering to disabled people and their families.

Access into our city really is that important to people.

Please, please reverse the changes.

Give disabled people the opportunity to live as others do. Please.

- 139 If you were disabled you would realise that we are all human beings, who have the right to enter into our city.
- 140 Inhumane. Shocking
- 141 Isolation is a killer please abolish this ban.
- 142 It is appalling that people with reduced mobility are prevented from participating in York's social and cultural life. Everyone is likely to be affected by reduced mobility at

- some point in their lives, and it should not be difficult to find solutions that allow people in this situation to access the city centre. I urge the Council to do better.
- A 'solution' to an issue that disproportionately disadvantages disabled people isn't a solution at all. Our lives matter just as much as yours
- 144 No other city has taken away the right of access to people to be able to enter parts of their city freely and without prejudice York as a city which claims to be for Human Rights should read the charter they signed in 2017 and remember all people want to enjoy this beautiful city and the facilities it has, not just those who have no restrictions to their access.
- 145 The social model of disability emphasizes that people have impairments, but what disables them are the barriers we place in the way of their inclusion. The Blue Badge ban is a clear example of a failure to remove the barriers to disabled people's inclusion in the life of our city. It is shameful, divisive, and unacceptable from a self-declared "Human Rights City". How can our ambitions around tackling health inequalities & building a city for all be taken seriously when council leaders took a decision like this despite being begged not to? How can people believe it when we say we will shape the future of our city around what matters to our residents if we ignore the voices we most need to hear? Reverse the ban, show you understand it was wrong, before you are made to. It will be too late if that day comes.
- Please allow all people of York access to their city again. Disability should not be a barrier to accessing the city centre.
- 147 Changes should not be at the expense of people with disabilities.
- I feel that there is no rhyme or reason for this ban on blue badge holders. I've lost my independence and my liberty. I want & need to get into town to spend money. No can do. I strongly object to being told on how to live my life. Disabled peoples' lives are hard & difficult enough without this ban. It's a disgrace.
- The COYC issues Blue Badges which are impossible to use in the city where I pay rates. Guess where my voice will go at the next local elections!
- 150 This is pure discrimination. I am doing this on my dad's behalf as he has health related issues. York needs to be community-driven, <u>not</u> profit-driven
- 151 We should make York an inclusive city for all!
- 152 Security should never mean exclusion.
- 153 This is blatant discrimination, if you wouldn't allow Blue Badge holders to park at least give them free public transport
- 154 Everyone deserves to be able to access and enjoy our beautiful city
- 155 Keith you are a bellend
- 156 Essential that full and proper provision is made!
- 157 Many blue badge holders are reduced to driving round looking for parking places which are full then having to return home as they couldn't find a space near enough for them to access the city centre. This affects their quality of life and health. Please reconsider
- Equal rights and independence for the disabled to park in York, like other welcoming cities in the UK.
- 159 Disability rights = human rights
- 160 This would effectively make the city centre unreachable for most blue badge holders
- 161 Get rid of pavement tables and chairs
- 162 Get rid of pavement cafes

- 163 Yes I think it's wrong. I work at St. Sampson's for the over 60s and there is no longer access for blue badge holders. This issue needs to be reversed as other cities have overturned it
- 164 I volunteer at St. Sampson's and it is sad to hear previous customers regret that they can no longer access the centre
- 165 Obvious, init?
- 166 Selfish, thoughtless council. Shame on you
- Disgusting to stop the disabled coming into the city centre
- 168 The changes to parking for the disabled has resulted in me no longer coming into York unless it's essential
- 169 The ban on Blue Badge parking has now reduced our visits to York by 98%!!
- 170 Discrimination Council should be ashamed of themselves
- 171 As a Blue Badge user, I find it difficult to access services in York now. I am excluded from socialising also
- 172 This is causing a lot of problems to my 92-year-old neighbor
- 173 No need to punish disabled people by restricting lives further
- 174 Disability discrimination!
- 175 I am a Blue Badge holder and find the parking options in York restrictive. Transfer to taxi option is not practical need a special car and assistance
- 176 You should be supporting the residents just as much as the tourists. York seems to be becoming a money making exercise these days!
- 177 It's discrimination
- 178 Hope you never get to be handicapped, life can be hard
- 179 It's simple, reverse the ban!
- 180 This is utterly ridiculous and is a horrendous breach of the HRA and the Equality Act
- Please consult York residents before you make such big decisions and NRM is another example!
- To be an inclusive/Human Rights City, York Council should include <u>everyone</u> and give <u>everyone</u> the right to access the city centre, not exclude an entire community of people who need to use their vehicles to access banks/shops/cafes etc. Life is hard enough for them without this additional stress. It's time to put this right!
- Everyone should have the right to come into our city centre whenever they want. People should <u>not</u> be prevented from coming into the city centre because they are disabled. It is the highest level of discrimination and quite frankly utterly disgraceful. What has happened to York?
- 184 Think it's appalling. Blue badge holders have just as much right to be there as everyone else, why should their access be denied!!!
- The ban will increase loneliness and isolation of people with mobility issues and further decrease their opportunity to interact and access stimulation, culture/etc.
- 186 I am embarrassed about this ban and have had friends visit from abroad who were able to travel internationally with their disability, only to receive a hostile welcome from the City of York.
- 187 Please consider reversing the ban
- 188 I think this is disgraceful.
- Now being disabled, I find it hard to get into the city centre & then walk from a car park, when the only bank is in the city centre.

- 190 Allow disabled parking as parking is hard at the best of times.
- 191 How can this happen. People need spaces
- Disgraceful that the elderly and infirm cannot get into the city centre. These people worked and paid taxes for many years.
- 193 The City of York's treatment of disabled people is shameful and needs to be corrected.
- 194 I feel these people should be allowed to park in town and have the freedom of the City like everyone else.
- 195 Keeping the ban is anti-historical!
- 196 I have friends who are disabled and really worry that they will not be able to enjoy York or go shopping.
- 197 It's not acceptable that you are excluding disabled residents and visitors from York city centre.
- 198 Would of expected better from Lib Dems/Green Party!
- Shame on you York council, people with disabilities have enough challenges to overcome without being denied access into their own town centre! Honestly I was hopeful when a joint Lib Dem/Green Council got voted in but see no improvements under your leadership.

- 206 Don't target disabled people why are you discriminating against the elderly? It is a disgrace. Shame on you!!
- 207 Blue Badge holders rely on freedom of access to the city and should not be restricted
- 208 Thank you for supporting this case.
- I think York should allow blue badge holders in the city centre, as it would enable disabled people to access the city, as it is more difficult to walk from a car park. By doing this you will enable disabled people to have freedom of choice and enhance their mobility.
- I am very angry about the current ban on Blue Badge holders...... It seems to me that this is indicative of the move to prioritise commercial and tourist industry interests in York over those of the residents. I have always supported tourism as a vital part of the city's economy, but it strikes me that the main purpose of the city's economy should be to provide for the city's residents, and that doesn't seem to be happening. I am an elderly resident of York, I first came here nearly fifty years ago, and I am very saddened to see so many residents being excluded from the heart of their city.
- 211 This car park is my lifeline to coming into York at all.
- 212 Please reverse the ban, to allow people with disabilities to have access to the city centre, for important services, eg banks, opticians.
- 213 Not happy with current restrictions for blue badge holders wanting to access the city centre. Need to reverse the ban!
- 214 I have an elderly father and this would affect him
- This is discriminatory for people who have various disabilities. I thought York was a friendly city.

- 216 The ban is not good for disabled in these days of equality and diversity.
- 217 It's unfair!
- 218 This is an embarrassment for the city!
- 219 How on earth was this ridiculous rule passed. Council is not listening to the residents.
- 220 How did this get passed????
- 221 My sister spends all her time doing this!
- 222 A discriminatory disgrace!!!
- 223 6 months ago I fell on the dreadful pavements and broke my hip. I have been unable to get to York to the bank. I think the city council should spend more money on the pavements.
- For the people needing a blue badge, being able to park near to locality treasure troves like the centre of our amazing city is a fabulous way of enriching their lives. Please don't continue to deprive them.
- The lack of access amounts to disability discrimination with this council's repeated failure to make reasonable adjustments. Someone needs to go round York in a wheelchair and see just how difficult it is for someone with mobility issues to navigate the city.
- As I am disabled and cannot walk far, I have a walker I push. But to come into York for entertainment or singing at St Sampsons Church [Centre] Fridays, I have to use Dial A Ride to bring me in. £9.50 fare one way, otherwise it's £14 each way ordinary taxi. The bus stops in Acomb to York are too far away from where I live and walk to. If I use Fleetways or York Cars they drop me at Pavement outside Marks and Spencers. Still a long walk to St Sampsons and shops nearby. Hope this helps the cause.
- 227 Please support people who have no choice but wish to enjoy York and all it offers.
- 228 Can't bring other people with mobility issues into town.
- Without our car my husband is housebound. We are too far for him to walk to the nearest bus stop and I do all the driving. As far as we are concerned this is discrimination for people who are not able-bodied and old.
- This is discrimination against disabled people. These people have enough problems to cope with and being unable to park near the city centre may lead to them being housebound.
- 231 My mum got a disabled badge. She needs it to get in York city centre.
- I entirely agree that the City of York Council must reverse the ban on blue badge holders in central York.
- 233 Please help everyone have a simpler life.
- 234 My husband enjoyed being in York many times due to parking in city. Although he is now dead, I wish this for others.
- 235 We will be judged by how well we reach out to those most in need.
- I object to pavement coffee culture, unless it is a pedestrian walkway with no cars. It not only impacts wheelchair users and guide dogs but pushchairs and general public.
- 237 A disgraceful and possibly illegal act, with no consideration for older folk whatsoever.
- 238 Essential!!
- I believe that the ban reversal will be beneficial to York City Council and to blue badge holders who need to use the city centre for essential shopping.
- 240 This would make life easier for any amount of people.
- 241 Blue Badge holder. Yes please.
- 242 Discrimination against disability.

- This is shocking and should not be allowed. People with disabilities are being kept from the city. This is disability discrimination.
- 244 Disability discrimination.
- 245 Disgraceful
- 246 This policy is discrimination!
- 247 Many blue badge holders are prevented from using such an essential service as their Bank by this ban. Several banks and building societies are located within the boundary of the banned area.
- 248 Disgusting policy
- (all from one person) I recognise the need to address security issues in our city, but feel that banning blue badge holders from the city is quite unacceptable. Banning any group is a form of discrimination which should not be permitted.

All out citizens have a right to go about their lawful business, in their city. As a retired OT, I'm a strong advocate for people remaining as independent as possible. By stopping disabled people from shopping, using the bank, attending appointments etc, the council is preventing people from exercising their independence.

Other cities seem to be managing security concerns in a way which is not discriminatory. Please lift this ban at once. It has no place in a free society!!

I'd also add that the environment of the city currently does little to support the ability of disabled people – too many events attracting crowds of visitors, and too many pavement cafes blocking easy transit!!

- 250 I'd also add that the environment of the city currently does little to support the ability of disabled people – too many events attracting crowds of visitors, and too many pavement cafes blocking easy transit!!"
- The provision for disabled people in York is already massively lacking and a ban for blue badge holders is a direct attack on disabled people. NO BAN!
- I am in full agreement that steps need to be taken in this matter, having acted as a carer for 2 family members and a close friend.
- 253 We should find a way to make York a more inclusive city.
- 254 Please reverse this. I care for a blue badge holder with Alzheimers and it's impossible to get her into the city centre. It's against human rights.
- Any councillor of York are you disabled or does any of your family who may be disabled. If you don't know what it's like to be disabled then you do not know what it's like to manage disability, living with it 24/7
- 256 Access to city centre for disabled people should be a priority.
- 257 We suffer enough. Please don't make us suffer any more.
- The ban on blue badge holders is an insult to older York residents who deserve better treatment from Y.C.C as a Human Rights City.
- 259 Please reverse the ban to enable those with disabilities access to the city centre for vital goods and services.
- (all from one person) The banning of blue badge holders is discriminatory and will hit on the most vulnerable people in our society. It was understandable that during the covid restrictions that access for blue badge holders should be banned. Not that these restrictions have been lifted there is no reason why this ban should remain in place. Citing security measures is a poor excuse. Why not ban people with backpacks!

Whilst the measures appear to have the full support of the business community, perhaps this is because over the last few years the number of pavement cafes has increased. Fossgate every other establishment appears to be a cafe.

The change in the type of establishment more towards hospitality has driven residents in general away from shopping in the city centre and in particular blue badge holders. The current ban also assumes that those with certain disabilities will be able to walk any distance, this is not the case which is precisely the reason for the introduction of blue badges in the first place.

261 (all from one person) Please make the city centre easily accessible to all disabled people. So many (including blue badge holders) are unable to access the city centre from the distances allowed at present. Our streets are very narrow and are often jammed with tourists by 9.30 or 10am every day of the week. Pavement cafes also increase the hazards for disabled people.

Whilst tourism is an important source of income for York, it is also now making it impossible for small independent shops or the market to survive.

Most disabled people (especially physically disabled) cannot use the Park and Ride services successfully for two reasons:

- 1. Most bus drivers do not offer help
- 2. The buses have a very small proportion of seats available.
- 262 York Council should be doing more for elderly and resident people and disabled people.
- 263 This affects a <u>lot</u> of people.
- 264 Please overturn this decision and improve accessibility.
- 265 This needs overturning.
- 266 They should be entitled to make it easier to get about.
- 267 Do change your mind
- 268 It's my partner who drives and needs this.
- 269 My husband is disabled so we want this ban to be lifted.
- 270 I am disabled. I need to park in the town centre. This ban needs to be lifted.
- 271 Please reverse this discriminatory policy that severely curtails the lives and human rights of disabled people.
- 272 This is vital for disabled people to visit our town.
- 273 DON'T BAN THE BLUE BADGE!!
- 274 Surely disabled people have just as much right.
- 275 What a ridiculous decision. Reverse it.
- 276 Let them have access.
- 277 I definitely [dis]agree. My dad needs one.
- 278 Reverse the ban on blue badge holders.
- 279 Rubbish Council.
- 280 This is discrimination at its best. Try getting into shops etc in a wheelchair.
- 281 Should bring it back.

- Disabled people need to live too. It is unfair and an invasion of their human rights. Please reverse the ban.
- 283 Bring back D.P.A.G.
- Just make it easier. Don't make the situation more difficult with the stress!
- 285 Keep open to blue badge holders.
- 286 Please help blue badge owners to access York.
- 287 It is inconvenient.
- 288 Disabled access needed **URGENTLY**.
- 289 Out of order. Not good.
- 290 This decision was not thought out in respect of the needs of disabled people.
- 291 Disabled need to park if they can't walk.
- 292 Should not be banned.
- 293 Yes, please remove the barrier.
- 294 It is essential for disabled parking to be allowed in the city centre to give them access to the centre.
- I am able bodied now but who knows what the future holds this is my city and I want to be able to access it with both my able bodied and disabled friends and family.
- 1'm writing to express my support to a reverse the ban on blue badge holders from parking in the city of York as they previously were able to. This ban is discriminatory and impacts the lives of those who are unable to get into the city centre because of their disability to support the local economy and enjoy what the city centre has to offer them, be that retail, eating out or attending choir rehearsals which are held in the city.
- 297 My parents have been York residents since the 1950's and have been directly affected by this ban and, as elderly residents of York, it has hugely impacted their wellbeing and social opportunities. I was born and raised in York and I return frequently to support my parents. My sister and I both find it stressful and inconvenient when we want to bring them into the city centre as we have to drop them off as close to where we need to be in the centre and leave them alone whilst we go and park elsewhere.
- 298 I am a manual wheelchair user who moved to County Durham three years ago. The ban means that York, which I expected to be an excellent shopping and socialising choice, is not possible for me.
- 299 To ban disabled people from our town centre is an absolute disgrace shame on you York Council you think more of the tourists than your own citizens.
- We feel that City of York council cannot hide behind dubious claims about terrorist prevention methods in order to justify this. They have also clearly failed to provide the shuttle bus service that was mentioned numerous times in the infamous meeting a few months ago. Surely that should be a simple and quick thing to arrange?!
- I have not been into town since the parking changed for Blue Badge holders as it has become too inconvenient and would be detrimental to my health with having further to go to access services in the town centre. Pleasure outings such as to the cinema or for meals out have ceased and I have sought alternative out of town locations for things like the opticians. Shopping I would have done with a quick visit to town is being replaced with online purchases. These examples, combined with many others in a similar situation, must be harming the economy of the city.

- The ban will keep disabled people from entering the City. Would you (the council) act differently if you had a mobility issue. Disabled parking in the car parks you suggest are too far out of the City, please use some common sense for once.
- The ban is ridiculous and I find it discriminating against people with disabilities. Do these people actually know or even understand what it is like to be unable to walk just a few yards?
- 304 My Dad was a blue badge holder and very much enjoyed being able to get into York every week to meet up with friends for coffee. He would have been very upset to know that the City now no longer welcome disabled visitors.
- I am a disabled person who relies on a mobility scooter to get around. York has long been a favourite place to visit, either for day trips or longer visits, but with the changes to Blue Badge parking arrangements it is no longer accessible to me. There is simply no point in trying to visit when people like me are being made to feel so unwelcome. The worry of finding somewhere to park ruins a visit and unless you reverse the ban I can't imagine us coming back.
- 306 Please reverse the ban on disabled parking in York city centre. This ban affects May people including businesses where disabled people shop. It is inhumane & cruel to keep this situation
- We are moving to Doncaster shortly and one of the things we were looking forward to was visiting York. As a blue badge holder and someone whose mobility is becoming increasingly impaired, not being able to park in the centre and having to walk longer distances on crutches, this ban will inevitably mean we are less likely to visit.
- 308 I am the main carer for my 92 year old father, twice per year he likes to go to his bank and get it updated, his bank is, was the Yorkshire Bank on Coney Street, we usually went there for 09:30 for when the bank opened and only stayed there 5 -10 minutes tops, now I can't take him and he has lost his independence and feels very undervalued as a citizen of York. Please can you reconsider your decision.
- I am horrified to hear that the Council is planning to ban Blue Badge holders from the city centre. My late partner had the benefit of one when he was very ill. It made all the difference to the quality of his life that he was able to visit the city centre as it gave him a modicum of independence and a normal life. We went into town every afternoon. He was very limited in what he could do but he enjoyed going out for a cup of tea and feeling part of things. Otherwise he would have been stuck at home all the time. If this appalling plan is approved by the Council, at the next election I will vote for whatever Party proposes overturning it.
- 310 An absolute disgrace that this has been put in place!
- I wish to join the protest at the high-handed actions of City of York council in banning blue badge holders from the streets of the city.
- Please have a heart for those people unable to get to the shops without being able to park. I used to take my mother in and park outside Brown's department store, where she could buy most things she needed plus she could get to Hotters shoe shop with her walking aid. Now she would be unable to do that. I know how much she enjoyed being able to choose and do things for herself. To take away people's independence is heartless.
- I often visited York before Covid, especially with family and friends. But without the accessibility of a close blue badge parking I will not be able to visit in the future. This is a shame as it's one of my favourite cities, and I come for music as well as

- shopping/sightseeing/food. You really have not thought about the rights of those with mobility issues. We don't all have access or the need for a wheelchair/mobility scooter and I liked to visit occasionally on my own too, but this is now completely impossible. Please reverse the ban.
- 314 I frequently took my 93 year old mother into town to visit the cafes and shops. She can only mobilise very short distances with a wheeled walker. We have had to resort to very occasional trips in the wheelchair when my husband is available to accompany us to lift the wheelchair in and out of the car. You seem to have no thought or consideration for people such as my Mum who would like to be able to get out of the car and walk a few paces to a cafe etc let alone the wheelchair users. Please reverse the ban.
- 315 I'm a Blue Badge holder who can't walk far and used to thoroughly enjoy visiting the city centre, fairs etc. but was incredulous when the Council decided to discriminate against me and people like me by preventing access. I haven't been into the City since. It's an appalling and shortsighted action against disabled people
- I am blind and moving around is very difficult and stressful without more barriers relating to blue badge parking.
- Please think again. You're here to look after every one not just the few. We have a say at the ballot box remember!
- As a disabled person I no longer feel welcome in town, or in the York community. I rarely get into town these days because of access limitations. I can't bring my kids into the city centre for activities as my son and I are both disabled and he can't manage buses. I miss feeling like I belong and am welcome here.
- I am deeply dismayed at how York Council is so clearly and openly discriminating against people with disability, effectively banning them from the city centre and other areas with no regard to disability legislation and without the slightest show of humanity in your approach. It's a disgrace for this city.
- I tried to have input during the consultation but felt from the start that the decisions were already made it was in fact a fait a complis and I was being "used" so that boxes were ticked and the consultants had consulted people with disabilities. The situation is getting worse with the street cafes using the footpaths and the designated parking bays being too far away from the city for people with limited mobility what ever causes this in their situations.
- 321 (all from one person) By preventing blue badge holders from accessing the city centre, they are missing out on services and opportunities, for example the opportunity to work in the city centre or even to enjoy leisure time. The ban will very likely contribute to stripping disabled people of independence and social connections, impacting on mental health. The council claims the ban will protect against terrorism, but Liverpool did not take any such action following the terrorist attack there in November 2021, the event which I believe this ban is in response to.

The council is now proposing to close the car park next to Clifford's tower, which has 31 Blue Badge spaces, forcing Blue Badge holders to use St George's Field Car Park, which only has 4 Blue Badge spaces and is prohibitively far for some, making accessing the city centre exhausting, stressful, and dangerous, especially as much of the city's paving means it is already hard to navigate with disabilities. The council seems to be favouring tourist influx over the quality of life of York's permanent disabled residents.'

- Access to York city centre is very poor and requires careful planning! What needs to happen is a coordinated approach to encourage a more diverse populous into this human rights city.
- York is becoming a national embarrassment. Clearly disabled people aren't welcome. This is not the 19<sup>th</sup> century when people were hidden away.
- 324 It's a disgrace that blue badge holders can't enter York's city centre since Nov 2021. This ban needs to be reversed immediately. It's discriminatory and breaches human rights.

  Other cities have found ways to keep people safe why not York?
- Your current policies have stopped me getting into town, even in my wheelchair, as I can't park close enough to my desired destinations to get to them, and I can't get passed a lot of obstructions (pavement cafes, etc). Please, please reassess & overturn your current policies as a matter of urgency as they are thoroughly discriminatory and completely neglect the human rights of disabled residents like me.
- 326 Please don't exclude disabled people!
- This is really something that needs addressing as a matter of urgency as there a people out there with genuine need to be able to access places that those without health problems access as a matter of routine.
- 328 Do IT Do IT Now Please
- 329 This is completely unacceptable a major step backwards.
- 330 SORT YOURSELF OUT, KEITH !!!
- Please change this as disabled people need to be able to get to town and public transport just isn't enough!
- 1've been a York citizen for 25 years and frankly, this disgusting behaviour makes me ashamed to be. Sort it out.
- 333 I can't access York anymore!
- The pavements are difficult without all the tables and chairs. Residents should take priority over tourists.
- Please stop making it impossible for residents and visitors to shop & visit THEIR city. Not everyone is fit enough to to ride a bicycles. Other historic cities manage to do this without banning blue badges.
- 336 It's a shame you don't look after your own residents.
- This is discrimination of disabled and older people of York. Most of them have lived, worked and shopped in York all their lives and are now not allowed in the city!
- I believe all should have access to part of the city. Visitors should bear able to experience all of the city and even more residents should have access to their own town centre.
- 339 It's discrimination and unfair. Disabled people have their own rights.
- York is already an old city where there are restrictions on some building on how accessible they can be. We get this. But the parking is a whole other issue there are other ways to keep our beautiful city safe without making it inaccessible to people who live here! This can be an amazing place to live for EVERYONE.
- This move is a disgrace! Tarnishes this city's reputation and breaks the 2010 Equality Act due to the false pretext of it being an anti-terrorism measure.
- You should be ashamed and I hope you are.
- 343 Shocking lack of disability access. My grandad and uncle cannot come and visit me in town.
- Having had a disabled husband I know how restricting and frustrating it is to banned fro the city we financially support.

- 345 It's an absolute disgrace that disabled people are treated in this way.
- 346 I feel York is all about tourists now. As a blue badge holder. I find it disgusting.
- One of our children is a blue badge holder due to Duchene Muscular dystrophy a muscle wasting, life limiting condition. We are fortunate to be staying very close to York for a holiday but having to pay for taxis to get as close to the city as we can because of our son's difficulties with walking long distances.
- 348 Goodramgate should be open to disabled people earlier.
- Living where I do with a very limited bus service and severe walking problems this decision has spoilt the few times I tried to get to the theatre or city screen or to go to a special shop.
- A 7pm curfew is heartless and Castlegate impossible unless you come very early. Please reconsider.
- 351 I can't even drive a car, but I agree with this ban being removed.
- 352 Now I struggle to enjoy my home city.
- As a disabled person it's difficult to get into the city centre which means I am isolated from being able to go to the city centre. Please reconsider the decision so me and others can access and park in the city centre.
- 354 Seems like a way to make York less inclusive.
- I find it strange that in a time of such inclusivity, City of York Council should make life so much harder for a group of people who already have additional needs.
- This definitely needs over-turning. What a disgrace to stop blue badge holders going into York this is blatant disability discrimination.
- 357 Please reverse this ban now.
- 358 The ban on blue badge holders in York city centre could be seen at its best as thoughtless and inconsiderate and at its worst as spiteful and vindictive. The council seems to be saying please come and visit York... but not if you are disabled.
- Please come and visit our many welcoming pubs, cafes and restaurants... but not if you are disabled.
- Please come amend spend in our wonderful shops and keep the city centre alive... but not if you are disabled. I not that delivery vans, post office vans and other business related vehicles have permission to drive in the city centre so why not blue badge holders? Surely this small number of people can be accommodated by a council that wishes to promote York as a welcoming city and show that all people matter to York, and that all are welcome.
- 361 Reverse the ban please.
- 362 Parking generally needs a major rethink.
- 363 A very unfair policy but the whole parking situation needs to be carefully considered.
- 364 It's an absolute disgrace that disabled people are treated this way.
- This is discrimination of disabled and older people of York. Most of them have lived worked and shopped in York all their lives and are now not allowed in the city.
- I have worked with disabled people and have disabled friends. I know first hand how hard it is to get around for the person and the carer. Accessibility in York is bad enough as it is without the council making it worse. I think it's a disgrace and discriminates against disabled people. I am sure solutions could be found.
- 367 They should have the right to park in town again.
- 368 Blue badge holders struggle and need help. Anything to help the elderly community.

- 369 It's shameful that York is so unfriendly for disabled. The council should be working to change that image, not make the situation worse.
- I am disabled and have a blue badge. I have great difficulty walking and have to plane my route when in town. For instance if I am going to Coney Street /Ousegate /Coppergate I park near the Castle Museum then when I want to go Goodramgate/Colliergate/Petergate/Stonegate I move the car to Aldwark area If I use my mobility scooter I have problems with pavements as cafes have been allowed to over spill onto the pavement and I can't get off the pavement as there are no drop kerbs for instance in Castlegate. I have written to the council about this and they have said they are looking into these areas. That was last July and still nothing been done. It's easier for me to go to out of town shopping like Vangarde/ designer centre but I need to go to coney street/market street for my bank and building society.
- 371 I urge the Lib Dem-Green Council administration to reverse the ban on blue badge holders entering the city centre. Other cities have addressed security concerns without excluding disabled people and York should do the same. As a Human Rights City, York should not be acting in this way.
- I am a resident, and disabled. I really feel that this rule should be re considered as soon as possible. It would make a massive difference
- 373 I am a blue badge holder and it has very much limited my visit to city centre even with other places to park the side streets were very much needed hopefully they can be reinstated in future.
- I have not been in York centre since first lock down.. I now find shopping on line is better.. I miss being able to sit in a cafe and enjoy a tea or coffee. Resident. (Postcode not supplied)
- 175 I'm 50, disabled & have lived in York most of my life. Now that my health has declined I feel it's cruel to penalise disabled ppl, by removing their right to park within York, just because we have a disability that prevents us from walking far.
- 376 It's ruining this amazing city. Let's change it for the better & make it accessible for all who wish to shop & take in the wonderful sights of York without having to drive miles out of York. Resident. (Postcode not supplied)
- 377 Resident of York for 63 years. We think the parking ban is a disgrace & unfortunately are nearing age & health where it will affect us too. This council simply does not care for its residents disabled and able bodied!!
- 378 I'm a 57 year old severely disabled York resident and find this parking ban has, indeed, impacted on my visiting the City Centre. I will be very interested t to learn how the Council responds.
- 379 My wife has a blue badge we bank with Lloyds branch in Acomb which has closed and transferred us to the city centre which we cannot access. To add insult to injury the badge is now due for renewal at a cost of £10.
- 380 Being Disabled can cause restrictions in our Body and Mind. So being restricted by the Council who run our city is so wrong. You can become Disabled by Illness or Accident. But dictating against us is Wrong.
- Discrimination of the worst kind against someone who was born and raised in the city 73 years ago.
- Disabled people are made to feel very unwelcome in York and like second class citizens.
- How dare you discriminate against disabled people! This goes completely counter to equality, diversity and inclusion! I thought Lib Dems and Greens would be inclusive.

- I think of York as a welcoming and inclusive city, I am so sad and shocked that our Council should behave in this way and exclude a valued part of our community.
- In an age when we are working towards complete equality, diversity and inclusion, it is paramount that York the city of Sanctuary demonstrates its commitment to including disabled people.
- 386 Let my granddaughter back into her city!
- 387 Discrimination!!
- 388 Please change the rules!
- 389 Disgusting, shameful and discriminative.
- 390 I have friends that would greatly benefit from reverse the ban.
- 391 York city centre should be a place for everyone to enjoy.
- 392 The ban has had a really bad effect on disabled people. Its limiting their freedom. I thought there was an Equality Act that makes it illegal to discriminate not provide opportunities the ban breaches this now.
- 393 Think about your own residents! Not Tourists and money!
- I have family members with disabilities which means this ban has a huge negative effect on their lifestyle.
- 395 My disabled daughter and her blue badge who I have to drive is restricted in her daily life and activities by this ban.
- The Blue Badge ban is ableist. Why not work with advocacy groups as Bath Council did, to balance counter-terrorist measures with disabled people's rights to a full life?
- 397 This ban is unacceptably discriminatory and must be reversed.
- 398 It's against disability human rights to deny access to public spaces.
- 399 It feels like I'm being discriminated against for being a wheelchair user. Let me access my city!
- 400 (all from one person) "What else can you take away from disabled people especially disabled children! I had a phone call from CYC last week permanently terminating the transport my disabled 12 year old son receives to take him to his respite he is a full time, personal assisted wheelchair user. Are you saying, because he is disabled, he doesn't have a right to be in the city centre like everyone else? That is ridiculous and you should be very embarrassed and ashamed. I work very hard to ensure my disabled son is included in every aspect of everyday life I recommend you do the same and give disabled people a break they don't need this when life is already tough enough! I live in hope of change!"
- 401 As a person that has mobility issues, it is a nightmare to get into the city and the cost of parking is absurd
- 402 As an elderly disabled person, I depend on friends & taxis to travel cannot use walker safely to need to be taken to outside destination. This restriction on disabled badges is simply discrimination!
- 403 Stop discriminating against disabled people! Do more for your constituency! Be kind!
- I don't fully understand why York prioritises able-bodied people (scooters etc\_. Disgusted. Also need more support for elderly/younger people who are not blue badge holders but need cheaper parking, later buses. I go to Malton & Thirsk rather than York. As easier..... this is tragic.
- 405 My daughter would love to visit York again but is now a blue badge holder and needs an escort.
- 406 This is a short sighted and discriminatory decision by the Council
- 407 Do not discriminate and reverse the ban
- 408 Please reverse the ban as we and other businesses need the trade in York city centre and it makes it harder to get about to shop!

- 409 York is for all residents and tourists and disabled people have as much right to these facilities as any able-bodied person.
- Why make life hard for those who are finding it hard enough to get around, never mind more added restrictions. Shops also need every customer they can get it's hard times.
- 411 Lost a lot of regular customers due to the ban definitely needs to be reversed!
- It has affected business in the city centre. We have missed all the blue badges, they spent money in the city and now this has gone. The shop will go too!
- 413 This is stopping customers shopping in the city centre.
- 414 My friend is a wheelchair user, she can no longer come into town and shop. This is discrimination against disabled people and especially one who has been a resident for a lot of years.
- 415 Discrimination at its finest!!! Disgraceful!!
- Disgraceful. I have a mum and a sister that have blue badges and we need to get into the city. Life is hard enough. Do something about it!
- 417 Make sense!
- 418 How dare you!
- I didn't even know this was a thing. I guess we are all flat-out stupid at some point. Bad move, don't do it.
- 420 Blue badge holders should be able to access shops close to them rather than (streets) being completely pedestrianised.
- Our customers need to be able to park closer to the branch for us to be able to help them with their finances!
- We need to allow people to have the ability to come to the Branch.
- Disability is a protected characteristic, we must ensure their rights and needs are protected!
- 424 Come on York City sort it out, human rights for everybody.
- 425 My brother has a blue badge. This isn't fair. It's discrimination.
- 426 Please lift the ban. Disabled rights please.
- It should be a basic right for disabled people to be able to access the city of York why is this an issue!!
- 428 Having issues with mobility shouldn't make it harder still to access the city's facilities.
- 429 Since the ban we have lost some of our older clients who cannot manage to get into York City Centre so lost sales! This also affects me personally as my mum is in a wheelchair and a Blue Badge holder with breathing difficulties. With her medication she cannot leave the house before 10.20am until it takes effect and since the ban we have been going to Barclays Bank in Haxby which is now closing and she has NO access to Barclays York City Centre!! (city centre dress shop manager)
- 430 Policies that allow Blue Badge holders to access the same amenities as other individuals has to be a positive step for York. I am sure it will also benefit independent stores in the area. (city centre lingerie business owner)
- Closing the roads won't stop people driving, it simply makes places less accessible and adds to the problem of traffic (having to go round places like The Groves of city centre) so adding to pollution. This access is needed to include disabled people who cannot access our city centre!
- 432 My brother, a lifelong York resident is no longer able to visit his own city centre due to this ban.

- 433 This ban is unacceptable.
- 434 Disabled people are not something to be ignored.
- 435 It's totally unacceptable to create further barriers for people with disabilities.
- 436 Everyone should have access to the city centre.
- 437 It's sad that holders of blue badges are treated like this.
- I believe it's vitally important for disabled people to have equal access to the town centre as non-disabled people.
- 439 A discriminatory Council.
- 440 My brother, a lifelong resident, is no longer able to visit his own city centre due to this ban
- 441 All citizens need to be considered, some much more than others.
- 442 Disgrace!!
- 443 Absolutely crackpot idea!!
- 444 This ban is unacceptable. It treats a human right as something to be ignored
- Banning blue badge holders is giving way to terrorists.
- The YCC needs to think carefully about the needs of disabled people in York
- This is restricting life for people whose everyday life is already filled with challenges ablebodied people do not give a second thought.
- 448 This is a disgrace
- 449 Shocking treatment of disabled people
- 450 I'd like the Council to consider whether they would still consider this decision fair if they themselves or their families were disabled and were denied access to the city centre and its facilities
- 451 Needs more parking in city centre. Car park charges are so expensive for residents
- 452 More fairness for disabled people
- 453 This is an act of discrimination against disabled people visitors and residents
- 454 This ban is a complete disgrace. Reverse the decision, effective immediately. Look after your citizens
- 455 This is unfair
- Act 2010. When disabled people cannot enter the city centre is a clear breach of the Equality accessing a whole host of services and facilities that should be available to all. This is obviously discriminatory and the current policy needs to be changed immediately
- 457 The ban is a disgusting violation of basic human rights
- 458 York needs to give every person the equal opportunity to use and enjoy our city
- 459 Typical York!
- 460 It is disgusting behaviour of York Council
- 461 Councillors should visit Stratford-on-Avon and see for themselves disabled parking provision right in the centre
- 462 This is disgraceful!
- 463 It is a disgrace and an affront to basic human rights. No other city has implemented security in such a draconian way that it breaches all semblance of equality and penalises the most vulnerable in our society.
- I work with people who have learning difficulties and I know how distressed they are about this.

- 465 It is totally wrong that people live in a city and cannot go into town, particularly as when they moved or were born here they could and that the council has now chosen to exclude them. There are other ways to make the city secure. This is total discrimination.
- I think that in this day and age YCC would be more inclusive and not discriminatory to people with disability. Is this even legal to exclude people with disability from shopping and enjoying their lives to the full?
- I am a carer for a person in a wheelchair and find it very difficult to visit the city centre.

  This is very discriminating of YCC
- 468 This is terrible. Please listen to disabled people in York.
- I don't think you should stop blue badge holders in the middle of town because Brunswick people need to park where we are close to things
- 470 It is a shame that the York Council are not thinking about <u>all</u> its residents and visitors! Excluding people with disabilities is outrageous!!
- 471 We need some car park[ing]
- 472 Surely to make life easier for everyone, regardless of disability, is good for everybody
- 473 As an 'older resident' I dread getting older and being unable to enter my city
- 474 Please reverse all the crazy policies relating to disabled people the parking issue is a nonsense
- We have a granddaughter who has cerebral palsy, 8 years old, so do we assume that she would be expected to be pushed into York and not allowed to enter the city by car? Such a perverse state of affairs!
- Footpaths is blocked by café tables/chairs/signs forces us to walk on the roads we cannot hear cyclists etc coming up fast behind us, especially speedy 'Deliveroos' & @Just Eat' cyclists riding all over the footpaths too. A cyclist knocked me down and broke my bones.
- 477 Ridiculous! Uncaring! Bizarre! It could be you!
- 478 Have a disabled sister and mother and will struggle to find places near to the centre for them
- 479 Unable to visit town centre due to no streets to park
- 480 My daughter is terminally ill and it is difficult to get disabled parking in a place where she can go to popular shops in the centre
- 481 This <u>must</u> be reversed. Disabled people should be given rights!
- 482 It seems discriminatory to banish disabled people
- 483 Unacceptable to increase barriers to those with blue badges
- Disgusting to ban blue badge holders in the first place. The people that made this decision are obviously not disabled themselves. Selfish
- 485 It is very important for disabled badge holders to have access to our city centre
- 486 This is completely wrong in every regard
- 487 Everyone deserves access
- This seems discriminatory to me. Why would you want to deny disabled people access to the city?
- 489 This ban is discriminatory and disappointing
- 490 As a granddaughter of a disabled grandfather, I feel passionately about reversing the ban.
- 491 Permanently barring Blue Badge holders in the city reduces accessibility for vulnerable groups and encourages discriminatory practices. To avoid this, it is essential to reverse the ban and promote human rights.

- I am a university student. My father has recently become disabled due to a workplace accident which will soon require him to undergo amputation. York has come to be my second home which I love to show off to my family and friends when they visit me. My home town is in Kent which means travelling to visit me is a significant task for a disabled person on its own. It is therefore heartbreaking for me to hear that exclusion will greatly hinder and restrict my ability to show my father this beautiful and historic city that I have come to call home. So much of the culture that made me fall in love with York is found in the city centre which will soon become inaccessible for him. This I wholeheartedly support the reversal of this ban. Covid has already prevented me from sharing this city with my family. Thus after shielding for so long in the hopes that one day they could properly visit, this ban effectively ends the ability for me to share the wonders of the city centre with my family.
- I vote Green because of your commitment to making the world a better place for future generations. This should include people with disabilities!
- I am currently a manager for a care company within York and have witnessed first hand the difficulty my clients are having with the restrictions in place. Many are choosing to not even go into town as it just causes upset and frustration. The city should be open to everyone, not a select few.
- 495 As a Human Rights City, York should **not** be acting this way.
- 496 How are disabled people to access the services and facilities that you take for granted banks, GPs etc
- Having resigned from the Lib Dems last year in protest of the blue badge ban, I continue to be furious that compromise wasn't reached. It is not too late to do the right thing!!
- 498 You smell like mouldy sausages
- 499 You are all useless blood sucking parasites
- I have been unable to bring my sister, 83, into the fun of the town as she cannot walk far
- 501 Surely these people have enough problems
- 502 From a disabled woman
- 503 From a disabled lad
- 504 Why is city of York council acting like this?
- I feel this is discrimination against the disabled. My friend, a blue badge holder, can no longer access her bank!
- 506 York is meant to be a welcoming and humane city please reverse this ban
- 507 Reverse this it's obviously wrong!
- 508 Please reverse the ban to be an accessible city
- 509 It's time this was sorted out!
- 510 Reverse the ban!
- 511 Why would you think this [reversing the ban] is a bad idea?
- 512 I feel that the strict security operation is well over the top for York. Far too "politically correct"
- 513 Making it impossible for blue badge holders to access their city is **NOT** what we want to see!
- We need to use walkers so going round York is difficult as we have to go on the road or up and down the pavements
- We have to use walkers so café tables and chairs mean we have to go up and down pavements or on the road

- In addition you need to end the obstruction of pavements. Patently this is incompatible in the CYC equalities obligations
- 517 Removing blue badges limits individuals with additional mobility requirements from being able to access the city centre. York is a gorgeous place that should be easily accessible to everyone regardless of ability/disability. This is ableist and, quite frankly, embarrassing
- People need to be able to have easy access to the city and bringing their car in makes life better for them
- 519 We should be helping disabled people not hindering them

- I am a support worker regularly needing to assist service users for shopping / appointments/ social engagements in York Centre. This is increasingly difficult. Reversing the ban would assist transportation.
- As a support worker this situation is proving very very difficult for me to pick up and drop off the clients, I support either wheelchair users or those with sight loss.
- 531 Seems like York does not welcome blue badge holders.
- Because of the ban, as a wheelchair user, I am struggling to push my chair because of poor street pavements. Being visually impaired I have fallen out of my chair not been able to see obstacles.
- 533 This is indirect discrimination against disabled people
- 534 This is against the Equality Act 2010
- 535 Café culture is discriminatory, a hazard to everyone, intrusive, taking over the place as though you have a right to, and stops disabled people having access to what they have a right to.
- A ridiculous discriminatory behaviour for the sake of tables usually empty blocking pavement and access. It is a wonder any resident, able-bodied or needing mobility support, ever goes in York city centre. A bloody joke
- Excluding blue badge holders from York city centre is wrong. York is a Human Rights City? I don't think so!
- 538 York is for everyone

- A city that excludes disabled people can never be a home rather, it is an inaccessible monument to ableism
- This is crucial to the well-being and independence of many from out city and for visitors. Those who are differently-abled must be given equal access and equal rights to all citizens. This is, indeed, an equality and human rights issue
- 541 Because of this ban, I am now reliant on a wheelchair to cover long distances to access places in the city centre. Also because I am blind I require the services of someone to push me.
- I am over 60 years old and I volunteer to take a blind person with severe mobility issues into town twice a week. Without these trips he would be confined to his house. Since these restrictive measures were introduced, he has been forced to buy a wheelchair in order to get to these places. Please reverse this ban.
- I am a 30 year old with a chronic lung condition and I am very limited in the distance which I can walk. My quality of life is severely reduced by the lack of access to York city centre, caused by these draconian measures
- It is essential that blue badge holders should have access to York city centre at all times. Delivery drivers and taxis have not been banned so why should blue badge holders be discriminated against
- 545 Elections are coming!
- Not allowing disabled people into York town centre discriminates against our disabilities and human rights. I am unable to use public transport. I have special needs and can become anxious while out, so need to be able to access the car easily

- 124 It is totally wrong that disabled people should be denied the splendour of York
- 125 Ultimately the action discriminates against the people who need such access. And it also affects mental health, capacity and quality of life. Is such action as banning people who need assistance truly a local matter? Terrorist planning will not defeat those who are determined
- 126 It's not, just the parking. Street cafes force people in chairs into the road. State of the paths camber flag stones are all conspiring to make wheelchair users feel very unsafe

I oversee counter terrorism protected security in York district and am a permanent member of the CYC Counter Terrorism Task Group. For some years I have been advising the council and private businesses on Hostile Vehicle Mitigation (HVM) for both the city centre and some outlying venues. HVM is an effective and proven security measure for protecting crowded places such as the centre of York, many examples of HVM can be seen at other large city and town centres throughout the UK. They have been put in place to protect the public from the various terrorist attack methodologies using vehicles. This includes vehicles that contain explosives as well as everyday vehicles that are used to drive into crowded areas (known as Vehicle as Weapon attacks). When considering a vehicle access scheme involving the use of security hardware which mitigates or prevents a vehicle gaining access to the designated protected area, it is necessary to create a sterile zone free from all vehicles at times when the area is a crowded place. Entry to such areas must be restricted to emergency response vehicles which can be done during the planning phase of any such scheme. I am aware that CYC have a well-developed plan to introduce such a vehicle access scheme to the centre of York, it has been subject to consultation and has received advice from the likes of myself as well as my colleagues from CPNI (Centre for the Protection of National Infrastructure) who have advised on other projects nationally. To have an effective scheme in place it would be necessary to exclude all vehicles from access to the sterile area when it is operational ie when it is busy with pedestrians, this unfortunately includes 'blue badge' holders. Terrorists plan attacks meticulously and hold no regard to blue badge holders, they do not follow the everyday rules that you and I would and would see the use of a vehicle displaying a blue badge as an opportunity rather than something that is in place to assist others. I therefore would advocate that any vehicle having 'blue badge' status should be excluded from entry to the vehicle access zone within the city centre during the times when it is operational. I understand that the council is consulting to find alternative parking for such vehicles as close to the city centre as is possible and this hopefully will enable parking for 'blue badge' holders and their vehicles.

Original Annex D November 2021 Executive Report

North Yorkshire Police support for Hostile Vehicle Mitigation (HVM) measures

Thank you for the recent invitation to meet Executive Members which took place on Monday 6th August 2018. Following my attendance, I would like to place on record my support, on behalf of North Yorkshire Police, in relation to the proposed HVM measures planned for the City of York. As I am sure you are aware, the national threat level remains at severe. This means that a terrorist attack is highly likely and any attack is likely to come without notice. Further, there has been a clear shift in attack methodology, from complex pre-planned coordinated attacks such as those seen at the World Trade Center to the more recent attacks on mainland Europe and those in the United Kingdom where attack planning is very basic, including the use of hire vehicles and knives as weapons. Public spaces are currently the most favoured locations because they have ready access to a large number of potential victims. York has very tight streets where there are large crowds of people regularly going about their daily business. Any attack carried out by a vehicle is therefore likely to result in multiple fatalities and many significant injuries. Currently there are no suitable vehicle mitigation measures in York. My colleague, Superintendent Mark Khan, a specialist Security Coordinator, is of the opinion that this is an unacceptable risk for the city to carry. I would echo this view, especially when we, as public authorities, have responsibilities in relation to the European Convention of Human Rights (ECHR). This is particularly relevant when Article 2, The Right to Life, is considered as this article places a positive duty on the state (i.e. public bodies) to protect life. Hostile vehicle mitigation can work in two ways. It can be a visible deterrent and also a physical barrier. I am therefore in full support of the proposed measures and look forward to continuing to support City of York Council as this work moves forward.

Report of the Chief Finance Officer

#### **Budget Setting Overview**

#### **Summary**

1. This report outlines the Council's approach to budget setting and provides an update on some of the current financial challenges.

#### Recommendations

2. Members are asked to note the information in this report

Reason: To keep the Committee informed of any financial issues.

## Finance Update 2022/23

- 3. The gross financial pressures facing the council are projected at c£8m. This is a significant overspend, and a great deal of work is ongoing to identify mitigation and the further actions needed to bring current spending under control. Finance & Performance Monitor 2 is currently being prepared and will be presented to Executive in late November.
- 4. Since the budget was set in February 2022 a number of new financial pressures have emerged. The ongoing cost of living crisis, inflationary pressures and significant increase in energy prices have added c£5m to the overall overspend. The 2022/23 pay award, although not yet confirmed, is expected to cost £2.5m more than was originally estimated.
- 5. The regular finance and performance update reports to Executive identify the various pressures that need to be actively monitored and managed, with mitigating actions agreed and regularly monitored across all directorates. Through ongoing monitoring, identification of mitigation and a review of reserves, the Council will continue to make every effort to reduce this forecast position, but it remains a possibility that it will not be reduced to the point that the outturn will be within the approved budget. The Council has £6.9m of general reserves that would need to be called on if this were the case.

- 6. A number of measures have been introduced to ensure that there are additional expenditure controls in place, particularly around vacancy management and the use of temporary staff. In addition, measures are being introduced to reduce any non-essential expenditure.
- 7. All areas of the Council are currently considering where further efficiencies and reductions in spend can be achieved in order to support the overall financial position.
- 8. Whilst the Council's track record of delivering savings and robust financial management provides a sound platform to continue to be able to deal with these future challenges there remains a significant risk to ongoing service delivery and achievement of Council priorities that needs to be managed effectively.

## **Annual Budget Setting Process**

- 9. The following paragraphs outline the annual budget setting process in terms of the legislative requirements, decision making and outline timetable.
- 10. Every council must have a balanced and robust budget for the forthcoming financial year and also a Medium Term Financial Strategy (MTFS) which projects forward likely income and expenditure over the next 3 years. Due to income constraints and the pressure on service expenditure through increased demand and inflation, projected expenditure is usually higher than projected income.
- 11. Whilst such budget gaps are common in years two and three of the MTFS, the requirement to approve a balanced and robust budget for the immediate forthcoming year means that efforts need to be made to ensure that any budget gap in the next financial year is closed. This is achieved by making proposals to reduce expenditure and/or increase income. Clearly all stakeholders will be concerned with any potential effect that these financial decisions have on service delivery.
- 12. The annual budget report outlines the proposals that will be taken forward and includes an overarching Equalities Impact Assessment that attempts to look at the cumulative impact of the budget. A number of the individual proposals will also require their own assessments and consultation with service users which will be undertaken separately at the appropriate time.
- 13. There is a significant amount of legislation around local authority financial planning and budgeting.

- 14. The Local Government Act 2000 states that it is the responsibility of the full council, on the recommendation of the Executive, to approve the budget and related council tax demand.
- 15. The Local Government Act 2003, section 25 requires the council's Section 151 officer to report to the council on the robustness of the estimates made and the adequacy of the proposed financial reserves assumed in the budget calculations.
- 16. The Local Government Finance Act 1988, section 114 requires the Section 151 officer to report to all of the authority's councillors if there is or is likely to be unlawful expenditure or an unbalanced budget. The council must meet within 21 days to consider the report and during that period the authority is prohibited from entering into new arrangements that will cause money to be spent.
- 17. Failure to set a legal budget may lead to intervention from the Secretary of State under section 15 of the Local Government Act 1999.
- 18. The following paragraphs outline the usual annual budget setting process. Due to the pandemic and ongoing financial uncertainty at a national level, the timings have been slightly different over recent years but the principles remain the same.

### **April to July**

• Estimate revenue income and expenditure over at the next 3 years, updating for previous years outturn position and any other information available.

# July to September

- Identify any new budget pressures
- Calculate forecast budget gap (difference between forecast expenditure and forecast income)
- Chief Officers and Heads of Service start detailed work to identify new efficiencies and savings proposals
- Consider any capital projects needed
- Begin discussions with Executive Members as to the level and type of savings required

#### October to December

Finalise budget proposals with the Executive, including potential impacts and risks

 Review budget in light of spending review and Local Government Provisional Settlement and update budget assumptions for any Govt announcements

#### December

 Executive Member Decision Sessions publish budget proposals and allow for wider discussion with residents and other stakeholders, including local businesses

### <u>February</u>

- Revenue and capital budgets considered by Executive and debated at Full Council. Council Tax is set.
- 19. Once the year starts, actual spending and income will be monitored against the approved budgets with regular reports to Executive highlighting any variations.

## **Summary / Medium Term Financial Outlook**

- 20. Ordinarily, we would be able to use information provided by Government to forecast our funding streams over a 4 year period. Whilst there would sometimes be changes at the draft settlement in December, these would usually be minor adjustments and we could plan with a reasonable amount of certainty.
- 21. However, following the pandemic, cost of living crisis and changes in leadership at a national level there is an unprecedented level of uncertainty in terms of financial planning for local government. Given the reversal of the Health & Social Care Levy it is expected that Adult Social Care reform and the care cap will be deferred by at least one year. It is also assumed that funding for 2023/24 will be another "rollover" year. However, it is also understood that all Government departments have been asked to identify spending cuts for next year and it is likely that this again will have a negative impact on local government funding.
- 22. At the time of writing the UK had just appointed its 3rd Prime Minister of 2022 and its 4th Chancellor of the last 4 months. This inevitably leads to uncertainty and delay. The next budget is due to be announced on the 31 October, which is after the publication of this report. Therefore, any further emerging issues will be reported verbally at the meeting.
- 23. The ongoing inflationary pressures and impact of rising prices on the Council is, of course, a significant concern. There is clearly also a significant impact on the financial health of key providers and partners as well as that of individual residents.

## Scrutiny Review Support Budget 2023/24

#### Summary

- 1. This report sets out the current position in relation to available Council funding for research in support of scrutiny review work.
- Customer and Corporate Services Scrutiny Management Committee (CCSMC) has a constitutional right, under its delegated authority, to consider and recommend to the Executive a budget for scrutiny research. This report seeks to consult Members on any recommendations it may wish to make to the Executive prior to the budget setting process for 2023/24.

# **Background**

- 3. Since February 2011, Scrutiny has been allocated a research support budget for reviews in the sum of £5k per annum. In previous years, that budget has either been shared out across each Scrutiny Committee or retained for use by CCSMC as appropriate.
- 4. In making its recommendations on this budget to Budget Council for the last few financial years, this Committee has debated at some length the merits of potentially asking Council to increase this support budget to enable more outward facing scrutiny to take place. In light of the low spend reported below consistently against this budget, the Council has continued to allocate an annual sum of £5k.
- 5. The impact of the Covid 19 pandemic on scrutiny activity and resources available to support any activity has affected spend and what work has been possible to undertake.

# **Analysis**

6. In this current financial year to date 2022/23, there has been no spend against this budget which, at this stage, again demonstrates a continuing trend and one which is unlikely to change for the remainder of the

financial year given the comparatively small, dedicated resource available to support scrutiny. Members will recall that new working arrangements, to continue some scrutiny activity, were introduced during the pandemic, namely the introduction of informal Scrutiny Forums meeting remotely, with a reduced number of mainline public Committee meetings. In March 2022, Council approved revised Scrutiny Procedural Rules, broadly confirming a pattern of scrutiny meetings and arrangements to reflect the resource available to support to it. Even prior to the pandemic, this Committee had received reports for several years outlining a declining spend on external scrutiny research activity.

- 7. Historically, there has been no spend against this budget since 2016/17, when this Committee allocated the available budget to cover required training costs for newly-appointed Scrutiny Chairs, to reflect new working arrangements which accompanied the amended scrutiny structure at that time. This training also doubled up as refresher training in scrutiny skills and feedback from those Members attending at the time was extremely positive. Total costs for this training amounted to £1,426.40.
- 8. Irrespective of recent changes to scrutiny arrangements, to demonstrate the historical pattern of low spend against this budget for a number of years, the position is as follows:
  - 2010/11 £380
  - 2011/12 £0
  - 2012/13 £1,500 (health workshop facilitation)
  - 2013/14 £0
  - 2014/15 £2,500. Following a decision by this Committee in January 2015, the available budget was again used for scrutiny training purposes i.e.:
    - 3 cross party Members (and 2 officers) travelling to and attending the Annual Centre for Public Scrutiny Studies Conference and Awards;
    - £1k contribution to Leeds City Council to cover the cost of running the regional Joint Health & Overview Scrutiny Committee; and
    - Some travel expenses for a Councillor attending an event in London to gather information for an ongoing scrutiny review; and
    - > 2 Members attending a Pupil Premium Conference

2015/16 - £350 in relation to support costs for the Tour De France Scrutiny Review.

9. Given the use of IT facilities and the internet in recent years as essential research tools, it is noticeable that there has been no need to 'buy in' paid external research in relation to the chosen reviews which have taken place. Significantly, any external research support engaged for scrutiny in the last decade has been at no cost to the Authority, as a result of the willingness on the part of external 'specialists' to engage freely with the Council. Such examples would be the Bootham Park Hospital review completed by the former Health & Adult Social Care Policy & Scrutiny Committee in September 2016 and academic support provided by the University of York and The Joseph Rowntree Foundation on various reviews.

### **Member Training**

- 10. As reported in paragraphs 7 and 8 above, this particular research budget has sometimes been used for specific training on scrutiny, when there has been little or no spend in relation to specific research work.
- 11. There is, however, a specific budget set aside for Member Training.

  Annually, this amounts to £5k and is often supplemented specifically for an induction year of newly elected Members.
- 12. Prior to the start of the pandemic, Scrutiny Chairs and Vice Chairs had planned to discuss the potential for specific scrutiny training for scrutiny members, looking at the possibility of utilising funds from this budget for the specific purpose. However, this Committee has acknowledged that any training for Scrutiny Members would now be best addressed as part of the full induction round following the forthcoming local elections in May 2023.

#### Consultation

13. No consultation was required on this report at this stage, given that it provides this Committee with their constitutional opportunity to consider making a recommendation to Executive for a research support budget for scrutiny.

# **Options**

- 14. Having regard to the analysis section in this report, Members can
  - (i) to note the position and recommend to Executive not to provide any budget specifically to support external research and consultancy work for scrutiny in 2023/24 onwards; or

- (ii) to recommend Executive retains the current budgetary support for external research and consultancy work, explaining why; or
- (iii) to recommend Executive increases the current budgetary support for external scrutiny research/consultancy, explaining why and suggesting an appropriate figure.

#### Council Plan 2019-23

15. Whilst this report does not in itself materially affect how the work of scrutiny can support and develop the Council's overall priorities to set out in the new Council Plan 2019-23, how scrutiny organises itself and undertakes its activities could have a significant impact on how it contributes to the Council's development.

### **Implications**

- 16. Financial There would, of course, continue to be some financial impact should this Committee recommend continuing with a scrutiny research support budget, if the Executive supported that proposal. If funding continues at a comparatively low level as currently provided, then that impact would be minimal in comparison to the potential benefits of receiving any support, if required. However, in times of financial constraint upon all Councils following the pandemic, Members would be prudent to consider the recommendation of any funding most carefully for 2023/24, given the lack of spend over many consecutive years.
- 17. There are no Human Resources, Equalities, Legal, Information Technology, Crime & Disorder or other implications associated with the recommendations in this report. Constitutionally, this Committee has the right to recommend to Executive an appropriate budget to support scrutiny research.

# **Risk Management**

18. Clearly, this Committee needs to address what it believes the current and future needs of scrutiny may be, taking into account the historical levels of spend and any potential impact on improvements to Council performance/services.

#### **Conclusions**

19. It is clear that there has been very little call on this budget spend since 2009/10 and that it has become a continuing trend for the budget not to be

required to be spent on external research or consultancy. Rather in recent years this Committee and other Scrutiny Committees have looked to diversify and seek to use the funds in alternative ways.

- 20. The reasons for this are diverse as referenced in this report. In part it is also due to the topics chosen in recent times and to a decreasing number of those running up to a local election year.
- 21. It is difficult to envisage scrutiny needing to call upon this particular budget in the coming year given the information contained in this report.

#### Recommendations

22. Members are asked to consider what recommendation to make to the Executive in relation to a scrutiny support budget for use on external consultation/market research, for consideration as part of the Council's budget setting process for 2023/24
