## When should I apply for a school place?

If your child is in Year 2 at an infant school, you need to apply for a junior school place by **15 January 2027**. There are 2 junior schools in York, Archbishop of York's CE Junior and Carr Junior. You will be notified of the results of your application from **16 April 2027**.
