Some facts and figures - overall

- **Social care is used by 1.8m people**
- **Employs more than 1.5m people**
- **(More than construction)**
- **Contributes £20bn+ to the economy**
- **(More than electric and gas distribution).**

Some facts and figures – care homes

- **There are almost 20,500 Registered Care Homes, Nursing Homes and Residential Homes in the UK.**
- **More than 200,000 people aged 65+ are in residential care funded by the council or NHS (end 2010)**
- **A further 120,000 people in care homes are self-funded.**

Some facts and figures – care homes in North Yorkshire

- **There are 258 registered care and nursing homes in North Yorkshire**
- **Providing a total of 7,041 beds**
- **Only 15 are run by NYCC**
- **Rest are private or voluntary-sector run**
- **In York 33 care/nursing homes, 1,270 beds – 9 run by City of York Council**





Some facts and figures

The value of the care market in North Yorkshire is around £220m and it employs at least 10,670 people - one of the highest proportions in the country.





Some facts and figures – home care

- **517,000 adults received home care in 2011-12**
- **188m hours (168m independent sector)**
- **Market worth £5.5bn**
- **£2.2bn state purchased**
- **£3.3bn privately-purchased**
- **4,515 registered providers in England in 2012.**

The Francis Report

- **Following on from the Francis inquiry into the Mid Staffordshire NHS Foundation Trust**
- **Asking why up to 1,200 people died due to a lack of care between 2005-2009**
- **Made 290 recommendations**
- **Called for ‘fundamental change’**
- **Only looked at NHS provision**
- **Has far-reaching implications for wide range of care providers**

Values, standards and compliance

- **Francis talks about standards that: “should be defined by what patients and the public want and are entitled to, and what healthcare professionals agree can be delivered.”**
- **any organisation unable consistently to comply should be “prevented from continuing”.**

Values, standards and compliance

- **New Chief Inspector of Social Care**
- **A new Sector Compact on common values is being launched**
- **New CQC and NICE standards**
- **A new Code of Conduct and National Minimum Training Standards of care and support workers**
- **New “values-based” toolkit launched by the NSA**
- **CQC likely to inspect more closely on ‘risk’**

investment in the sector
leading to difficulties staff,
recruitment, training and
retention**

**Information sharing
“Patients, the public,
employers,
commissioners and
regulators need access
to accurate, comparable
and timely information,”
Francis says**





Information sharing

Great strides over recent months – through NHS Choices for example – in care providers being able to make information about their provision and any inspection of those services, public.





Leadership

Francis talks of leaders working under a common code of ethics and conduct, properly trained and held to account, to “increase the public’s confidence in the NHS”.





Leadership

The National Skills Academy for social care is working on leadership in initiatives like its Front-line Leaders Programme and support for Registered Managers.



Challenges

- **Making change in the current climate**
- **Lack of funding for the sector**
- **Commissioners' practices**
- **Low pay and low morale in the sector**
- **Difficulty in recruitment and retention.**
