LICENSING ACT 2003 SUB – COMMITTEES PROCEDURE FOR REMOTE LICENSING HEARINGS

Introduction

- During the coronavirus pandemic emergency period it will be necessary for licensing hearings to be dealt with remotely. This procedure sets out how City of York Council will deal with such hearings. This procedure must be considered in conjunction with the Council's Delivery of Remote Meetings document which sets out how all meetings, including licensing hearings will be held in York.
- The procedure adopted at a licensing hearing is at the discretion of the Sub-Committee but will normally follow the pattern outlined below-
- 3. The Council's hearings procedure is based on regulations made by the Secretary of State under the Licensing Act 2003. The procedure is intended as a general framework to ensure natural justice and a fair hearing. The Sub-Committee has a duty to view all evidence presented before them impartially. The Sub-Committee is not bound by the formal rules of evidence. Nevertheless, Members must carry out their duty placing what weight they feel is appropriate given the nature of the evidence and the manner in which it was obtained, and communicated.
- 4. The Council will provide a record of the hearing in a permanent and intelligible form and keep it for 6 years from the date of determination or disposal of any Appeal. The Hearing will be recorded and the recording placed on the Council's website.

Preparation for the Remote Licensing Hearing

5. The Sub-Committee will use the video-conferencing platform when the hearing is in public session. Clear instructions will be provided to participants on how to join the remote hearing. The Sub-Committee may exclude the public from all or part of a hearing if it considers it is in the public interest to do so. Should any part of the hearing need to be held in private session, a separate private online meeting will be convened by the Sub-Committee. This video-conferencing platform will also be used for decision making in private. All paperwork relevant to the hearing will be published online on the Council's website, 5 working days before the remote hearing. The documents will be produced in PDF format and will be paginated to permit ease of reference during the remote hearing. Name and address details of those making representations will be made public. Telephone numbers, email addresses and signatures will be omitted.

- 6. 5 working days before the remote hearing is due to take place, the Council will contact the parties with a list of issues they would like any party to specifically address them on or clarify at the hearing.
- 7. If in light of the Council's list of issues any party wishes to produce any further documentary evidence they should submit this to the Council by email three working days before the hearing.
- 8. Any documentary evidence that is not submitted to the Council by email three working days before the hearing will not be admitted without the agreement of all parties. If it is essential to a party's case that the material be admitted, then the Sub-Committee will consider adjourning the remote hearing to allow all parties a fair opportunity to consider it.
- 9. Should any party wish to rely on any points of law, specific references in the s.182 Guidance, specific references in the Council's Policy or any other external resources, these should be set down in an electronic document and submitted to the Council by email three working days before the hearing.

The Remote Licensing Hearing

- 10. The Applicant is permitted to speak at the remote hearing (see below). Ward Councillors, responsible Authorities and Representors are only permitted to speak if they have made written submissions during the consultation period. Any party to a hearing may be assisted or represented by any person, legally or otherwise.
- 11. All parties will be given a fair hearing and each party will have the same amount of time in which to address the Sub-Committee and question each other. Each party will have 15 minutes to address the Sub-Committee and call any witnesses and 5 minutes for questions.

- 12. However, where there are groups of individuals with a common interest, for example local residents making similar representations either for or against an application, consideration should be given to nominating a spokesperson. Otherwise the Sub-Committee may impose a time limit for such representations where there is pressure on the Sub-Committee to hear numerous applications in a short period of time or for any other valid reason.
- 13. If any Representors fail to attend the hearing, the Sub-Committee will normally proceed but will consider their written representation. In considering written evidence in the absence of a Representor, appropriate weight will be attached, given that the person cannot be questioned by Members.
- 14. The Sub-Committee is required to disregard any information given or evidence produced by a party or witness which is not relevant to the application, representations, or notice, and the promotion of the licensing objectives. Duplication should be avoided. Comments must be confined to those points already made, although the parties may expand on their written submissions. The Sub-Committee will have read and familiarised themselves with all the written submissions and the issues prior to the hearing, and therefore do not require the points to be made at length.
- 15. A Representor **may not** introduce any new ground or objection not referred to in their written submission. Additional representations which do not amount to an amplification of the original representation will not be considered by the Sub-Committee.
- 16. Any person behaving in a disruptive manner will be asked to leave the hearing. However, if this occurs, that person will be entitled to submit in writing any information they would have been entitled to give orally.

ORDER OF PROCEEDINGS AT THE REMOTE HEARING

Chair's introduction and opening comments

17. The Chair will introduce the Sub-Committee Members and Officers and welcome the Applicant and Representors (or their representatives), and establish the identity of all who will be taking part.

- 18. The Chair will outline the procedure to be followed.
- 19. The Chair will proceed with the order of business on the agenda.

Licensing Manager

20. When the agenda item relating to the application is reached, the Chair will invite the Licensing Officer to present the application. The Chair will invite all present, one by one, to ask the Licensing Officer questions if they wish, to clarify any points raised in the report.

The Application

- 21. The Applicant (and/or their representative) will address the Sub-Committee and present information in support of the application and may call any witnesses to support the application, one witness at a time [maximum 15 minutes].
- 22. The Chair will invite the Representors to ask questions of the Applicant in the following order [maximum 5 minutes each party]:
 - Police;
 - Other Responsible Authorities;
 - Ward Councillors;
 - Public representation
 - Members of the Sub-Committee;
 - The Sub-Committee's legal adviser.

The Representations

- 23. The Chair will invite the Representors and/or their representative in the following order to address the Members of the Sub-Committee and call any witnesses in support of their representation [maximum 15 minutes each party]:
 - Police
 - Other Responsible Authorities
 - Ward Councillors
 - Public representation
 - Members of the Sub-Committee

- 24. The Chair will invite the Applicant and each other party to ask questions of each Representor and/or their witnesses after each presentation [maximum 5 minutes per Representor]. The Chair will invite the Committee Members to ask questions of each Representor (or their representative) and/or their witnesses after each presentation.
- 25. Where there are groups of individuals with a common interest, for example local residents, presentation through an appointed spokesperson is preferred but not mandated.

Summaries

- 26. The Chair will invite the Representors (or their representative) in the following order to summarise their case [maximum 5 minutes each party]
 - Police
 - Other Responsible Authorities
 - Ward Councillors
 - Public representation
- 27. The Chair will invite the Applicant (or their representative) to summarise their case [maximum 5 minutes].
- 28. The Chair will provide the Sub-Committee with a final opportunity to seek clarification from any of the parties on any points raised, or seek advice from the Licensing Officer on policy, or from the Legal Advisor on law and jurisdiction.

Determination

- 29. The Sub-Committee will withdraw to consider their decision with the Legal Adviser and the Democratic Services Officer in a separate private on line meeting. These officers will not comment on the merits of the application, but will be present to provide advice on legal and procedural points and to record the decision.
- 30. If the decision is made following the conclusion of the hearing, the Sub-Committee will return to the public online meeting to announce an outline of the decision to those present. This decision will then be communicated in full in writing, including reasons for the decision, to the Applicant and all Representors (whether in attendance or not)

- usually within 5 working days of the hearing. There can be no further questions or statements.
- 31. If the Sub-Committee does not make a decision on the day of the hearing, the decision will be made within 5 working days beginning with the day or the last day on which the hearing was held. The Democratic Services Officer will inform the parties that they are no longer required and the decision will be communicated in writing to the Applicant and Representors within 5 working days of the decision being made.

The notification will include information about the rights of appeal against the determination made.

Summary

- 1. This report seeks Members determination of an application for the grant of a premises licence, which has been made under the Licensing Act 2003.
- 2. Application reference number: CYC 69217
- Name of applicant: Roxy Leisure Ltd
- 4. Type of authorisation applied for: Grant of Premises Licence
- 5. Summary of application:

The proposal is to allow for the provision of the following activities at 3 St Mary's Square, Coppergate, York being the first floor (entrance at ground floor) of the unit previously occupied by Top Shop within the Coppergate Centre

Background

- 6. A copy of the application can be found at Annex 1, including a plan(s) of the premises.
- 7. The premises is described in the application as bowling alley plus additional gaming with bar facilities.
- 8. An overview of the circumstances in which entertainment activities are not licensable can be found at Annex 2.

Promotion of Licensing Objectives

9. The operating schedule submitted by the applicant shows that the licensing objectives would be met as follows:

10. General

The premises licence will only be operated by Roxy Leisure Limited and will only be able to have licensable activities when trading as a bowling alley/competitive socialising venue with a minimum of 4 bowling Lanes.

11. The Prevention of Crime and Disorder

- a. There will be a communication link via radio to other venues in the city centre. This will be the system recognised by the current Business Crime Reduction Partnership for the City, City of York Council and North Yorkshire Police.
- b. The Licence Holder/Designated Premises Supervisor must participate in a local Pubwatch scheme or licensing association (where one exists), that is recognised by North Yorkshire Police.
- c. A suitable Closed-Circuit Television (CCTV) system will be operational at the premises at all times when licensable activities are being carried out and at any other times where members of the public are present on the premises.
- d. The CCTV system will cover all areas of the premises occupied by the public under the terms of the licence, including corridors and stairways (excluding WCs and changing rooms).
- e. The CCTV system will cover the main entrance/s and exit/s and designated emergency egress routes from the premises.
- f. The CCTV system will contain the correct time and date stamp information.
- g. The CCTV system will have sufficient storage retention capacity for a minimum of 31 days' continuous footage which will be of good quality.
- h. The CCTV footage will be controlled and kept in a secure environment to prevent tampering or unauthorised viewing. A record will be kept of who has accessed the system, the reason why and when.
- A designated member / members of staff at the premises will be authorised to access the CCTV footage and be conversant with operating the CCTV system. At the request of an authorised officer

of the Licensing Authority or a Responsible Authority (under the Licensing Act 2003) any CCTV footage, as requested, will be downloaded immediately or secured to prevent any overwriting. The CCTV footage material will be supplied, on request, to an authorised officer of the Licensing Authority or a Responsible Authority.

- j. The CCTV system will be adequately maintained and be capable of transporting recorded material onto a removable media.
- k. The Premises Licence Holder (PLH)/Designated Premises Supervisor (DPS) will ensure that a 'Daily Record Register' is maintained on the premises by the door staff.
- I. The Daily Record Register will contain consecutively numbered pages, the full name and registration number of each person on duty, the employer of that person and the date and time he/she commenced duty and finished duty (verified by the individual's signature).
- m. The Daily Record Register will be retained on the premises for a period of twelve months from the date of the last entry. Security staff/designated supervisors will be familiar with the premises policy concerning the admission, exclusion and safeguarding of customers whilst in the premises.
- n. The PLH/DPS will ensure that an Incident Report Register is maintained on the premises to record incidents such as anti-social behaviour, admissions refusals and ejections from the premises.
- All instances of crime and disorder will be reported to North Yorkshire Police and will be recorded in an Incident log book.
- p. The Incident Report Register will contain consecutively numbered pages, the date time and location of the incident, details of the nature of the incident, the names and registration numbers of any door staff involved or to whom the incident was reported, the names and personal licence numbers (if any) of any other staff involved or to whom the incident was reported, the names and numbers of any police officers attending, the police incident and / or crime number, names and addresses of any witnesses and confirmation of whether there is CCTV footage of the incident.
- q. The Incident Report Register will be produced for inspection immediately on the request of an authorised officer. There will be a

communication link via radio to other venues in the city centre. This will be the system recognised by the current Business Crime Reduction Partnership for the city, York City Council and North Yorkshire Police.

- r. There will be a minimum of 1 SIA Registered Door Supervisor from 22:00 hours on Fridays, Saturdays and Sundays before Bank Holidays.
- s. The Licensee shall ensure that any persons employed on the premises to work in the capacity as a door supervisor, hold current registration with the SIA and comply with all relevant rules and regulations laid down by that body.
- t. A suitable purpose-made receptacle for the safe retention of illegal substances will be provided and arrangements made for the safe disposal of its contents as agreed with North Yorkshire Police or British Transport Police.

12. Public Safety

- a. Regular safety checks of the premises including decorative and functional fixtures, floor surface and equipment (including electrical appliances) to which the public may come into contact, must be undertaken. Records of these safety checks must be kept and made available for inspection by an authorised officer.
- b. Empty bottles and glasses will be collected regularly paying particular attention to balcony areas and raised levels.
- c. The licensee shall ensure that drinks glasses and any other glass receptacles are prevented from being taken off the premises except for off-sales and their legitimate sale.
- d. Electrical installations will be inspected on a periodic basis (at least every 3 years or at a frequency specified in writing) by a suitably qualified and competent person. If used, any temporary electrical wiring and distributions will also be inspected. Inspection records/certificates will be kept. These will be made available at the request of an authorised officer.
- e. Regular safety checks of guarding to stairs, balconies, landings and ramps will be undertaken, and a supervision policy will be maintained to prevent people from inappropriate behaviour

including climbing which may lead to a fall from height. Safety glass that is impact resistant or shielded to protect it from impact will be used in all areas where the public may come into contact with it.

- f. All floor surfaces will be kept in good condition and free of obstructions to prevent slips, trips and falls.
- g. Members of the public will be prevented from accessing hot food and drink preparation areas to prevent risks of scalds and burns to them.
- h. Where strobes, lasers, smoke machines and other special effects equipment may be used, a written health and safety policy covering all aspects of their use will be provided, and staff will be appropriately trained.

13. The Prevention of Public Nuisance

- a. Queues shall be restricted to cordoned areas to prevent them obstructing footpaths and spilling out onto roads, and to keep noise and obstructions away from residential property. Staff shall be trained to intercept and manage any incidents and sufficient staff shall be employed to properly manage queues to prevent noise and aggression.
- b. The Licensee shall ensure that no nuisance is caused by noise or vibration from the licensed premises resulting from the use of this licence.

14. The Protection of Children from Harm

- a. The premises must operate the Challenge 25 proof of age scheme in accordance with guidance issued by North Yorkshire Police.
- b. Children will be required to be supervised by an accompanying adult at all times.

Special Policy Consideration

15. This premises is located within the cumulative impact assessment area which was approved by full council on 21 March 2019. The assessment can be found at Annex 3. Section 9 of the Statement of Licensing Policy which deals with Cumulative Impact can be found at Annex 4.

Consultation

- 16. Consultation was carried out by the applicant in accordance with s13, and s17 (5) of the Act and Regulation 42, Parts 2 and 4 of the Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005, which concern the displaying of a notice on the premises and an advertisement in a local paper giving details of the application and serving a copy of the application on all responsible authorities. The applicant complied with all statutory requirements. In addition the relevant ward councillors and/or parish council were notified by way of register.
- 17. All procedural aspects of this application have been complied with.

Summary of Representations made by Responsible Authorities

18. North Yorkshire Police made representation on the prevention of crime and disorder, however they have mediated with the applicant who has agreed to amend the hours as follows:

All licensable activities-Sunday 1000 - 2230 with an extra hour on Bank Holidays Monday to Thursday 1000 - 2300 Fri and Sat 1000 - 0000

Non-standard timings have been removed with the exception of the 1 hour listed above for Sundays preceding Bank Holidays.

Therefore North Yorkshire Police have withdrawn their representation.

Summary of Representations made by Other Parties

- There have been 7 relevant representations received from other persons. The list of representors is attached at Annex 5.
- 20. The representations are predominantly based on the grounds of the Prevention of Public Nuisance and Prevention of Crime and Disorder objectives. They state that these objectives will be undermined if the application is granted.
- 21. A copy of all the representations are attached at Annex 6.

- 22. A map showing the general area around the venue is attached at Annex 7.
- 23. The mandatory conditions that will be attached to this licence if granted can be found at Annex 8. The Legislation and Policy considerations can be found at Annex 9.

Options

- 24. By virtue of s18(4) of the Act, the Committee have the following options available to them in making their decision: -
- 25. Option 1: Grant the licence in the terms applied for.
- 26. Option 2: Grant the licence with modified/additional conditions imposed by the licensing committee.
- Option 3: Grant the licence to exclude any of the licensable activities to which the application relates and modify/add conditions accordingly.
- 28. Option 4: Refuse to specify a person on the licence as premises supervisor.
- 29. Option 5: Reject the application.

Analysis

- 30. The following could be the result of any decision made this Sub Committee:-
- 31. Option 1: This decision could be appealed at Magistrates Court by any of the representors.
- 32. Option 2: This decision could be appealed at Magistrates Court by the applicant or any of the representors.
- 33. Option 3: This decision could be appealed at Magistrates Court by the applicant or any of the representors.
- 34. Option 4: This decision could be appealed at Magistrates Court by the applicant.
- Option 5: This decision could be appealed at Magistrates Court by the applicant.

Council Plan

- 36. The Licensing Act 2003 has four objectives the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm.
- 37. By taking the statutory requirements of the Licensing Act into consideration, as well as the four licensing objectives when determining licensing applications the Council are supporting the new and existing licence trade, as well as local residents and businesses. The functions support the Council's Plan of safe communities and culture for all, and a good quality of life for everyone.

- 3. A suitable Closed-Circuit Television (CCTV) system will be operational at the premises at all times when licensable activities are being carried out and at any other times where members of the public are present on the premises.
- 4. The CCTV system will cover all areas of the premises occupied by the public under the terms of the licence, including corridors and stairways (excluding WCs and changing rooms).
- 5. The CCTV system will cover the main entrance/s and exit/s and designated emergency egress routes from the premises.
- 6. The CCTV system will contain the correct time and date stamp information.
- 7. The CCTV system will have sufficient storage retention capacity for a minimum of 31 days' continuous footage which will be of good quality.
- 8. The CCTV footage will be controlled and kept in a secure environment to prevent tampering or unauthorised viewing. A record will be kept of who has accessed the system, the reason why and when.
- 9. A designated member / members of staff at the premises will be authorised to access the CCTV footage and be conversant with operating the CCTV system. At the request of an authorised officer of the Licensing Authority or a Responsible Authority (under the Licensing Act 2003) any CCTV footage, as requested, will be downloaded immediately or secured to prevent any overwriting. The CCTV footage material will be supplied, on request, to an authorised officer of the Licensing Authority or a Responsible Authority.
- 10. The CCTV system will be adequately maintained and be capable of transporting recorded material onto a removable media.
- 11. The Premises Licence Holder (PLH)/Designated Premises Supervisor (DPS) will ensure that a 'Daily Record Register' is maintained on the premises by the door staff.
- 12. The Daily Record Register will contain consecutively numbered pages, the full name and registration number of each person on duty, the employer of that person and the date and time he/she commenced duty and finished duty (verified by the individual's signature).
- 13. The Daily Record Register will be retained on the premises for a period of twelve months from the date of the last entry. Security staff/designated supervisors will be familiar with the premises policy concerning the admission, exclusion and safeguarding of customers whilst in the premises.
- 14. The PLH/DPS will ensure that an Incident Report Register is maintained on the premises to record incidents such as antisocial behaviour, admissions refusals and ejections from the premises.
- 15. All instances of crime and disorder will be reported to North Yorkshire Police and will be recorded in an Incident log book.
- 16. The Incident Report Register will contain consecutively numbered pages, the date time and location of the incident, details of the nature of the incident, the names and registration numbers of any door staff involved or to whom the incident was reported, the names and personal licence numbers (if any) of any other staff involved or to whom the incident was reported, the names and numbers of any police officers attending, the police incident and / or crime number, names and addresses of any witnesses and confirmation of whether there is CCTV footage of the incident.
- 17. The Incident Report Register will be produced for inspection immediately on the request of an authorised officer. There will be a communication link via radio to other venues in the city centre. This will be the system recognised by the current Business Crime Reduction Partnership for the city, York City Council and North Yorkshire Police.
- 18. There will be a minimum of 1 SIA Registered Door Supervisor from 22:00 hours on Fridays, Saturdays and Sundays before Bank Holidays.
- 19. The Licensee shall ensure that any persons employed on the premises to work in the capacity as a door supervisor, hold

current registration with the SIA and comply with all relevant rules and regulations laid down by that body.

20. A suitable purpose-made receptacle for the safe retention of illegal substances will be provided and arrangements made for the safe disposal of its contents as agreed with North Yorkshire Police or British Transport Police.

c) Public safety

- 21. Regular safety checks of the premises including decorative and functional fixtures, floor surface and equipment (including electrical appliances) to which the public may come into contact, must be undertaken. Records of these safety checks must be kept and made available for inspection by an authorised officer.
- 22. Empty bottles and glasses will be collected regularly paying particular attention to balcony areas and raised levels.
- 23. The licensee shall ensure that drinks glasses and any other glass receptacles are prevented from being taken off the premises accepting off-sales and their legitimate sale.
- 24. Electrical installations will be inspected on a periodic basis (at least every 3 years or at a frequency specified in writing) by a suitably qualified and competent person. If used, any temporary electrical wiring and distributions will also be inspected. Inspection records/certificates will be kept. These will be made available at the request of an authorised officer.
- 25. Regular safety checks of guarding to stairs, balconies, landings and ramps will be undertaken, and a supervision policy will be maintained to prevent people from inappropriate behaviour including climbing which may lead to a fall from height. Safety glass that is impact resistant or shielded to protect it from impact will be used in all areas where the public may come into contact with it.
- 26. All floor surfaces will be kept in good condition and free of obstructions to prevent slips, trips and falls.
- 27. Members of the public will be prevented from accessing hot food and drink preparation areas to prevent risks of scalds and burns to them.
- 28. Where strobes, lasers, smoke machines and other special effects equipment may be used, a written health and safety policy covering all aspects of their use will be provided, and staff will be appropriately trained.
- d) The prevention of public nuisance
- 30. Queues shall be restricted to cordoned areas to prevent them obstructing footpaths and spilling out onto roads, and to keep noise and obstructions away from residential property. Staff shall be trained to intercept and manage any incidents and sufficient staff shall be employed to properly manage queues to prevent noise and aggression.
- 31. The Licensee shall ensure that no nuisance is caused by noise or vibration from the licensed premises resulting from the use of this licence.
- e) The protection of children from harm
- 32. The premises must operate the Challenge 25 proof of age scheme in accordance with guidance issued by North Yorkshire Police.
- 33. Children will be required to be supervised by an accompanying adult at all times.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national
 of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an
 official document giving the person's permanent National Insurance number and their name issued by a
 Government agency or a previous employer.

- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to
 work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a
 licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office under regulation 18(3) or 20(2)
 of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a
 European Economic Area state or Switzerland but who is a family member of such a national or who has
 derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
 with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
 reasonable evidence that the person has an appeal or administrative review pending on an immigration
 decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
 who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
 the UK including:-
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one
 of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at https://www.gov.uk/prove-right-to-work) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. 



Annex 2

Home Office – Guidance Issued Under Section 182 of the Licensing Act 2003

Section 16 Regulated Entertainment

Overview of circumstances in which entertainment activities are not licensable

- 16.5 There are a number of exemptions that mean that a licence (or other authorisation18) under the 2003 Act is not required. This Guidance cannot give examples of every eventuality or possible entertainment activity that is not licensable. However, the following activities are examples of entertainment which are not licensable:
 - activities which involve participation as acts of worship in a religious context;
 - · activities in places of public religious worship;
 - education teaching students to perform music or to dance;
 - the demonstration of a product for example, a guitar in a music shop;
 - the rehearsal of a play or performance of music for a private audience where no charge is made with a view to making a profit;
 - Morris dancing (or similar)
 - Incidental music the performance of live music or the playing of recorded music if it is incidental to some other activity;
 - Incidental film an exhibition of moving pictures if it is incidental to some other activity;
 - A spontaneous performance of music, singing or dancing;
 - Garden fetes or similar if not being promoted or held for purposes of private gain:
 - Films for advertisement, information, education or in museums or art galleries;
 - Television or radio broadcasts as long as the programme is live and simultaneous;
 - Vehicles in motion at a time when the vehicle is not permanently or temporarily parked;
 - Games played in pubs, youth clubs etc. (e.g. pool, darts and table tennis);
 - Stand-up comedy; and
 - Provision of entertainment facilities (e.g. dance floors).
- 16.6 As a result of deregulatory changes that have amended the 2003 Act, no licence is required for the following activities:
 - Plays: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500.
 - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the

- audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for an event between 08.00 and 23.00 on any day, provided that those present do not exceed 1000.
- Boxing or wrestling entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace26 that does not have a licence, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non- residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;

- any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
- any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
- any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
- 16.7 The deregulatory changes mean that, for example, an indoor sporting event that takes place between 07.00 and 23.30 on a particular day is licensable in respect of activities taking place between 07.00-08.00 and 23.00-23.30. Similarly, where the audience for a performance of dance fluctuates, those activities are licensable if, and for so long as, the number of people in the audience exceeds 500. If organisers are uncertain as to audience sizes or if audience migration is likely, it might be easier and more flexible to secure an appropriate authorisation. Examples of where a Temporary Event Notice (TEN) could still be required include if the activity is the playing of recorded music or the exhibition of a film that requires an authorisation; or if the entertainment is not authorised by an existing licence or certificate and its conditions.
- 16.8 Of course, anyone involved in the organisation or provision of entertainment activities whether or not any such activity is licensable under the 2003 Act must comply with any applicable duties that may be imposed by other legislation relevant to the event (e.g. in areas such as crime and disorder, fire, health and safety, noise, nuisance and planning). Any such person should take steps to be aware of relevant best practice, and may find responsible authorities a useful source of expert support and advice.



ANNEX 3

Cumulative Impact

- 1. Cumulative impact has been included within the Section 182 guidance issued by the Home Office since the commencement of the Act. Cumulative impact assessments were introduced at Section 5A of the Act by the Police and Crime Act 2017, with effect from 6 April 2018. This provides provision for licensing authorities to publish a document, cumulative impact assessment, stating that the licensing authority considers that a number of relevant authorisations in respect of premises in one or more parts of its area, described in the assessment, is such that it is likely that it would be inconsistent with the authority's duty under the Act to grant any further relevant authorisations in respect of premises in that part or those parts.
- 2. Relevant authorisations means:
 - premises licence
 - club premises certificate
- 3. Cumulative impact is the potential impact on the promotion of the licensing objectives of a significant number of licensed premises concentrated in one area.
- 4. The Council has included a Cumulative Impact Policy within its Statement of Licensing Policy since 2005, in relation to an area within York city centre. Due to the changes within the city centre, mainly the locations where licensed premises are predominately operating, this area has increased over the years.

Cumulative Impact Assessment

- 5. As required by the Act the Council has reviewed the cumulative impact area following the receipt of evidence provided by North Yorkshire Police and the Councils Public Protection Service (noise). The Council has published its first cumulative impact assessment (assessment) in relation to an area that has been identified in York city centre. The assessment is available on the Council website or from the Licensing Section. The assessment will be reviewed at least every three years as required by the Act. A map showing the area can be found in the assessment.
- 6. As required by the Act the Council has formally consulted on the assessment.
- 7. By publishing the assessment the Council is setting down a strong statement of intent about its approach to considering applications for grant and variation of premises licences or club premises certificates in the area described. The Council must have regard to the assessment when determining or revising this Statement of Licensing Policy. The assessment does not change the fundamental way that a licensing decision is made, each application will be considered on its own merits. It is open for the Council to grant an application where it is considered appropriate and where the applicant can demonstrate in the operating schedule that they would not be adding to the cumulative impact. Applications in the area covered by the assessment should therefore give consideration to potential cumulative impact issues when setting out the steps that will be taken to promote the licensing objectives. Where relevant representations are received and the Council determines to grant an application reasons for granting the application will be given to the applicant, the Chief Officer of

- Police and all parties who made a relevant representation, with the reasons for departing from the Policy.
- 8. Where no relevant representations are received an application within the cumulative impact area will be granted in terms consistent with the operating schedule.
- 9. Applications for new premises licences or variations for premises situated within the cumulative impact area that are likely to add to the cumulative impact already experienced will normally be refused if relevant representations are received. The applicant must demonstrate through the operating schedule, the steps that they intend to take so that the Council and responsible authorities can be satisfied that granting a new or varied licence will not add to the cumulative impact already being experienced.
- 10. The onus is on the applicant to demonstrate to the responsible authorities the suitability of how their proposal will not add to the cumulative impact. To assist this process the Council recommends early consultation with responsible authorities; this can be done directly with those authorities or through the Council's Licensing Section.
- 11. The Statement of Licensing Policy and Cumulative Impact Assessment were approved by the City of York on the 21 March 2019.

9. Cumulative Impact

- 9.1 Cumulative impact has been included within the Section 182 guidance issued by the Home Office since the commencement of the Act. Cumulative impact assessments were introduced at Section 5A of the Act by the Police and Crime Act 2017, with effect from 6 April 2018. This provides provision for licensing authorities to publish a document, cumulative impact assessment, stating that the licensing authority considers that a number of relevant authorisations in respect of premises in one or more parts of its area, described in the assessment, is such that it is likely that it would be inconsistent with the authority's duty under the Act to grant any further relevant authorisations in respect of premises in that part or those parts.
- 9.2 Relevant authorisations means:
 - premises licence
 - club premises certificate
- 9.3 Cumulative impact is the potential impact on the promotion of the licensing objectives of a significant number of licensed premises concentrated in one area.
- 9.4 The Council has included a Cumulative Impact Policy within its Statement of Licensing Policy since 2005, in relation to an area within York city centre. Due to the changes within the city centre, mainly the locations where licensed premises are predominately operating, this area has increased over the years.

Cumulative Impact Assessment

- 9.5 As required by the Act the Council has reviewed the cumulative impact area following the receipt of evidence provided by North Yorkshire Police and the Councils Public Protection Service (noise). The Council has published its first cumulative impact assessment (assessment) in relation to an area that has been identified in York city centre. The assessment is available on the Council website or from the Licensing Section. The assessment will be reviewed at least every three years as required by the Act. A map showing the area can be found in the assessment.
- 9.6 As required by the Act the Council has formally consulted on the assessment.
- 9.7 By publishing the assessment the Council is setting down a strong statement of intent about its approach to considering applications for grant and variation of premises licences or club premises certificates in the area described. The Council must have regard to the assessment when determining or revising this Statement of Licensing Policy. The assessment does not change the fundamental way that a licensing decision is made, each application will be considered on its own merits. It is open for the Council to grant an application where it is considered appropriate and where the applicant can demonstrate in the operating schedule that they would not be adding to the cumulative impact. Applications in the area covered by the assessment should therefore give consideration to potential cumulative impact issues when setting out the steps that will be taken to promote the licensing objectives. Where relevant representations are received and the Council

- determines to grant an application reasons for granting the application will be given to the applicant, the Chief Officer of Police and all parties who made a relevant representation, with the reasons for departing from the Policy.
- 9.8 Where no relevant representations are received an application within the cumulative impact area will be granted in terms consistent with the operating schedule.
- 9.9 Applications for new premises licences or variations for premises situated within the cumulative impact area that are likely to add to the cumulative impact already experienced will normally be refused if relevant representations are received. I refer to the application made by Roxy Leisure Limited for the grant of a Premises Licence in respect of premises to be known as Roxy Lanes, 3, St Mary's Square, Coppergate, York YO1 9NY.

I wish to object against this application.

I live across from the premises in question. My bedroom and lounge both facing onto the square directly opposite to the St Mary's Square entrance into the property.

The grounds for my objection are as follows:-

Prevention of crime and disorder

I believe this licence application will make an adverse contribution to the levels of crime and disorder when you take into account that:-

- No other business in the Coppergate Centre is allowed to stay open longer than 6.30pm (apart from the Christmas late night opening on Thursdays).
- This is supposed to be a family-friendly business but if the sale of alcohol 10.00am to midnight and late light refreshment 11.00pm to 12.30am are allowed I can see that this will lead to an increase in drunken behaviour including physical violence and vandalism.

Prevention of public nuisance

Noise nuisance

Films and music to played 10.00am till midnight – what steps are to be taken to limit noise escape from the premises? If doors and windows are to be kept closed will this lead to problems with ventilation thereby requiring the installation of new ventilation systems which in themselves will cause excessive noise nuisance which I have found to my cost has happened at Fenwicks and Café 21 that are next door to the premises at 3, St Mary's Square.

Queues to enter the premises - if on Piccadilly they will no doubt interfere with customers using the bus stops. If in St Mary,s Square then there will no doubt be excessive noise from the queue when all other businesses have closed.

Patrons exiting the premises, especially into St Mary's Square, will no doubt make excessive noise especially after the consumption of alcohol.

Litter

There will no doubt be excessive discarded litter from patrons exiting the premises due to the sale of late light refreshment (takeaway?). In St Mary's Square the litter bins available are always full at the end of the day when businesses usually close ie 6.30pm therefore any litter after this time will no doubt be left on the floor. On Piccadilly there are not many litter bins available for takeaway wrappings to be disposed of so again the litter will probably be just left on the floor.

I trust that my objections will be taken into account when the above premises licence application is considered.

Dear Sir/Madam,

As a resident at Merchants Place, living in a flat facing Piccadilly, I am concerned about the impact that the operation of the proposed licensed venue at 3 St Marys Square, Coppergate (as filed by Roxy Leisure Ltd on 18 August 2021) may have on the neighbouring area.

The venue, formerly occupied by Topshop, was originally designed as a retail building, and it therefore lacks essential soundproofing on its windows and doors. As a consequence, even the standard operation of a venue that is open until 00:30 is likely to have significant sound pollution towards buildings on Piccadilly.

One of the current entrances to the venue is from Piccadilly; if this was used by the applicant, it would likely create a lot of nuisance in the neighbourhood (eg. noise of people entering and leaving, music and noise coming out while doors are open, and general antisocial behaviour expected from a venue that serves alcohol until late night).

The covered walkway by the side of Coppergate Centre (by River Foss) is already a problem area that sees people drinking, loitering and urinating; the proposed new venue with late night opening hours and serving alcohol until later than most other establishments in the area is likely to add to these problems.

Therefore, I call the Council to reject the license application.

Should a license be granted, I would like the following conditions to be added to it:

- The doors to Piccadilly not to be in use for the general public entering/leaving the venue;
- Any music license to only be granted subject to sufficient soundproofing and frequent monitoring;
- No outside service areas to be installed on Piccadilly.

To add to the above, I strongly feel that granding this license would generally encourage antisocial behaviour and would be very much against the direction that the ongoing rehabilitation of the Piccadilly area is taking.

I own a property in the adjacent Piccadilly Lofts and my concerns/recommendations about the additional customer noise and traffic are as follows:

Reduced closing hours, eg 10pm latest at least. If you say you are catering for the family market, you don't need to be open until 12.30am.

Access/egress via St Marys Square - NOT Piccadilly.

Smoking area in St Marys Square - once again, NOT Piccadilly.

The above two points are especially important as the river walk from Piccadilly along the Foss has a long unguarded section which is a trap for the unwary. Ben Clarkson drowned there only a few years ago..

We already have to put up with homeless making a noise in the recessed seating areas along the river walk between Piccadilly and the Castle Car Park, and yet more late night disturbance and noise would occur.

To discourage large and noisy single sex groups eg stags/hens etc there should be permanent door supervision after 7pm; all day Sat/Sun; and Bank Holidays.

Noise monitoring from various points along Piccadilly including Piccadilly Lofts, the FR Stubbs building and the Merchant Adventurers Hall.

Sufficient soundproofing to include boarded windows and passageways. No sound may escape the building, including extraction fans etc. Air conditioning units may not be mounted or be visible/audible in Piccadilly.

All entry and exit points to be supervised and remain closed during service; with lobbies to minimise sound leakage. Especially the fire exits on Piccadilly.

The manager, or duty manager, to be contactable at all times during service by mobile phone. Noise or nuisance complaints must not have to be dealt with in person ie going to the front door and negotiating with a doorman/cashier/receptionist to find who is in charge. It is reasonable to assume that a complainant may not be able to go to the venue themselves because, for example, they are ill or incapacitated, in charge of children, or just plain frightened to go out in the city centre at night.

Wall-mounted cigarette bins to be provided and Piccadilly to be swept and tidied after service.

No outside service areas or tables (cafe bar licence) on Piccadilly.

Spark and the Red Lion are well supervised and I hope you see fit to impose these measures on the bowling alley to keep the area as ordered, clean and tidy as possible

I believe that the location and target demographic of this operation will increase noise, nuisance and disorder in Piccadilly. The company states they are targeting the family market but the proposed closing time of 12.30am clearly does not chime with that, indeed with beer pong (families?), pool (families?) and bars (again, families?) it is obviously aiming for the older market of weekend stags/hens and large single sex groups during the week.

Anybody on Micklegate or Ouse Bridge on a weekend night can tell you how threatening the atmosphere is. This is precisely the crowd that will gravitate to Piccadilly.

I would define public nuisance as litter, urinating in the street, loud singing and shouting, fighting, and normal people feeling intimidated in the area - aren't the police stretched enough? Piccadilly is in the process of building large upmarket hotels and apartments (of which I own one right next to this development) - not a good look for York and the families/tourists that would be making their way back to their accommodation. My property, and many others, will also be seriously affected if this is allowed to go ahead until after midnight.

As a landlord owning one of the flats in Merchants Place facing Piccadilly, I am concerned about the impact that the operation of the proposed licensed venue at 3 St Marys Square, Coppergate (as filed by Roxy Leisure Ltd on 18 August 2021) may have on the neighbouring area.

The venue was designed as a retail building, and therefore likely to lack essential soundproofing. As a result of the proposed venues opening hours (until 00:30 daily), it is likely to result in significant noise pollution on Piccadilly 7 days per week.

As there are bus stops outside the Piccadilly entrances to this building, it may encourage crowds to gather in this area, & potentially result in antisocial behaviour due to the proposed venue serving alcohol until late night. In addition, the entrance to the Coppergate Centre (by the River Foss) is already a problem area due to the antisocial behaviour of a small number of individuals. As I'm sure you're aware, there has been 21 river fatalities in York in the last five years. Allowing access to the proposed venue by this route, & serving alcohol until late, is likely to add to such problems.

Therefore, I call on the Council to reject the applications, both for the venue, & for its license application. I believe the two existing bowling alleys in York are enough, & that the locations of these existing facilities are more suited to such a venue, as they aren't surrounded by residential buildings.

Should this facility & its license be granted, I would like the following conditions to be applied:

- Entry/ exit only via St Marys Square, & not via Piccadilly or the River Foss entrance;
- Reduced opening hours, until 22:00 at the latest;
- Any music license to be granted subject to sufficient soundproofing and frequent noise monitoring for adjacent residential areas;
- Continual supervision by trained staff, & restrictions on the size of groups admitted.

(within the Coppergate Centre) wish to register my objections to the proposed licensing application submitted by Roxy Leisure Ltd in respect of premises to be known as ROXY LANES.

These concern:

- 1) PUBLIC NUISANCE
- 2) PREVENTION OF CRIME AND DISORDER

The premises, No.3. St, Mary's Square is situated within the compact Residential & Retail Coppergate Shopping Centre. A Pedestrian Zone.

There are approximately 19 retail units operating between the hours of 9am and 6.30pm and 19 residential properties. 10 in St. George's House, situated on two floors above shops in and around the square and 9 above retail outlets along Coppergate Walk.

All in close proximity to Roxy's proposed Entertainment Venue. (4 in St.Georges House directly fronting onto 'Premise No.3, are a mere 30 metre distance away and there are 6 others which face St. Mary's Church directly across one of the 3 pedestrian routes to enter & exit the square, from and to Castlegate. My own flat windows, front & rear are located at a distance between 38 and 43 metres away and those of the Residential properties above the shops along Coppergate Walk, another pedestrian route leading into & out of the square are situated at a maximum of 70metres away.

Once the commercial premises close early evening, (18.30) the Coppergate Centre is solely Residential.

Roxy Leisure states on its LINKEDIN page, that it is 'Leading the way for a customer first business, with customer first experience. (What about consideration for neighbouring Residents)?? This, all done with 'BOOZE & BALL GAMES'!

10 pin bowling, beer ping-pong, arcade games, etc. beer and cocktails, plus showing of films and recorded music to be played, provision of late night refreshment and the venue to be open until 00.30, 7 days a week!! This is NOT a quiet venture suitable for a Residential zone.

10 pin bowling is in itself a noisy activity. What soundproofing is proposed? Also, if extra air conditioning were to be required, I trust there would be no plan to vent it into the Square as that would cause further noise pollution for the Residents & we already suffer with enough of that from Fenwick's ventilation fans.

A venue such as this, so close to Residential properties is not acceptable and will I believe, have a detrimental impact on all Residents who will without doubt be disturbed both during the evening and late into the night by revellers weaving noisily past their properties. Most possibly leading to sleep depravation & mental health issues due to unruly, anti-social behaviour, aggression, shouting, swearing etc. as people wend their way into or out of the venue.

There will no doubt be those, who vomit & others who will urinate around the walls of St. Mary's Church and litter will be scattered. It is extremely sad to say, but these are unfortunately, all behaviours that occur when alcohol is imbibed to excess and for extended periods.

Within St. Mary's Square, there are concrete blocks and a ready-made low seating area surrounding Astroturf positioned directly outside the entrance/exit of the venue, directly below 4 of the flats bedroom windows & not far from the others opposite St. Mary's church, where revellers in an inebriated state may be inclined to gather, fool around and socialise loudly, not wishing for the nights entertainment to end. All noise reverberates loudly around the square.

The potential for mischief and vandalism is great, with plate-glass windows & glass overhangs surrounding the predominantly enclosed square, hanging baskets to play with or destroy and 3 food wagons to tamper with, not to mention Cafe 21.

There is also a small, unlit yard off Castle Walk, another of the 3 routes out of the square, behind both Fairfax House and the Flying Tiger shop & below the rear balcony of St. George's House, which frequently has piles of collapsed cardboard packing cases and wooden pallets from the shop piled up ready for collection, positioned close by the door of the gas & electric stop cock & meter room belonging to the above mentioned St.George's House. A perfect place for anyone loitering in that area, having exited the venue to cause mayhem if so inclined, by throwing a lighted cigarette or firework onto this rubbish through the wrought iron railing.

I hope that all concerned will take serious notice of my objections/comments and the reasons for them and I urge the licensing committee to reject this licensing application.



MANDATORY & PROHIBITED CONDITIONS – PREMISES LICENCE LICENSING ACT 2003

MANDATORY CONDITIONS WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

- 1. In accordance with section 19 of the Licensing Act 2003, where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- 2. The first condition is that no supply of alcohol may be made under the premises licence -
 - (a) at a time where there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 3. The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
 - (a) games or other activities which require or encourage, or are designed to require or encourage individuals to
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner:
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 7. The responsible person must ensure that
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
 - (iii) still wine in a glass: 125ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

MANDATORY CONDITION: ALCOHOL PRICING

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979(6);
 - (b) "permitted price" is the price found by applying the formula –

 $P = D + (D \times V)$

where -

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994(7).
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

MANDATORY CONDITION: DOOR SUPERVISION

- 1. In accordance with section 21 of the Licensing Act 2003 (as amended by section 25 Violent Crime Reduction Act 2006), where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must -
 - (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
 - (b) be entitled to carry out that activity by virtue of section 4 of that Act.
- 2. But nothing in subsection (1) requires such a condition to be imposed -
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to -
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence, or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- 3. For the purposes of this section -
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and which is licensable conduct for the purposes of that Act (see section 3(2) of that Act), and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

MANDATORY CONDITION: EXHIBITION OF FILMS

- 1. In accordance with section 20 of the Licensing Act 2003, where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- 2. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
- 3. Where -
 - (a) the film classification body is not specified in the licence, or
 - (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- 4. In this section 'children' means persons aged under 18; and 'film classification body' means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).



Legislation and Policy Considerations

- The following provisions of The Licensing Act 2003 apply to this application: S4 general duties of licensing authorities; s17 application for premises licence; s18 determination of application for premises licence; s23 grant or rejection of application; ss19, 20 and 21 mandatory conditions; The Licensing Act (Mandatory Licensing Conditions) Order 2010; and The Licensing Act 2003 (Mandatory Conditions) Order 2014.
- 2. The following provisions of The Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005 apply to this application: Regulation 42, Part 2 (Premises licences) and Part 4 (General) relating to applications, notices and representations and advertisement of applications
- 3. The following provisions of the Secretary of State's guidance apply to this application: Section 2 The Licensing Objectives; Section 9 Determining applications; Section 10 Conditions attached to premises licences and club certificates; and Section 14 Statements of licensing policy.
- 4. The following paragraphs of the licensing authority's statement of licensing policy apply to this application: 5.0 Applications for Premises Licences, Club Premises Certificates and Variations; 6.0 Guidelines for Applicants; 7.0 Saturation and Cumulative Impact and 8.0 Licensing Hours.
- 5. The Committee is reminded of their duty under the Crime and Disorder Act 1998 to consider the crime and disorder implications of their decisions and the authority's responsibility to co-operate in the reduction of crime and disorder in the city.
- 6. The Committee is reminded that the Human Rights Act 1998 guarantees the right to a fair hearing for all parties in the determination of their civil rights. The Act also provides for the protection of property, which may include licences in existence, and the protection of private and family life.
