Report of the Assistant Director for Housing and Public Protection

E-Crime Enforcement

Summary

- 1. To inform the Cabinet Member of a successful bid for grant funding to establish a national trading standards E-Crime enforcement facility in partnership with North Yorkshire County Council.
- 2. To seek approval to accept the grant offer and expand the regional trading standards Scambuster Team to accommodate the additional work.

Background

- 3. E-crime, or cyber crime, is an area of trading standards' work that is increasing as more and more falsely described products or services are being sold online, and scams or frauds are being perpetrated through the use of the internet. In essence, rogue traders are using the internet to facilitate their illegal activities for financial gain. Such activities exploit vulnerabilities in the use of the internet and other electronic systems by citizens and businesses.
- 4. A report published last year by the Cabinet Office estimates the cost to UK citizens resulting from online scams amounted to £1.4bn. In addition, the costs of scareware and fake anti-virus scams are estimated at another £30m and rising.
- **5.** Consumers are not the only victims of cyber crime. Businesses also report being targeted for scams, data theft and on-line theft. Whilst online theft and data theft will be a direct police matter,

- enforcement of business targeted scams are a trading standards responsibility and the report estimates an overall impact to businesses costing in the order of £1.44bn.
- 6. As part of the Government's Consumer Landscape Review, the Department for Business, Innovation & Skills (BIS) is diverting national funding of internet enforcement away from the Office of Fair Trading (OFT) to enforcement by Local Authority Trading Standards Services (LATSS).
- 7. BIS is of the view that LATSS deliver consumer protection very effectively and the intention is to enhance the capacity and capability of trading standards officers to deal with e-crime, such as consumer online scams and frauds and unfair or misleading commercial practices affecting both consumers and businesses of national or regional importance, which are causing significant harm to consumers

The BIS E-Crime Project

- 8. BIS sought bids from local authorities to undertake enhanced ecrime enforcement work. This initiative was divided into four subprojects which may be categorised as investigation, intelligence, coordination and training.
- 9. North Yorkshire County Council trading standards service (NYCC) and City of York Council's trading standards service (CYC) are ideally suited to undertake the investigation project as the 'foundations' for an enhanced service are already in place:
 - NYCC has an internet and digital evidence recovery laboratory (DERIC) which was originally set up with funding provided to the Yorkshire & Humber region from the Department of Trade and Industry to provide a digital evidence recovery facility to the region.
 - CYC hosts a successful 'cross border' investigation team on behalf of the Yorkshire and Humber Trading Standards Group.
- 10. A joint bid by NYCC, CYC and the East of England Trading Standards Association (EESTA) was submitted to BIS in September 2011 to deliver all four sub-projects. This joint bid was successful and NYCC/CYC has been invited to provide

investigation and coordination and EETSA will be responsible for intelligence and training.

Contractual Arrangements and Funding

- 11. Under the terms of the grant offer NYCC would act as the accountable body. A collaboration agreement (MOU) will be necessary with NYCC for them to 'passport' the grant funding through to CYC and arrangements will be made to put this in place.
- **12.** The CYC element of the grant will provide 'set up' costs for the current financial year of £46K and funding of £750K over the next 3 years to provide the e-crime investigation facility. This would result in the creation of 3 new jobs in York.

Consultation

13. The NYCC/CYC bid for funding had the support of the other nine trading standards services in the Yorkshire and the Humber Region.

Options

- **14.** A. That the Cabinet Member notes the report and recommends acceptance of the grant to expand the investigative capacity of the trading standards Scambuster Team.
- **15.** B. That the Cabinet Member notes the report but recommends not to accept the grant.

Analysis

- 16. Option A. Residents and businesses will receive an enhanced service in relation to protection from on-line fraudulent trading activities. Consumer detriment locally, regionally and nationally will be reduced. CYC's reputation in this area of work would be greatly enhanced and York and North Yorkshire would be seen as the national centre of excellence for trading standards e-crime enforcement.
- **17.** Option B. Would put at risk the future status of the council's Scambuster Team and deny additional employment opportunities.

Council Plan

18. E-crime enforcement supports the council priorities to "Protect jobs and grow the economy" and "Protect vulnerable people".

Implications

- **19. Financial:** The cost of the project will be met from grant funding and there will be no impact on existing budgets.
- **20. Human Resources:** The project will involve the appointment of 3 4 members of staff on either a fixed term or secondment basis.
- **21. Equalities:** Rogue trading and scams on the internet is often targeted at vulnerable individuals. This project will increase the council's ability to tackle this issue.
- **22.** Legal: There are no legal implications associated with this report
- **23. Crime and Disorder:** Formal enforcement action taken by environmental health, trading standards and licensing services contributes to reducing anti social behaviour and dishonest trading.
- **24. Information Technology (IT):** The eCrime team will require the provision of bespoke 'stand alone' hardware and software to carry our investigations.
- **25. Other:** There are no other implications associated with this report.

Public Protection Legal Actions

Summary

1. The purpose of this report is to enable the Cabinet Member for Crime & Community Safety to review the results of legal actions (prosecutions, cautions and fixed penalties) undertaken by Environmental Health, Trading Standards, and Licensing Services in the Communities and Neighbourhoods Directorate for the period 1st October 2011 – 31st December 2011.

Background

- 2. The Cabinet Member for Environment and Sustainability approved an enforcement policy for Environmental Health, Trading Standards, Licensing, Street Environment and Enforcement Services in March 2008. This policy was updated and approved by the Cabinet Member for Crime and Community Safety in February 2012.
- 3. This report details the results of prosecutions taken in the period 1st October 2011 30th December 2011 by Environmental Health, Trading Standards, and Licensing Services (under the policy approved in 2008). Each case is considered on its merits before legal proceedings are instituted.

A simple caution is a Home Office approved procedure which is an alternative to prosecution. Report of the Director of Communities & Neighbourhoods

CRIME SUMMIT 2012

Summary

1. This report outlines the proposal for an annual Crime Summit, and sets out the proposed format for the event.

Background

2. The Cabinet have given their commitment to hosting an annual Crime Summit to provide residents with the opportunity to meet with police, council staff and other key stakeholders responsible from tackling crime and anti-social behaviour in York. An initial paper outlining a suggested date of March 2012 for the Summit was approved by the Cabinet Member in October 2011.

Rationale

- 3. Community Safety Partnerships (CSPs) in York and North Yorkshire are currently undertaking their Joint Strategic Intelligence Assessments (JSIA) in order to refresh the three year Community Safety Plans. The JSIA is a comprehensive analysis of multi-agency data and information which will identify the strategic priorities for Safer York Partnership for the next twelve months. This process is timely to inform the topical debate and discussion focus for the Crime Summit.
- 3.1 Safer York Partnership has tried and tested a number of formats for public community safety events in York over the 12 years that the partnership has been in existence. The most successful format for maximising public interest has been through an interactive multi-agency market where members of the community can meet representatives from all agencies engaged in community

safety. It is proposed that a market be organised to provide a City Centre Community Focus for the Crime Summit. The market could include opportunity for interactive displays such as demonstrating the effects of alcohol by through inviting participants to play Jenga whilst wearing the vision distorting "beer goggles", launching the Road Safety Pledge to encourage residents to abide by the highway code and police Operation Spoke cycle marking. It could also provide an opportunity to promote key community safety messages through the use of the media van plasma screen streaming community safety videos and Fire and Rescue promoting their River Safety programme. The market would ensure public participation in the Crime Summit and facilitate interaction between the community and agencies engaged in community safety.

- 3.2 It is proposed that a Stakeholder Event be organised to take place in a City Centre location yet to be arranged. This could include opportunity for presentations on the Joint Strategic Intelligence Assessment, Safer York Partnership's performance and workshop discussions on the strategic priorities. The aim of the day would be to agree some high level objectives aligned to the strategic priorities which each of the Responsible Authorities that make up the Community Safety Partnership could sign up to. The Stakeholder event would consolidate the contribution of responsible agencies involved in Safer York Partnership and identify some strategic aims to contribute to a refresh of the Community Safety Plan for York.
- 3.3 Simultaneous to the City Centre based events, it is proposed that the Safer Neighbourhood Policing Teams participate in a "No Crime Day". This concept was introduced in 2008 with the police and key partners working together at ward level and in conjunction with local communities to address their local community safety priorities through multi-agency operations and projects. Examples have been joint operations between DVLC and NYP to undertake ANPR vehicle checks, execution of warrants on properties and community clean-up campaigns. A No Crime Day would engage all agencies across the city in focusing on community safety for a 24 hour period and provide a joint contribution to achieving high performance in the first quarter of the financial year.
- 3.4 It is envisaged that this three pronged approach to the Summit event would maximise the opportunities for multi-agency support,

provide a range of events simultaneously that would attract media interest and provide the opportunity for key stakeholder debate and input to the refresh of the Community Safety Plan for York. There is also scope for business community involvement and if the outlined approach to the summit is approved, Safer York Partnership will work alongside CYC Economic Development Unit to generate support from the business community.

3.5 Safer York Partnership is predicted to meet its crime reduction performance target by the end of March 2012. However, due to the continuation of the economic recession, crime is beginning to increase and in particular, the city is experiencing some significant increases in Serious Acquisitive Crime. We know from experience that multi-agency days of action can significantly boost performance as all agencies are focused on reducing crime over a 24/48 hour period. Having consulted with the Police Safer Neighbourhood Commander for York, it would better to focus the Crime Summit on 25th April in order to boost the figures for 2012/13 in the knowledge that sustaining such high levels of performance beyond March 2012 will become significantly more of a challenge.

Consultation

4. Safer York Partnership has consulted with North Yorkshire Police as the main stakeholder in this event. Support has been approved by ACC lain Spittal.

Options

- 5. Option A: That the Cabinet Member notes the report and approves the proposed format for an annual crime summit event, as set out in paragraphs 3.1, 3.2 and 3.3.
 - Option B: That the Cabinet Member notes the report but does not approve the proposed format.

Analysis

6. Option A: The event is planned for 25th April in accordance with timescales agreed by the police and Safer York Partnership. The format proposed ensures maximum media coverage for the event

and participation from a range of organisations as well as community involvement.

Option B: Would put at risk the likelihood of an event in April due to the timescales needed to identify an alternative format.

Council Plan

7. Community Safety continues to be a priority within the Council's corporate plan and the role and contribution of Safer York Partnership is recognised.

Implications

- 8. **Financial** Whilst there are financial implications to such an event, Safer York Partnership would be engaging with the community at this time and money has been allocated within the partnership budget to support this work. Approaches would also be made to local business to support/sponsor the event.
- 9. Human Resources (HR) Staff across a range of Council directorates would be required to be involved in a crime summit to ensure that relevant services are available and able to engage with residents attending. The administration and organisation of the event can be met from resource with the Safer York Partnership team.
- 10. Equalities Diversity and social inclusion play a key role within all aspects of community safety. Therefore it is crucial to involve the equalities team within the planning and running of the event to ensure that all communities have equal access.

- 12. **Crime and Disorder** This is a crime and disorder related event and therefore requires substantial input from the SYP team to organise and host.
