<b>1. Employment, Office, Trade, Profession or Vocation</b>

<b>3. Securities</b>	
You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and <b>either</b> the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, <b>or</b> one hundredth of the total issued share capital of any class of shares issued.	n/a

<p><b>4. Contracts</b></p>	
<p>You should detail any current undischarged contract made between you, or a body in which you have a beneficial interest, and the Council under which goods or services are to be provided or works are to be executed</p> <p>You have a beneficial interest in a body which is a firm in which you are a partner or a body corporate of which you are a director, or in the securities of which you have a beneficial interest</p>	<p>York CVS holds the contracts for Healthwatch York and the Independent Living Scheme.</p>

<p><b>5. Land, Licences and Corporate Tenancies</b></p>
