**16. DECLARATIONS OF INTEREST**

**19. REVENUE BUDGET ESTIMATES 2010/11 - RESOURCES**

The Executive Member received a report as part of the consultation on the 2010/11 budget process. The report presented the 2010/11 budget proposals for Resources and included:

- The base revenue budget for 2010/11 (Annex 1) to show the existing budgets
- The cost of pay and price increases, increments and settlement of pay and grading appeals for the portfolio
- Proposals for budget service pressure costs and savings options for the portfolio area (Annexes 2 and 3)
- Fees and charges proposals (Annex 4)

Full details of the budget would be considered by the Executive on 16 February 2010 and then Budget Council on 25 February 2010. The report sought the comments of the Executive Member on the proposals put forward.

The Executive Member stated that the budget for 2010/11 was being considered at a time of worldwide recession and at a time of great financial

stringency for both national and local government. The focus had to be on the council's core functions, the statutory services, front line delivery and working to maintain excellent services. Despite extra investment, savings must be made across the Council, both at a corporate and directorate level. The report that had been presented sought to find savings within the revenue budget.

The Executive Member thanked officers for their efforts in achieving a balanced budget. He also thanked Unison for their involvement in the budget process.

- RESOLVED: (i) That it be confirmed that the budget proposals are in line with the council's priorities.
- (ii) That the report and annexes be referred to the Executive for consideration.
- (iii) That all written and verbal representations made to the Executive Member be taken into consideration when the Executive considers the final budget.
- (iv) That officers be thanked for the work which has been undertaken to produce the report, especially considering the current economic situation.

Bad Debt Write Off Report – Period mid November 2009 to January 2010

### Summary

- 1 This report presents to the Executive Member for Corporate Services the irrecoverable accounts in respect of Council Tax (CT), National Non-Domestic Rates (NNDR), Sundry Debtors and Housing Benefit overpayment for write-off covering the period 21 November 2009 to 22 January 2010. The last write-off report was presented to the Executive Member for Corporate Services on 15 December 2009 for the period 1 October 2009 to 20 November 2009.

### Background

- 2 The council's Constitution and supporting Financial Regulations delegate the responsibility for writing-off all individual debts up to and including £5k to Chief Officers in consultation with the Chief Financial Officer (CFO) under the officer scheme of delegation. Above this threshold debts are written-off in consultation with the Executive Member for Corporate Services. Any exceptional debts with an individual value above £200k may only be written off on the authority of the Executive.
- 3 The council only writes off debt where it is irrecoverable for example where a customer has died and has no assets, or a business is bankrupt and has no assets. The only exception to this is where a debt is not cost effective to recover.
- 4 The council's in year collection rate for CT (2008/09) was in excess of 97% and placed York above the Unitary average of 96.7%. There was a 97.52% collection rate in 2008/09 for NNDR, which was down slightly on 2007/08 (98%) which reflected the recent economic conditions. The total collection rate for Sundry Debtor accounts is in excess of 99%.
- 5 The council is prudent in managing bad debt and makes provision for them in its annual statement of accounts. This ensures that the writing off of bad debt has no detrimental affect on service provision or the council taxpayer. In the case of NNDR the Government meets the cost of writing off bad debt.

**Debt to be written off 21 November 2009 – 22 January 2010**

- 6 Details of accounts with individual values above £5k in respect of NNDR and Sundry Debtors are set out at Annex A excluding any personal data, and in detail in confidential Annex B of this report respectively. The value of the accounts to be written off this period is £169,560 and Table 1 below shows the value of accounts by each area of debt.

- 7 The figures alone do not reflect the overall performance of the recovery teams. This can be more clearly demonstrated when the figures are compared to the value of debts raised. A more detailed breakdown of the debt write off relating to each year, compared to the respective value of accounts raised is set out at Annex C.
- 8 The council is continuing to develop and improve the efficiency of its debt collection and is working with the 'More for York' programme during 2009/10 to further improve its performance in the collection of both in year and prior year debt across all of the council's income streams.

**Consultation**

- 9 No consultation was necessary in the production of this report.

**Options**

- 10 There are two options for the Executive Member for Corporate Services to consider in relation to this report. These are:
- i. to write off the over £5k accounts totalling £46,736 in line with the council's Financial regulations;
  - ii. to leave the accounts on the council's accounts, but acknowledging the risk of doing so as laid down in paragraph 14 below.

- 11 All analysis is contained in the annexes to this report.

- 12 The effective and efficient management of income collection directly supports the corporate strategy objective of delivering an Effective Organisation. Improved income to the council also provides cross-cutting financial support in delivering all eight corporate objectives.

- a) approve the write off of bad debt as set out at Table 1 above and in the confidential annexe B attached to this report.

### Reason

To remove irrecoverable bad debt from the council's accounts in accordance with accountancy best practice.
