3. Securities	
You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and either the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, or one hundredth of the total issued share capital of any class of shares issued.	n/a

<p>4. Contracts</p>	
<p>You should detail any current undischarged contract made between you, or a body in which you have a beneficial interest, and the Council under which goods or services are to be provided or works are to be executed</p> <p>You have a beneficial interest in a body which is a firm in which you are a partner or a body corporate of which you are a director, or in the securities of which you have a beneficial interest</p>	<p>York CVS holds the contracts for Healthwatch York and the Independent Living Scheme.</p>

<p>5. Land, Licences and Corporate Tenancies</p>
