Disclosable Pecuniary Interests	
1. Employment, Office, Trade, Profession or Vocation	
You should disclose any employment, office, trade, profession or vocation carried on for profit or gain, including the name of any person or body who employs or has appointed you	CHARITIED FINANCIAL PLANNING INVESTOR WEALTH + INVESTMENT LTD
And of your spouse/civil partner (or person with whom you are living as such) of which you are aware	MR PARTNER AVIVA
2. Sponsorship	
You should declare any payment or provision of any other financial benefit (other than from the Council) made or provided within the last 12 months in respect of expenses incurred by you in carrying out your duties as a member, or towards your election expenses. <i>Note - This includes any payment or financial benefit from a trade union</i>	
3. Securities	
You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and either the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, or one	

<p>(excluding any easement, or right in or over land which does not carry the right to occupy or receive income).</p> <p>For these purposes land includes buildings and so if you own or are the tenant of your house you will have an interest in land.</p>	
<p>And of your spouse/civil partner (or person with whom you are living as such) of which you are aware</p>	<p>OWNERS OF 3 LOCIC HOUSE LANE, FANSWICK.</p>
<p><u>Licences</u> You should detail any licence (alone or jointly with others) to occupy land in the Parish for a month or longer.</p>	
<p>And of your spouse/civil partner (or person with whom you are living as such) of which you are aware</p>	
<p><u>Corporate Tenancies</u> You should detail any tenancy where to your knowledge, the Council is the landlord and the tenant is a body in which you have a beneficial interest.</p>	
<p>And any such tenancy of your spouse/civil partner (or person with whom you are living as such) of which you are aware</p>	

<p>hundredth of the total issued share capital of any class of shares issued.</p> <p>“Securities” does not include building society accounts but includes securities of all other descriptions such as shares, debentures, stock, loan stock and units of a collective investment scheme</p>	
<p>And of your spouse/civil partner (or person with whom you are living as such) of which you are aware</p>	
<p>4. Contracts</p>	
<p>You should detail any current undischarged contract made between you, or a body in which you have a beneficial interest, and the Council under which goods or services are to be provided or works are to be executed</p> <p>You have a beneficial interest in a body which is a firm in which you are a partner or a body corporate of which you are a director, or in the securities of which you have a beneficial interest</p>	
<p>And of your spouse/civil partner (or person with whom you are living as such) of which you are aware</p>	
<p>5. Land, Licences and Corporate Tenancies</p>	
<p><u>Land</u> You should detail any beneficial interest in land within the Parish</p>	<p>OWNERS OF 3 LOCK HOUSE LANE, SANDWICH.</p>

Other Interests:

6. Membership of other bodies

You should detail any body of which you are in a position of general control or management and to which you have been appointed or nominated by the Council

And any body—
(a) exercising functions of a public nature;
(b) directed to charitable purposes; or
(c) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union) of which you are a member or in a position of general control or management

7. Disclosure of Gifts and Hospitality

You must reveal the name of any person from whom you have received a gift or hospitality with an estimated value of at least £50 which you have received in your capacity as a member of the Council.
