022/23 Agenda Items.

- i. Closure of Sutton Bridge - the closure on 7th February by Yorkshire Water to carry out emergency repair works caused chaos. There was little signage warning of the closure. The situation was exacerbated by traffic using the route to avoid the temporary traffic lights on the A1079. Yorkshire Water is apologetic and has advised that the bridge will have to be closed again for further repairs. They have assured that Elvington and Sutton upon Derwent Parish Councils and CYC will be notified in future. The work will not be commenced until the A1079 is fully open.
- ii. Telephone Box - a suggestion to use the old telephone box as a book lending store has been received. The box is a listed building for which BT is responsible. The Parish Council does not want to take on the liability of the box at this current time. Cllr Laverack will respond. **JL**

Other Matters: City of York Local Plan Modifications Consultation 2023 - The Parish Council has considered the document and comments as follows:

ST15 (Langdale) looks like a done deal with approximately 40-50% of the runway being dug up for the creation of a new village of over 3300 houses. Work will not commence until major traffic and ecological studies are complete, so work will not be commencing for several years. The B1228 will be used until approximately 1000 houses are built at which point a new junction will be created on the A64.

Likewise, it would appear that the extension to Beckside, a scheme for 32 houses, has been waived through without any consideration to alternative sites that were put forward at the hearings which were supported by the majority of parishioners.

The Stables travelling showpeople site will likewise form part of the permitted development.

Finally an extra 270,000sq.ft of employment floorspace for research and development, light industrial/storage and distribution can be constructed at the Airfield Business Park. The Parish Council will respond re-iterating the fact that no valid consultation was held with the village. **JL**

031/23 Recent and Forthcoming Meetings:

- i. York Branch of YCLA - 16th February. Attended by Cllr Moorhouse. The main issue was the forthcoming elections. Residents will have to provide ID when attending the Polling Stations. Parish Council Clerks will not be allowed to be involved in the submission of nominations.
- ii. Decision Session Executive for Transport - 21st February – Cllr Laverack and Ward Cllr Vassie attended this meeting to further put forward the requirement for a weight limit through the village. The recent closure of the bridge by YW is being blamed on the amount and weight of traffic now flowing through the village. To avoid this being a regular occurrence it was requested that an Experimental Traffic Regulation Order (ETRO) is put in place for 18 months limiting vehicles over 7.5t travelling through the village. CYC will investigate this and said they would liaise with EYRC as any ETRO should be in collaboration with a similar one over Sutton bridge which is controlled by EYRC.
