Cllr Fisher declared a personal interest in Agenda Item 12 (Minute 44 refers), as Chair of the Planning Committee referred to in one of the cases listed on Annex A to the report.

The Monitoring Officer declared an interest in Item 12 insofar as it related to case 2021/20 on the list at Annex A to the report.

For transparency, Cllrs Carr and Fisher declared their membership of Copmanthorpe and Osbaldwick parish councils respectively, in relation to cases listed on Annex A to the report at Item 12.

Gwen Swinburn spoke in relation to Agenda Item 8 (Model Code of Conduct – Review of Procedures), suggesting amendments to parts of the draft case handling procedure at Annex A in order to reduce reliance on delegated decisions by officers.

40. York's Parish Charter

Members considered a report which provided an update on the review of the charter between City of York Council and the parish and town councils within the York local authority area, following Members' input to the draft charter at the meeting on 6 July 2021.

The review had been co-ordinated by the York Parish Council Liaison Group. The finalised Charter, attached as Annex to the

report, incorporated Members' suggested amendments. It had now been signed by the Executive Member for Culture, Leisure & Communities on behalf of the council and by the Chair of the York Branch of the Yorkshire Local Councils Association (YLCA).

In response to questions from Members, officers confirmed that:

- All parish / town councils in the area had been offered the opportunity to comment on the Charter before it was finalised, including any that were not members of YLCA.
- Timescales for planning application consultations (paragraph 11 of the Charter) would be discussed by the Liaison Group.
- Relationships, confidence and trust between the parties would be key to the success of the Charter.

Resolved: That the finalised Charter at Annex 1 to the report be

noted.

Reason: To advance joint working between City of York

Council and York's parish councils.

The Chair of Joint Standards Committee had granted the dispensation as a 'one-off' to enable Cllr Webb to be substituted at a meeting when he was unable to attend and both named substitutes were unavailable. Council had since approved an amendment to the substitution rules for Planning committees.

During the municipal year 2021-2022, the Council received X complaints.

Of these, X complaints related to X City of York Councillors and X complaints related to Parish and or Town Councils.

Of the X Complaints received,

The remainder are still being investigated and await determination in accordance with the published procedures.

The Joint Standards Committee is also considering a number of complaints from the previous municipal year and where necessary these will be determined by a Joint Standards Committee Hearing Panel.

All of the complaints received have been reported to meetings of the Joint Standards Committee throughout the year.

Other work

Model Code of Conduct for Members and review of Supporting Procedures

A substantial amount of work has been carried out to adopt the LGA Model Code of Conduct during this municipal year. This work was undertaken with advice and support from Paul Hoey and Natalie Ainscough from Hoey Ainscough Associates, who attended several Joint Standard Committee Meetings throughout the municipal year.

The Model Code, which was adopted by Full Council in October 2021, contributes to the delivery of the Action Plan, arising from the Public Interest Report which is currently being monitored by Audit and Governance Committee. The Joint Standards Committee are also grateful to the Chair and Vice Chair of the Audit and Governance Committee for their assistance and feedback in discussions around the adoption of the Model Code of Conduct.

Following the adoption of the Model Code of Conduct it has been essential for the Committee to review the supporting procedures and this was undertaken with the ongoing support of Hoey Ainscough Associates. The revised procedures provide additional assistance and clarity in key areas of the process, including assessment of complaints, a FAQ document for complainants or subject Councillors and a flowchart of the key stages in the process.

Consultation with the Chair and Vice Chair of the Joint Standards Committee has been introduced at key stages in the complaints process, including assessment stage and also when deciding whether a matter should progress to a Hearing.

Recruitment of Independent Persons

A recruitment exercise took place during the middle of 2021. Unfortunately, there were no applicants, and the Chief Operating Officer and Director of Governance are now working on a further recruitment exercise following the resignation of our two Independent Persons. It is hoped that a third could be appointed which will add resilience especially in view of the volume of complaints currently being experienced.

York's Parish Charter

The Joint Standards Committee has been kept informed on the progression of the review of the charter between City of York Council and the 31 Parish and Town Council's across the City, as represented by the York Branch of the Yorkshire Local Councils Associations. The Committee was assisted in these discussions by Charlie Croft, Assistant Director of Communities and Culture.

Dispensations granted to City of York Councillors

The Committee noted a dispensation given by the Monitoring Officer to Councillors relating to an agenda item at Full Council in July 2021 and also a further dispensation given at the Customer and Corporate Services Scrutiny Management Committee Meeting which took place in February 2022. The meeting was convened as an Executive decision was called in for further scrutiny.

Review of the Constitution

The Joint Standards Committee has actively contributed to the Review of the Council's Constitution and as aforementioned the Model Code of Conduct and the supporting procedures will form an integral part of the revised constitution, which should be in place in time for the municipal year 2022-2023.

The Joint Standards Committee has also taken the opportunity to review its terms of reference to ensure they remain fit for purpose and satisfactorily address the remit of the Committee's work and in doing so has made a recommendation that the Parish Council Members of the Committee should have the support of substitute Parish Councillors to add resilience.

The Joint Standards Committee will continue to develop and strengthen its role in embedding a positive culture of ethical governance and hopes to work collaboratively with the Audit & Governance Committee as regards issues such as member development and induction programmes.

Report of the Monitoring Officer

Government response to the Committee for Standards in Public Life's Review of Local Government Ethical Standards

Summary

1. On 18th March 2022, the Department for Levelling Up, Housing and Communities, published its formal response to the Committee for Standards in Public Life's Recommendations to Local Government Ethical Standards.

Background

- In January 2019, The Committee for Standards in Public Life issued its report and recommendations on ethical standards in Local Government. This report was published following extensive consultation with local authorities and the Joint Standards Committee submitted a consultation response on behalf of City of York Council.
- 3. In its published response, Government has provided its response to the numerous recommendations however it does not propose any immediate plans to amend or introduce revised legislation to address some of the issues raised, for example amendments to the Localism Act 2011, to sanctions and further clarity as regards disclosable pecuniary interests.
- 4. However with regards to other recommendations, the Government does support and encourage local authorities to develop best practice, for example adoption of the LGA Model Code of Conduct, reporting and monitoring gifts and hospitality for councillors from the same source over a period of time and preparation of annual reports including code of conduct complaints.

Dispensation granted to Councillors sitting on the Customer & Corporate Services Scrutiny Management Committee on 7th February 2022 to enable them to participate in a call –in of a decision taken by the Executive Member for Environment and Climate Change.

Summary

 To confirm, a dispensation was granted to Councillors Crawshaw, Fenton, Hollyer, Pearson, Orrell, Wann, Melly and Douglas on 7th February 2022, to enable them to participate in a call-in of a decision taken by the Executive Member for Environment and Climate Change.

Background

2. At the request of Councillor Crawshaw a dispensation was granted to Councillors Crawshaw, Fenton, Hollyer, Pearson, Orrell, Wann, Melly and Douglas, so that they could fully participate in a Customer & Corporate Services Scrutiny Management Committee call-in of a decision made by the Executive Member for Environment and Climate Change on 12th January 2022. This decision related to Weed Management of Highways and Associated Areas. Councillor Crawshaw believed that the dispensation was required due to Member voting unanimously in favour of A Motion granted by Full Council in 2019, relating to the promotion of a pollinator strategy which links to the council's use of pesticides. The dispensation was granted by the Chair of the Joint Standards Committee who, in doing so, raised concerns as to his ability to grant himself a dispensation as he was also a member of the Committee considering the call-in. The Monitoring Officer therefore agreed to grant a dispensation for the Chair of Joint Standards Committee as to not do so would have the

undemocratic effect of restricting Councillor Rowley's ability to fully contribute to the meeting in the same way his colleagues could.
