Report of the Assistant Director of Communities and Equalities

Forgotten Corners - fund towards transformation of neglected and unloved green spaces in York

Summary

- 1. An Executive decision made on 21 June created a fund of £100,000 to improve forgotten corners within the City of York. Improvement would involve putting areas of land in good order, making them accessible to residents and creating landscapes which would require minimal ongoing maintenance.
- 2. The fund was promoted to communities across York. Thirty expressions of interest were received from ten wards within York.
- A formal evaluation of projects was conducted which scored all projects received.
- 4. This paper proposes that the funding is awarded to the highest scoring projects which result in an accessible and cleaner green space and are deliverable in the timescale.

Each project is expected to meet the below criteria:

- a. offering good value for money;
- b. providing lasting improvements to an area;
- c. is deliverable by March 2019;
- d. engages residents, encouraging them to volunteer in green spaces in the city;
- e. is centred round previously unmanaged/ uncared for area;
- f. is of benefit to a large number of people;
- g. does not have ongoing maintenance liabilities.

Recommendations

5. That funding requested for projects listed in **Table 1** is agreed. Projects in **Table 1** are listed in order of highest to lowest score against the criteria. This approach exhausts the available funding.

Background

- 6. On the 21st June 2018 the Executive agreed that a one off Fund was established towards transformation of neglected green parts of the city.
- 7. The Fund was set at £100,000 and was advertised to community groups, charities and other organisations who were asked to identify a neglected corner of the city they wished to improve. The City of York Council Environment and Community Officers offered to support to groups which had not previously applied for grant funding to build capacity within these groups.
- 8. Projects seeking financial support from the Fund should:
 - a. seek to enhance public open space for the benefit of York residents and its environment;
 - b. seek to improve the appearance of the space, enhance its biodiversity and accessibility to members of the public;
 - c. involve community volunteers in the improvement and maintenance of the space;
 - d. produce a project plan outlining how the space could be maintained in a sustainable way without further funding from the City of York Council.
- 9. A project team defined the criteria, assessed applicant eligibility and invited expressions of interest in the fund.
- 10. The Project Team received expressions of interest which were then assessed and ranked against the Fund criteria.

Consultation

11. The Fund, its objectives and the opportunity to submit an expression of interest was advertised by means of a press release, Ward Team distribution lists, York CVS, Minster FM and third party news bulletins, for example Social Vision.

Projects list

12. The table below lists organisations recommended for funding, a summary of each project and the amount of grant requested. Agreement is sought to fully fund the highest scoring projects and part-fund the lowest scoring projects (featured in italics) until the fund is exhausted.

15. Organisations will be required to fully deliver projects by end of March 2019 and to report back by the 30th April 2019 on project delivery.

Council Plan

16. Transforming green parts of the city into cleaner, more accessible and sustainable spaces align with a prosperous city for all. Investment in green spaces allows creation of better flora and

fauna habitats as well as attractive green amenities for residents and visitors alike.

Implications

- 17. **Financial** there are no financial implications beyond the previously agreed budget. Funding is released to organisations on the understanding that ongoing maintenance costs associated with the project will be funded from alternative sources.
- 18. **Human Resources (HR) -** Some of the projects will be led by Environment and Community Officers within their day to day capacity therefore there are no human resource implications.
- 19. **Equalities** A criteria of the fund was that Forgotten Corners should be made more accessible to communities in York. Many of the projects proposed for funding improve the accessibility of green spaces to those with mobility issues. All projects involve volunteers in delivery of the project, engaging people from many communities within the City.
- 20. **Legal** All projects recommended for funding are either on the land owned by the City of York Council, or have the landowner agreement therefore there are no legal implications.
