20.150 - TO RECEIVE THE CITY OF YORK COUNCILLOR'S REPORT - FOR INFORMATION ONLY

City Councillor Anne Hook reported that: -

- 1. City Council continues to provide help to residents through their email covid19help@york.gov.uk and helpline 01904 551550. Help comes in various forms, such as getting urgent supplies, but also extends to a befriending service for people who are lonely and need to talk to someone. This help has never stopped. There is also new help for businesses as the Council seeks to process the new government support as quickly as possible.
- 2. The purchase of land between the B1224 and A59 for the Northern Forest is in an advanced stage. There are plans for a mixture of woodland and meadows, including wildflower meadows. There will be cycle paths and a café. A team is currently building a "straw man" plan and will be putting it to interested local parties in the new year. If anyone is interested in discussing the plans, please contact me.
- 3. Following one of the latest investigations in the area, Yorkshire Water made a decision to visit the area every 6 month to monitor the sewers nearby. This work will involve lifting and checking manholes and undertaking camera surveys. If any issues are found they will then

raise the appropriate follow on work. If <u>any</u> resident experiences an issue, **please report it immediately to Yorkshire Water on 0345 1 24 24 24**. They will then attend for no charge and investigate and register this on their system. This will allow them to build up an accurate picture of the area so that they can consider the best steps to reduce any further issues.

	1. <u>INFRASTRUCTURE</u>
	A. A new housing estate of 60 houses will have an increased number of children. The distance to the nearest primary school, Poppleton Ousebank, is considerable with no ready access to bus transport. Parents will take their children to and from school by car causing further traffic mayhem. This school is currently at maximum capacity, so children could have even further to travel if they were to be accommodated at another school.

	В.	Access to services (and schools) would mean crossing the very busy A59, a hazardous process especially for children at peak times.
		Further traffic exiting this development will only aggravate the already severe back log of traffic at the moment. At the rush hour between 7.00am and 9.30am the traffic is already backed up on the A59, often up to a mile or more in the direction of Harrogate. Already motorists 'rat run' through Poppleton via Hodgson Lane or Black Dyke Lane to bypass the congestion. Both roads are too narrow to accommodate through traffic. The new development will only increase the adverse traffic problems.
	D	People use their cars to access railways, and Poppleton Station has very limited car parking, and therefore this will increase the already problematic road parking along Station Road causing further congestion for residents. Sustainable transport links do not exist in this area.

The Clerk had asked the YLCA for advice and the response gave no indication that spending of
Section 106 money was limited to specific projects and that spending was at the discretion of the
Parish Council.

(e) To agree to pay half of the cost of fixing the plan4poppleton website

The Clerk explained that it was a condition of grants for the Neighbourhood Plan that a separate website be kept open for five years. The website in question is https://plan4poppleton.co.uk/. Two weeks ago, IONOS who host the website, contacted the Clerk to say that the website had been compromised by hackers and had been closed down. In consultation with Councillor Jones, the lead Councillor on the Neighbourhood Plan, the Clerk had asked the website creators, Hutton Peach, to repair the website. This had been carried out successfully at a total cost of £135. It was agreed that the Parish Council should pay half the cost of the work.

Councillor Catterick raised the subject of the poor state of the footpath between the Green and the Poppleton Centre. City Councillor Anne Hook reported that she was in discussion with the City Council about the problem.

The narrowness of Westfield Lane was discussed. Given that there are no longer any verges
down a long stretch of the lane it was agreed that the lane would benefit from the construction of
passing places. It was agreed that the City Council be asked for their advice with regards to the

number of passing places required and that a request for the construction of that number be made. (Action Clerk)

(d) To look at the question of registering School Lane with the Land Registry

The Clerk reported that he had asked the YLCA for advice regarding the registration of land it didn't own. He had received a comprehensive reply which he forwarded to the Councillors. It was agreed to defer discussion on the subject until the next Parish Council meeting to give the Councillors time to consider the YLCA's advice.

20.156 - TO SEEK CLARIFICATION OVER THE STATUS OF THE TWO AREAS OF LAND WHICH THE CITY COUNCIL HAS CLASSED AS VILLAGE GREENS I.E. THE AREA BEHIND MODEL FARM AND THE AREA IN THE FIELD BEHIND THE COMMUNITY CENTRE

Councillor Langford explained that the areas designated as "Village Greens" by the City Council were not actually such but had been created to allow the farmer to graze ten cows between May and October.
