Councillor M. Waudby spoke fondly of Daphne Stead, who has sadly recently passed away. Daphne was a member of Rawcliffe Parish Council from 1972 until 1999 and during that time served as both Chairman and Vice Chairman. Daphne was also one of Rawcliffe's two District Councillors from 1976 until 1996. Daphne was the first woman to serve as Chair of Ryedale District Council. Daphne also ran the post office on Eastholme Drive from 1968 until 1987. Daphne was always very charming and gave a lot of support to young and new councillors. Rawcliffe Parish Council gave thanks for the hard work and commitment Daphne gave to the parish and residents over many years.

Ward Councillors D. Smalley, S. Waudby and D. Wann provided the following report:

- City of York Council has decided to reject plans for a right hand turn out of Hurricane Way. Parish Councils will be informed in the future of any plans affecting this area.
- A tree has been felled in Troutsdale Avenue. This will be replaced with ten new trees.
- The planning enforcement team have been contacted regarding 1 Howard Link and will be investigating that the developer is working within the perimeters of the planning permission.
- TSAR Consultation regarding A19 Shipton Road/Park & Ride Access is taking place.
- The retrospective planning application for an HMO on Mitchell Way has been called into the planning committee.
- Further examinations will continue in the summer for City of York Council's Local Plan.

- Ad Astra, a group supporting young people in alternative education are looking for a base in York.
- City of York Council's budget will be reviewed and approved in February.
- The recent flooding has caused damage to some of the local river banks. The Environment Agency will start work on Shipton Road, including cutting the hedges by the allotments in the spring.

It was resolved to make a financial contribution of up to £2000 to refurbish the play area, as required by the grant application process.

c. To provide an update on the new defibrillator

The defibrillator has been received, but the Parish Council is waiting for delivery of the case and class 2 electrics. Once received, the equipment will be relocated to the old phone box on Shipton Road. Vinyl wrap designs and costs to advertise the location of the defibrillator in the phone box will be investigated.
