22/134 - TO CONFIRM THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON 25 APRIL 2022

The minutes of the Parish Council meeting held on 25 April 2022, having been circulated prior to the meeting, were approved and signed.

22/135 - TO RECEIVE A REPORT FROM A CITY OF YORK COUNCILLOR

City Councillor Anne Hook reported: -

- Grass verges have not been cut because many operatives are on long term sick. Six have been recruited from other councils but need training on equipment which takes a few months.
- Level crossing on Millfield Lane is to be made safer, but it will involve partial and full road closures. Where it is a full closure, penalties for using Low Poppleton Lane will be waived.
- Network Rail own land between level crossing and A1237 embankment and are using it to do works on level crossing and may well want to use it when those works are done. Could help residents to write/petition Network Rail to reopen it as a BMX cycle track when done to help young people.

This was agreed.

(e) To consider making a financial contribution to help villagers, including Poppleton Community Trust, helping Ukrainian refugees.

In consequence of the Russian invasion of Ukraine the UK has been granting visas to displaced Ukrainian families. Five families are being looked after by Poppleton residents. Cllr Steward reported that at the last meeting of the Poppleton Community Trust it was reported they were helping refugees in the village and how some items had a cost, for example materials needed to help teach the children English. Councillors were supportive of providing help and agreed to pay the initially incurred expenses and potential further bills up to a total of £250.

22/138 - PARISH COUNCIL LAND - TO RECEIVE PROGRESS REPORTS AND MAKE APPROPRIATE DECISIONS ON

(a) Grass cutting.

The first cut of the Common Land grass has taken place. The verge along Main Street has been left until the daffodils have died back enough.

(b) The management of Warren Lea

Cllr. Jones said that it was now time that the vegetation in Warren Lea be trimmed. The Clerk is to request Sleightholm to carry out the work. (Action Clerk)

(c) The management of the Common Land including the pollarding of the willows on the riverbank

It was agreed that some of the willows which are now obscuring the view upriver should be pollarded. (Action Clerk)

- (f) The Cartsheds

The Clerk reported that the builder who is quoting for the work to install a trench drain is waiting for a response from the sub-contractor who would lay the tarmac.

 - i. It was reported that the area had been strimmed.
 - ii. The subject of the grinding of the stump will be discussed at the June meeting.

- (a) It was reported that the directional arrows on the Millfield Lane/A1237 roundabout have faded and need to be repainted for safety's sake. The City Council is to be asked to action the work. (Action Clerk)
- (b) It was noted that graffiti has appeared on the A1237 bridge over the railway line. The City Council is to be asked to remove it. (Action Clerk)
- (c) The Millfield Lane cycle lane, which ends at the junction with Long Ridge Lane, was discussed. It was agreed that there should be clearer markings at the junction. The City Council is to be asked to expedite the work. (Action Clerk)
