#### 19. **Declarations of Interest**

Members were asked to declare, at this point in the meeting, any personal interests, not included on the Register of Interests, or any prejudicial or disclosable pecuniary interests they may have in respect of business on the agenda.

Cllr S Barnes disclosed a personal non-prejudicial interest in agenda item 7 (School Improvement Update) and agenda item 8 (Academisation, School Organisation and Place Planning) Summary), due to his daughter attending Robert Wilkinson Primary School.

Cllr Taylor disclosed a personal non-prejudicial interest in agenda item 4 (Scrutiny Report - Explore York Libraries and Archives) due to his involvement in the promotion of Big City Read through his employment at City Screen.

Cllr Brooks disclosed a personal non-prejudicial interest in that she is a governor on the Leeds and York Mental Health Trust.

#### 20. **Minutes**

Resolved: That the minutes of the meeting of the Committee

held on 19 September 2017 be approved as a correct record and then signed by the Chair.

#### 21. **Public Participation**

It was reported that there had been no registrations to speak at the meeting under the Council's Public Participation Scheme.

# 22. Scrutiny Report - Explore York Libraries and Archives

Committee Members considered a report that updated them on the performance of Explore York Libraries and Archives Mutual Ltd (Explore).

Members noted that the Chief Executive of York Explore had sent her apologies and the Scrutiny Officer offered to feed any questions back to her.

Some Members commented on the results of the staff wellbeing survey and the committee welcomed the encouraging results around staff feeling their job was worthwhile.

The Chair stated that the consultation on the future of library services had begun and would run until 14 February 2018. Members noted that the consultation could be viewed at <a href="https://www.york.gov.uk/consultations">www.york.gov.uk/consultations</a> and staff working at York Explore would be available to assist anyone who may need help completing it online.

Resolved: That the report be noted.

Reason: To help monitor the service received under the contract.

# 23. Make It York Scrutiny Update

Members considered a report that updated them on the progress of Make It York (MIY) with regard to the Service Level Agreement with City of York Council.

The Managing Director of MIY was in attendance to present the report and he highlighted some of the events and festivals that had taken place over 2017, which had contributed to a rise in visitor numbers, resulting in a positive outlook for York's tourism. He stated that Visit York were re-launching their website and that the purchase of the York Pass was 62% up on last years figures.

The proposed 2018 events and festivals were discussed and Members noted York's offer would include a new 4 day horticultural festival called Bloom which would tie in with the 250<sup>th</sup> anniversary of the Ancient Society of York Florists.

The Managing Director highlighted the cultural events taking place, which included the 2<sup>nd</sup> Culture Awards and it was noted that the progress made on developing a cultural strategy for the city was taking longer than anticipated.

Members were informed that MIY were on track to achieve their full year budget, which was helped by the renaissance of the Shambles Market and the growing success of the food court.

In answer to Members questions it was noted that:

- The early evening offer within the city centre had uplifted due to the vast selection of restaurants and bars but that it was still proving difficult to persuade shops to stay open late one night a week.
- Organisers of the Balloon Festival were considering the comments received and were working on repairing any damaged caused by the adverse weather.
- The Shambles Market currently had a temporary cover and that a permanent cover was being considered to maintain momentum during the winter months and to allow the area to be used for performances during the day and evening.
- Better signage to the Shambles Market was required and the approach from Silver Street needed to be made more attractive.
- MIY were in the process of raising funding to promote Bloom and to date had received a positive response from many organisations who would like to provide content for the festival, which if successful, could become a potential annual event.

Following discussions around engaging more young people in the development of the cultural offer, Members thanked the Managing Director for his report and were encouraged to hear what was on offer during 2018.

Resolved: That the update be noted.

Reason: To fulfil the Council's role under the agreed

partnership arrangements.

# 24. Update on Implementation of Local Area Teams

Members considered a report that provided them with an update on Local Area Teams.

The Corporate Director of Children, Education and Communities introduced the report and stated that the development of Local Area Teams had been a significant piece of work that was not just a set of council services but a multi agency approach that brought together all partners in a local area that existed in the lives of children, young people and families.

The new set of arrangements were launched in January 2017 and the Head of Early Help and Local Area Teams continued to explain the progress made since Members were last updated in March 2017 and it was noted that:

- The transition plan ran until March 2018.
- Local Area Teams now included the Healthy Child Service where progress had already been achieved through the integration.
- Engagement with all elected Members had taken place and briefing sessions had been provided.
- Childcare funding for two year olds had increased to 76%.
- The young people's service was now established at 30 Clarence Street and the transition had gone well, the offer would be developed through the creation of a new partnership.

Officers responded to Members questions where it was acknowledged that:

- Volunteers were recruited by publicising the schemes through press releases and social media and then appointed following appropriate checks and training.
- Officers had received feedback from young people and were currently considering ways to promote 30 Clarence Street to engage more young people in the development of the offer.
- There was a system in place to ensure all queries received were logged and then pursued, should the enquiry require further support.
- Officers were developing a reporting system that would reflect the work of Local Area Teams.

- Officers had developed good relationships with all the multi agency's, which had already helped bring communities together.
- Two school nurses had been recruited and the number of health outreach nurses had also increased.
- Complaints on anti social behaviour would be considered by all the relevant partners, who would work together to develop a solution.

Members thanked officers and everyone involved in the development of LAT's and it was recognised that the implementation had been a considerable piece of work.

Resolved: That the report be noted.

Reason: To keep Members updated on the implementation of Local Area Teams.

# 25. School Improvement Update

Members considered a report that provided information about school performance in the academic year 2016/17, and about the positions of schools according to Ofsted inspection judgements as of 1 November 2017.

The Assistant Director of Education and Skills was in attendance to present the report and she highlighted the primary and secondary school performance results from Early Years Foundation Stage through to Key Stage 5. She confirmed that across all Key Stages the city continued to perform well against national benchmarks and that the early years foundation stage had maintained their good level of development, which gave children a more secure journey through the Key Stages.

Members were informed that:

- Primary outcomes had progressed and the work undertaken to improve writing had been successful resulting in a significant uplift in writing outcomes in both Key Stages. This success had lead to a partnership funding bid win of £196,000 to extend work in writing.
- A new KS4 numerical national performance grading system was now used in English and mathematics where grade 4 was a standard pass and grade 5 a good pass.

All other subjects would continue to be graded using the A\*-G grading system until a phased roll out had been completed.

- The gaps had narrowed throughout KS1 to KS4
- Outcomes in KS5 continued to be strong with all school sixth forms performing strongly against value added benchmarks.
- Ofsted Judgements continued to improve and specialist provision was 100% better.
- Schools continued to work together to ensure the correct interventions were in place to improve performance results.
- School sixth forms were working more closely together to ensure a more sustainable offer to enable a more balanced and broad curriculum.

Members noted that the performance in the new reformed GCSEs was very strong and the percentage of pupils achieving grade 5 and above in English and mathematics was above national average. Members also noted that the new results were not directly comparable to the A\*-G grading due to an enhancement in the national standards and discussions took place around how schools were going to monitor and benchmark those results.

Officers responded to Members questions and in regard to narrowing the gap officers agreed to provide further information on school improvement interventions at a future committee meeting.

Members thanked officers for the report and welcomed the positive outcomes throughout the Key Stages and the encouraging results in narrowing the gaps.

Resolved: That the report be noted.

Reason: To provide the committee with an update on school performance in the academic year 2016/17.

# 26. Academisation, School Organisation and Place Planning Summary

Members considered a report that provided an update on academisation in York and the councils work on school place planning. The Assistant Director of Education and Skills gave an update and confirmed 20 York schools had converted to academy status and all apart from one had joined one of the four locally constituted multi-academy trusts (MATs), Ebor, Hope, Pathfinder or South Bank. Members noted that a fifth MAT, the South Partnership, was in the process of forming.

Members noted there were no further expressions of interest from any maintained schools to move to academisation and that the Local Authority retained a strong working relationship with all academies/multi academy trusts.

Officers stated that although figures currently showed a city wide surplus in primary school places some schools would continue to have pressure points within certain year groups as the high number of pupils admitted over the last few years made their way through their primary school education.

Officers highlighted how the council was working to ensure sufficient school places were available for current and future residents and how they forecast likely demand and supply of school places over the medium and longer term e.g. taking account of future housing developments and how new schools must be delivered at the right time.

Members thanked officers for their report and following discussions around supply and demand pressures, use of none teaching areas and the academy schools admission policies, it was agreed that all ward Members should be kept updated to engage in future planning.

Resolved: That the report be noted.

Reason: To provide the Committee with an update on the pace of academisation and the work taking place to meet the council's statutory duty to deliver sufficient school places in its area.

# 27. York Museums Trust (YMT) Scrutiny Review Update

Members considered a report that updated them on the progress with developing a new legal relationship between the Council and York Museums Trust.

Members noted that a further update would be reported at a future meeting and Members agreed to email any additional questions to the Assistant Director of Communities & Equalities.

Reason: To update Members the future legal relationship between the Council and YMT.

### 28. Work plan 2017/18

Members considered the Committees work plan for the 2017/18 municipal year.

Following discussion:

- The Scrutiny Officer agreed to consult with the Assistant Director of Education and Skills regarding the most appropriate time for the committee to receive an update on the interventions used to narrow the gaps.
- Cllr S Barnes agreed to email the Scrutiny Officer his proposals for undertaking a Youth Offending scrutiny review and the Scrutiny Officer would then confirm if the Children, Education & Communities Policy & Scrutiny Committee was the correct committee to consider it.

### YMT Report Against Core Partnership Objectives - July to December 2017

# Creation of museum and gallery provision capable of contributing to positioning York as a world class cultural centre

YMT was successful in its application to Arts Council England (ACE) to be granted National Portfolio Organisation status. As such, ACE has committed to contributing £1.2m per year to the Trust for the next four years beginning in fiscal year 2018-19. This recognition of the quality of YMT's programming, service and operations comes as competition for NPO status has increased and with some well-established museum services being denied this status and/or having their funding reduced.

YMT is creating a four-year Business Plan for the years 2018-19 to 2021-22 which indicates how the Trust will pursue and achieve the five headlines priorities from its Forward Plan 2016-2021. The Business Plan will update the Forward Plan and will specify aims and measurable targets for the teams within the Trust to realise our ambitions. One of the headlines priorities is the redevelopment of the Castle Museum and the Castle area. Planning for this initiative continues in close collaboration with CYC and the Castle Gateway Project. The appointment of an external project manager, a conservation survey and an options appraisal for the site are the next immediate steps to be taken in this process.

The Trust has received a number of awards including the following:

Visitor Attraction of the Year -- York Art Gallery (2nd year running), Visit York Tourism Awards Gold Award -- York Museum Gardens, Yorkshire in Bloom

*Excellence in Media Arts* -- Viking exhibition Virtual Reality (YMT and University of York Digital Creativity Labs), York Culture Awards

Blunt Prize -- Dr. Andrew Woods, Senior Curator Yorkshire Museum, for significant contributions to the field of numismatics, British Numismatic Society

At the time of writing this report, the YMT has also been shortlisted for the following Little Viking Awards: *Best Attraction* (York Castle Museum)

Best Christmas Experience (York Castle Museum)

Best Children's Festival (Eboracum Roman Festival, YMT)

# Provision that is a source of inspiration and enjoyment for all and a stimulus for learning and skills development

Much of the Trust's public provision is reported in a subsequent section below, including exhibitions and online and learning offerings. However, several examples are included in this section.

With HLF funding, YMT has commissioned the author Rebecca Manley's to write a bespoke, site-specific play, entitled 'These Walls,' drawing on the stories of the Debtors' Prison to bring characters to life and challenge audiences to think about issues of justice, human rights, debt and the rights of women. York Theatre Royal Youth Theatre will perform this exciting new work in March 2018.

YMT delivered several events as part of the York Food Festival in September, bringing opportunities for learning and access to YMT collections through this popular annual festival. Especially successful was 'Behind the Scenes at the Chocolate Factory' a talk at the Castle Museum by Mike Grimes, former Terry's employee.

In December YMT delivered a discovery day for secondary school, A level students at York Art Gallery. The day, a partnership with the University of Leeds, introduced young people to research skills and supported them in giving a series of presentations on artworks in the gallery.

In partnership with Reading University, we are developing a workshop for KS 2&3 based on research into the Ivory Bangle Lady, a bronze sculpture on view in the Art Gallery. The workshop will be based on gallery on the theme of diversity and migration in Roman York focusing on Ivory Bangle Lady, Septimius Severus, Lucius Rufinus. The session is likely to be delivered to the public during the Roman Festival in June 2018.

The quality of provision at YMT is reflected, in part, by the continuing increase in visitor numbers at the Trusts' sites, in particular, the significant increase in numbers at the Yorkshire Museum in response to the Viking exhibition. This is supported by the continuing level of four- and five-star reviews on Tripadvisor. More information on visitor numbers and customer service are provided later in this report.

# The protection and conservation of the collections, gardens and buildings for future generations including improved storage

Plans to address most of the Trust's remaining collections storage and management issues will be dovetailed with the Castle Museum project. The social history collection alone has c.350,000 objects, and this Designated collection is one of the best social history resources in the UK. The process of properly documenting the collection and making it accessible to staff, volunteers and researchers is ongoing.

An extensive programme of work on the trees in the museum gardens has commenced. This will entail reshaping some trees and clearing branches that are no longer viable. This is as part of a longer term strategy to conserve and maintain the safety of the trees in the Garden and to ensure that other planting is unaffected by excessive growth.

# Promotion of the city's museums and collections through a varied range of activities which could include exhibitions, displays, community projects, volunteering opportunities, formal learning for schools, informal activities for families, and adult learning

YMT presented an active, high-quality exhibition programme this year. Highlights include:

### York Art Gallery

Albert Moore: Of Beauty and Aesthetics (April – October)

The first monographic exhibition of York born artist Albert Joseph Moore since the memorial exhibition in 1894. The exhibition featured an impressive selection of Moore's paintings, watercolours and sketches, highlighting the beautiful and classical women for which the artist is most famous and demonstrated the modernity of his approach.

### Foundation Myths (August 2016 – November 2017)

Foundation Myths was the first installation ever to be commission for the Artists Garden site which provide the public with free access to works of art by accomplished artists. The installation was created by Charles Holland of Ordinary Architecture, an art, architecture and design practice with an international profile. The installation, produced especially for the Garden, drew on the rich history of the site and its many uses over the centuries.

### Aesthetica Art Prize 2017 (May – September)

A platform for innovation and originality, the Aesthetica Art Prize Exhibition invited audiences to engage with captivating projects from some of today's leading artists, both established and emerging.

### *Leisure Land Golf* (June – September)

Following a successful crowdfunding campaign, York Art Gallery brought Doug Fishbone's Leisure Land Golf to the Artists Garden.

### *Picasso Ceramics from the Attenborough Collection* (July – September)

York Art Gallery and the Centre of Ceramic Art (CoCA displayed highlights from the Attenborough Collection of ceramics created by one of the world's most famous artists.

### Marinella Senatore: York Symphony (From Sept)

Through a series of workshops and conversations collecting individual stories in York, Italian artist Marinella Senatore has created the York Symphony: an artwork that engages York's communities and culminates in a film on show in the Gallery. This new Evelyn Commission is a contemporary response to the historic Evelyn Award, a scheme which ran from 1950 until 1962 with the aim of bringing York's topographical collection up to date.

Paul Nash and the Uncanny Landscape: An Exhibition Curated by John Stezaker (From October 2017) Paul Nash's groundbreaking inter-war landscapes which transformed the genre of British landscape painting feature in this exhibition curated by artist John Stezaker at York Art Gallery. The exhibition also includes works by Stezaker including new landscapes created in response to the themes of the uncanny landscape. A private collection of rarely seen Nash drawings, paintings, photographs and ephemera is also on display.

#### Yorkshire Museum

*Vikings: Rediscover the Legend* (May – November)

This major new partnership exhibition with the British Museum was curated by YMT and brought together objects from the YMT and the British Museum: two of the most significant and internationally recognised collections of Viking Age treasure in Britain. The exhibition is now touring across the UK.

### *Medieval York: Capital of the North* (From November)

This installation explores how York became England's second city and how its fortunes rose and fell with its ties to the Crown and the Church. Through the finest medieval discoveries ever unearthed, including the Middleham Jewel, the Escrick ring and a Richard III supporter's Boar Badge, the latest metal detected finds and brand new research, this new display tells the only complete Medieval history of York in the city.

#### Castle Museum

Chocolate – York's Sweet Past (From April)

A dispersed exhibition delving into the history of some of the world's most iconic chocolates and sweets. The collections tell the story of York's key confectionary producers, including Rowntrees and Terry's, and explore how the Georgians, Victorians and the Jacobeans satisfied their sweet tooth.

#### York St. Mary's

*The Dark Self – Susan Aldsworth* (May – September)

Susan Aldworth's exhibition The Dark Self was inspired by her research into sleep during her three year residency at the University of York working with neuroscientist Professor Miles Whittington and art historian Professor Michael White.

#### Online visitors

Our digital practice plays a significant role in providing access to YMT collections. Presently we have more than 180,000 collections records and 50,000 openly-licensed images – making YMTs collection highly visible to digital audiences. In fiscal year 2017-18 we are on track to have over 700,00 unique visits to our collections pages online. Our partnerships with companies such as Google, Wikimedia UK and Sketchfab –

has resulted in YMT collections being viewed by approximately 24 million views on our collection items via those sites. These initiatives also further our headline priority to improve the Trust's profile through partnerships.

Our commitment to open licensing, allowing free access to and free re-use of a large proportion of our digital assets, also enhances access to our collections and intellectual property. YMT's approach has been lauded by the National Museum Directors' Council as the most 'radically open' institution in the UK. We have focused our efforts not only nationally but regionally as well, through the Museum Development Yorkshire network.

#### Learning and Volunteers

YMT's learning, volunteer and Yorkshire Museum curatorial teams took part in September's annual Yorkshire Fossil Festival in Scarborough. This high-profile, three-day festival was organised by Scarborough Museums Trust with funding from The Palaeontological Association. Participating institutions included; the Natural History Museum; Oxford University Natural History Museum; Leeds University, Hull University and Leicester University. YMT's activities for schools on Friday 22 September reached 120 children and 16 accompanying adults. The free family festival on the Saturday and Sunday attracted over 5,000 people.

Through its learning offerings, YMT reaches many school children and families both through specific programmes on aspects of the collections and through visits to our various sites. For the current fiscal year, we are on pace to serve 4,500 York school children who will participate in our programmes and 170,000 family programme participants. In total, over 100,000 children and young people will visit the museum this fiscal year.

An example of a more intensive, focused programme is the YMT's four-day Teenage Art School presented in July. A deliberately small number of students, eleven in this case, worked with four different artists producing sculpture, ceramics, paintings and collage. The sculptures, inspired by the wok of ceramic artist Kate Haywood, are currently on display in the Project Gallery.

YMT works in partnership with other local organisations to develop and strengthen its public programme. Two examples include:

- Ethnic Minority Support Services in Selby and York Refugee families have contributed stories inspired by buttons which will be included in a storytelling area in next year's CoCA Lucie Rie exhibition.
- YMT worked in partnership with York Theatre Royal, York Explore Libraries, York Minster and York Army Museum to deliver Arts Award Discover to local children through our family arts and craft activities over the summer holidays.

Since 1 July of this year, over 250 volunteers contributed 7,500 hours on 52 different activities throughout the Trust. Core projects such as costumed roles on Kirkgate increased as new volunteer offers came on line, and as a result of this, our volunteer Sewing Bee also expanded to meet the increased demand for authentic replica costume. The Sewing Bee have also supported the Chocolate and Shaping the Body exhibitions, by creating some authentic 'trying on' costumes for visitors, which were as wide ranging as giant Quality Street costumes to a complete Henry VIII outfit.

### Increased access to the city's collections, gardens and buildings and increasing visitor numbers, especially young people

Visitor numbers from 1 July to 18 December 2017 are very positive when compared to the same period in 2016:

The 'YMT Card' scheme, introduced in summer 2015, remains very popular:

- Over 50,000 'YMT Cards' have been sold to date
- There are currently 24,500 active card holders
- 55% of members are York residents, meaning 14% of adults within the CoYC boundary have purchased a YMT Card

# Recognition of the special significance of the museums and gallery for York residents through the maintenance of pricing incentives for York residents and opportunities for free access

The offer to York residents has been improved in partnership with York Explore. York Card holders can still use their cards as evidence of residence to purchase YMT Cards at half price and they are now also entitled to 20% off day tickets. Alternatively, residents without York Cards can use their Council Tax bill as evidence to gain the discount on YMT Cards.

The YMT residents open days proved popular in June 2017, with nearly 3,000 additional visitors across all the sites over the weekend. We look forward to participating in the Residents Festival again in Jan 2018.

# The facilitation of outreach activities and pricing mechanisms designed to encourage visits by those who do not traditionally use the museums or gallery

YMT's public programme of talks, workshops and events for adults continues to includes regular sensory tours, particularly suitable to those with a sight impairment, and monthly practical, inclusive Arts for well-being sessions. Dementia, autism and deaf awareness training has been introduced for staff, and 'relaxed openings' have been introduced for people with sensory impairments.

Admission for children is free of charge at all YMT sites. Previously, thanks to a contribution from CYC, residents aged 17-24, those entitled to most forms of income related benefit, carers and community groups in excluded categories could get a YMT Card free of charge. Once this allocation was expended, the YMT decided to continue providing this benefit.

As part of the Culture & Wellbeing York project funded by City of York Council, YMT has been commissioned to support the work of the cultural sector and improve health and wellbeing outcomes in York by offering opportunities to engage in activities normally out of reach. During the period addressed in this report, the following actions have been taken:

- Creation of a 'Cultural Menu' comprising a broad range of cultural opportunities designed to improve health and wellbeing under development
- Supported the delivery of 'Cuppa and a Chorus' by the National Centre for Early Music. This programme helps reduce isolation and hopes to improve both lung and mental health
- Continued to build a referral network using the Social Prescription Service (Priory Group GP practices) and Local Area Teams
- Submitted a full application to Arts Council England's Celebrating Age programme. If successful, this would secure additional funding to support the engagement of cultural organisations with older people in the city

### **Excellent customer service and visitor experience**

The Trust has again taken part in the Visit England Visitor Attraction Quality Assurance Scheme. Results from the mystery visits undertaken in Summer 2017 show an improvement at all sites, with all site's scores now being over 80%--the Art Gallery being the best performing with an overall score of 89%. The three sites maintain their positions in the York Tripadvisor ratings, being ranked 2<sup>nd</sup> (Castle Museum); 8<sup>th</sup> (Yorkshire Museum) and 11<sup>th</sup> (York Art Gallery) at present.

In order to accommodate visitors with access issues, the Trust has sent Front of House staff on training for working with such visitors, and we have produced information packs on how these visitors can make the most of their visit to our sites. In order to evaluate our progress in making all the sites more accessible, the Trust engaged a mystery visitor who is a wheelchair user and access consultant. Following his visits, the mystery visitor produced a report which highlighted the friendly and confident manner in which the staff engaged with him and his party. He also commended the information provided to enable a wheelchair user to best take advantage of the Trusts' offerings.

# Active international partnerships to enhance public programmes, to increase YMT's and the city's reputation, and to raise funds

One of the Trust's aims is to share our collections and expertise with regional, national and international audiences. One example of an initiative in the last six months which has furthered this objective is the Trust's partnership with the British Museum, referenced above. The exhibition, *Vikings: Rediscover the Legend* presented star objects from the British Museum featured alongside the Yorkshire Museum's world class collections, with new interpretations to give a fresh perspective on how the Vikings shaped every aspect of life in Britain. The exhibition debuted at the Yorkshire Museum, is now showing in Nottingham and will travel to Southport. The exhibition also allowed the Trust to showcase its Digital Narratives for Archaeology Research (DiNAR) Project, a joint research project led by the Centre for Digital Heritage, Digital Creativity Labs and York Museums Trust. The exhibition was the first major output of the project comprising of a cinematic VR experience showing immersive vignettes of what life in the camp of the Viking Great Army at Torksey in Lincolnshire could have looked like.

# Retention of registered museum status and development of the designated collections to ensure maximum public benefit

Continues. YMT now formally provides expert support and advice to other museums in the region which are seeking to renew or gain accredited museum status.

YMT has received a grant of over £71,000 from the ACE 'Designation Development Fund' to support research into the Roman collections managed by the Trust. As a result of this investment, we have been able to enrich object information with some of the latest research into York during the Roman period. During summer 2017 the we ran a conference bringing together leading academics and museum curators to explore and identify opportunities for current and future research. This will help inform the redisplay of Roman collections at the Yorkshire Museum over the next couple of years. The investment will also have a more immediate public benefit by increasing the number and quality of records available online.

# The maintenance of the Museum Gardens on the Register of Parks and Gardens of Special Historic Interest maintained and the register of botanical gardens

As referenced in the first section above, York Museum Gardens won another Yorkshire In Bloom Gold Award in 2017. York Museum Gardens will be an active member in the forthcoming 2018 Bloom! Festival.

# Effective, open and transparent governance including effective access and equalities policies covering trustees and staff recruitment practices

As part of its new Business Plan, the Trust is updating its Equality Action Plan (EAP) for the years 2018-19 to 2021-22. Through the EAP, YMT aims to champion diversity throughout the Trust, with a focus on improving representation and inclusion within our audiences, communications, programme and workforce.

The YMT's Equality Action Plan will be monitored by the Trust's Senior Management Team (SMT). The SMT reviews progress against plans each quarter and ensures that the organisation is on track to achieve its objectives. The YMT Board also monitors progress against plans and policies at their regular board meetings, held six times per year. The Success Indicators in this plan will be incorporated into the organisation's KPI report which is monitored by the board on a quarterly basis.

We run fair and transparent selection processes for both Trustees and staff. Trustee vacancies are advertised and board diversity is an important consideration in recruitment. For staff posts, HR representatives are present on each interview panel, questions are submitted to HR in advance and all candidates receive the same information and are asked the same questions. The system of Personal Development Reviews means that routes to training are also open and fair.

# 2017/18 Finance and Performance Second Quarter Report – Children, Education & Communities

## Summary

This report analyses the latest performance for 2017/18 and forecasts the financial outturn position by reference to the service plans and budgets for all of the services falling under the responsibility of the Corporate Director of Children, Education & Communities.

## **Financial Analysis**

2 A summary of the service plan variations is shown at table 1 below.

### Children's Specialist Services (+£149k / 0.7%)

- 4 Children's Social Care (CSC) staffing budgets are currently projecting a net overspend of £115k, mainly due to relatively expensive agency staff being used to cover important but hard to fill social worker posts. In light of this, and as reported to Staffing & Urgency Committee in July, additional unbudgeted costs of £59k will be incurred this year paying 'golden hello' and 'golden handcuff' payments to new and existing staff in the referral and assessment team, along with a major social work recruitment advertising campaign estimated at £30k.
- Based on the current numbers of Looked After Children (LAC) being maintained throughout the rest of the year there is a net projected overspend on placement costs of £200k, including +£192k on local fostering, +£89k on Inter Agency Adoption Fees and +£161k on Adoption and Special Guardianship Order allowances. This is offset by a net projected underspend of £176k on out of city placements and £66k on Leaving Care costs.
- There is a net projected overspend of £93k within The Glen and disability short breaks budgets, due mainly to delays in implementing the new model of provision for children with the most complex needs that was planned to deliver a budget saving in 2017/18.
- Within the Dedicated Schools Grant (DSG) funded Special Educational Needs budgets there is a net projected underspend of £328k. This is mainly due to savings on out of city education placements in light of the on-going efforts to support as many young people as possible in York.
- 8 Education Psychology budgets are projected to underspend by £43k mainly due to difficulties being experienced in recruiting to some psychologist posts. A number of other more minor variations make up the remaining projected net overspend of £23k.

# Communities & Equalities (+£12k / 0.3%)

9 There are currently no significant variations to report.

# Education & Skills (-£194k / 1.9%)

Local Area Teams budgets are projecting a net £349k underspend, mainly due to the early delivery of the full £1.4m saving in advance of the final £300k budget being removed from 2018/19. There is a net projected underspend of £97k within School Improvement due to a number of staffing vacancies, particularly within the Skills Team, but offset by some additional costs including for the LAC virtual school headteacher.

11 Home to School Transport budgets are currently projected to overspend by a net £274k. There are significant pressures within SEN taxi budgets where contract inflation has been higher than expected, and additional costs may be being incurred as more high needs pupils return to the city as a result of the Make York Home project, resulting in not all of the savings planned for 2017/18 being delivered. This is partly offset by some small additional savings on mainstream school bus contracts. A number of other more minor variations make up the remaining projected net underspend of £22k.

## Schools Funding & Assets (+£316 / 4.6%)

- 12 The net projected variation is made up of the following items:
  - a carry forward of surplus DSG from 2016/17 that is £266k higher than budgeted for,
  - a projected saving of £350k on prudential borrowing repayments as the provision set aside following the closure of Burnholme Community College has not yet been committed;
  - a projected £250k write off of school deficits for schools converting to sponsored academy status;
  - a revised projected surplus carry forward of DSG into 2018/19 of £682k.

## Director of CEC and Central Budgets (+£111k / 2.4%)

13 Following the early delivery of some budget savings, there is additional pressure on the directorate's £100k budget for early retirement and redundancy costs. Although the majority of the costs will be more than offset by the savings achieved, a one off over spend of £150k is forecast for 2017/18. A number of other more minor variations make up the remaining projected net underspend of £39k.

# **Performance Analysis**

### **Number of Children Looked After**

- 14 There were 195 children and young people in care at the end of September 2017. This evidences a continued consistency of practice and need, against the national trend of increasing looked after numbers.
- The stability of placements of children and young people in care has shown consistent improvement over the last three years, with the number of children experiencing three or more moves of placement falling to 4% by the end of Q2 from nearly 12% in 2014/15.
- 16 In line with national trends, York has been facing challenges with recruiting foster carers and has launched a new approach to encourage people to foster. Partnership working with 'You Can Foster' has improved enquiry rates, with 36

enquires received in Q2 2017/18 compared to 10 enquiries during the same period last year.

# Average Progress 8 score from Key Stage 2 to Key Stage 4

- 17 Progress 8 is a measure of the progress made by pupils between Key Stage 2 and selected subjects at GCSE. It is calculated for every pupil and progress in English and Maths is double weighted. A positive score represents progress above the average for all pupils and a negative score progress below the average for all pupils.
- 18 In 2017, the average Progress 8 score for Year 11 pupils was slightly above the national average and an improvement on 2016. Provisional results show that York compares well with regional results.
- 19 Building on the success of our six school primary writing project, which contributed to improved Key Stage 2 outcomes in 2017, we joined Pathfinder Teaching School Alliance and Huntington Research School in a bid for funding to the DfE Strategic School Improvement Funding for a larger project starting in January 2018. The bid was successful and realised £196k to deliver a programme of intensive training and support across at least 14 schools this year. The project will expand to include a further group of schools in 2018-19.

# %pt gap between FSM and non-FSM pupils at 15, who attain a Level 3 qualification by the age of 19

- Attainment at age 19 remains generally positive however there have been concerns about the outcome gap between both disadvantaged young people and young people with Special Educational Needs (SEN) and their peers. Latest figures from April 2017 show the attainment gap is closing in some areas and, to address remaining challenges, Further Education providers will be worked with and strategically supported by the council to sustain focus on these groups.
- In addition, Learning and Work Advisers from the council's Local Area Teams will provide specialist information, advice and guidance to young people who are in the care of the local authority, those in alternative education provision, those in the youth justice system, and those aged 16-18 who are Not in Employment, Education or Training (NEET). Appointments and group work will be available at locations across the city based on local need and will complement the careers guidance and support provided through schools and other education providers under their statutory duties.

#### **Voice and Involvement**

22 The Youth Council have drafted and agreed a new constitution which includes three distinct work groups focusing on campaigns, consultation and

engagement. Elections have also taken place for the positions of Chair, Vice Chair and Treasurer. Training has been undertaken focusing on consultation with CYC and the Future Plan/Key Decisions. The consultation group will take an active role in providing an offer of consultation and the views of young people on key decisions that affect young people in York. The Youth Council will be carrying out a review of their constitution at the end of November and will make any necessary changes.

- A 'Make your Mark' ballot has been completed this year and for the first time, in addition to secondary schools, colleges and targeted groups have also been consulted. 'Make your Mark' is a national ballot where young people across the country are asked which issues matter most to them, in order to determine what is debated by the UK Youth Parliament (UKYP) in the House of Commons on 11th November. These groups included Show me that I matter, the Virtual School, Danesgate, York Learning, YOT, York and Askham Bryan College, the Apprenticeship Event, 30 Clarence Street and Young Carers.
- The Primary Voice event was held at City of York Council on June 26 with children from 18 primary schools present. Discussions between local councillors and the schoolchildren covered a wide variety of topics, from how the children would manage the council budget to their ideas on parks and school meals. The report has been fed back to Councillors and was well received. A Secondary Voice event has been arranged for Wednesday 15th November and will include opportunities for the Young People to again meet with Councillors from each of the three main parties as well as opportunities to consult on the York Central Project, The Healthy Child Service and this years York Youth Council campaigns.

### **Council Plan**

25 This report is directly linked to the three key priorities of the Council Plan for 2015-19: A Prosperous City for All; A Focus on Frontline Services; and A Council that Listens to Residents.

# WW1 Commemorations 2018 Scrutiny Review Draft Final Report

## Summary

 This draft final report presents the findings of the Scrutiny Review into the city's plans for commemorating the centenary of the end of World War One (WW1). The Committee are asked to consider and endorse the Task Group's draft recommendations ahead of this report being presented to the Executive on 25 January 2018.

# **Background**

2. In March 2017 Council considered a Motion proposed by Cllr Steward which stated:

'Council notes that 2018 will mark 100 years since the ceasing of the hostilities in the Great War;

Council recognises that residents of York will wish to commemorate this event and to express their appreciation to all who sacrificed so much during that conflict;

Council therefore invites the Leader and Deputy Leader to set up a working group to coordinate a series of commemorative events for next year, such working group to include, at their discretion, councillors, officers, civic leaders, organisations representing the armed forces and similar groups; artists and residents. The working group will plan an overall strategy for the council's commemoration activities, determine and address its funding needs as the steering group deem appropriate. Council further instructs that the working group should ensure that the programme of activities fully reflects the following:

- The horrors of war, including the suffering caused by the 37 million military and civilian casualties during the First World War;
- A diversity of perspectives on the causes and consequences of the war;

- A commitment to learn the lessons of the past to help build peace in the future.'
- 3. Council agreed a Member Working Group should be formed to carry out the coordination work as described in the Motion above. However, by late July 2017 a Working Group had yet to be formed and so mindful of the limited time available, this Committee agreed to form a Scrutiny Review Task Group to progress the required work.

#### **Information Gathered**

- 4. The Task Group made up of Cllrs Steward, Mason, Taylor and Wells met for the first time in August 2017. The Assistant Director (Communities & Equalities) provided information on previous events and commemorations that the Council had facilitated e.g. the 50<sup>th</sup> anniversary commemorations for Victory in Europe and Victory in Japan, and the annual Holocaust Memorial Day, including the budget requirements for those events.
- 5. In addition, the Task Group discussed some of the many events and exhibitions that had been held across the country or that had been ongoing since 2014 to commemorate WW1 and/or mark the centenary of its start. For example, York Museums Trust had an ongoing 1914-1918 exhibition.

### Consultation

- 6. The Task Group agreed any plans should involve as many residents and citywide organisations as possible. They also agreed it would be useful to understand what if any plans were already in place across the city, and agreed to write to a range of organisations to gather their views and record their plans. - 7. A number of the organisations provided an initial response. In addition, the Task Group issued a press release and used the Council's social media channels to advertise its work. This generated further feedback from the public.
- 8. See Annex A for a summary of feedback received.

# **Analysis**

- 9. The Task Group were pleased to note the level of interest that their initial communication had generated and the amount of positive feedback they had received which included some details on plans already in place for 2018 and ideas for additional events.
- 10. The Task Group agreed that the Council's primary role should be to facilitate the coordination of a programme of events organised by others, and help in the promotion of those events to residents and visitors. It was agreed that this should include the production of both a printed programme as well as web-based information.
- 11. The Task group agreed that the programme should focus on the period between 1 October 2018 and Armistice Day on Sunday 11 November 2018, culminating in a civic ceremonial procession, a laying of wreaths and a service in the Minster.
- 12. The Task Group agreed that the Council should seek to facilitate a programme that, in addition to a civic component, includes contributions from:
  - The military
  - The business community
  - The city's faith communities

- 13. The Task Group noted that there are a number of potential civic contributions to the programme including use of the Mansion House. This might include exhibiting items from the WW1 period from within its historic collection and displaying information on:
  - the civic party of the time
  - how the Mansion House was used during the war
  - the Council and the city's contribution to the war effort
- 14. The Task Group agreed that the work would require a budget of £10k, the majority of which could be used to procure the services of an event organiser to carry out the work associated with the production of a programme and any costs associated with the activities proposed in paragraph 12 above. The Task Group therefore drafted a brief for the post for the Committee's consideration see Annex C.
- 15. The Task Group agreed that the remainder of the budget could be used to support the involvement of the Mansion House and/or any other emerging ideas.
- 16. Finally, the Task Group suggested that a Reference Group be formed to support the Event Organiser in their work. They agreed the Group should include the AD for Communities, Culture & Public Realm with a number of CYC Councillors and representatives from those external bodies who have expressed an interest in being involved see consultation feedback.
- 17. To further explore and develop the ideas generated as a result of the Task Group's publicity and to recruit to and establish the Reference Group, the Task Group agreed that an open meeting should be held at the end of January.

# **Options**

18. The Scrutiny Committee may choose to either endorse the draft recommendation contained in this report or identify alternative recommendation(s) for presentation to the Executive.

#### **Council Plan**

19. As part of the review the Task Group sought the views of a range of partner organisations, community groups and children and young people thereby demonstrating the Council's commitment to listen to residents,

which is one of the Council's corporate priorities, as set out in the Council's Plan 2015-19.

## **Implications**

- Financial The financial implications associated with the recommendation arising from this review and detailed in paragraph 13 above.
- 21. There are no other known HR, Equalities, Legal, Crime & Disorder or other implications associated with the review recommendations listed at paragraph 20 of this report.

## **Risk Management**

22. There are no known risks, associated with the recommendations arising from this review.

#### Recommendations

- 23. As a consequence of their review, the Task Group agreed to recommend that:
  - i. The Executive provide a budget of £10k to enable the procurement of an event organiser to develop and promote a programme of events to commemorate the end of WW1, in line with the brief shown at Annex C.
  - A Reference Group be set up to support and steer the work of the Event Organiser, with its membership as suggested in paragraph 15 above.

Reason: To ensure the City reflects the appreciation of its residents to all those who sacrificed so much during the conflict, and to conclude this review in line with scrutiny procedure and protocols.

Thank you for your e-mail regarding plans for the commemoration of the 100th anniversary of Armistice Day on 11 Nov 2018.

I would be pleased to see what others are planning and a round table meeting sounds like a good way to do this. Delma Tomlin, from NCEM, called a meeting some years ago about WW1 and has built up an archive so she would be a good contact to start the conversation. delma.tomlin@ncem.co.uk

In our churches, we have started to formulate and implement some plans for the anniversary:-

- 1. York Peace Bells these are already in position at Holy Trinity Goodramgate, St Paul's Bookshop and in theMerchant Adventurers' Garden (the latter will be moved to Holy Trinity Micklegate soon). Information attached. Nearer the time, we will put information about the WW1 bell story beside the bells.
- 2. We have bought banners with the poppy emblem for the lantern at All Saints Pavement. These were installed in 2017 and have now been taken down. We will use them again in 2018
- 3. We have launched a Poppy Project asking people to make poppies and keep hold ofthem until Sept 2018. At that point we will bring groups of people together to attach the poppies to camouflage netting. The whole of the outside of All Saints Pavement Church will be covered with the netting and poppies with sandbags around the base to make an art installation for 30 days leading up to 11 Nov 2018. E mail address is Poppies 2018@aol.com Knitting/crocheting patterns can be found on All Saints Pavement website <a href="https://www.allsaintspavement.org.uk/poppy-project-2018.html">https://www.allsaintspavement.org.uk/poppy-project-2018.html</a>

This is in partnership with York Press, RBL York Branch and the families of the three young men remembered in the Afghanistan Window in All Saints Pavement. We are hoping that people will embroider names on to the poppies of family members or friends who died or were injured in WW1 and all conflicts/wars since then to link WW1 with Afghanistan. <a href="http://www.yorkpress.co.uk/news/15634535.Spectacular\_poppy">http://www.yorkpress.co.uk/news/15634535.Spectacular\_poppy</a> installation planned for Armistice centenary/ More publicity will be done in Jan 2018 and continue through until Nov 2018.

- 4. We have researched the names of those who are commemorated on the memorial boards in our churches. This information will be made available for public viewing in our churches in 2018.
- 5. Plans are in place for the 2nd Annual Peace and Reconciliation Lecture in June 2018. We are hoping that Pastor Robert Pfeiffer and Pastor Annegret Wegner-Braun from Marienkirche in Lubeck, Germany will be with us to have dialogue.
- Those named in the WW1 memorial book in St Martin Coney Street are being remembered by name in church services, on the anniversary of their death. This has been in place since 2014 and continues.
- 7. Holy Trinity Micklegate has educational information panels about WW1 on display in the church and joined in with the Micklegate businesses initiative to display wooden and knitted poppies along Micklegate.
- 8. We are planning Remembrance Day services or Acts of Remembrance for all of our churches to include silence at 11am on 11.11.18 and bell ringing that day to announce the 100th anniversary of the Armístice. The content for St Helen and St Martin will depend on the city's plans eg if a huge event is planned in the city centre.
- 9. We are planning services of music and readings in some of our churches on the eve of the Armistice (Sat night)
- 10. We are considering the use of All Saints Pavement Church for the 30 days during the Poppy Project installation. This could be in partnership with others to provide a programme of lectures, music, readings etc.

Other thoughts:-

a. I have been impressed in 2017 by the use of the words of in Flanders Fields which were marked out in poppies in several locations across the UK. Could something similar adorn the grassed areas of the walls of York?

- b. Falso wonder how the stories of local families carribe told eg. the 10 Calpin brothers who went to war in WW1 <a href="http://www.bbc.co.uk/news/av/uk-england-york-north-yorkshire-27622656/york-s-calpin-brothers-hailed-as-ww1-heroes">http://www.bbc.co.uk/news/av/uk-england-york-north-yorkshire-27622656/york-s-calpin-brothers-hailed-as-ww1-heroes</a>



The Defence Of the Realm Act forbade the ringing of some church bells during war time – this project asks people to ring a bell for peace to commemorate the 100th anniversary of WW1.

With permission of The York Bell Fund, three remaining bells from the old church of Holy Trinity



Chamberlain's of London circa 1440. These bells would have been heard by Saint Margaret Clitherow and by the butchers in the Shambles.



Rev'd Jane Nattrass is chaplain to the York Gild of Butchers who agreed to support the project. The link with Holy Trinity, Micklegate is apt because the Gild now meets in Jacob's Well, Holy Trinity, Micklegate's hall. Butchers were reserved occupations during wartime so it is pleasing that the Gild can be part of a peace bell project.

#### Aims:

- To enable the people of York to reclaim their connection with part of their heritage by telling the story of the bells and history to those who live here.
- To allow access to 15th century bells and bring them back into use.

- To assist in providing a City wide project which will be a legacy in the City of York commemorating the 100th anniversary of WW1.
- To bring back into use an empty bell tower for the benefit of the community and to engage with the heritage of York's only remaining priory church. It is hoped that the bells will find a permanent home in a church in York with three new bells. They will be known as York Peace Bells commemorating the 100th anniversary of WW1.


The bells were founded by William Chamberlain c. 1440 each has a latin inscription:

SANCTA MARGARETA ORA PRO NOBIS Located St Paul's Bookshop (St Margaret, pray for us)

SIT NOMEN DOMINI BENEDICTUM Located at Holy Trinity Goodramgate (Blessed be the name of the Lord)

ETERNIS ANNIS RESONET DOMINIS JOHANNES Located at Merchant Adventurers Hall Gardens (Through eternal years, let John resound for the Lord)

Thank-you for your email regarding WW1 Commemorations in 2018. We would be keen to work with other groups and organisations across the city with regard to WW1 Commemorations in 2018, and would be happy to attend any round table meetings if required.

The York Army Museum current plans for commemoration include a new HLF funded project Impact: First World War Legacies , details below:

The York Army Museum has recently received £6300 from the Heritage Lottery Fund for an exciting new project, Impact: First World War

Legacies , through HLF's First World War: Then and Now programme. The project will focus on exploring the experiences of Yorkshire soldiers when returning home to Yorkshire, and the efforts made to memorialise those who did not. This project involves discussion of soldiers' return to the UK and will work to support school and community groups explore war memorials in their areas, and research soldiers appearing on them. The project will result in greater awareness and understanding of the diversity of those who fought in the First World War and how the conflict affected the local area after its conclusion. We are offering free workshops and resources to local school and community groups to help document war memorials that are housed within buildings and areas they use. The outcomes of this project will be a temporary exhibition hosted at York Army Museum and a database compiling information regarding the local war memorials documented and the soldiers who are documented on them. The information generated on this database will be available through the exhibition and also in the archive and via the website of York Army Museum.

We will also have a programme of talks and activities throughout the year.

#### Other Suggestions

1. One thing which might prove useful would be a central website or printed leaflet which draws together key details of the various events planned across the city. We have approached the Minster, Mansion House, NRM and Bar Convent about liaising to produce joint information aimed at schools and youth groups which simply gives details of the themes/topics in relation to WW1 which each organisation is concentrating on during 2018 so it is helpful for teachers, planning and information purposes, perhaps something like that would be useful but on a bigger scale.

Such an event with an emphasis on WWI history could allow people across the city to share stories, learn how to look after their documents and artefacts and create a community led exhibition which could be displayed at various venues across the city.

The total recorded losses for the First World War were 2,479 ships and 14,287 seamen plus 675 vessels of the fishing fleet and 434 seamen. There were many more seafarers who died ashore and were not commemorated. They had to die at sea to be commemorated even whey they were hospitalised because of their wounds. They were also off pay when their ships were sunk. They actually had to die at sea to be commemorated.

The men, women and boys who were lost at sea during the First World War included lads such as Redan Sydney Jeffries (aged 13) of Lowestoft, presumed drowned on 24th October 1917. Redan was a Cook aboard the fishing vessel Vanguard. More than twenty-nine Boy seamen aged only 14 lost their lives for their King and Country. At the other end of the scale were men long overdue for retirement who insisted on "doing their bit" and who paid the ultimate sacrifice. Men such as A.B. Patrick Casey, aged 73, killed when the S.S. Dotterel was sunk by a mine off the French coast on 29th November 1915....they were the forgotten heroes, their lines of support were never










### Hi Richard

I understand Dawn has spoken to you about my ongoing scrutiny review to consider the city's commemoration of the centenary of the end of the First World War.

The Scrutiny Task Group are planning to recommend that the Executive provide a budget of approx £10k to fund the procurement of an external consultant to develop and promote a programme of events (provided by others) during the period of 1 Oct -- 11 No 2018, which culminates in a civic ceremonial procession, a taying of wreaths and a service in the Minster (the usual remembrance day shenanigans).

The Task Group are expecting that the majority of the £10k will be required for that procurement but have suggested that the remainder be used to support a Council contribution to the programme of events in the manner of utilising the Mansion House throughout the period of the programme to:

- the Council and the city's contribution to the war effort



# THE GREAT WAR - CENTENARY COMMEMORATIONS 2018

A soldier and a young girl get trapped in a trench. They discuss duty and what is right or wrong in a war, but when an enemy is captured by the soldier everything is going to change.

"My Tender Trench" was nominated for best play at the Tehran Theatre Festival 2016 and received wide applause from the audience. Also was recently the subject of a seminar at the University of North Iowa.

"MY TENDER TRENCH" is a high quality production written by the EMMY winning writer, JR Villar.

Considering that next year we are commemorating the Centenary of the end of the Great War, I'm intending to put into stage.

The play has minimum production needs and can be performed in open air (as a summer production, for a more realistic setting) as well as a studio performance

The original script is suitable for 15 Years and above, due to some strong language, adult subjects and some upsetting visual scenes, obviously related to the theme of the war.

The performance also has space for musical moments in scene transition. Other community groups (for example, choirs) can be incorporated in this transitions and turn it in a more diverse and inclusive event. ## WW1 Commemoration in York

Further to the article in the Press, I am writing to say that Fishergate, Fulford and Heslington Local History Society will be interested in supporting these commemorations.

You may already be aware that our Society has researched the lives of the men named on WW1 Memorials in our area and we have held a number of events, including an exhibition involving other local groups and speakers at the Cemetery Chapel.

Since the start of the commemorations, we have published three booklets on the lives of the 86 men named on the memorial which stands outside St Oswald's Church in Fulford.

In November this year, we published a similar booklet on the seven men named on the Heslington Church Great War Memorial Window and we held a very moving event in front of the window, where seven people from the village read sections from the biographies, written in the first person. These were interspersed with passages describing the village these men would have known.

We have almost completed our research into the lives of the 87 former pupils of Fishergate School who are named on the memorial plaque in the entrance to the school. We will present this research in a booklet which we plan to 'launch' at an event at the school in November 2018, where we hope to

attract parents and former pupils to hear some of the men's stories and view our exhibition.

We propose to publish the Fishergate School booklet as a single volume, but because so many men are included in one volume, printing will cost approx. £20 per copy. We are therefore seeking grants to enable us to sell the booklet at an affordable price of £10.

We anticipate that printing 50 copies, so we are seeking a grant of £500.

Can the WW1 Commemoration Project help us?

Would the Project like to be involved in presentation of the research on these men?

I hope you find our work of interest and look forward to hearing from you.

### WW1 Commemorations 2018

The Council notes that 2018 will mark 100 years since the ceasing of the hostilities in the Great War. Whilst all those that fought in the war have sadly now passed away and those who lived through it are now few in number, it is vital we continue to remember those that died in WW1 and those that have subsequently died in defence of our nation, and to educate people for the future. The Council would therefore like to ensure that a programme of activities take place across York which will enable the residents of York to express their appreciation to all who sacrificed so much during that conflict.

The key objectives for this will be to:

- i. Fully reflect the:
  - The horrors of war, including the suffering caused by the 37 million military and civilian casualties during the First World War;
  - A diversity of perspectives on the causes and consequences of the war;
  - A commitment to learn the lessons of the past to help build peace in the future.
- ii. To commemorate the 100 year milestone

The Council is looking to develop and promote a programme of events commencing on Monday 1<sup>st</sup> October 2018 and culminating on Sunday 11 November 2018.

The event organiser will be required to:

- Develop a programme in consultation with partner organisations, faith groups and other interested parties
- Liaise with businesses and other civil society organisations in York to ensure contribution to the programme
- Liaise with Council departments as appropriate to develop the programme
- Provide event management for any directly delivered components of the programme including risk assessment, liaison with the Safety Advisory Group, etc.

Elements of the programme that would be expected:

A military contribution: This would include but not limited to a military parade with tri-service representation as part of the Remembrance Sunday Procession.

**A business contribution:** Activities and one off events from a range of organisations that demonstrate appreciation of those who sacrificed so much during that conflict and its effect on the city and its residents.

A council contribution: A special exhibition /event in the Mansion House throughout the period.

**A civic contribution:** This would include but not limited to the Remembrance Sunday Procession, laying of wreaths and attendance at the Remembrance Service at York Minster on 11 November 2018.

The Council's maximum budget for the development and promotion of a programme of events is £10k

Interested parties are asked to submit proposals by 28 February 2018 setting out:

- Their initial proposals for the programme (accepting that this will develop through consultation and engagement with partner organisations)
- A budget breakdown indicating days required and the charge per day
- A statement concerning relevant experience with specific reference to relevant experience of the armed forces community
