#### 5. ACTION REVIEW

Following a meeting attended by Cllr Whitfield and the Clerk with the Chairmen of Askham Richard and Askham Bryan Parish Councils, a letter has been sent to the Chairman of the Governors of Askham Bryan College to try to find a constructive way forward in tackling a variety of anti-social behaviour problems experienced by residents of all three villages.

The Parish Council is reminded of its commitment to install a commemorative bench, Or similar, in memory of those residents whose lives have been lost during the Covid pandemic. This could be linked with the tree planting project.

# 7. RECREATION CENTRE- Application for grant aid

#### 8. SCHOOL SWIMMING POOL

It was AGREED that the Clerk should write to the Chairman of the Governors to ask what alternative use they are proposing for the building which was a gift to the School from the village community many years ago.

#### 9. YOUTH CLUB and HOWELL HALL

Following on from Cllr and Mrs Auton's declared intention to step down from managing the Youth Club, it now seems that the one remaining Youth Leader is very keen to keep the Club going and has made an appeal for new Management Committee members. Three potential Youth Leaders have been also been identified.

#### 10. YORKFIELD LANE

The final decision of the Inspector on the Public Right of Way is still awaited. A piece outlining our intentions and vision for the whole of Yorkfield Lane will appear in the September edition of the Newsletter, and will also go on the website.

#### 12. COPMANTHORPE WARD

Cllr Carr has observed a good deal of "re-wilding" of gardens in recent weeks. The Scouts are meeting with Dave Meigh, CYC, to discuss whether some of the verges could be re-wilded in a similar way, having in mind the safety of road users and pedestrians.

Cllr Carr has been approached by the Friends of Copmanthorpe School for funding towards the purchase of a polytunnel. (A formal application for funding from the Parish Council has also been received). No formal quotes or estimates have yet been obtained, and more information is required before any decisions can be taken.
