We would be grateful if you could provide us with, as a Freedom of Information Request, details of any complaints that have been made in respect of public nuisance over the last 4 years (whether that be noise, smells, lighting etc) by businesses or local residents in respect of the Grays Court Hotel, Grays Court, Chapter House Street, York, YO1 7JH. We would also be grateful if, when you reply, you could confirm from how many different addresses these complaints have come from. We are not asking for the addresses themselves but, rather, simply the number of different addresses these complaints have come from over the last 4 years. If 4 years is too long a period, then perhaps you can provide us with as long as you are able to do so within the costs restrictions that we know you need to operate within.

The following is a summary of relevant complaints over the last 4 years:

29.4.22 – two different addresses complaining about afternoon music outdoors at a wedding. No breach of licence or statutory nuisance.

17.1.22 - one address complaining about noise, smoking and light nuisance. No breaches or statutory nuisance confirmed.

24.8.20 - one address complaining about noise and light nuisance – the issue was resolved, therefore no breaches and not a statutory nuisance.

22.8.18 – one address complaining about noise from bottle collections waking

them at 8.20 a.m.

In summary we received 4 complaints from 2 different addresses over a 4 year period. There have been no instances of any public or statutory nuisance confirmed as a result of any of these complaints.
