Scheme objectives

To improve the existing infrastructure :

- Drainage, street lighting and road resurfacing

To support and encourage people to :

- walk, cycle and to use the bus

To improve the safety, convenience and attractiveness of the Tadcaster Road corridor

To improve the York economy

Scheme Proposals

Highway Maintenance

- Improved drainage system
- Street lighting renewal
- Road resurfacing

Pedestrians

- 3 new pedestrian signalised crossings
- Widening of existing refuge islands
- Footway resurfacing
- Targeted footway widening

Cyclists

- Wider cycle lanes
- Green coloured surfacing at side roads
- 'Light segregation' (cycle) bollards
- Low level cycle signals
- Bus stop bypass opposite Slingsby Grove shops
- Localised section of raised (stepped) cycle track between The Horseshoes and Slingsby Grove
- Bus stop bypass for cyclist with segregated cycle track northbound adjacent to Tesco
- Improved pedestrian/cycle signal controlled crossing at York College
- Widened footway adjacent to Dringhouses Cemetery to reduce existing

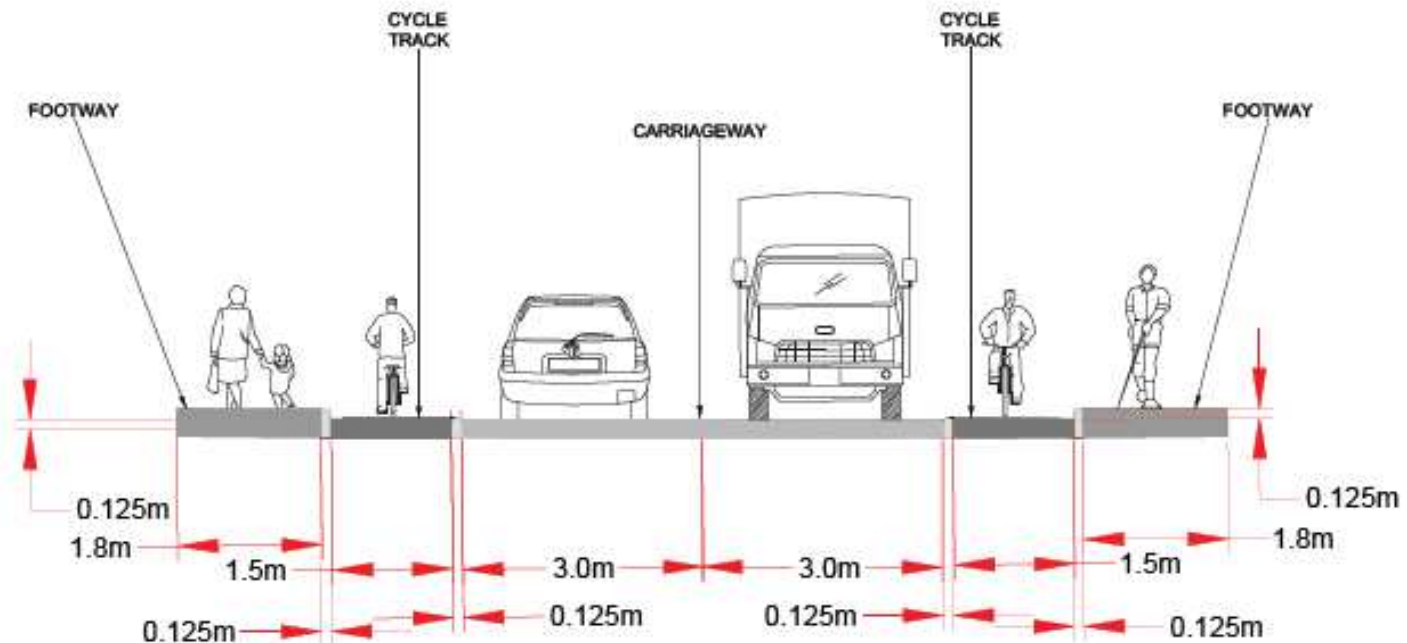
CYC hierarchy of transport users

- i. Pedestrians
- ii. People with mobility problems
- iii. Cyclists
- iv. Public transport users (includes rail, bus, coach and water)
- v. Powered two wheelers
- vi. Commercial/business users (includes deliveries and HGV)
- vii. Car-borne shoppers and visitors
- viii. Car-borne commuters

Tadcaster Road / Slingsby Grove shops : 2022 scheme proposal

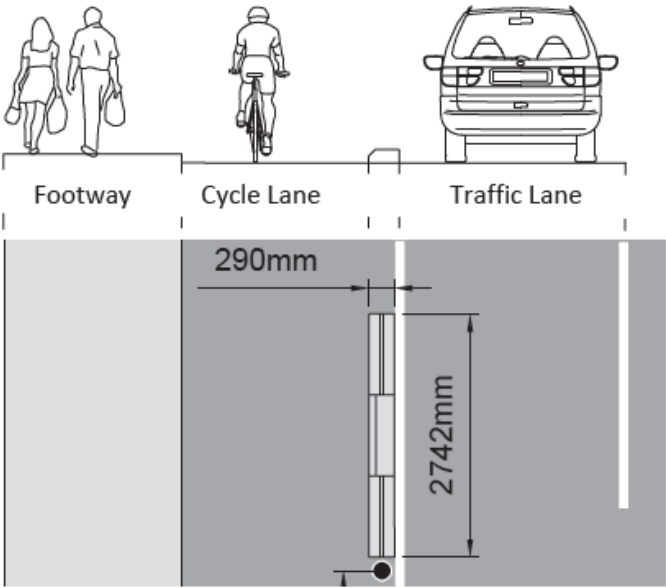


“Stepped” track cross-section
