#### 1. **DECLARATIONS OF INTEREST**

At this point in the meeting, the Cabinet Member was asked to declare any personal or prejudicial interests he may have in the business on the agenda. None were declared.

#### 2. **MINUTES**

#### **PUBLIC PARTICIPATION - DECISION SESSION** 3.

It was reported that there had been no registrations to speak under the Council's Public Participation Scheme.

Written representations had been received prior to the meeting, and had been attached to the online version of the agenda. Officers confirmed they had responded directly to the individuals concerned.

#### PETITION FOR ADDITIONAL STREET LIGHTING AT HOLLY TREE 4. CROFT, DUNNINGTON.

The Cabinet member considered a report which informed him of a petition presented by Cllr Brooks on behalf of Dunnington residents. The petition asked for an extra street light to be placed in the snicket located at the bottom of Holly Tree Croft.

Officers outlined the report and advised that following investigation by street lighting engineers, the snicket was not considered suitable for a street light.

The Cabinet Member noted the contents of the report and the officers comments and acknowledged residents concerns about the snicket. However, due to budget pressures, mobility issues and low crime rates in the area, he was unable to grant the request at present.

Officers confirmed that they would be willing to work alongside the Parish Council to design a suitable scheme for the snicket if they wished to fund it.

RESOLVED: (i) That the Cabinet Member chose Option 2 to leave the snicket as it is.

(ii) That the Cabinet Member instructs officers to work with the Parish Council to design a scheme that addresses accessibility concerns, should the Parish wish to fund such a scheme.

REASON: (i) The street light would cause an obstruction to those with limited mobility. There are low crime rates in the area and currently no budgets for additional street lighting.

(ii) To provide the street light without presenting an obstruction if the Parish Council considers it a local priority.

# Petitions requesting the reinstatement of litter bins

# **Summary**

- This report responds to two petitions received at Council on 11 October 2012:
  - a. From 561 residents of Dunnington: "We the undersigned ask City of York Council to replace some of the litter bins removed from Dunnington Village". Some of the petitioners refer specifically to bins removed from: The Children's Activity Park, the bus stop on York Street, and the corner of Eastfield Lane and Church Balk
  - b. From 1,530 residents in Fulford, Huntington and New Earswick: "We believe that removing 349 litter and dog bins is a false economy that will only lead to more litter and support the Liberal Democrat campaign to restore the bins removed from York"
- 2. Council referred the petitions to the Cabinet Member for Environmental Services.

# **Background**

- 3. During June 2012 approximately 320 litter bins were removed from service across the city; this was part of the implementation of a saving agreed in the 12/13 budget setting by Budget Council.
- 4. The bins removed were identified by the team responsible for servicing them; there were three criteria used :
  - Bin was being misused (e.g. for commercial or household waste)
  - Bin was under used

Bin was wrongly located

## Consultation

- 5. Where members, residents or local businesses felt that a particular bin should not have been removed we have worked with them to agree reinstatement or relocation where possible. This has resulted in the reinstatement of 12 bins and the relocation of 17 others across 14 wards (see annex).
- 6. This work continues to take place and ongoing talks with the Dunnington in Bloom group and the Parish Council have led to us to agreement that the replacement of one of the bins in Dunnington will be sufficient to meet their needs.
- 7. Furthermore, as part of the Smarter York initiative we have also donated 2 of the bins removed in June to the sports club at Dunnington to assist them with keeping their local area tidy. We have provided the bins free of charge and the sports club along with their members are servicing them.

# **Options**

- 8. The Cabinet could:
  - a. Continue to listen to the views of members, residents and local businesses and implement changes where appropriate, at the same time being aware of budgetary restrictions, and using the Smarter York objectives.
  - b. Restore all the bins as suggested by the second petition.

# **Analysis**

9. By agreeing to option a. budget savings will be delivered as agreed and local needs will be met. This option is recommended.

# **Council Plan**

- 10. Through the proposed measures we will support the following areas of the Council Plan:
  - Build Stronger Communities by talking to and listening to views.
  - Protect the Environment maintaining a level of service required for each local area.

11. We will also continue to use the Smarter York initiative as a driver for change and improvement in services.

# **Implications**

- 12. **Financial:** A saving of £40k was delivered in 2012/13 through the reduction in the number of litter bins.
- 13. There are no Human Resources, Equality, Legal, Crime and Disorder, IT, or Property implications.

# **Risk Management**

14. There are no known risks.

- 15. The Cabinet Member is recommended to:
  - i. Note the receipt of the petitions
  - ii. Note the work undertaken with communities as set out in paragraphs 6 and 7
