Minutes of the Ordinary Meeting of Rawcliffe Parish Council (RPC) held on Monday 13 July 2020 at 7.00pm which was held remotely via a Zoom meeting.

217/2020. To receive a report from Ward Councillors

Ward Councillor D. Wann thanked the Parish Council for inviting him to the meeting. The recycling bins are overflowing at the Park and Ride. This has been reported.

Ward Councillor S. Waudby provided the following report:

On 4th July there was an incident at Tesco carpark on Clifton Moor, there was around 400 youths between 17-20 years of age. They were there revving engines playing music and being intimidating towards customers of Tesco. Police were called and came to disperse them. They moved but only to the Vue Cinema carpark. There is apparently another one coming up on 25th July. We have let police know and will be contacting the landlord of the site. We went on Saturday as it was advertised there would be another but we went at the same time and only a handful of cars there. We will continue to keep an eye on this issue.

I have had complaints from a resident in regards to Home Bargains, there has been a noise complaint for when lorries are delivering – the request is that they put down a rubber paint with grit into it and rubber wheels for the trollies, also the resident says that in a planning application there was privacy panels for residents, officers are looking for the mentioned planning app which isn't on the CYC planning portal. Also the Council will be contacting Home Bargains on Clifton Moor and if not Head Office.

Residents have been in contact about parking on pavements and are asking for double yellow lines, residents are unable to walk on pavements safely. There has been a near miss with a child on a bike and a car, also there is a child at the end of the road that walks with a frame and she has

to walk on the road which is unacceptable. This has been reported to the council highways team and we have asked for this to go for consideration.

A conifer tree outside numbers 3 and 5 Troutsdale Avenue is to be felled. City of York Council are writing to neighbours.

Minutes from last meeting – update:

On the Park and Ride number 2 bus regarding the bus stopping outside The Mitre on the main road, and stopping just inside the gate of Park and Ride, we have had an email confirming that it will go to their next meeting and will be up for consideration.

The leylandii trees have now been inspected and we are contacting residents to inform them that some of the trees are dying, others have fire damage to them but the rest are very wide so unable to merely cut them back as it would look unsightly.

Ward Councillor D. Smalley provided the following report:

Anti Dog Fouling signs going up across our area

We've had increasing reports of dog fouling in certain areas of Rawcliffe, Clifton Without and Clifton Moor. In response, we now have a stock of stickers which we can place to remind people about the potential penalties for not cleaning up after dogs (a maximum penalty of £1000). Please get in touch if you know of a problem area that needs some attention. We can request a stock of stickers for the parish council if that would be helpful.

Our local library reopens with changes

Last week (on 7th July) Clifton Explore Library on Rawcliffe Lane reopened its doors for the first time since shutting in March.

Shipton Road cycle improvements

Further details will be announced soon, including the designs for the Shipton Road cycle route investment, but no update at the moment other than confirmation from officers that detailed design work is underway and that their intention is that this runs from the Park & Ride all the way to Gillygate junction. So the programme look to include the length of Shipton Road within the parish, the length of Bootham and the two complex junctions (Rawcliffe Lane/Shipton Road and the Clifton Green junctions). As soon as were hear more details, we will share them with residents and the parish council.

Devolution update

The devolution process continues for York and North Yorkshire. There are many steps that need to be taken before a deal is agreed, but the first major step provides York the opportunity to present a series of 'asks' to Government, which would outline what the city would like to see if a devolution deal is agreed.

A devolution deal for York and North Yorkshire could potentially unlock significant investment in the region, including investment in York's transport infrastructure, more affordable housing, funding to boost tourism and investment in major schemes, like York Central.

Given the potential scale of funding that a devolution deal could unlock for York, local residents and businesses are being invited to find out more on the Council's website here and share their thoughts via Our Big Conversation.

Play area at the rec:

Although it has been very wet recently I'm still very pleased with the progress of the weeding and preparation for reopening. The new strimmer cord has helped tremendously! I will unlock the gate and remove the chain late evening on the 3rd of July so it is open for children immediately on the 4th.

The strimmer:

New lease of life with new cord! So far I have taken excessive greenery from around the dog bins and the grit bin on the path to the school. More areas are earmarked when the weather allows.

Resident issues:

I have received several comments from residents about use of the tennis courts (or lack of). I have explained this is a matter for the RRA but residents have historically not been able differentiate between the parish council and the RRA. I've tried explaining but it's not easy to!

CYC:

I fortuitously met the man responsible for the litter bins and dog bins from CYC. We discussed issues of note and exchanged numbers. Very happy to have a contact within the CYC to help with issues which should speed matters up should something arise.
