

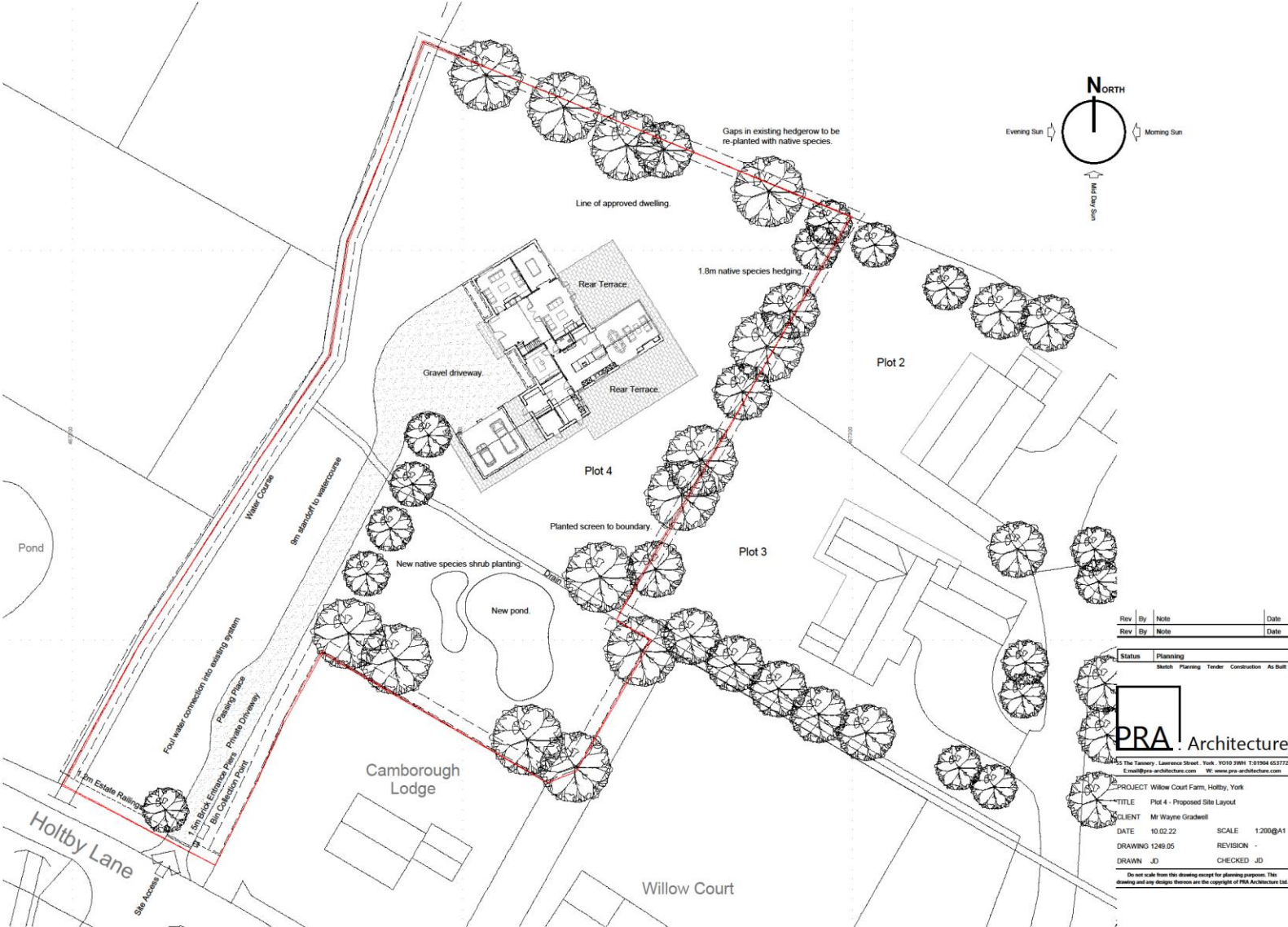

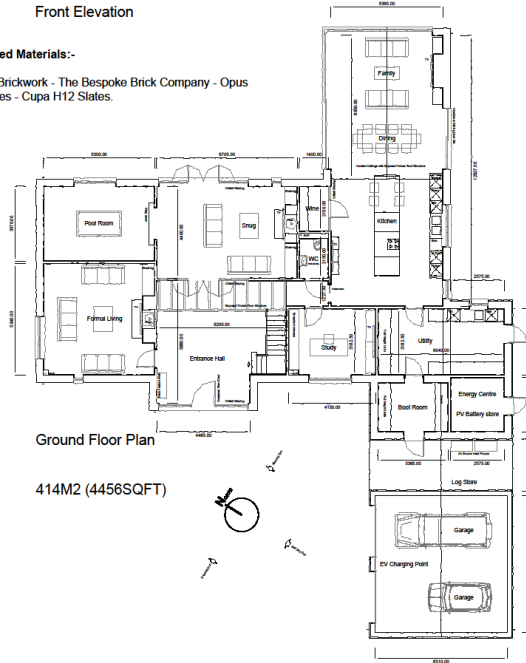
Front Elevation

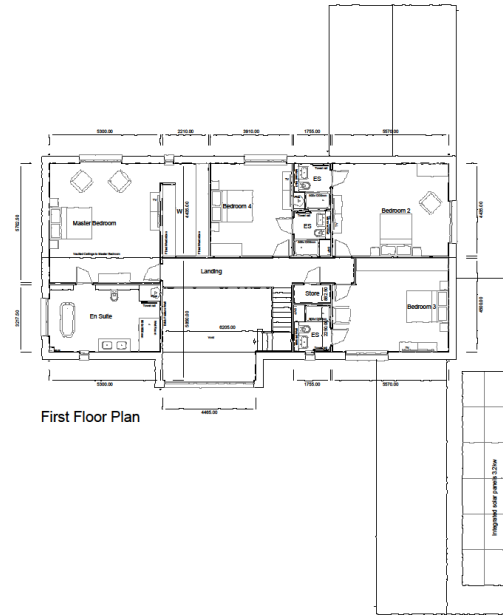

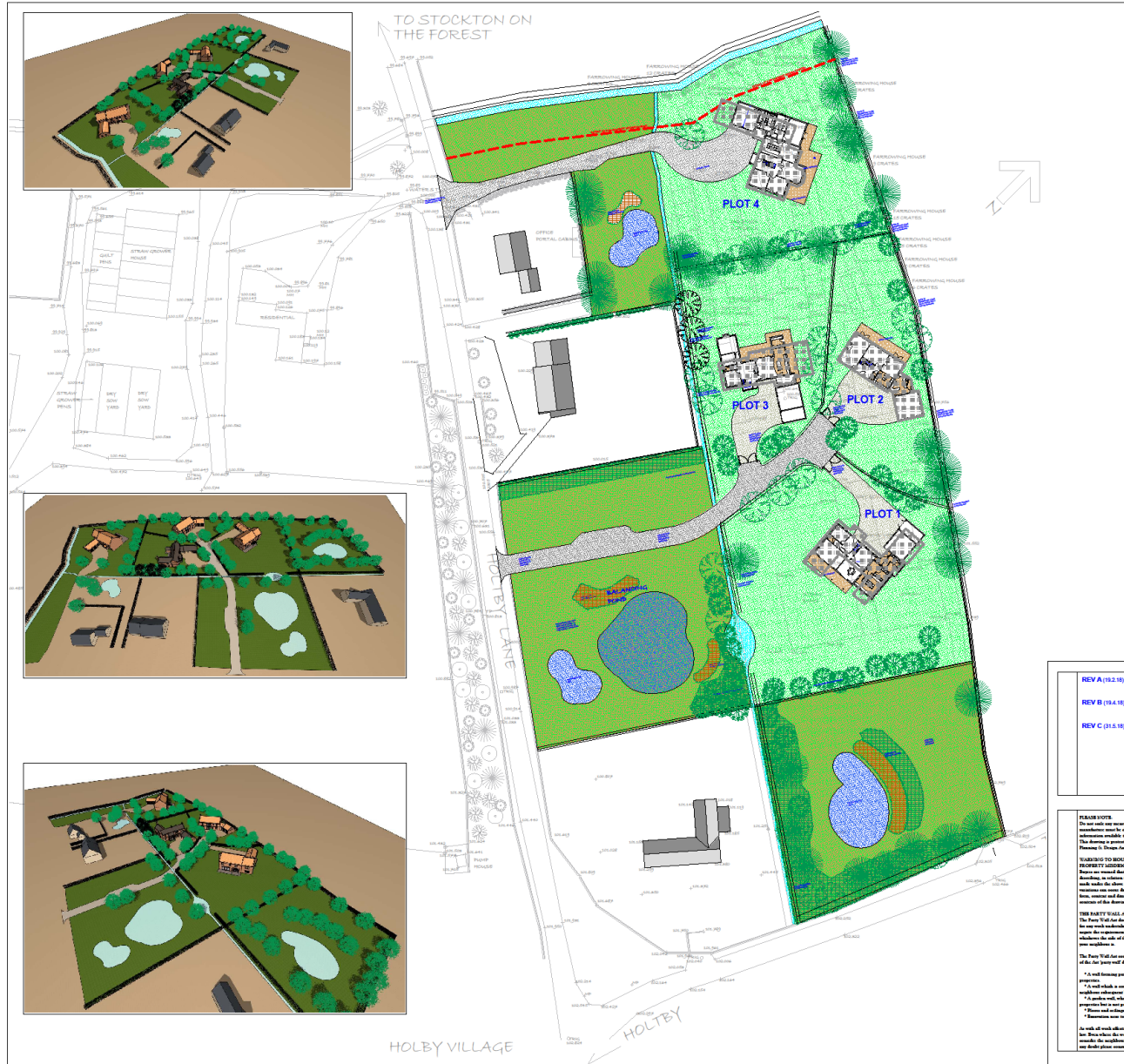
