31. Declarations of Interest

The Executive Member confirmed that he had no personal interests that were not included on the Register of Interests, nor any prejudicial or disclosable pecuniary interests, to declare in the business on the agenda.

32. Minutes

Resolved: That the minutes of the Decision Session held on 8 January 2018 be approved and signed as a correct record.

33. Public Participation

It was reported that there had been one request from a councillor to speak at the meeting under the Council's Public Participation Scheme and one written representation, both in respect of the 5 Year Flood Plan Update.

Cllr D'Agorne welcomed the activity to date, but expressed residents' concerns about the knock-on effects of the proposed measures on other parts of the city, and on the conduct of consultation. He requested further information about how the flood barrier would protect the city centre, and asked for complete transparency in any communication issued regarding flood protection work in the city.

Written representations were received from Cllr Dave Taylor expressing concerns about the effect of increased pumping capacity of the Foss Barrier on residents to the south of the barrier, and the need to find acceptable solutions to flooding on New Walk, with measures to slow the flow of water upstream. Officers undertook to provide a written response. [Note: the written representations and response have now been published online as a supplement to the agenda for this meeting.]

34. York 5 Year Flood Plan Update

The Executive Member considered a report that provided an update on progress with the York 5 Year Plan, including work carried out by the Environment Agency (EA) since the last update in December 2017.

The EA representative reported that they had been working closely with communities across the city to look at what could be done to mitigate flood risk in each community area. There had been polarised opinions in some areas and the EA would continue to meet with groups. Cllr Dave Taylor had volunteered to co-ordinate discussions in Fishergate.

During the discussion on the report, the following points were made and clarified:

- The B16 flood cell (New Walk) had been split into eight sub-cells. Though a drain on staff time, this had proved effective and was likely to save time in the longer term. A monthly newsletter was distributed within the cell.
- Feedback was encouraged from residents and communities, and it was hoped to get people on board with any plans that would be implemented.
- A proposal was being developed in cells F8, F10 and F11 to combine resources into upstream storage, similar to work done in Pickering, to create benefits all the way downstream into the city.
- A workable solution had been developed for Clementhorpe Road and a detailed design was now being developed, with a view to start building in the Autumn.
- Blue Beck in Cell B10 would require additional approval processes before work could be done, to ensure no damage was done to the SSSI.
- It was suggested that a report be taken to Executive outlining how funds had been spent to date, future spending plans, and how key decisions would be scrutinised and supported by the council's democratic process.
- Work was ongoing to identify social media groups across the city, and the EA were working with council communications teams to ensure messages were effectively communicated.
- The council's newly appointed resilience officer would work closely with the EA project team and the council's Emergency Planning Unit to ensure flood resilience

messages and works programmes were developed in the city.

Resolved: (i) That the update report and the information presented by the Environment Agency be noted.

(ii) That Officers be recommended to prepare a report for Executive to review the strategic development issues relating to the flood defence schemes across the city.

Reason: To update the Executive on work done to progress the five year flood plan for York.

35. Declarations of Interest

The Executive Member confirmed that he had no personal interests that were not included on the Register of Interests, nor any prejudicial or disclosable pecuniary interests, to declare in the business on the agenda.

36. Public Participation

It was reported that there had been no registrations to speak at the meeting under the Council's Public Participation Scheme.

37. Corporate Energy and Environmental Activity Update

The Executive Member considered a report which detailed the council's progress on delivery against its Carbon and Resource Smart Management objectives (CRSM), with particular reference to carbon reduction, energy use and waste reduction.

Progress, as summarised in paragraphs 4 to 11 of report and detailed in paragraphs 13 to 45, included:

- Completion of 41 of the 91 short term projects in the CRSM
- A 26% decline in the council's carbon footprint since 2010/11
- A decline of 19.3% in CO2 emissions from building utilities
- A drop of 34.3% in electricity consumption
- A decline of 37.5% in total miles travelled by car
- A drop of 20.3% in corporate waste.
- The 2014/15 baseline of 15,000 tonnes of CO2 generated across the corporate estate and street lighting would be fully updated in 2019/20.

The council would also work closely with Leeds City Region (LCR) to ensure the CRSM was full aligned to opportunities arising from the LCR Energy Review.

The Executive Member commented that further detail was needed on the potential future projects listed in paragraph 25, and that reference should be made to the OnePlanetCouncil Plan considered at the Decision Session on 1 August 2016 and the first Carbon Management Plan agreed by Executive on 22 April 2008.

- Resolved: (i) That the progress made in delivering the CRSM, the ongoing alignment with the emerging Leeds City Region Energy Plan, and the plans to refresh the carbon baseline in 2019/20, be noted.
- Reason: To confirm that the Executive Member is aware of the progress being made and able to scrutinise performance in this area.

(ii) That a further report be brought to the Executive Member, providing detailed plans on targets and outcomes for carbon savings and plans for future work in this area, including reference to the work by the Leeds City Region's Energy Accelerator.

Reason: To ensure that the delivery of the council's plans can be monitored and that York can benefit from the funding awarded to LCR for this work.

(iii) That details be provided of how the council can support York Community Energy in schemes to increase renewable power in the city.

Reason: To provide clarity to YCE in creating their business case for these schemes.

(iv) That clearer reference be made to this work on the council's website.

Reason: So that residents can be fully informed.

Report of the Director of Economy & Place

York 5 Year Flood Plan Update

Summary

- 1. The flooding in late December 2015 followed an intense period of rainfall across November and December due to the impacts of Storms Desmond and Eva. Record river levels were observed in many river catchments across the north of England. More than 4000 homes and 2000 businesses flooded across Yorkshire with 453 properties and 174 businesses flooded in York.
- Funding has been allocated to the Environment Agency (EA) following the floods to renew existing and provide new flood defences across the city, £17m has been allocated to the Foss Barrier improvements and £45m to the wider flood defences across the city.
- 3. An update on progress has been supplied by the EA, this can be seen in Annex 1.
- 4. The Community Hub on Wellington Row gives a base for co-working by EA, CYC and consultants and a drop in location for residents to visit to understand the work that we are developing across the city.
- 5. Formal consultation events have been held in the Clementhorpe and New Walk flood cells and with residents in the Almery Terrace area in the last few months.

Recommendations

6. The Executive Member for the Environment is asked to note the updated report and the evidence presented by the Environment Agency in the session, feedback is sought from the Executive Member on all content.

Background

- 7. Following the development and publication of the York Five Year Plan (<u>https://www.gov.uk/government/publications/york-5-year-flood-plan</u>) the EA have developed the Defra Strategic Outline Business Case and financial approvals have been sought and obtained from Defra. Detailed businesses cases are being developed for 19 flood cells across the city.
- 8. The Environment Agency continue to work closely with City of York Council on all aspects of the York Five Year Plan, an update has been provided by the EA at Annex 1.
- 9. The Wellington Row Community Hub continues to be an invaluable work space, the hub is an opportunity for the EA, CYC and consultants to colocate to ensure a joined up delivery of the works within the programme. The hub is open to the public Monday 10am-4pm, Wednesday 10am-4pm and Thursday 10am-4pm, EA and CYC officers are on hand to respond to questions and provide information on the schemes as they develop.
- 10. The Hub has also hosted a wide range of groups including schools, colleges, local interest forums and national and international guests. The physical flood model can be used to demonstrate the way in which a river channel can be managed to reduce flood risk, this has proven to be a popular way to convey the concepts behind hydraulic river management. - 11. Formal consultation events have been held in the Clementhorpe (22nd May) and New Walk (23rd May) flood cells and residents in the Almery Terrace area (7th March). A wide range of attendees have provided detailed feedback on current designs and plans and we are working with individuals and flood groups in the flood cells to further refine options. A range of specific meetings and site visits have been completed in the areas of interest throughout these cells.
- Following the recommendations of the 5 March 2018 Executive Member for the Environment Decision Session, meetings have been held between the EA and CYC to prepare a revised approach to project endorsement by CYC.

13. A wide range of information is now available via the Citezen Space website through the below link, CYC and EA are discussing options to further host information on the CYC website.

14. EA and CYC are currently discussing the role of the planning system in the development of the flood schemes across all flood cells, further information will be presented in the decision session for consideration.

Consultation

- 15. Public consultation on the York Five Year Plan was held in late November 2016 and quarterly newsletters have been developed by the EA to further inform on progress. Regular formal updates will be provided to the Executive Member for Environment and the Economy & Place Scrutiny Committee at quarterly and six month frequencies respectively.
- 16. Consultation events have been held in the Clementhorpe, New Walk and Scarborough Bridge to Ouse Bridge flood cells were attended by approximately 150 people, further events are being set up to further include the communities in proposals as they are developed. Additional meetings have been held by Rachael Maskell MP in the New Walk community attended by EA and CYC officers.

Options

17. The principal options open to the Executive Member for Environment are to comment on and review the work undertaken to date, the future work identified and the representations made by the Environment Agency.

Analysis

18. Ongoing liaison will continue between the Executive Member for Environment and the CYC Flood Risk and Asset Manager, future briefings to the Executive Member for Environment Decision Session will be made to ensure key outputs and decisions are supported by CYC and to provide formal opportunities for members and the public to consult. Further recommendations will be made for agreement at these sessions.

Council Plan

19. Improved provision of flood defences supports a prosperous city for all through safer communities for residents, businesses and visitors, a wide range of consultation events will ensure this is in line with the needs and expectations of local communities.

Implications

- **Financial** Funding is allocated directly to the EA, the additional funding of £45M is available to be directed towards key flood risk projects in the city in the short term. The extent of required works may require wider funding and Defra funding bids will be developed. There are likely to be contribution requirements as part of this wider work.
- **Property** The Site Investigation programme will include sites under CYC ownership and/or control, consultation will be carried out with Estates teams and all relevant agreements will be put in place.

Update for June's Executive Decision Session

This is an update of the progression made over the last three months on the flood alleviation work in York. In this update we have provided:

- Summary of city wide flood alleviation activities
- Update on progress of each flood cells
- Map of the flood cells

Summary of city wide flood alleviation activities

Ground Investigation Programme

Ground investigation has now been completed for the River Ouse flood cells. Work on the River Foss ground investigation will begin in July. This will be focussed on a possible flood storage area upstream of the city meaning that we are not likely to see too much activity in the city itself. We are currently talking to landowners and we will give formal notice of the works before it begins.

Planning process

Following advice we have received we are reviewing our approach to the planning process and whether to use our permitted development rights at some locations. The advantage of this is that it will enable us to move work forward faster and with more confidence. If we use permitted development rights we will make sure that consult on these locations and that we give members of the public a chance to see and comment on the planned work as part of our engagement process.

Engagement activity

The Hub provides residents with a central location where they can come to ask questions about our work, view plans, and provide feedback. The opening hours have changes and we are now open 10:00 to 16:00 on Monday, Wednesday and Thursday each week. Our quarterly newsletter was sent out in early May. Area (flood cell) specific engagement continues as outline in the next section.

We have recently gone live with our York flood alleviation scheme web pages. These are hosted on Citizen Space, an engagement portal that will allow residents to view all engagement material and provide feedback. Working with City of York Council, we are also working to improve the 'flood' pages on the council website to ensure effective and transparent communication with residents before, during and after flooding.

At OBC a further review will take place as to whether to proceed to Full Business Case (FBC) and then construction on site.



B12 - Scarborough Bridge to Lendal Bridge (Left Bank)	A significant area of this flood cell falls within the historic city centre and therefore any scheme needs to have the support of heritage bodies. We are keen to ensure this support before shortlisting options. B15 - King's Staith to Skeldergate Bridge	As was highlighted in the publication of the 5 Year Plan, providing protection at King's Staith to the same level as elsewhere in the city would not be acceptable. We are assessing the optimum size of any defence in this location to provide additional protection without negatively impacting the riverside amenity and neighbouring businesses. 


Map of the flood cells



What do you think of our Long Term Plan?

We understand that as river levels rise, we cannot continue to build walls and banks indefinitely. To counter the effects of climate change over the next 100 years we are looking at how river flows could be slowed and managed in areas upstream of York.

We have completed and published a study called 'Slowing the flow in the rivers Ouse and Foss; a long-term plan for York'. The nature of the work required lends itself to working in partnership with private, public and charitable bodies to achieve multiple benefits. This could be an opportunity to enhance the natural environment, create habitat, reduce flooding in rural areas and improve the amenity value and commercial value of land.



We are currently seeking opportunities to work with others on projects that could achieve multiple benefits, and are seeking views from partners, landowners, the public and other
