LICENSING ACT 2003 SUB – COMMITTEES PROCEDURE FOR HEARINGS

<u>Introduction</u>

The procedure outlined below will be followed at all Licensing Hearings.

As Licensing Hearings are quasi-judicial the Sub-Committee will, in effect, act like a Court and the rules of natural justice will apply. The Sub-Committee will be guided by legal principles in determining whether evidence is both relevant and fairly admitted. Committee Members have a duty to view all evidence presented before them impartially. Members of the Licensing Sub-Committee have all received relevant training and are used to making decisions of this type. No matter how strong local opinion may be, Committee Members can only make decisions based on relevant licensing issues as set out before the Sub-Committee in determining applications.

The hearing will be in public session. However, the Sub-Committee may exclude the public from a hearing if it considers it in the public interest to do so. However, the decision will be made in private.

The purpose of the hearing is

- To enable those with a right to appear to advance their point of view and to test the case of their opponents
- To assist the Sub-Committee to gather evidence and understand the relevant issues

In view of the requirement to hold hearings within specified times, the Licensing Authority will generally be unable to enter into discussions to identify dates convenient to all parties concerned. In <u>exceptional</u> circumstances, the Licensing Authority will consider applications to adjourn hearings to a later date.

Representations at Licensing Hearings

The Applicant, Ward Councillors, and Representors who have made written submissions will be allowed to speak at the Sub-Committee. At any hearing of an application, the Applicant and any Representors shall attend in person wherever possible. Any party to a hearing may be assisted or represented by any person, legally or otherwise.

All parties will be given a fair hearing and each party will have the same amount of time in which to address the Sub-Committee. A time limit has been set because of the pressures on the Sub-Committees to hear so many applications in a short period of time. Each party will have 15 minutes to address the Sub-Committee, give any further information, and call any witnesses. If any party considers this time to

be insufficient then a request in writing may be made to the Democracy Officer for an extension of time at least 2 working days before the hearing. However, this will not be automatically granted and will be at the discretion of the Sub-Committee.

The Sub-Committee may take into account any documentary evidence or other information in support of the application, representations or notice, either before the hearing or, with the consent of all other parties, at the hearing.

If any Representors fail to attend the hearing, the Sub-Committee will normally proceed but will consider their written objection and hear and consider any evidence and argument in relation to it put forward by the Applicant. In considering written evidence in the absence of a Representor, appropriate weight will be attached, given that the person cannot be questioned by the Applicant and Members.

The Sub-Committee is required to disregard any information given or evidence produced by a party or witness which is not relevant to the application, representations, or notice, and the promotion of the licensing objectives. Duplication should be avoided. Comments must be confined to those points already made, although the parties may extend or expand on their written submissions. The Sub-Committee will have read and familiarised themselves with all the written submissions and the issues prior to the hearing, and therefore do not require the points to be repeated or made at length. The Applicant and Representors cannot raise substantial new information at a hearing which has not been seen previously by the other parties.

A Representor **may not** introduce any new ground or objection not referred to in the written submission unless the Sub-Committee considers there are <u>exceptional</u> circumstances for doing so and the Representor is able to justify why the ground or objection should be raised. The Applicant may make representations to the Sub-Committee as to why any such request to introduce a new ground should or should not be granted. In considering whether to grant a request by a Representor to introduce a new ground, the Sub-Committee will consider why the new evidence has not been produced earlier and whether the admission of such a ground would necessitate the grant of an adjournment and will consider any unfairness to the Applicant or other Representors by reason of the extra cost or delay thereby caused.

Any person behaving in a disruptive manner will be asked to leave the hearing. If this does occur, that person may, before the end of the hearing, submit in writing any information which they would have been entitled to give orally.

Procedure prior to the Hearing

The Members sitting on the Sub-Committee will meet prior to the hearing to note the matters that are to be presented. They will only be accompanied by the Democracy Officer and Legal Advisor (*if present*). Attention will only be drawn to the nature of the application and the premises or person to which it relates. The actual application will not be discussed.

At any hearing of an application, the Licensing Officer, the Applicant and any Representors or representatives will report to reception and be asked to wait in reception until the democracy officer calls them through to the committee room.

Procedure at the Hearing

- 1. Members of the Sub-Committee will appoint a chair.
- 2. The Chair introduces the Committee Members and officers [Democracy Officer, Legal Advisor to the committee (if present) and the Licensing Officer], welcomes the Applicant and Representors (or their representatives), and establishes the identity of all who will be taking part.
- 3. The Chair will explain to the parties the procedure that will be followed at the hearing.
- 4. The Chair will proceed with the order of business on the agenda.
- 5. When the agenda item relating to the application is reached, the Chair will invite the Licensing Officer to present the application.
- 6. The Licensing Officer outlines the application, confirms the application details, introduces the report and gives an update on any recent changes.
- 7. The Chair will invite Committee Members, the Applicant and Representors (or representatives) to ask the Licensing Officer questions to clarify any points raised in the report.
- 8. The Chair will ask the Applicant (or their representative) to present their case.
- 9. The Applicant (or their representative) will present their case and may call any witnesses to support their case [maximum 15 minutes].
- 10. The Chair will invite the Representors (or their representative) in the following order to ask questions of the Applicant (or their representative) and/or witnesses [maximum 5 minutes each party]
 - (i) Police
 - (ii) Other Responsible Authorities
 - (iii) Ward Councillors
 - (iv) Interested Parties
- 11. The Chair will invite the Committee Members to ask questions of the Applicant (or their representative) and/or witnesses.
- 12. The Chair will invite the Representors (or their representative) in the following order to state the nature of their interest in the matter, present their case and call any witnesses to support their case [maximum 15 minutes each party]
 - (i) Police
 - (ii) Other Responsible Authorities
 - (iii) Ward Councillors
 - (iv) Interested Parties

- 13. The Chair will invite the Applicant to ask questions of each Representor (or their representative) and/or their witnesses after each presentation [maximum 5 minutes per Representor].
- 14. The Chair will invite the Committee Members to ask questions of each Representor (or their representative) and/or their witnesses after each presentation.
- 15. The Chair will invite the Representors (or their representative) in the following order to summarise their case [maximum 5 minutes each party]
 - (i) Police
 - (ii) Other Responsible Authorities
 - (iii) Ward Councillors
 - (iv) Interested Parties
- 16. The Chair will invite the Applicant (or their representative) to summarise their case [maximum 5 minutes].
- 17. The Chair will provide the Sub-Committee with a final opportunity to seek clarification from any of the parties on any points raised, or seek advice from the Licensing Officer on policy, or from the Legal Advisor (*if present*) on law and jurisdiction.
- 18. When all the evidence has been heard, the Chair will declare the hearing closed and ask the Licensing Officer, the Applicant and Representors (or their representatives) plus any witnesses present to leave the committee room and wait in reception while the Sub-Committee considers the evidence.

Procedure after the Hearing

- 19. If the Sub-Committee wish to seek further clarification on the evidence given, the Democracy Officer will invite all parties back into the committee room.
- 20. If possible, and for all hearings under:-
 - section 35 or 39 which is in respect of an application made at the same time as an application for conversion of an existing licence under paragraph 2 of Schedule 8 (determination of application under section 34 or 37)
 - section 85 which is in respect of an application made at the same time as an application for conversion of an existing club certificate under paragraph 14 of Schedule 8 (determination of application under section 85)
 - section 105(2)(a) (counter notice following police objection to temporary event notice)
 - section 167(5)(a) (review of premises licence following closure order)
 - paragraph 4(3)(a) of Schedule 8 (determination of application for conversion of existing licence)

- paragraph 16(3)(a) of Schedule 8 (determination of application for conversion of existing club certificate)
- paragraph 26(3)(a) of Schedule 8 (determination of application by holder of a justices' licence for grant of personal licence)

the Sub-Committee will make a decision on conclusion of the hearing and only the Democracy Officer and the Legal Advisor to the Sub-Committee (if present) will remain in the room with the Committee Members. These officers will not comment on the merits of the application, but will be present to provide advice on legal and procedural points and to record the decision.

- 21. If the decision has been made, all the parties will be invited back into the committee room by the Democracy Officer. The Chair will announce the decision including reasons together with, if appropriate, details of any conditions to be attached to the grant of the licence. This decision will then be communicated in writing to the Applicant and Representors within 3 working days of the hearing. There can be no further questions or statements.
- 22. For all other hearings not listed above, if the Sub-Committee is unable to make a decision on the day of the hearing, the decision will be made within 5 working days beginning with the day or the last day on which the hearing was held. The Democracy Officer will inform the parties that they are no longer required and the decision will be communicated in writing to the Applicant and Representors within 3 working days of the decision being made.
- 23. The notification will include information about the rights of appeal against the determination made.

Report of the Director of Neighbourhood Services

Section 18(3)(a) Application for a premise licence for Tesco Stores Ltd, 376 Huntington Road, York, YO31 9HP

Summary

- 1. This report seeks Members determination of an application for the grant of a premise licence, which has been made under the Licensing Act 2003.
- 2. Application reference number: CYC-012832.
- 3. Name of applicant: Tesco Stores Ltd.
- 4. Type of authorisation applied for: Grant of a premises licence.
- 5. <u>Summary of application</u>: The nature of the application is to permit the supply of alcohol for consumption off the premises.

Background

6. A copy of the application is attached at Annex 1.

Promotion Of Licensing Objectives

- 7. The operating schedule submitted by the applicant shows that the licensing objectives would be met as follows:
- 8. The prevention of crime and disorder: 1) The premises will have digital CCTV system that covers many areas of the shop floor, including the proposed area which will be used for beer and wine. Images will be retained for a minimum of 21 days and made available on enforcement request. 2) A member of the management team will be on the premises all the time the store is open. 3) Checkout area will be constantly manned whilst the store is open.
- 9. <u>Public safety</u>: 1) A member of the management team will be on the premises all the time the store is open and will be trained to manage the store including looking after the safety of the public. 2) The store will adhere to the rules and regulations relating to public safety.

- 10. The prevention of public nuisance: 1) The store intends to be an active member of the community. 2) We will be happy to liaise with police and enforcement authorities should the need arise.
- 11. The protection of children from harm: 1) All staff will be trained and regularly refreshed in the corporate 'Think 21' policy. 2) A till prompt will appear on the initial sale of alcohol that will remind the seller of the 'Think 21' policy and remind staff not to sell alcohol to anyone under the age of 18. 3) When alcohol is refused by the seller after the product has been scanned the refusal will be recorded in a report that can be produced at store level on a weekly basis. 4) The store will display signage around the premises informing both staff and customers of our 'Think 21' policy.

Special Policy Consideration

12. This premise is not located within the special policy area.

Consultation

- 13. Consultation was carried out by the applicant in accordance with s13, and s17(5) of the Act and Regulation 42, Parts 2 and 4 of the Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005, which concern the displaying of a notice on the premises and an advertisement in a local paper giving details of the application and serving a copy of the application on all responsible authorities. The applicant complied with all statutory requirements. In addition the relevant ward councillors and/or parish council were notified by way of register.
- 14. All procedural aspects of this application have been complied with.

Summary of Representations made by Responsible Authorities

15. There were no representations received from responsible authorities.

Summary of Representations made by Interested Parties

- 16. A representation has been received from one interested party listed at Annex 2 (confidential). His/her representation is attached at Annex 3.
- 17. The address of the interested party is indicated on the map attached as Annex 4 (confidential). A further map indicating the general area from which the representation was received is attached at Annex 5.
- 18. An "interested party" is defined at s13(3) of the Act as being a person living in the vicinity of the premises, a body representing persons who live in that vicinity, a person involved in a business in that vicinity, or a body representing persons involved in such businesses.

19. Members are reminded that representations are only "relevant" if they relate to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives.

Planning Issues

20. Planning permission was granted on appeal with the following conditions;

Opening hours: Monday to Saturday 07:00 hours to 22.00 hours

Sunday and Bank Holidays 07.00 hours to 21.00 hours

Delivery times: Monday to Saturday 07:00 hours to 09:00 hours and 19:00

hours to 21:00 hours

Sunday and Bank Holidays 08:00 hours to 10:00 hours.

Options

- 21. By virtue of s18(4) of the Act, the Committee have the following options available to them in making their decision:-
- 22. Option 1: Grant the licence in the terms applied for.
- 23. Option 2: Grant the licence with modified/additional conditions imposed by the licensing committee.
- 24. Option 3: Grant the licence to exclude any of the licensable activities to which the application relates and modify/add conditions accordingly.
- 25. Option 4: Reject the application.

Analysis

- 26. The following could be the result of any decision made by this Sub Committee:-
- 27. Option 1: This decision could be appealed at Magistrates Court by any of the representors.
- 28. Option 2: This decision could be appealed at Magistrates Court by the applicant or any of the representors.
- 29. Option 3: This decision could be appealed at Magistrates Court by the applicant or any of the representors.
- 30. Option 4: This decision could be appealed at Magistrates Court by the applicant.

Corporate Priorities

31. The Licensing Act 2003 has 4 objectives the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm.

32. The promotion of the licensing objectives will support the Council's priority to reduce the actual and perceived impact of violent, aggressive and nuisance behaviour on people in York.

We are a national retailer that sells alcohol as part of a broad offering of goods and services. We have held offlicences in our stores for many years and are an approved British Institute of Inn-keeping examination centre. We have written training policies and formal training programmes are in place, which ensure our people are equipped to meet all licensing objectives. All training and revision/refresher materials are reviewed regularly and are currently being rewritten to reflect the requirements of the new Act. We have introduced our 'Think 21' policy to all of our stores in July 2004, this policy is brought to customer's attention through point of sale material at the checkout and wherever alcohol is displayed for sale. We take legal compliance very seriously and in addition to local training we employ a central alcohol licensing compliance manager and have a compliance committee.

b) The prevention of crime and disorder

The premises will have digital CCTV system that covers many areas of the shop floor, including the proposed area which will be used for beer and wine, should we be successful with our application.

Images will be retained for a minimum of 21 days and made available on enforcement request.

A member of the Management team will be on the premises all the time the store is open.

Checkout area will be constantly manned whilst the store is open.

c) Public safety

A member of the Management team will be on the premises all the time the store is open and will be trained to manage the store including looking after the safety of the public.

The store will adhere to all rules and regulations relating to public safety.

d) The prevention of public nuisance

The store intends to be an active member of the community.

We will be happy to liaise with Police and enforcement authorities should the need arise.

e) The protection of children from harm

All staff will be trained and regularly refreshed in the corporate 'Think 21' Policy. Staff will be trained to look at the customer and 'Think 21' when selling age restricted products.

A till prompt will appear on the initial sale of alcohol that will remind the seller of the Think 21 policy and remind staff not to sell alcohol to anyone under the age of 18.

When alcohol is refused by the seller after the product has been scanned the refusal will be recorded in a report that can be produced at store level on a weekly basis

The store will display signage around the premises informing both staff and customers of our 'Think 21' policy.

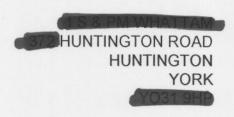

I am in receipt of your letter dated 28 March 2007, in response to my letter in which I stated my objections to the application for granting of a an alcohol sales licence from the above mentioned premises.

First I must draw your attention to a mistake in the applicants stated address of the site as detailed in your letter. Number 376 Huntington Road is a private residence.

This property is part of the same development as 372, and in the deeds there is a covenant which forbids the sale of alcohol from this site / area.

However my main objections to the granting of such a licence to this Tesco Express, are as follows:-

When this site operated as a Murco Filling Station and Shop excessive litter of all types was dropped by persons using that facility, even though bins were provided for the disposal of such litter.

The depositing of "litter" other than in the bins provided was very noticeable by all residents in the area in that the amount of litter cleared from the gardens, verges and paths, which together in our case from around the bus shelter at the front of our garden, reduced dramatically when the garage facility ceased trading.

This was accompanied by a drop in the level of public nuisance and the use of the bus shelter and surrounding area "as a not so public urinal and toilet used by both sexes". The risk of increased "litter dropping" and "miss use of the area as a public toilet" will increase dramatically if such a licence is granted.

The granting of a licence to this type of facility, which is not always policed or managed to the same extent as a public house, of which there are two within a very short walking distance of this site, are known to be a magnet to all drinkers, particularly those who are under age and those who would not normally be served in a public house. By not granting this application, it would eliminate, at source, any possible crime and disorder factors, in that the perpetrators would not be drawn into the area in the first place.

With regard to aspects of public safety, there was during the Planning Tribunal great thought and consideration given to the need for protecting the public both on and off the site and that of access and egress by mixed transport types.

The sale of alcohol from this site, will mean an increase in traffic of all types which when mixed with the more than probable drinking of alcohol both on the site and the immediate area will greatly increase the risk of accidents happening, leading to injuries of persons and damage to property.

I have earlier eluded to the use of this site by under aged drinkers as a source of alcohol. This not only means teenagers, but those under the age of 12 who are classified as children.

In other areas relatively close, there are a number of so called exclusion zones in place, which are supposed to eliminate the gathering of such groups.

These areas are rarely if ever policed or managed by persons of authourity, which then puts an undue responsibility on the occupants of properties in these areas to control gatherings. When this public action is undertaken, it usually results in an increase in the disruption caused by such groups.

As I said at the Planning Tribunal, I do not agree with this imposition that I or any other person should have thes responsibility to police or manage the use of this site.

I strongly object to the granting of an Alcohol Sales Licence to this site, now or in the future.

The application for such a licence is completely contrary to promises made by the legal representatives for Tesco to the Planning Inspector during the Planning Tribunal, which was taken into account and no doubt influenced the decision of the Planning Tribunal.

There are more than sufficient alcohol sales points in this area, which adequately fullfill the needs of those who wish to purchase alcohol.

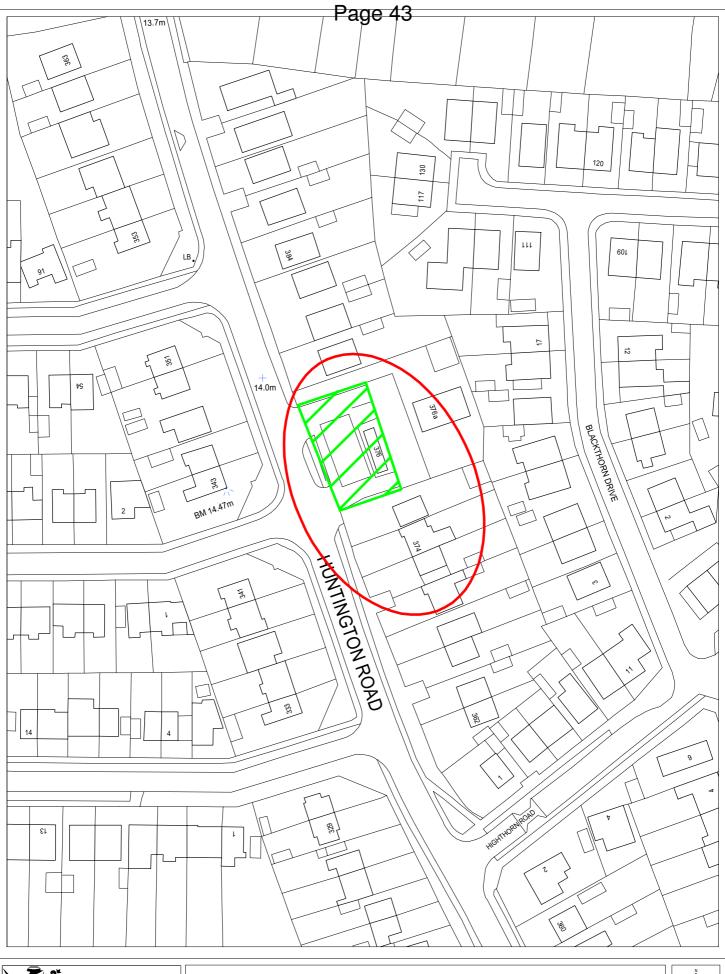
I see no reason, other than the increase of sales for Tesco from this site, that the granting of such a licence would be beneficial to the area.

By granting such a licence, it will negatively affect the living standards of residents and will greatly reduce the general desirability of area.

Page 45 MANDATORY CONDITIONS – PREMISES LICENCE LICENSING ACT 2003

MANDATORY CONDITIONS WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

- (1) In accordance with section 19 of the Licensing Act 2003, where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- (2) The first condition is that no supply of alcohol may be made under the premises licence
 - (a) at a time where there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

MANDATORY CONDITION: EXHIBITION OF FILMS

- (1) In accordance with section 20 of the Licensing Act 2003, where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- (2) Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
- (3) Where
 - (a) the film classification body is not specified in the licence, or
 - (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,
 - admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- (4) In this section
 - "children" means persons aged under 18; and
 - "film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

MANDATORY CONDITION: DOOR SUPERVISION

- (1) In accordance with section 21 of the Licensing Act 2003, where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in subsection (1) requires such a condition to be imposed
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence, or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Legislation and Policy Considerations
