4. Tourism Progress Report and Update (Pa

The report informs the Committee of current issues affecting the tourism/visitor economy. It outlines key points in the Tourism Strategy and Action Plan, adopted in 2007, and the key findings of an Evening Economy report which was endorsed by the Council's Executive in July 2007. It emphasises the desire for a high quality and varied visitor offer in order to maximise the economic benefits arising from tourism.

5. Revision of Statutory Guidance to Licensing (Pages 13 - 28) Act 2003

This report advises members of changes to the guidance accompanying the Licensing Act 2003 to which they are required to have regard to in making related licensing decisions.

6. Review of Licensing Policy (Licensing Act (Pages 29 - 162) 2003)

This report advises members of the review of the council's licensing policy, of the consultation undertaken and of the changes made as a result of the revised guidance and legislative changes. The report seeks a recommendation to full council that the revised policy be approved.

7. Members Involvement in Licensing Appeals (Pages 163 - 168) and the Introduction of the Summary Review Process

This report examines the process involved in appeals made to the magistrates court against decisions of the Licensing Act and Gambling Act Sub committees. It looks at the options for member involvement in that process and seeks a determination of future policy. The report also advises members of the impact of the Violent Crime Reduction Act 2006 on the hearing process.
