LICENSING ACT 2003 SUB – COMMITTEES PROCEDURE FOR HEARINGS

Introduction

The procedure outlined below will be followed at all Licensing Hearings.

As Licensing Hearings are quasi-judicial the Sub-Committee will, in effect, act like a Court and the rules of natural justice will apply. The Sub-Committee will be guided by legal principles in determining whether evidence is both relevant and fairly admitted. Committee Members have a duty to view all evidence presented before them impartially. Members of the Licensing Sub-Committee have all received relevant training and are used to making decisions of this type. No matter how strong local opinion may be, Committee Members can only make decisions based on relevant licensing issues as set out before the Sub-Committee in determining applications.

The hearing will be in public session. However, the Sub-Committee may exclude the public from a hearing if it considers it in the public interest to do so. However, the decision will be made in private.

The purpose of the hearing is

- To enable those with a right to appear to advance their point of view and to test the case of their opponents
- To assist the Sub-Committee to gather evidence and understand the relevant issues

In view of the requirement to hold hearings within specified times, the Licensing Authority will generally be unable to enter into discussions to identify dates convenient to all parties concerned. In exceptional circumstances, the Licensing Authority will consider applications to adjourn hearings to a later date.

Representations at Licensing Hearings

The Applicant, Ward Councillors, and Representors who have made written submissions will be allowed to speak at the Sub-Committee. At any hearing of an application, the Applicant and any Representors shall attend in person wherever possible. Any party to a hearing may be assisted or represented by any person, legally or otherwise.

All parties will be given a fair hearing and each party will have the same amount of time in which to address the Sub-Committee. A time limit has been set because of the pressures on the Sub-Committees to hear so many applications in a short period of time. **Each party will have 15 minutes to address the Sub-Committee, give any further information, and call any witnesses.** If any party considers this time to

be insufficient then a request in writing may be made to the Democracy Officer for an extension of time at least 2 working days before the hearing. However, this will not be automatically granted and will be at the discretion of the Sub-Committee.

The Sub-Committee may take into account any documentary evidence or other information in support of the application, representations or notice, either before the hearing or, with the consent of all other parties, at the hearing.

If any Representors fail to attend the hearing, the Sub-Committee will normally proceed but will consider their written objection and hear and consider any evidence and argument in relation to it put forward by the Applicant. In considering written evidence in the absence of a Representor, appropriate weight will be attached, given that the person cannot be questioned by the Applicant and Members.

The Sub-Committee is required to disregard any information given or evidence produced by a party or witness which is not relevant to the application, representations, or notice, and the promotion of the licensing objectives. Duplication should be avoided. Comments must be confined to those points already made, although the parties may extend or expand on their written submissions. The Sub-Committee will have read and familiarised themselves with all the written submissions and the issues prior to the hearing, and therefore do not require the points to be repeated or made at length. The Applicant and Representors cannot raise substantial new information at a hearing which has not been seen previously by the other parties.

A Representor **may not** introduce any new ground or objection not referred to in the written submission. Additional representations which do not amount to an amplification of the original representation may not be made at the hearing.

Any person behaving in a disruptive manner will be asked to leave the hearing. If this does occur, that person may, before the end of the hearing, submit in writing any information which they would have been entitled to give orally.

Procedure prior to the Hearing

The Members sitting on the Sub-Committee will meet prior to the hearing to note the matters that are to be presented. They will only be accompanied by the Democracy Officer and Legal Advisor (*if present*). Attention will only be drawn to the nature of the application and the premises or person to which it relates. The actual application will not be discussed.

At any hearing of an application, the Licensing Officer, the Applicant and any Representors or representatives will report to reception and be asked to wait in reception until the democracy officer calls them through to the committee room.

Procedure at the Hearing

1. Members of the Sub-Committee will appoint a chair.
2. The Chair introduces the Committee Members and officers [*Democracy Officer, Legal Advisor to the committee (if present) and the Licensing Officer*],

welcomes the Applicant and Representors (or their representatives), and establishes the identity of all who will be taking part.

3. The Chair will explain to the parties the procedure that will be followed at the hearing.
4. The Chair will proceed with the order of business on the agenda.
5. When the agenda item relating to the application is reached, the Chair will invite the Licensing Officer to present the application.
6. The Licensing Officer outlines the application, confirms the application details, introduces the report and gives an update on any recent changes.
7. The Chair will invite Committee Members, the Applicant and Representors (or representatives) to ask the Licensing Officer questions to clarify any points raised in the report.
8. The Chair will ask the Applicant (or their representative) to present their case.
9. The Applicant (or their representative) will present their case and may call any witnesses to support their case *[maximum 15 minutes]*.
10. The Chair will invite the Representors (or their representative) in the following order to ask questions of the Applicant (or their representative) and/or witnesses *[maximum 5 minutes each party]*
 - (i) Police
 - (ii) Other Responsible Authorities
 - (iii) Ward Councillors
 - (iv) Interested Parties
11. The Chair will invite the Committee Members to ask questions of the Applicant (or their representative) and/or witnesses.
12. The Chair will invite the Representors (or their representative) in the following order to state the nature of their interest in the matter, present their case and call any witnesses to support their case *[maximum 15 minutes each party]*
 - (i) Police
 - (ii) Other Responsible Authorities
 - (iii) Ward Councillors
 - (iv) Interested Parties
13. The Chair will invite the Applicant to ask questions of each Representor (or their representative) and/or their witnesses after each presentation *[maximum 5 minutes per Representor]*.
14. The Chair will invite the Committee Members to ask questions of each Representor (or their representative) and/or their witnesses after each presentation.

15. The Chair will invite the Representors (or their representative) in the following order to summarise their case [*maximum 5 minutes each party*]
 - (i) Police
 - (ii) Other Responsible Authorities
 - (iii) Ward Councillors
 - (iv) Interested Parties
16. The Chair will invite the Applicant (or their representative) to summarise their case [*maximum 5 minutes*].
17. The Chair will provide the Sub-Committee with a final opportunity to seek clarification from any of the parties on any points raised, or seek advice from the Licensing Officer on policy, or from the Legal Advisor (*if present*) on law and jurisdiction.
18. When all the evidence has been heard, the Chair will declare the hearing closed and ask the Licensing Officer, the Applicant and Representors (or their representatives) plus any witnesses present to leave the committee room and wait in reception while the Sub-Committee considers the evidence.

Procedure after the Hearing

19. If the Sub-Committee wish to seek further clarification on the evidence given, the Democracy Officer will invite all parties back into the committee room.
20. If possible, and for all hearings under:-
 - section 35 or 39 which is in respect of an application made at the same time as an application for conversion of an existing licence under paragraph 2 of Schedule 8 (determination of application under section 34 or 37)
 - section 85 which is in respect of an application made at the same time as an application for conversion of an existing club certificate under paragraph 14 of Schedule 8 (determination of application under section 85)
 - section 105(2)(a) (counter notice following police objection to temporary event notice)
 - section 167(5)(a) (review of premises licence following closure order)
 - paragraph 4(3)(a) of Schedule 8 (determination of application for conversion of existing licence)
 - paragraph 16(3)(a) of Schedule 8 (determination of application for conversion of existing club certificate)
 - paragraph 26(3)(a) of Schedule 8 (determination of application by holder of a justices' licence for grant of personal licence)

the Sub-Committee will make a decision on conclusion of the hearing and only the Democracy Officer and the Legal Advisor to the Sub-Committee (*if present*) will remain in the room with the Committee Members. These officers

will not comment on the merits of the application, but will be present to provide advice on legal and procedural points and to record the decision.

21. If the decision has been made, all the parties will be invited back into the committee room by the Democracy Officer. The Chair will announce the decision including reasons together with, if appropriate, details of any conditions to be attached to the grant of the licence. This decision will then be communicated in writing to the Applicant and Representors within 3 working days of the hearing. There can be no further questions or statements.
22. For all other hearings not listed above, if the Sub-Committee is unable to make a decision on the day of the hearing, the decision will be made within 5 working days beginning with the day or the last day on which the hearing was held. The Democracy Officer will inform the parties that they are no longer required and the decision will be communicated in writing to the Applicant and Representors within 3 working days of the decision being made.
23. The notification will include information about the rights of appeal against the determination made.

This decision will then be communicated in writing to the Applicant for the Review, the Licence Holder(s) and Representors within 3 working days of the hearing. At this point in the meeting, Members were asked to declare any personal or prejudicial interest they might have in the business on the agenda. No interests were declared.

26. THE DETERMINATION OF AN APPLICATION BY MR. DAVID NORTH FOR A PREMISES LICENCE SECTION 18 (3)(A) IN RESPECT OF 1 PETER LANE, YORK, YO1 8SW (CYC-017182)

Members considered an application by Mr David North for a Premises Licence for 1 Peter Lane, York.

In coming to their decision the Sub-Committee took into consideration all of the evidence and submissions that were presented to them and determined their relevance to the issues raised and the licensing objectives. The following were taken into account:

- (i) The application form, in particular the operating schedule and the additional steps agreed to be taken by the applicant to promote the four licensing objectives.
- (ii) The Licensing Officer's report and his comments made at the Hearing, including the fact that planning permission had been granted for the change of use of the premises from a shop to a café/restaurant. As part of this a condition had been imposed which restricted the opening of the premises to between 08:00 hours and 20:00 hours on all days. He also pointed out that the premises would fall within the Special Policy Area in which additional licensing controls would be in force, if that area is agreed by Council on 7 October 2010.
- (iii) The Applicant's representations at the Hearing, including the nature of their business and the fact that they had endeavoured to mediate the representations prior to the hearing but without success.

- (iv) The representations made by Ms Barnes-Chapman and Ms Barnes-Wilson of Gillies Fabrics, 2 Peter Lane, York in writing and at the hearing. The Sub-Committee considered the written representation to be relevant to the issues raised and the licensing objectives listed above as concerns were raised regarding the potential for public safety and public nuisance in relation to rubbish removal, alcohol consumption and the playing of music which could affect the use of their premises. Photographs were produced at the Hearing, which showed refuse storage issues in Peter Lane viewed from Market Street and the fire escape.

Members were presented with the following options:

| Option 3 | Grant the licence to exclude any of the licensable activities to which the application relates and modify/add conditions accordingly. |

Members chose Option 2 and the following conditions were added to the licence:

1. Alcohol shall only be served ancillary to a meal.
2. The sale of alcohol shall cease 30 minutes prior to the closing of the premises.
3. Seated covers shall be laid out at all times the venue is open for business.
4. The only acceptable proof of age identification shall be a current Passport, photocard Driving Licence or identification carrying the PASS logo (until other effective identification technology, e.g. thumb print or pupil recognition, is adopted by the Premises Licence Holder).
5. Prominent clear and legible notices shall be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and area quietly.

Mandatory condition 19 shall apply.

RESOLVED: That in line with Option 2 the licence be granted.

REASON: To address the representations made.

Report of the Director of Communities & Neighbourhoods

Section 52(2) review of premise licence for the Little John, 5 Castlegate, York, YO1 9RN

Summary

1. This report seeks Members determination of an application for a review of a premise licence, which has been made under the Licensing Act 2003 in respect of Little John, 5 Castlegate, York, YO1 9RN.
2. Name of applicant: Mrs J Robinson
3. Summary of review: This application to review relates to the following licensing objectives: The prevention crime and disorder and the prevention of public nuisance.
4. A copy of the review is attached at Annex 1 and is summarised as follows: This application for review is based on complaints of noise emanating from the premises and the conduct of customers attending the premises. It is accompanied by a “record of issues” recorded by the applicants over a number of years, between August 2007 – October 2010. The “record of issues” is attached at Annex 2.
5. A copy of the premises licence is attached at Annex 3. Which resulted from the simultaneous conversion and variation of an existing licence. The variation was granted following mediation. At this time the licensed area covered both the Little John and Jacks. In October 2005 a variation application was submitted to remove Jacks from the licensed area, following mediation this application was granted. In March 2007 the premise licence was transferred to Mr Chris Ransome who also became the designated premise supervisor. The premise licence authorises the following licensable activities: -

Live Music & Recorded Music	Monday – Saturday 10:00 – 02:00 Sunday 10:00 – 23:00

Supply of alcohol	Monday – Saturday 10:00 – 02:00 Sunday 10:00 – 23:00
Non Standard Timings	From the end of permitted hours New Year’s Eve to the start of permitted hours New Year’s Day.

Background

6. The applicant, in the capacity of ‘interested party’, has requested a review of the premises licence. An “interested party” is defined at s13(3) of the Act as being a person living in the vicinity of the premises, a body representing persons who live in that vicinity, a person involved in a business in that vicinity, or a body representing persons involved in such businesses.
7. A map showing the address of the applicant in relation to the premises is attached at Annex 4. The applicants property is ajoined to the Little John, the applicants lives at the property and operates a bed and breakfast business.
8. Members are reminded that a representation is only “relevant” if it relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives. This is in accordance with S52(7) and (8) of the Act.
9. A representation supporting this application has been received from the City of York Council Environmental Protection Unit. Their representation is attached at Annex 5.
10. A representation has also been received from Gosschalks Solicitors on behalf of their clients, Enterprise Inns Plc, who are the freehold owner of these premises. Their representation is attached at Annex 6.
11. A response from the premises licence holder to the application has been compiled by Denison Till Solicitors. A copy of this response is attached at Annex 7.

Other Relevant Information

12. There are no planning implications in relation to this application.
13. North Yorkshire Police have received a number of reported issues at this premise, a list of the reported issues received for the last 3 months is attached at Annex 8.
14. The Licensing Unit has visited this premise on 5 occasions between 2007 to the present date as part of routine multi agency enforcement work. At 2 of these visits the police found positive drug use in the toilets, 19 April 2008 and 28 June 2008, the police dealt with these issues. Following a visit on 20 December 2008 the Fire Authority determined that a further visit was needed to

carry out a full audit of fire safety measures. At the other 2 visits, 21 February 2008 and 14 August 2010, there were no issues.

Consultation

15. Consultation was carried out by the Applicant and Licensing Authority in accordance with S51(3) of the Act and Regulation 42, Part 4, paragraphs 29 and 38 of the Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005, which concern the notification of a review and the advertisement of review by licensing authority. Copies of the application were served on all responsible authorities and the premise licence holder. Notice of the application was displayed on the premises and on the exterior noticeboard at the Guildhall. In addition relevant Ward Councillors were informed by way of register.
16. As a result of the consultation further representations were received from the City of York Council Environmental Protection Unit and Gosschalks Solicitors on behalf of Enterprise Inns Plc.

Options

17. By virtue of S52(4) of the Act, the Committee have the following options available to them in making their decision:-
18. Option 1: To modify the conditions of the licence (ie to alter, omit or add any new condition).
19. Option 2: To exclude a licensable activity from the scope of the licence.
20. Option 3: To remove the designated premises supervisor.
21. Option 4: To suspend the licence for a period not exceeding three months.
22. Option 5: To revoke the licence.
23. Members are also reminded of the option to issue a 'yellow card', ie a warning as to future conduct which may accompany options 1 – 4.

Analysis

24. The following could be the result of any decision made this Sub Committee:-
25. Option 1: This decision could be appealed at Magistrates Court by the premises licence holder, the review applicant or any of the representors.
26. Option 2: This decision could be appealed at Magistrates Court by the premises licence holder, the review applicant or any of the representors.
27. Option 3: This decision could be appealed at Magistrates Court by the premises licence holder, the review applicant or any of the representors.

28. Option 4: This decision could be appealed by the premises licence holder.
29. Option 5: This decision could be appealed by the premises licence holder.

Corporate Priorities

30. The Licensing Act 2003 has 4 objectives the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm.
31. The promotion of the licensing objectives will support the Council's priority to reduce the actual and perceived impact of violent, aggressive and nuisance behaviour on people in York.

34. The report details the options available to the panel in determining the application and recommends that a decision be reached. There are no risks involved with this recommendation.
