### 1. DECLARATIONS OF INTEREST

The Cabinet Member was invited to declare any personal or prejudicial interests in the business on the agenda. None were declared.

### 2. MINUTES

RESOLVED: That the minutes of the Decision Session held

on 8 March 2011 be signed by the Chair.

### 3. PUBLIC PARTICIPATION

It was reported that there had been no registrations to speak under the Council's Public Participation Scheme.

## 4. APPOINTMENT OF LOCAL AUTHORITY (LA) SCHOOL GOVERNORS

The Cabinet Member considered a report which provided information about the current position with regard to vacancies for Authority seats on governing bodies, listed current nominations for those vacancies, as detailed in Annex 1, and requested the appointment or re-appointment of the listed nominees.

The Cabinet Member thanked Officers for the report and for the hard work of the Governor Service in keeping vacancies at a low level. In response to officers' comments, the Cabinet Member suggested that rather than redressing the political balance of Governors, the Service should encourage members of all political parties to put themselves forward to be Governors.

RESOLVED: That the Cabinet Member appointed or re-

appointed Authority Governors to fill vacant places as proposed in Annex 1 of the Officer's

report.

REASON: To ensure that the Local Authority places on

School Governing Bodies continue to be

effectively filled.

## 5. RESTRUCTURE OF CHILDREN'S CENTRES, EARLY YEARS AND EXTENDED SERVICES

The Cabinet Member considered a report which described the rationale for the review and restructure of Children's Centres, Early Years and Extended Services as a result of national and local policy, local reviews and national and local financial contexts. The report asked the Cabinet Member to approve the restructure.

In response to the written representation and questions from Unison, officers advised as follows:

- There will be a formal review of the 3 strand structure. It
  will be checked within 6 weeks to look for any initial
  problems, then again at Christmas and Easter followed by
  a formal review after 1 year. The views of stakeholders
  and partners will be considered.
- Key roles will be looked at across Early Years and a simple summary chart will be drawn up of the roles to establish who is responsible for what.
- In relation to a post that delivers Extended Learning Opportunities, Officers advised that whilst this had been considered and although they did not want to undervalue such a role, at the moment it would not be possible to fund a part time position. It would be something that could happen in the future.
- It is positive that 9 Children Centres have stayed open, but with a reduced number of staff, the opening times will need to be looked at. Numbers of staff at each centre would be based on the need in each area and the particular Centre.
- The 28% reduction in Government funding and the £1.8m shortfall in grants would not all be met through the restructure. In terms of staffing the figure is 4-500,000k with the rest being found through other routes. Staffing

decisions had not been a 'knee jerk' reaction and had been done in consultation with Unions and taking into consideration the strategic responsibility to Early Years and Children's Centres.

The Cabinet Member thanked Officers for the report and Unison for their feedback and then made the following comments:

- It is important to look at the budget now to avoid further cuts in following years as it is not anticipated that there will be any more cash available in the future.
- It is important to measure the effectiveness of work in Children's Centres and to consider how the work fits in with the Community Cohesion Agenda. Ideally the Children's Centres would be open for longer but this needs to be balanced by jobs.
- The Cabinet Member suggested work could be undertaken with the Director of Communities and Neighbourhood's team to identify opportunities for the Children's Centre buildings to be used for other community groups and purposes.

RESOLVED:

That the Cabinet Member approved Option 1 and so approved the revised structure to enable the delivery of both universal and targeted services against the key principles described in Paragraph 9 of the Officer report, to meet the statutory duties of the Local Authority and to improve outcomes for all children and families.

**REASON:** 

Option 1 keeps all 9 Childrens Centres open, thus providing both universal and targeted services to the most deprived areas of the City, improving outcomes for users. Services are deliverable with the appropriate balance of management, front line delivery and support posts, and the structure will deliver savings still to be found in the 2012-2013 budget. Statutory duties across Early Years will be met.

### 6. TRANSFORMING YOUTH SUPPORT SERVICES

The Cabinet Member considered a report which presented a review of the current City of York Council (CYC) Young Peoples Services (YPS) and York Youth Offending Team (YOT) and offered options and proposals on three interlinked areas of a new integrated service.

The Head of Integrated Youth Support outlined the report and advised that the proposals followed on from the decisions made in July 2010 by the former Executive, to complete the integration of CYC Youth Services and Connexions, to include York YOT. He advised that the challenging areas of work going forward, would be the Youth Support Services Structure as highlighted on page 63 of the agenda and the staff pay and conditions as detailed on page 64.

The Cabinet Member commented that she was happy with the 'Youth Offer' as set out in Annex A and queried how Officers would report on the implementation of it. The Director of Adults, Children and Education suggested that a progress report could be brought back to a future decision session.

The Cabinet Member thanked Officers for the report and all their hard work.

### **RESOLVED:**

- (i)That Option 2 in Annex A of the Report be agreed as the basis of the restructuring of the Youth Support Services with effect from September 2011.
- (ii)That the York Youth Offer set out in Annex A be agreed as the high level framework both for restructuring Youth Support Services and for engaging with the voluntary, community, faith and uniformed youth sectors.
- (iii)That the proposal for a staged approach to harmonisation of pay and conditions as set out in Annex A be endorsed as the starting point for consultation and negotiation with staff and unions.

**REASON:** 

To continue with a process of integration of all youth support services that started a year ago,

## **Appointment of Local Authority Governors**

## Summary

1. This report provides information about the current position with regard to vacancies for Local Authority seats on governing bodies, lists current nominations for those vacancies, as detailed in Annexes 1 and 2, and requests the appointment, or re-appointment, of the listed nominees.

## **Background**

- 2. National benchmarking data on governor vacancies indicates a national average of 10.2% for Local Authority governor vacancies. York has 3 (1.7%) Local Authority vacancies at the time of writing this report.
- 3. The following table summarises the current position of Local Authority vacancies and appointments in City of York schools.

### **Identification of vacancies**

- 4. The overall picture of governor vacancies is informed by a detailed database, which includes records of all schools, the structure of their governing bodies, individuals who serve as governors and terms of office.
- 5. From the database can be determined such information as current vacancies and terms of office which are due to expire. In this way the Governance Service can clearly identify in advance the actions which are required and act accordingly.

## **Reviewing Vacancies**

6. The vacancy position is under constant review. When potential new governors are identified the candidate is interviewed to discuss their interest and suitability. The Chair of Governors and headteacher are also asked to meet with the candidate and show him or her around the school prior to nomination for appointment. This allows the school to assess the potential candidate in terms of

- a good match for the needs of the governing body and current governors.
- 7. Where a term of office is due to expire, the individuals are contacted to ask whether they would like their name to be put forward again for reappointment. Chairs and headteachers are contacted to invite any relevant supporting information. Where a reappointment is appropriate, this is included on the nomination paper for consideration by the Cabinet Member.
- 8. All Local Authority governors are required to apply for an enhanced disclosure from the Criminal Records Bureau.
- 9. It should be noted that, as well as filling Local Authority vacancies, the Governance Service also assists schools who are having difficulties filling community governor vacancies.

### **Political Balance**

10. In York the Local Authority governor seats are filled on merit, rather than by strict consideration of political balance. Just under a fifth of Local Authority governors are, in practice, linked to one of the political parties. Since the recent local election the balance of political representation on governing bodies across the city no longer reflects the balance of the current administration. Steps will be taken to redress the balance over a period of time, whilst always considering the need to identify the best possible governor for a school, rather than taking account of individuals' political affiliation.

### Consultation

11. Consultation on the nominations for appointment has been undertaken in accordance with the agreed procedure for the appointment of Local Authority governors.

## **Options**

12. The Cabinet Member has the options of appointing/re-appointing or not appointing to fill vacant seats as proposed at Annexes 1 and 2.

## **Analysis**

13. If the Cabinet Member chooses not to appoint to fill vacant seats this will have a detrimental impact on the work of governing bodies and their ability to meet statutory requirements. However equally importantly is the need for confidence that the proposals in Annexes 1 and 2 will deliver volunteers who are committed to developing their skills in order to make a strong contribution to the work of the school.

## **Corporate Priorities**

14. Good effective school governance does play a significant role in enhancing individual institutions and contributing as a result to the Learning City corporate priority which describes how

"We want to make sure that local people have access to world class education and training facilities and provision"

### **Implications**

15. There are no implications relating to equalities, crime and disorder, ITT, property, financial, legal or HR issues arising from this report.

## **Risk Management**

16. In compliance with the Council's risk management strategy, there are no risks associated with the recommendations of this report. Good active governance arrangements do contribute to effective school management arrangements and, as a result, reduce risks to the organisation.

### Quarter 1 April – June 2011, Finance and Performance update

## Summary

1. The purpose of this report is to provide the Cabinet Member for Education, Children & Young People with an update on financial performance, progress against service plan improvement actions and performance measures. The Status Card for quarter 1 actions is attached at Appendix 1 and the status for performance measures is at paragraph 9.

### **Financial Performance**

- 2. Leisure and Culture is forecast to achieve £369k against an in year budget savings target of £410k. Savings are being achieved through service reviews and improvements. The £41k shortfall from the savings target is due to additional one off costs incurred during the restructure of the music service. Full year savings will be achieved in 2012/13.
- 3. The approved 2011/12 revenue budget for Leisure and Culture is summarised as follows:




