## **Holding the Cabinet to Account**

# **Changes to Appointments to Council Bodies**

## **Summary**

1. At the Annual Council meeting on 24 May 2012 appointments were made to Committees, outside and partnership bodies together with the appointment of Chairs and Vice-Chairs for the 2012/13 municipal year. However, since those appointments were made, a number of changes have arisen in year.

## **Background**

- 2. The main changes relate to the recent resignation of Cllr Jeffries from the Labour Group to become an Independent Member on the Council and the subsequent effect of this on her membership of a number of Committee's, Sub-Committees and Outside Bodies.
- 3. The second relates to a change in Cabinet Member which requires a change to be made to an outside body appointment.
- 4. The final change is a request to amend a nomination made to the Yorkshire Museums Trust.

## **Legal Implications**

11. The Council is statutorily obliged to make appointments to committees, advisory committees, sub Committees and certain other prescribed bodies in accordance with the political balance rules. These rules may only be waived where no Member votes against the proposal. The above changes in paragraph 5 do not, in part, strictly meet the requirements of rules in so far as the ruling group will no longer have an overall outright majority on 2 Committees. To meet legal requirements therefore, this Committee will need to unanimously agree to the above proposed changes to membership of committees/outside bodies in the light of Councillor Jeffries becoming an independent member of Council.

## **Risk Management**

12. In compliance with the Council's risk management strategy, there are no known risks associated with the recommendation in this report.
