

# **Appointments to Committees and Outside Bodies**

# Summary

1. Following the Council meeting on 11 December 2014 and the appointment of a new Leader of the Council and the subsequent reduction in Cabinet members, a number of changes are now required to the previously agreed list of appointments to Committees and Outside Bodies.

# Background

- 2. At Council on 11 December 2014 Councillor Williams was appointed to replace Councillor Alexander as Leader of the Council. This was followed by Councillor Merrett stepping down from the Cabinet, changes in the Cabinet Members portfolios and Councillor Steward joining the Cabinet as a Cabinet Member without portfolio.
- 3. Although the Council makes appointments at its Annual Meeting, to Committees for the coming year and the Extraordinary Meeting, held on 23 October 2014, reviewed the allocation of seats, appointments to the Council structure and outside bodies for the remainder of the municipal year, further changes have been now requested, in light of the above changes in Cabinet membership.
- 4. Additional changes have also been requested to the Conservative Group's membership on and the Vice-Chair appointment to the Local Plan Working Group.
- 5. As the Staffing Matters & Urgency Committee has authority to deal with any changes or appointments to those Committees and bodies within year, Annex A sets out the list of changes now put forward for consideration.
