# Changes to Committee and Outside Body Appointments

# Summary

 At the Annual Council meeting on 26 May 2016, appointments were made to Committees, Sub-Committees and Outside Bodies for the 2016/17 municipal year. Since then Cllr Steward has stepped down as Executive Member for Finance and Performance, the Leader has taken responsibility for that portfolio and appointed Cllr Lisle in his place as the new Executive Member for Housing & Safer Neighbourhoods. Further to these changes there are a number of consequential changes to the membership of Committee's and Outside Bodies, as set out below.

# Background

- 2. The Council makes appointments at its Annual Meeting, to Committees and Outside Bodies. As the Staffing Matters & Urgency Committee has authority to deal with any changes or appointments to those Committees and Outside Bodies, in year, the following are put forward for consideration;

To appoint Cllr Steward to replace Cllr Lisle on the above Committees.

To appoint a Conservative Member to replace Cllr Lisle as substitute representative on the Economic Development & Transport Policy & Scrutiny Committee (TBC).

- Local Government York, North & East Riding Housing Board
- North Yorkshire Strategic Housing Partnership
- Safer York Partnership

To appoint Cllr Lisle to replace Cllr Carr on the above Board's and Partnership bodies.

# <u>North Yorkshire Pension Fund Committee</u>

To appoint Cllr Carr to replace Cllr Steward on the North Yorkshire Pension Fund Committee.

# York College Governing Body

To appoint Cllr Brooks to replace Cllr Rawlings on the York College Governing Body.

# Consultation

3. Normal processes to consult the relevant political Group have been applied to ensure the Group nominate the Members of their choice. No other consultation is specifically required in this instance.

# Options

4. There are no alternative options available as this is simply for the Groups concerned to nominate appropriate candidates to either replace the Member concerned or to fill the position that has become available.

# Summary
