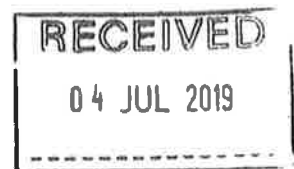



Playhouse are fully aware of the licensing objectives and their responsibilities of upholding these, which is why they are providing high levels of CCTV, door supervision & safety to ensure their establishment maintains the premises in which they are fully aware & proud of

b) The prevention of crime and disorder

A full colour CCTV system is installed and recordings are available on request.
Door supervisors are provided Monday - Sunday and are SIA registered. Mond - Thurs from 22:00 hrs to close and Friday - Sat - from 12:00 hrs - to close and Sun 22:00 hrs to close apart from Bank Holiday 12:00 - close

c) Public safety

A full fire risk assessment has been carried out and a safe occupancy given under the regulatory regime fire safety order.

d) The prevention of public nuisance

From 23:00 hrs All windows doors will be close apart from ingress & egress. Signage will be provided asking customer to respect neighbours and leave quietly. Staff & door supervisors will direct customers to the nearest taxi rank across the road.

e) The protection of children from harm

Families are very welcome in the restaurant with childrens menus provided and hot air balloons, table tennis and games specifically tailored for under 16. All proof of ID will be requested from anyone who appears to be under age of 25 years.
