

# Scrutiny Management Committee (Calling – In)

## Called-in Item: York Racecourse, Application for Lease Extension and Amendments – Report Back on the Results of Further Negotiations

#### Summary

1. This report sets out the reasons for the call-in of a decision made by the Executive in relation to a report that presented the results of further negotiations between Council Officers and York Racecourse regarding the granting of a new lease and recommended that the lease now be granted.

#### Background

- 2. The relevant extract from the minutes of the meeting of the Executive held on 30 June is attached as Annex A to this report. The original report to the Executive is attached as Annex B.
- 3. Following publication of the Executive's decision (in a decision list published on-line on 30 June), Councillors Fraser, Gunnell and Merrett called in the decision for review by the Scrutiny Management Committee (SMC) (Calling-In), in accordance with the constitutional requirements for post-decision call-in. The reason given for the call-in is:-

"That in making their decisions the Council's Executive gave inadequate consideration to the concerns of local residents."

#### Consultation

4. In accordance with the requirements of the Constitution, the calling-in Members have been invited to attend and/or speak at the Call-In meeting, as appropriate.

## Options

- 5. The following options are available to SMC (Calling-In) in relation to dealing with this call-in in relation to the constitutional and legal requirements under the Local Government Act 2000:
  - (a) to confirm the decision of the Executive, on the grounds that the SMC (Calling-In) does not believe there is any basis for reconsideration. If this option is chosen, the decision takes effect from the date of the SMC (Calling-In) meeting;
  - (b) to refer the decision back to the Executive, for them to reconsider or amend in part their decision. If this option is chosen, the decision will be re-considered at the meeting of the Executive (Calling-in) scheduled for Tuesday, 8 July 2008.

### Analysis

6. Members need to consider the reasons for call-in and the basis of the decision made by the Executive and form a view on whether there is a basis for reconsideration of that decision.

### **Corporate Priorities**

7. An indication of the Corporate Priorities to which the Executive's decision is expected to contribute is provided in paragraph 20 of Annex B to this report.
