Finance Update

Summary including Reason for this Decision

This paper sets out some of the known financial implications and asks for decisions on the HRA rent increase and payments to some suppliers.

Reason: To support our residents and suppliers through the Covid-19 outbreak.

Background

Members will be aware of the almost daily announcements from government on the financial support being made available to residents and business.

As well as offering 100% business rate for retail, hospitality and leisure grants of £10k or £25k (depending on rateable value) are also being paid. A government hardship fund has also been announced to support existing Council Tax Support schemes. In addition, a general Covid-19 support grant has been awarded of £4.7m. This is a non ring-fenced grant that can be used to cover any additional costs or loss of income.

To date, we have received just under £10m from government with a further £45m due to be received by the end of this week.

A summary of the financial support available to business and residents is set out in the table below.

Decisions

Following the report and decisions discussed last week, 2 further issues are brought to your attention for discussion.

Payment to Learning Disability Supported Living Providers

A scheme has already been agreed to ensure cash flow is maintained for our suppliers, including making payments in advance, continuing to pay for services that are not being delivered (eg Home to School transport) and paying on planned rather than actual service (eg concessionary fares). It is further proposed that providers of Learning Disability Supported Living Schemes are paid an increase of 5% from 1st April rather than the 2% agreed in the February budget report, at a total cost of £125k. This increase is to cover additional costs of COVID in agency costs etc. that providers are incurring and will be funded from the Covid-19 support grant.

Housing Revenue Account Rent Increase

It was also agreed that the increases in fees and charges agreed in the February to take effect from 1st April 2020 would not be implemented. However, given where we are in the financial year, the housing rent increase has already been implemented on the rents system and will require a software change in order to reverse it. This could take a number of weeks to implement and would require consultancy support costing some £1.5k per day.

All tenants have already been notified of their increase and housing benefit uplifted accordingly. The average increase is £2.09 per week.

We have 1885 tenants on full HB, 1010 on partial HB and 4608 full rent payers. As there is enhanced resident financial support available through YFAS and we are not undertaking any debt recovery activity, it is therefore proposed that the rent increase goes ahead as planned.

The alternative to this is that either no rent at all is taken for April or that credits are processed on to individual rent accounts to reduce the increase.

Work is ongoing to try and understand the overall financial impact on the council. Government has repeatedly assured us that all costs will be covered. The decisions set out in this paper can be funded from the Covid-19 support grant.
