1. Introduction

- 1.1 The National Planning Policy Framework (NPPF) sets out a duty to co-operate between local planning authorities, county councils and prescribed bodies on strategic matters that cross administrative boundaries. This requirement means that strategic policy-making authorities should collaborate to identify the relevant strategic matters which they need to address in their plan. It is recognised that effective and on-going joint working between strategic policy-making authorities and relevant bodies is integral to the production of a positively prepared and justified strategy. Under NPPF (2012), the duty expects local planning authorities to demonstrate evidence of having effectively cooperated to plan for issues with cross-boundary impacts when their Local Plans are submitted for examination. Best practice dictates that statements should also be produced following consultation engagement.
- 1.2 As part of the preparation, local planning authorities are required to consider different geographic boundaries as well as ensure collaboration with private sector, utility and infrastructure providers. The geographical and functional extent for co-operation is set out in the full Statement to Demonstrate Compliance with the Duty to Co-Operate (2018) [CD020¹ and EXCYC7a²]. Local Plan Progress

- 1.1. The City of York Local Plan was submitted to the Secretary of State for Housing, Communities and Local Government on 25 May 2018 for independent examination. Inspectors have been appointed by the Planning Inspectorate to conduct the examination into the City of York Local Plan to determine whether it is sound.
- 1.2. In March 2019 a letter was submitted to the Inspectors detailing 'proposed modifications' to the Local Plan, as a result of new evidence. The response letter from Inspectors in May acknowledged the substantial amount of work that had been undertaken and requested a further consultation on the new evidence and proposed modifications. This was due to new evidence being fundamental to the soundness of the Local Plan, particularly the Habitat Regulation Assessment, approach to the Green Belt and the assessed Objectively Assessed Housing Need.
- 1.3. The Local Plan Proposed Modifications consultation [EXCYC20] took place between 10 June to 22 July 2019. All comments made as part of the consultation were sent to the Inspectors for their consideration and are available via the Examination Library.
- 1.4. Following the consultation, the Inspectors confirmed that the Council would proceed to a first phase of Examination hearing sessions to discuss the principal matters of legal compliance, York's housing requirements and the principle of York's Green Belt. These sessions took place in between 9 -18 December 2019. As a result of these sessions the Council agreed a schedule of further work [EXCYC33] to clarify matters and issues raised through the hearing sessions. Documents to satisfy this schedule were submitted as agreed and added to the Examination Library.
- 1.5. In June 2020, the Inspectors wrote to the Council [EXINS15] to set out their view on Phase 1 hearing matters, particularly in relation to consideration of York's Green Belt. As a result, the Council confirmed it would produce a clarified Green Belt Addendum to address matters raised in the correspondence [EXCYC40].
- 1.6. Additionally, in July 2020, the Inspectors [EXCYC16] requested that the Council consider the release of updated sub-national household projections and whether this materially affected the Council's proposed housing requirement of 822dpa. The Council responded to the Inspectors [EXCYC43] confirming that no change was proposed to the housing requirement, appending for evidence a Housing Need Update (2020) [EXCYC43a].

1.7. The Inspectors confirmed through correspondence in March 2021 that the Council should proceed to consult on a proposed modifications schedule and evidence base produced since the 2019 phase 1 hearing sessions. Consequently, the Council ran a consultation on the 'Proposed Modification and Evidence Base Consultation' between 25 May-7 July 2021.

Purpose of this Addendum

- 1.8. The purpose of this addendum is to provide an overview of the ongoing joint working to satisfy the requirements of the duty to co-operate (the Duty) in preparing the City of York Local Plan since its submission in May 2018. It provides a summary of the consultation undertaken with prescribed bodies as part of the second proposed modifications consultation, setting out who was consulted, the outcomes of meetings undertaken and the responses received to the consultation.
- 1.9. This addendum should be read alongside the full Statement to Demonstrate Compliance with the Duty to Co-Operate (2018) [CD020³ and EXCYC7a⁴], which was submitted to the Secretary of State alongside the Local Plan. This set out a detailed explanation of how cross boundary working has influenced the Local Plan, leading to positive outcomes and providing the foundation for proving that the relevant cross-boundary issues have been identified and addressed in showing how the Council has met the requirements of the Duty.
- 1.10. This Addendum should also be read alongside the Duty-to-Cooperate Addendum (2019) [EX/CYC/23] produced following the first proposed modifications consultation in 2019².

Ongoing Engagement to Phase 1 Hearing Sessions

1.11. In preparation for these sessions, the Council agreed Statements of Common Ground with the following bodies as published on our Examination Library².

2. Proposed Modifications and Evidence Base Consultation 2021

- 2.1 Consultation on the Proposed Modifications and Evidence Base Consultation (2021) commenced for a period of 6 weeks from 25 May to 7 July 2021.
- 2.2 The consultees listed in para 1.2 were sent an email/letter informing them of the opportunity to comment and details of the consultation web page and where to find more information. Consultation procedures were formally set out in the 'Statement of Representations Procedure'.
- 2.3 Additionally, details of the consultation were informally presented to neighbouring authorities as part of ongoing duty-to-cooperate officer discussions with the Leeds City Region and the York, North Yorkshire and East Riding Development Plans Forum. As a result of this, some clarifications in relation to the consultation contents were received via email but no further formal meetings were requested or held.
- 2.4 A summary of the responses received from the statutory and prescribed bodies through the City of York Local Plan Proposed Modifications consultation is set out in Table 1. This is in essence a continuation of Table 4.4 from the full Statement to Demonstrate Compliance with the Duty to Co-Operate (2018) which presents the issues raised by relevant bodies through the Local Plan Preferred Options (2013), the Local Plan Further Sites Consultation (2014), the Preferred Sites Consultation (2016) and Pre-Publication Consultation (2017), in relation to the Duty and resultant outcomes.
- 2.5 In addition to the more formal approaches for cooperating with prescribed bodies and other relevant organisations, as detailed in the full Statement to Demonstrate Compliance with the Duty to Co-Operate (2018) [CD020], City of York Council has engaged on an on-going basis through an extensive series of informal (but recorded) meetings with such bodies and organisations, on a largely one-to-one basis, in relation to the Duty for preparing the City of York Local Plan. This has continued since the Local Plan was submitted to the Secretary of State with ongoing meetings with Highways England, Historic England and Natural England, alongside a number of meetings with sub regional groups of neighbouring local authorities and other bodies as part of the proposed modifications consultation. This recorded informal engagement is summarised in Table 2 / Appendix 1 and should be read alongside Table 4.5 and Annex 2 in the main 2018 statement of compliance and Table 1/ Annex 1 of the 2019 addendum. Additionally, the Council has continued informal communications with organisations by email to update on matters as appropriate.
- 2.6 For this consultation, meetings were also offered to organisations to discuss consultation contents and, in some circumstances, to discuss the response received to progress further discussions and ongoing actions.

This position has been formalised by Selby (and York) and all other Local Authorities comprising the Leeds City Region through the Leeds City Region Statement of Common Ground (March 2020). The unique geography of the City Region determines that partner Councils have a close, but not dependent, relationship on each other for accommodating housing need/ That each Local Planning Authority is planning for their own needs within their own boundaries. For the avoidance of doubt this means that there is no housing shortfall or distribution of unmet need required. New evidence base produced for the City of York Council includes a housing figure of 822 dwellings per annum (Housing Needs Update, September 2020). This differs significantly from the standard methodology figure of 1,026 dwellings per annum. In light of the new evidence base, the standard method and York's complex housing supply position and to ensure that the agreed position of meeting need is delivered, it is essential that the Inspectors are confident that City of York can meet their own housing need within their own authority boundary. Whilst we are aware that City of York Council are being tested under the NPPF transitional arrangements, Selby council wish to seek assurances that City of York Council are able to meet their future housing needs without impacting on Selby District.

Respondent identified that one or more proposed development sites are crossed or in close proximity to National Grid's assets –Site ST9 'North of Haxby' and ST1 'British Sugar'. With respect to the electricity assets, developers of sites crossed or in close proximity to national grid assets should be aware that it is National Grid Policy to retain existing overhead line in-situ. Statutory safety clearances between overhead lines, the ground, and built structures must not be infringed. With respect to gas assets the client's approach is always to seek to leave their existing transmission pipelines in-situ. Contact should be made with the Health and Safety Executive (HSE) in respect of sites affected by High-pressure Gas Pipelines. The client has land rights for each asset which prevents the erection of permanent/temporary buildings, or structures, changes to existing ground levels, storage of materials.

York Teaching Hospital NHS Foundation Trust	Respondent considers that CD020 LP Submission Draft D-t-C Statement does not consider the document to comply with the duty to cooperate. They consider that there has been a lack of engagement with the Trust as the services at York Hospital have not been considered with regards to population growth as a result of the Local Plan. The Trust want to collaborate with CYC and ensure that York Teaching Hospitals NHS Foundation Trust is one of the key consultees at all stages of the Local Plan going forward. The respondent considers that CYC had only previously engaged with the Vale of York Clinical Commissioning Group regarding healthcare provision, but the York Hospital is facing pressures to meet demand in terms of access, A&E attendances, and other acute services. The increased population from the Local Plan projections will contribute additional strain on the Hospital services and therefore need consideration. The Trust would also be keen to be involved in any discussions around Section 106 monies that are available through the Local Plan development. Keen for the Trust and CYC to collaborate more closely to ensure future developments result in positive outcomes.

3. Conclusion

- 3.1 There is a long history of joint working and co-operation between City of York Council, its neighbouring authorities and key stakeholders to achieve better spatial planning outcomes. This has continued in the preparation of the Local Plan. As detailed in the full Statement to Demonstrate Compliance with the Duty to Co-Operate (2018) and the 2019 addendum, on-going and constructive engagement with neighbouring authorities and relevant organisations has taken place at all stages of plan preparation.
- 3.2 This addendum has provided an update in relation to ongoing engagement that has taken place in accordance with the Duty since 2019 and the first proposed modifications consultation. In particular it provides a summary of the recent proposed modifications consultation with regards neighbouring local authorities, the county council, prescribed bodies and other organisations.
- 3.3 It is the Council's view that it has complied with the requirements of the Duty to cooperate. In order to ensure this compliance is ongoing, the Council will continue to meet with other authorities and relevant bodies to discuss strategic cross boundary issues.
