# ASSETS of COMMUNITY VALUE BRIEFING NOTE

#### 1 Introduction

The Community Right to Bid, which was established by the 2011 Localism Act, came into force in September 2012. The right gives eligible groups the opportunity to identify and nominate assets that are of value to the local community and gives them a fair chance to make a bid to buy them on the open market if the owner decides to sell.

A community could use this right to buy a local asset like a village shop, community centre, library, children's centre, allotment or pub. The right covers private as well as public assets.

#### 2 Potential Assets

#### 2.1 Acaster Malbis Memorial Hall

The Memorial Hall is a hall built in 1927, built by the bricks from the local brickyard and using donations from villagers at the time.

The hall is managed by the Acaster Malbis Memorial Hall charity (No 232890) and has 12 trustees.

For the Memorial Hall to be sold the current scheme (Aug 2010) would require modification by the trustees in conjunction with the Charity Commission.

#### 2.2 The Ship Inn

The Ship Inn is a public house in the village that is only one of four listed building in the village and can be traced back to the 1600s. The Ship Inn is owned by Ei Group plc (formerly Enterprise Inns plc) which is the largest pub company in the UK.

The Ship Inn has had several tenants over the years with 1-3 years being a typical duration for a tenancy. The Ship Inn had a period when it was unoccupied around 2009.

The Ship Inn is prone to flooding which can be costly to rectify. The trade is seasonal with busy summer and little off-season trade.

#### 2.3 Holy Trinity Church

The Church of the Holy Trinity, Church Lane is a grade I listed building (entry 1148450) in Acaster Malbis.

#### 2.4 Acaster Malbis Chapel

The chapel sits in the middle of the village and was built in 1880 and is still in use as a chapel today.

#### 2.5 Broadband Mast near to Mount Pleasant

The communications mast near to Mount Pleasant was installed by Quickline Communications and serves Mount Pleasant. The mast was installed prior to the FTTC broadband rollout from Openreach.
