The only acceptable forms of dentification are an international passport, a UK photo card driving licence and a PASS Scheme proof of age card. 2 Do not sell alcohol to anyeody who you suspect is drunk. In addition, you should not sell to anyone whom you believe to be purchasing on behalf of an individual who is drunk or appears to be drunk. If you suspect that someone is drunk then inform the Manager immediately. Do not serve alcohol outside the hours listed on your premises licence. You must also make sure that drinking up is completed within 30 minutes. You must be aware of any conditions which are attached to the licence for your premises and abide by them. 5. Always ensure that you serve a correct measure. It is an offence to give an under measure 6. It is forbidden and against the law to smoke anywhere within the trading premises It is against the law for anyone under the age of 18 to purchase tobacco products such as organettes, if a customer looks under 21 you must ask for identification. 8 It is against the law for anyone under the age of 18 to play on Category C gaming machines, or for anyone to permit or participate in such play, and their use must therefore be supervised, if a player looks under 21 you must ask for identification. 9.
