148/22 Highways, Paths and Verges

- i. Beckside crossing a design has been received from CYC though it does not correspond with the design requested. The crossing needs to be moved nearer to The Green and be a build -out in design.
- ii. Wheldrake Lane the 30mph limit has been extended. The Parish Council has been informed that there is not any money in the current year's budget to do any further work.
- iii. HGVs and speeding there is no further news on the discussions between Julian Sturdy MP and Sir Greg Knight MP. This will be chased.
- iv. Elvington Traffic Survey A Freedom of Information request will be made for the data. YE

- v. Village Walk work on the dangerous barriers near the school is still outstanding. The Clerk will chase CYC. **YE**

152/22 Recent and Forthcoming Meetings:

- i. City of York Local Plan Phase 4 6th September Cllr Gallery was not able to attend. The first draft is expected early December.
- ii. Environment Agency Feasibility Study 20th September the lock gates have not been operational for 13 years and at present there's no intention of doing anything to them apart from making them safe & secure with the ability to open up again if feasible in the future as the cost is in the region of £2m. The sluice gates, built in the 1930's are at the end of their operational life as there's concern that the steel within the concrete counterweights has corroded. EA are modelling various scenarios for replacement, as these are required to maintain the levels for water extraction. Yorkshire Waters fee for extracting water from the Derwent is likely to cover the cost of replacing the sluice gates. The Fish Race does not work and will be replaced with one that is more suitable.
- iii. YLCA York Branch meeting 13th October attended by Cllr Moorhouse.

 Public Footpaths everything underfoot is the responsibility of CYC. Hedges, trees, stiles and gates are the responsibility of the landowner. Finger post signs on metal roads come under CYC. Definitive Maps the working copy on CYC website is up to date.

Stage 3 the IDB will start in a few days to lay a new outlet pipe from the pond followed by re-cutting a boundary ditch down to the outlet into The Derwent.
