The Local Plan forms part of the City's statutory development plan, sets out the vision and strategy for York until 2033 and provides the basis for decisions on planning applications. It also formally establishes the detailed Green Belt boundary.

Further to our letter of 17 February 2025, City of York Council resolved to adopt the Local Plan at a meeting of Full Council on 27 February 2025.

CITY OF YORK LOCAL PLAN 2017-2033

ADOPTION STATEMENT: 27 February 2025

In accordance with the Planning and Compulsory Purchase Act 2004, and the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) this Adoption Statement gives notice that City of York Council resolved to adopt the City of York Local Plan 2017-2033 on 27 February 2025.

The City of York Local Plan sets out the overall strategy and policies for the development and use of land to 2033 and includes a Policies Map.

The City of York Local Plan was subject to independent Examination by Inspectors Simon Berkeley BA MA MRTPI and Paul Griffiths BSc (Hons) BArch IHBC appointed by the Secretary of State. Public Hearings took place in 5 phases, as follows:

- Phase 1 December 2019
- Phase 2 May 2022
- Phase 3 July 2022
- Phase 4 September 2022
- Phase 5 March 2024

Following the Hearings, 'main modifications' were subject to public consultation. The <u>Inspectors' report issued to the council on 14 February 2025</u> confirms that, subject to their recommended main modifications, the Local Plan is sound and legally compliant.

The adopted Local Plan incorporates the Inspectors main modifications, along with additional minor modifications made by the council which do not materially affect the policies in the plan.

Any person aggrieved by the City of York Local Plan may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that:

- a) the Local Plan is not within the appropriate power conferred by Part 2 of the Planning and Compulsory Purchase Act 2004; and / or
- b) a procedural requirement (as defined within Section 113 (10) of the Planning and Compulsory Purchase Act 2004) has not been complied with.

Any such application to the High Court must be made not later than the end of the period of six weeks beginning with the day after the date on which the City of York Local Plan was adopted i.e. no later than 11 April 2025.
