I am writing to object to the request for a licence for Brewhemian Hopsody, 42 Broadway, Fulford, YO10 4JX

I object to this proposal as this is a residential area surrounded by family houses. Noise from people drinking in a beer garden will be heard in my garden and will be a disturbance. As residents that live near the Coop, we already have noise from crates and trolleys delivering early in the morning (often outside the agreed times) and are frequently woken up at weekends at 7am and earlier. It is not fair that we should also have to put up with noise from people drinking in the evenings too.

People should be able to feel that their home and garden is a place to rest and an escape from the hustle and bustle of town and shops etc.

People who have consumed alcohol tend to be loud and will not give much regard to the peace of the residents of the area, as they are there to have a good time and then will return home to the peace and quiet of their own house, away from the drinking premises.

People can also be noisy when they leave licensed premises, singing and shouting and as the proposal is to close at 11:30pm, this would be a public nuisance.

There is also a risk of alcohol-related crime, particularly with violence and anti-social behaviour if customers are drunk, and this will have an impact on how safe the area feels for residents and neighbours. There is an alleyway adjacent to the premises that is not very well lit, and would be dangerous if people were to throw glass over the fence if any disorder did break out.

Parking is also an issue in this area, particularly on Danum Road which is behind the premises. Cars park here to access the coop, and there is already a lack of parking spaces for the residents. The road is regularly blocked and drivers park on the grass verges and my drive has been blocked a number of times. When people are just popping to the coop, this isn't a major issue but if people are parking for a few hours while they visit the then this will put additional pressure on parking in the area.

Hello,

I would like to formally object to the licensing application for 42 Broadway currently under consideration. I am a resident living less than 50 m away from the premises and therefore will be directly affected by the proposed business. Further, I believe that granting a licence for alcohol sales and extended hours of operation poses serious concerns in relation to the four licensing objectives outlined under the Licensing Act 2003. My objections are as follows:

1) Public Safety and 2) Prevention of Crime and Disorder

Increase in crime, litter and anti-social behaviour. Alcohol-related establishments often correlate with an increase in anti-social behaviour, including vandalism, public intoxication, and altercations. The drinking establishment will significantly increase these events. Police are already a frequent presence in the Broadway area with high numbers of anti-social behaviour and public order. A drinking establishment will surely increase this even further. BBC News recently published an article stating that more than half of violent crimes reported in York are connected to alcohol (https://www.bbc.co.uk/news/articles/cly6qngjmg7o). Furthermore, the disposal of bottles and refuse could create additional disturbances and littering issues. The proposed bar is right next to the cut through alley which is already has broken glass, signs of vomit and urine on a regular basis. Allowing a beer bar in the area that already has frequent complaints about anti-social behaviour will only exacerbate the problem.

3) Prevention of Public Nuisance

Noise. No fence would contain the noise of a beer garden. Nor would it contain cigarette smoke. Having a beer garden right next to residents' back gardens would tremendously affect the quality of life. People use back gardens to relax in evenings and weekends, and enjoy the peace and quiet of the neighbourhood. There are also residential flats above the property and directly adjacent to it so these would be overlooking straight into the beer garden. Having a bar and a beer garden open every day and every evening till late would mean constant noise pollution and smoke. Even when the beer garden is closed, there is likely to be noise pollution from patrons arriving, departing, and congregating outside the premises, increased vehicle noise, shouting and the potential for loud music; all of which is deeply concerning and highly disruptive to local amenity, especially during late hours. Residents—including shift workers, the elderly, and young children—would be particularly affected by this.

Traffic. Parking is already a huge problem in the area. There are constant delivery trucks for the shops, people parking inconsiderately for long periods of time and parking all along Broadway and the adjacent streets as there are no parking restrictions yet. Increased footfall and vehicular traffic associated with a latenight drinking establishment will significantly heighten the risk of accidents, particularly in a neighbourhood with narrow streets and limited pedestrian infrastructure. The area is not equipped to handle the safety demands associated with late-night drinking, and the introduction of a licensed premises will compromise the wellbeing of local residents. Overall approval of this application would have a significant negative impact on the area.

Not inclusive. There are many residents of the local area of different cultures, religions and beliefs for whom a drinking establishment would not be appreciated and is likely to negatively affect their quality of life. Accepting this proposal would be unfair firstly on people whose houses would be adjacent to the proposed establishment and secondly to the whole neighbourhood and should be a large concern for the council around the UK equality and diversity principles.

4) Protection of Children from Harm

Out of keeping with the local area. This is a highly residential area with lots of families with young children who have moved to this area for the quiet, safe, clean atmosphere. A bar is not in keeping with the local character and amenities and I believe many residents, myself included, would not have chosen to live in the vicinity of a bar. Therefore introducing a new drinking establishment and beer garden next to residential houses is an unfair change of use for this property.

Furthermore, there is a nursery on the same street, plus a primary and secondary school on adjacent streets. The presence of a bar, especially if alcohol is served during school commuting hours or weekends, would expose children to inappropriate behaviours and potentially hazardous situations. In particular, pupils of Fulford Secondary School frequently commute through Broadway and socialize near the Co-Op store and thus are likely to be adversely affected by a bar at this location. This licencing application is wholly inconsistent with the values and safety standards of our community.

Summary. In light of the concerns I have raised above, I urge the Licensing Authority to reject this application to preserve the safety, peace, and integrity of our residential neighbourhood.
