### Annex 1 - Mandatory conditions

#### MANDATORY CONDITIONS WHERE LICENCE AUTHORISES SUPPLY OF ALCOHOL

- (1) In accordance with section 19 of the Licensing Act 2003, where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- (2) The first condition is that no supply of alcohol may be made under the premises licence -
- (a) at a time where there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

## Annex 2 – Conditions consistent with the operating schedule

#### **Licensing Objectives**

Prevention of Crime & Disorder

1. No one who is drunk or aggressive will be served alcohol.

**Public Safety** 

2. All staff are fully trained, they are familiar with the boat and emergency procedures.

Protection of Children from Harm

- 3. Children under the age of 16 are not allowed to board the vessel without an appropriate adult.
- 4. Proof of age checks carried out.

#### Annex 3 – Conditions attached after a hearing by the licensing authority

- 1. The supply of alcohol shall cease 30 minutes prior of the end of opening hours on each and every day.
- 2. The licensable activities detailed in sections E (Live Music), F (Recorded Music), G (Performances of Dance), J (Facilities for dancing) and K (Facility like music/dance) shall cease 60 minutes prior to the end of opening hours on Sunday to Thursday and at 23:30 on Friday and Saturday.
- 3. The licensable activities detailed in section I (Facility for making music) shall be available during opening hours on each and every day with the exception of singers and bands which shall cease at the same times as E, F, G, J and K. This is to allow for amplified announcements in relations to safety measures.
- 4. Late night refreshment shall cease 15 minutes prior to the end of opening hours on each and every day.
- 5. External speakers should not be used from amplification of regulated entertainment.
- 6. A dispersal policy shall be agreed in writing with the local Licensing Authority and shall be implemented prior to the licence taking affect and adhered to.
- 7. The style of business shall not be changed from a cruise operation and therefore alcohol shall only be served whilst the premises is in motion with the exception of a 30 minutes period prior to the cruise commencing.
