We are proposing to leave the Duchess of York moored at our own pontoons at Acaster Malbis, and use her as a holding facility for customers waiting for a boat trip on the River King, this would also provide a much needed service to the local tourists and boating community. The Duchess would still operate in its normal capacity under its current licence but would serve tea's - coffee - snacks and alcohol for longer periods than the current half an hour allowed and to make this effective we need to remove condition 7

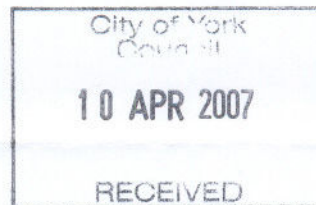
